# George Green Sues Jesus Christ

# 1982 Falkland Islands Crisis

## Look "Deep Within" For *TRUTH*

*(Editor's note: Eleven years ago at this same early-May timeframe, we-the-people were told by the media about a squabble going on between Great Britain and Argentina over some tiny, barren islands in the South Atlantic. I remember, on the front cover of one of the major weekly news magazines at the time, the intimidating picture of a British aircraft carrier and the screaming headline: "The Empire Strikes Back", borrowed from the then-popular Star Wars movies.*

*The media led us to believe it was a "tempest in a teapot" over ownership of those stark specks of real estate hardly visible on the map. We should have known better.*

To give proper placement of background, you must return in your memories back to April of 1982. Move back to the Falkland Islands and South Georgia Island and the war between Argentina and Great Britain over these barren, wind-swept wastelands. Or, were they? Oh, dear ones, what you have not been told would fill mammoth volumes and we haven't time for that. I am going to give you information which is well-known in certain circles but hardly known at all to the populace—you the people. A few have come into this information; enough to confirm the truth of my writings at any rate.

On the surface the whole incident represented a dispute between Argentina and Great Britain over those barren islands. **But surely you have learned by now, that nothing is as it seems.** You are told exactly that which you are to believe and you diligently go about following the orders.

The so-called Falklands crisis was just the visible tip of a giant military operation. During the month of April 1982, fierce naval battles were taking place, not only in the South Atlantic but also in the South Pacific.

The hostilities were very effectively kept under arrest by wartime censorship on all sides of the dispute (and yes, the U.S. was most certainly in the dispute).

On April 30, a total naval and air blockade of the Falklands by the Royal Navy began. At the same time a counterblockade had been declared by Argentina in the same area.

To be effective, a blockade must be imposed over a period of time, but the Royal Navy didn't have sufficient time. Winter was coming on in the South Atlantic, and the British supply lines were overextended. Having traveled so far, however,

Her Majesty's Navy could not simply drop the blockade and sail away in a few weeks time without drawing blood from Argentina. As a result the British would be forced to undertake military operations very quickly no matter how risky they might turn out to be.

**There was also another reason why the Royal Navy had no choice but to engage the Argentine forces in combat. That reason was that the Royal Navy had already suffered losses in secret combat that same month. Only when publicly admitted fighting erupts would the British dare to admit that they had already suffered great battle losses.** And further, to obtain that cover-story, the British had no choice but to sail into combat; but in so doing, they would be risking even heavier losses on top of those already sustained. In short, Her Majesty's Navy sailed directly into a trap.

### THE SPANISH ARMADA

The events which unfolded in the South Atlantic carried strange, ironic echoes of your past. For weeks you had been hearing countless commentators referring to the British task force as an "armada". The British of all people ought to have been very uneasy with that description. The original Spanish Armada some 400 years ago was renowned as a seemingly invincible fighting force, but it came to grief in a naval disaster so complete that it changed the course of history—and it was none other than the English navy that destroyed the Spanish Armada.

The original Spanish Armada put to sea in 1588 during the reign of England's Queen Elizabeth I. The Armada was an invasion fleet carrying thousands of crack fighting men to invade England. They were met by the daring sea dogs of Sir Francis Drake. Drake and his small fast ships turned the tables on the Spanish Armada by changing the rules of battle. The English fleet was equipped with new longer-range guns, and it stayed upwind and out of reach. From there the English pounded, smashed, and shattered the big ships of the mighty Armada. When it was all over, barely half the Spanish fleet was left to limp back to port. Drake's defeat of the Spanish Armada was a shock to the world. It opened the door for England under Queen Elizabeth I to start

its expansion into a truly global empire.

Four hundred years later, history seemed to have come full circle. Queen Elizabeth II witnessed the dismantling of the world empire whose heyday began under Queen Elizabeth I, and now the cultures of England and of Spain were once again in confrontation. Once again a so-called armada was preparing for invasion, but this time the armada was British, not Spanish. Four hundred years past Sir Francis Drake was the hero of the day; today, the ghost of Francis Drake would once again be on the scene.

Please note that the South Atlantic war zone was at the eastern end of the Drake Passage around the southern tip of South America. The defeat of the Spanish Armada four centuries ago broke the back of Spain's naval supremacy, and now it appeared that the defeat of the new British armada might very well break the back of what remained of the once glorious Royal Navy.

### **MILITARY SECRET OF SOUTH GEORGIA ISLAND**

When the Falkland Islands crisis began in early April it looked at first like a mere tempest in a little teapot. For a century and a half since 1833, the Islands had been controlled by Great Britain. During that entire time, British sovereignty over the Falklands had been disputed by Argentina. There had been countless threats by Argentina to seize the Islands, which it called the Malvinas, but the threats had always come to nothing in the past and Britain had never even gotten very concerned over them.

The Islands are four times as distant from Argentina as Cuba is from the United States, and they are not much of a prize, it would seem, under any circumstances. After over 150 years of occupancy, the Falklands are home to fewer than 2,000 British settlers and a great number of sheep and some lovely penguins. In short, the remote Falkland Islands would hardly look like something to fight over, and yet there you were watching another crisis take place. You watched as literal gun-battle war erupted between Great Britain and Argentina and further, without much more than fanfare on your news media presentations.

The Thatcher government was acting as if it had forgotten all about its usual preoccupation with the Soviet threat at NATO's doorstep. Instead, Britain was throwing almost everything it had at Argentina—aircraft carriers, cruisers, destroyers, submarines, assault ships - you name it and if they had it they used it. Luxury cruise ships were even commissioned and turned into troop carriers overnight. Wave after wave of additional assault troops were

activated and sent to join the fleet even after it sailed. Ships and submarines were pulled off station from normal NATO duty and sent to reinforce the task force. The initial 40-ship force grew steadily over the ensuing weeks into an armada numbering over 70. Over two-thirds of the entire Royal Navy was already deployed to the South Atlantic off Argentina.

As this was watched in the unfolding, a lot of people were asking: What's this fight really all about? The most popular answer suggested in the major media was "oil". Vast deposits of oil were known to exist under the continental shelf between Argentina and the Falklands (or so it was projected) and that had been espoused for well over a decade. In no way could it explain the timing of the sudden military offensive by Argentina, and oil explained even less about the Argentine seizure of South Georgia Island.

South Georgia Island is some 800 miles east of the Falklands with no known oil deposits anywhere near it; and compared to South Georgia, the Falklands are quite an island paradise. South Georgia Island is covered with rugged mountains, treacherous valleys, glaciers, and semi-permanent snow. Most of it is uninhabitable. On top of all that, Argentina had absolutely no legal or historical claim to South Georgia Island. In that respect it stood in sharp contrast to the Falklands.

In your early 1830s the Falklands were occupied for a while by Argentine colonists. In 1833 the British expelled them and took over the Islands. For that and other historical reasons, Argentina argued that the Falklands actually belonged to Argentina, not Britain.

But no such argument was possible for South Georgia Island. It was always controlled by Britain, never by Argentina or Spain. The Argentine seizure of South Georgia Island looked even more unreasonable from a military point of view. Argentina's leaders were military men and they thought in military terms and this should be a great clue to you readers. They were well aware ahead of time that far-off South Georgia Island could not possibly be held for long. By seizing it they were setting themselves up to absorb a military defeat, as the Island was retaken by Britain. So the question was: Why did Argentina's military junta bother with the seemingly worthless South Georgia Island at all?

The answers to all those questions were, of course, military, not political or economic. **South Georgia Island possesses an enormous military secret! It is a giant underground installation buried under the mountains at the northwest end of the Island. The real reason for the so-called Falkland crisis was this secret installation, together with two other similar installations which I will also**

**describe in a moment.**

**The secret military complexes had been in existence for many years; they were not new. What was new was an accelerated nuclear war timetable of the American Bolshevik war planners in Washington D.C.** For the prior two months reports of details of that war plan were leaking out as quickly as they could be verified.

**The plan called for NUCLEAR WAR ONE to erupt by September of the year 1982. It was that fast-approaching nuclear war threat that caused the so-called Falklands crisis to erupt when it did.**

What was actually taking place was a coordinated effort to spoil part of the Bolshevik grand strategy for the coming nuclear war. The mutual enemies of the American Bolsheviks in the U.S.—namely, the Rockefeller cartel, and Russia's new rulers in the Kremlin were behind the crisis. They were trying to ruin Phase #3 of the "PROJECT Z" war plan which has since been revealed. [*Described later in this narrative.*]

That phase was to be world domination by the American Bolsheviks after both Russia and the United States had been destroyed in NUCLEAR WAR ONE. The key to this plan was the existence of secret weapons stockpiles in various places around the world!

The American Bolshevik military planners in America were working with other Bolshevik agents in key military positions of other countries to set off war. Having done that, they intended to ride out the nuclear holocaust they had caused, safe and cozy in Government war bunkers! When the warring nations would finally lie smoldering and exhausted, the Bolsheviks would leave the shattered remains of their host countries. They would rendezvous at the secret weapons installations and bring their weapons into the open. They would confront the world with the only remaining fresh, up-to-date powerful military force on Earth; and using that military power, they would become the undisputed rulers of the world. They planned to do all that, and they planned to pave the way for world domination by setting off NUCLEAR WAR ONE within mere months of that April—remember, September!

The Rockefeller cartel and Russia's new anti-Bolshevik rulers were working together in a race against time to try to head off the Bolshevik war plan.

Ironically, the Bolsheviks in the U.S. were already benefitting from war preparations which were started by the Rockefellers long before. It had only been about three years since the Rockefellers were dislodged as the prime movers of the United States Government by the Bolsheviks. Since that time the United States Government

had been a house divided, torn by internal power struggles between rival Bolshevik and Rockefeller factions. But prior to that, the United States had been dominated for decades both economically and politically by the four Rockefeller brothers.

In 1961 the Brothers launched a new long-range plan for world domination. It was a two-pronged strategy, half visible and half secret, which has been described prior to this writing. It was a plan for the United States to arm to the teeth in secret while appearing to disarm gradually. Without repeating all the details, the basic idea was grandiose indeed, yet simple. By deliberately appearing weak, the Rockefeller-controlled United States would maneuver itself into a nuclear war with Russia. Then the secret weapons, including superweapons, would be unleashed to smash Russia and take over the world.

When they set the grand plan in motion in 1961, the Rockefeller Brothers were looking ahead to a nuclear war by the late 1970s. Their military analysts concluded very early that the war being planned would have very different effects on the Northern and Southern Hemispheres. Both superpowers, the United States and the Soviet Union, are located well up in the Northern Hemisphere; so are the other full-fledged nuclear powers—Great Britain, France, Red China, and India. By contrast, the strategic targets for nuclear war in the Southern Hemisphere are relatively few and far between. In other words, it was expected that the coming nuclear war would be essentially a Northern Hemisphere war.

In an all-out nuclear holocaust it is known that serious radioactive fallout would gradually spread to affect even areas not initially hit by war. But there are limits to how far the war clouds can spread. It was discovered long ago that there is very little mixing between the air of the Northern and Southern Hemispheres. In the northern half of your planet, cold air from the North Pole works its way southward toward the equator, then it works its way back to the north as warm air. A mirror image of this process takes up the southern half of the planet. Northern and Southern Hemisphere air meet in the equatorial zone, but very little of the air from either hemisphere changes places with the other's.

The military conclusion is this: The coming nuclear war could ruin vast areas of the Northern Hemisphere for generations forward; but if the calculations are correct, the Southern Hemisphere could escape virtually unaffected by the war. This was surely music to the ears of the four Rockefeller Brothers. A quick look at the globe of the world shows why this would be a reasonable calculation. The Rockefeller cartel has dominated Latin America ever since World War II. As discussed in prior publications, Nelson

Rockefeller solidified the cartel grip on Latin America during the war. He accomplished this as so-called "Coordinator of Hemispheric Defense" for then-President Franklin D. Roosevelt. So that takes care of the South American continent and its natural resources.

Then let us turn to the African continent. There, too, Rockefeller control was already in effect over wide areas of Black Africa, especially south of the equator. All this was thanks to the efforts of John D. Rockefeller III, as previously detailed elsewhere.

Looking around the globe, the most important remaining land masses from the standpoint of world domination are *AUSTRALIA AND NEW ZEALAND*. Thanks to World War II, both were wide open to the Rockefellers.

**The Rockefeller Brothers decided to establish secret military installations in the Southern Hemisphere for use after the coming war. By this means they expected to become the masters of the surviving southern half of planet Earth; after the Northern Hemisphere gradually recovered from the nuclear holocaust, the Rockefeller empire would be able to pick up the pieces. In this way the third generation Rockefeller Brothers expected their family dynasty to inherit the Earth.**

In order to control the Southern Hemisphere militarily after the war, some means would have to be available to project military power onto any land mass. For example, revolts against Rockefeller domination would require troops—not a blast from the beam weapons on the Moon (another very interesting story).

The most critical factor for postwar military domination of the world was found to be a NAVY! A minimum of two secret naval fleets would be required—one based in the South Atlantic, the other in the South Pacific. Since the reserve naval fleets were to be kept secret until after the Northern Hemisphere nuclear war, they could not be built in existing shipyards. New construction facilities had to be built and they had to be hidden. To hide an entire shipyard is no small task; they take up a lot of space. On top of that, it was essential that the ships remain hidden after they were built. The best way to achieve that was to combine the shipyard and naval base into one over-all secret installation. Finally, the secret naval installation had to be invulnerable to nuclear attack; otherwise if its existence were ever discovered prematurely, the secret navy might be wiped out.

The combined requirements for secrecy, space, and protection against attack were formidable; but one day in 1959, while all these plans were still in the early stages of development, the answer presented itself. During a so-called banking trip to Sweden,

David Rockefeller was given a tour of a unique hidden naval port. The port is hollowed out from solid granite cliffs which come right down to the water. The entrance to the port is a gigantic hole in the side of the cliff which can be sealed off with enormous steel doors. Inside this big doorway on the water a huge cavity has been hollowed out to accommodate ships.

The Rockefeller Brothers and their military advisers decided that a bigger, more secret, better protected version of the Swedish hidden port was just what they wanted. A survey of candidate sites was then initiated. The site survey covered coastal areas throughout the Southern Hemisphere. Many areas were rejected very quickly because the topography was wrong. Other areas were rejected because they were too close to the equator. Still others had to be ruled out because there were too many people living nearby, making the desired level of secrecy impossible. Finally, it was essential that the sites chosen for the secret naval installations be totally secure politically.

At last the sites for the secret naval installations were selected. In the South Pacific extreme southern New Zealand was selected. New Zealand would be extremely important during a coming war.

In order to obtain the necessary space, the secret New Zealand naval installation had to be divided up into two sites located close together. One is at the extreme southwest tip of South Island where the mountain range known as the Southern Alps comes down virtually to the water's edge. The other part of the installation is built into the northwest tip of Stewart Island, which is off the tip of South Island. The Stewart Uskabd facility is hollowed out within a rise known as Mt. Anglem.

The New Zealand location met all the requirements. Ever since World War II the government of New Zealand has been tied even closer to the United States than to Great Britain. The location is far from the equator, and the installations are buried deep under mountains, protected from nuclear attack. They are also too deep to be reached by particle-beam attacks, and the New Zealand site is well situated to command the entire South Pacific.

In the South Atlantic an even more perfect site was found. That site, my friends, is South Georgia Island. It is located perfectly for naval domination of the entire South Atlantic. The tall rugged mountains provided a perfect location for the secret installation at the northwest tip of the 100-mile long island. It is controlled by Great Britain whose government, like that of New Zealand, was willing to cooperate; and South Georgia Island was virtually uninhabited except for a whaling station on the northeast coast. The whaling station was some 50 miles away from the

secret new installation which was being built, but Britain took no chances. In 1965 the whaling station was closed down. Since that time there have been no inhabitants on South Georgia Island except for a few dozen alleged Antarctic scientists.

Construction of the secret naval facilities—two in New Zealand, one on South Georgia Island—began in the early 1960s. The techniques were adapted from those used previously to build other large underground facilities, such as the NORAD installation inside Cheyenne Mountain, Colorado (there are others well protected underground but we shall not go into those presently). However, these installations and techniques were adapted in radically new ways to achieve construction access directly from the sea instead of overland. In this way, the sheltering mountain was left undisturbed in appearance both during and after construction.

The cuts in the mountain side which were necessary to let ships in and out were kept as small as possible and were well camouflaged. Like the Swedish hidden naval port arrangement, the entrances to the secret installations can be sealed. When sealed, the entrance is virtually impossible to detect unless you know exactly where it is; and unlike most large construction projects, there are no tailing or piles of leftover rock lying round to attract undue attention. The man-made caverns which house the secret naval installations are enormous, but all the rock and debris was disposed of at sea.

Once the secret naval facilities were built, they had to be outfitted for ship construction and dockside storage. **The fake disarmament of the United States during the 1960's contributed greatly to this task. From 1961 to 1968 one man played a pivotal role in this elaborate Rockefeller scheme. He was then-Secretary of Defense Robert McNamara. All through the 1960's McNamara presided over the public paring back of America's visible military power. This included the closing down and dismantling of entire shipyards. What you were not told was where all that shipyard equipment went afterwards.** Where it went, my friends, was to the new secret installations which were being outfitted in New Zealand and South Georgia Island!

**The secret naval installations have been used as duplication facilities to reproduce certain ships and submarines designed and built here in the United States. As Defense Secretary Caspar Weinberger told Congress, "It is cheaper to build two ships at a time." That is most especially true if the second ship is an exact duplicate of the first.** This has become even more true in recent years through the use of computerized manufacturing techniques.

The secret naval fleets which have been built at the secret installations are made up of duplicates—EXACT DUPLICATES of certain other ships and submarines. They are all nuclear powered—nuclear "subs"; nuclear cruisers; nuclear destroyers; and yes, nuclear aircraft carriers, at least three of them. A secret twin was built for the U.S.S. Nimitz, for the U.S.S. Eisenhower, and for the U.S.S. Carl Vincent. All have been financed through the gigantic cost overruns, so called, that you constantly hear about in the Defense Department and can't find anything about due to above top secret designations; all three carriers have been provided with a full complement of aircraft whose manufacture was financed in the same manner.

The ships of the secret American Bolshevik naval fleets are all duplicates of other nuclear-powered vessels. Even so, **the secret naval ships possess one key difference.**

**The so-called "Stealth Program" may not be too effective with the planes, etc., you have been allowed to witness but, oh my, lots of interesting things go on with things you aren't given to witness.**

**There was developed a type of electromagnetic invisibility shielding. This technique makes an object invisible from a distance by distorting light waves in its vicinity.**

**A whole new fleet of Phantom warplanes went into crash production under a top secret shield. They utilize this principle; and all of the secret American Bolshevik navy ships have already been outfitted with similar Stealth-field equipment!** The Stealth principle is actually easier to apply to ships than to airplanes because there is more room for the powerful equipment that generates the force field.

After NUCLEAR WAR ONE, the secret Stealth navy of the American Bolsheviks would be light years ahead of any other navy left on Earth. It would be perfect for the intended role of world domination. The Rockefellers set it all in motion long ago—but about 1979 they lost control of the United States Military. Now it is the American Bolsheviks who are in control, and they are most surely bent straight ahead on war.

Now don't go about forgetting about the Nazi war machine also in the Antarctic—isn't this just about as much intrigue as you can take at one sitting?

#### SECRET NAVAL WAR OF THE SOUTHERN HEMISPHERE

As we move along and to make things clear, we shall discuss the referred-to "PROJECT Z" I mentioned in the previous

chapter. It is the new Bolshevik three-phase strategy for NUCLEAR WAR ONE. However, since it didn't come off on schedule I feel we will not be misleading if we stick with references to the area of the Antarctic. The most skeletons to arise from the dead to getcha are all parading around "under" and "within" the Southern Hemisphere and that, after all, was the subject of this JOURNAL. I do have trouble keeping to one subject for all facets are so intertwined.

The plan in 1982 was that of an elite group of American Bolshevik military planners by which the U.S. would strike the first nuclear blow, followed by all-out thermonuclear war with Russia.

After having set off the holocaust, the Bolsheviks in the U.S. and in certain other countries planned to ride it out safely in comfortable war bunkers already in place and well stocked with luxuries. Finally, after NUCLEAR WAR ONE fizzled out in stalemate, they planned to leave behind the ashes of the U.S. and her allies. Activating Phase #3 of their grand strategy, they planned to unveil their secret weapons, especially their secret naval fleets. With these they planned to conquer and rule what would be left of the world. The United States as you know it would be long dead and gone; but in the eyes of the Bolsheviks themselves, this outcome would constitute victory for many reasons.

Up to April of 1982 the nuclear war timetable was still on track. They were still shooting for nuclear war to begin by September of that year. Actually this continued right to the date set of September 17, 1982.

What saved you is that the Bolsheviks were running as fast as they could toward war; but, the Bolsheviks are not the only runners in the race. They have two deadly enemies, both of whom are equally determined to trip up the Bolsheviks. One enemy of the Bolsheviks in the U.S. is the Rockefeller cartel; the other enemy is the new anti-Bolsheviks ruling class in Russia: and now these two mutual enemies of the Bolsheviks are pooling their efforts in certain ways.

The new anti-Bolshevik coalition is now much more firmly established but in 1982 it was still quite new and was working between the Rockefeller cartel and the Russians. The January 26, 1982 meeting between Haig and Gromyko in Geneva, Switzerland, was a turning point in the formation of this coalition. It is now a reality, and is responsible for the so-called "Falkland crisis" which dominated the headlines in April and May of that year. It should be emphasized that the new relationship between the Rockefeller cartel and Russia fell far short of a true alliance, at least at that time. They have very major disputes to be settled between them, but

they called a truce between themselves to deal with the mutual deadly enemy—the Bolsheviks in America.

**The first priority of the Russians and the Rockefellers is to slow down the Bolshevik preparations for imminent nuclear war. If they could do that, time would be on the side of the Rockefeller cartel in certain political movements. A slow-down in the nuclear war timetable will also give more breathing space for additional anti-Bolshevik actions to be implemented.**

The joint Rockefeller-Russian planners decided by mid-February of 1982 that military action against the Bolsheviks was essential very quickly. No other type of action had any hope of taking effect fast enough to prevent nuclear war by the end of the summer.

The exact details of the "PROJECT Z" war plan were not known to either the Rockefellers or the Russians, but the general outlines were known to be pretty well outlined and set-up.

It was decided that military action should be devised that would undermine Phase #3 of the Bolshevik war plan—that is, the Bolshevik-controlled secret naval installations and fleets in the Southern Hemisphere should be attacked and crippled. By working together, the Rockefeller cartel and the Russians were able to devise an attack plan which neither could have carried out alone. The Rockefeller group, who built and originally controlled these bases, provided detailed intelligence about the best way to attack them. The Russians with their enormous military machine provided the muscle to actually carry out the attack.

It was essential to devise a scheme that would enable both secret fleets in the South Atlantic and South Pacific to be attacked. Survival intact of either fleet would leave the Bolshevik war plan still workable.

Military analysts concluded very quickly that a direct assault on the New Zealand facilities was out of the question. There was no combination of commandos, frogmen, or other military force which could possibly keep an attack secret from the outside world. Any attack on the New Zealand bases would set off the very war which the Rockefellers and Russians wanted to prevent.

But the situation in the South Atlantic was a different matter. In a way, the greatest asset of South Georgia Island was also its Achilles' heel. The extreme isolation which protected the secrecy of the South Georgia base also made a covert military assault feasible. The key lay with Argentina and her long-standing claims to the Falkland Islands.

### THE FALKLAND ISLAND WAR

The Rockefeller cartel had dominated all of Latin America for decades. Cartel operatives were sent to Argentina to work

out a deal with the government military junta there. The historic dispute over the Falkland Islands was to be used to provide a ruse, a military cover, to enable the South Georgia base to be attacked. The Argentine generals were not told everything about the situation by any means, but they were told enough to make clear what they were to do.

As an inducement to cooperate, the Argentine leaders were promised handsome rewards. They were guaranteed that after the shooting was over, the Falkland Islands would remain in Argentine hands. This guarantee included the promise of covert military assistance as needed against the Royal Navy. And, to bolster the troubled Argentine economy, it was promised that the Rockefeller cartel would help develop the immense offshore oil reserves. With those combined promises of military glory and financial rewards, the Argentine military junta agreed to the plan.

So, backing up to March 19th, Argentina carried out Act One in the joint attack plan. A group of Argentine scrap-metal merchants, of all things, landed at the abandoned old whaling station on South Georgia Island. Supposedly they were there to dismantle the old buildings and carry them off to sell. While they were at it they also raised the Argentine flag over the work-site. The British, always nervous about South Georgia Island, promptly reacted exactly as expected. The British Antarctic survey ship "Endurance" put 22 Marines ashore to clear up that little misunderstanding.

They drove off the scrap merchants and promptly tore down the Argentine flag. The incident provided the exact desired excuse for the Argentine Junta to bring the simmering 150-year-old Falklands dispute to a boil. From time to time in the past, Argentina claimed that South Georgia was part of the Falklands because it is administered that way by Britain. That argument was very flimsy but it then came in most handy indeed. It was nothing new to hear that claim from Argentine leaders, so there was no hint of what was really afoot.

During late March, Argentine military forces started assembling for an assault on the Falklands. The British command thought there was nothing new for Argentina had carried out threatening maneuvers in the past many times. It was believed that they were about to do it again; but on April 2 Argentine forces did the unexpected. After many past false alarms, this time they actually invaded and seized the Islands. All Argentine public statements emphasized the long-standing historical claims to the Falklands themselves; but just for good measure, the next day a small Argentine force also seized far-off South Georgia Island. The force was so small that it gave the appearance initially that it was just a side show from Ar-

gentina's point of view; however, the small contingent of 22 Royal Marines were overpowered and bundled off the Island along with a group of 13 alleged scientists. That was a moment of pay-off in the joint Rockefeller-Russian attack plan.

### "SPUDDING IN"

Thanks to the elaborate distraction staged by the Argentine forces; a special commando team got onto the Island totally undetected. Based on the detailed Rockefeller information about the base, the team moved to the location on the mountain directly above the cavernous secret base. Special high-speed drilling equipment was set up by the Rockefeller members of the team while the Russian members concentrated on military defense. By late that same evening, April 3, the military high command in London finally learned what was really taking place. The secret South Georgia base was under attack by virtually the only means possible. The joint Rockefeller-Russian team were drilling a shaft down through the mountain toward their hollowed out cavern inside. It was only a matter of time until their drill would break through the ceiling of the giant hidden naval base. Once the hole was made, the next step was obvious. The Rockefeller-Russian team would put a weapon of some kind through the hole. The best guess was that it would be probably nerve gas—it just doesn't pay to "guess".

The shock waves that went through the highest levels of British government on the evening of April 3 can hardly be described. The Thatcher government, like the so-called Reagan Administration in America, is Bolshevik controlled. Well, the Russians told you they would rule the world and it might very well be done without firing a shot!

That was why Margaret Thatcher always said, "Me, too." any time the Reagan Administration said it would do anything to Russia. Please note that it hasn't changed very much. What of the Stinger missile "sting" in Florida and the "I agree and support the U.S." in Panama this past December? Both governments are party to the secret nuclear war plan in complete betrayal of the people of their respective countries, and on the evening of April 3 they suddenly discovered that their precious war plan was in deep, deep yogurt, I believe you call it—amongst other terms.

Immediately the Thatcher government started assembling a naval armada to sail for the South Atlantic. Haste was their order of the day. The drilling on South Georgia Island was proceeding around the clock. The best estimates were that the drilling would break through into the roof of the naval base in about three weeks, on or about April 24—but it is a very long drive from England to Antarctica on the best of

ships. If help did not reach South Georgia by then, the secret installation might be doomed. The forces stationed at the installation itself were unable to defend themselves under the circumstances. Their mighty naval ships were ships in a bottle. They did not dare open the bottle to sail out and fight because the Russian commandos were armed with far superior technical and nuclear weapons. (Who do you think might be the closest allies to the Nazi undercover workers?) We are talking about ones who do not care greatly for the Jewish element, much less the Zionist-affiliated Jews. To open the blast-proof entrance doors would be suicide.

On April 5, just two days after South Georgia Island was seized, some 40 naval ships began moving out of British ports. The same day Lord Carrington was sacked as Foreign Minister. He was forced to resign because he had assisted the Rockefeller attack plan by downplaying the Argentine attack preparations. Even the evil don't have any way to count on their own.

That same day, April 5, New Zealand, the home of the other secret naval fleet, broke diplomatic relations with Argentina. The two hidden New Zealand facilities had been placed on "Red Alert" (no pun intended). As a precautionary measure, all submarines at the twin base were ordered to sea. Several surface ships were already at sea undergoing "sea trials", but that still left seven major ships inside the hidden twin naval base including one of the nuclear aircraft carriers.

On that busy day of April 5, Argentina's Foreign Minister, Costa Mendez, was at the United Nations in New York. Come on readers, go look it all up in the records—don't just stand off and accuse me of insanity—go look and find for yourselves.

Mendez was alarmed by the deployment of such a large part of the Royal Navy. Costa Mendez hurried to Washington to seek reassurances from certain U.S. officials. Of course he got them!

For the next two weeks or so the news was filled with stories about the allegedly slow movement of the British fleet while negotiations went on. That was only a cover story. The Royal Navy was actually joining up and paddling as rapidly as possible toward South Georgia Island. If the task force arrived in time to save the secret base, a major battle was likely. The official stories about "slow movement" of the British armada were intended to give a cushion of time for that battle. If need be, the fleet would have several days to retake South Georgia Island, then it could move on to arrive near the Falklands on the announced

schedule. In that way the crucial importance of South Georgia Island would be hidden and the big secret preserved.

It was initially expected that advance elements of the British fleet would reach the vicinity of South Georgia Island within two weeks. That would have been soon enough to attack the joint Rockefeller-Russian commando team and stop the drilling before it was completed. But Russian Cosmospheres and submarines made a shambles of the plan.

#### A KEY SHIP DESTROYED

Key advance elements of the South Georgia attack contingency left Ascension Island early April 14, two days before it was announced officially. Shortly after they did so, they ran into trouble. Russian Cosmospheres and attack submarines closed in on a single ship which was critical to the planned counterassault on South Georgia Island. The Cosmospheres bombarded the bridge and combat information center of the ship with neutron radiation. In moments the ship was without any command, its communications and radar silenced. Then a Russian "sub" closed in and quickly finished off this key British ship with torpedoes. It broke apart with secondary explosions and sank rapidly. So far as was known, there were no survivors.

That unexpected shock in the mid-Atlantic produced two results, both very important: First, it caused a slowdown in the race toward the South Atlantic by the British armada. The task force had to be regrouped into a configuration better suited for an enroute defense, but that cost valuable time. Public announcements from London about the progress of the fleet reflected the slowdown. The timetable for arrival on battle stations near the Falklands started stretching out longer and longer. All this bought extra time for the joint commando team on South Georgia Island. And so the drilling continued.

The other result of the sinking was equally important. Word was flashed to the South Pacific Stealth navy to prepare for possible action. It was obvious that the Russian Navy was getting involved in the Atlantic, which meant that the Royal Navy could be in big trouble. During the dead of night, early April 15, the seven Stealth ships put to sea from their twin secret bases in southern New Zealand. They deployed to a secret operational headquarters area in the Antipodes Islands, 450 miles southeast of New Zealand. Their electromagnetic shields were operating to provide protection from attack. These shields make it impossible to communicate with the outside world or even to see it. But once they arrived

at the Antipodes, the Stealth ships hooked up to buoys equipped with shielded communication cables to the Island headquarters. The Island headquarters, in turn, was in constant touch with the South Georgia base by way of a transoceanic cable around the tip of South America. The deployment of the available ships of the South Pacific Stealth fleet was exactly what the joint Rockefeller-Russian planners had hoped for. The ships had been flushed out from their essentially invulnerable hiding place in New Zealand!

The British ship's sinking of April 14 was also followed by other events. On April 15 the Argentine Navy started moving out of port. The same day, Alexander Haig arrived again in Buenos Aires. Supposedly he was there as a diplomat, but in reality he was there as a General, dealing with Generals. Haig was the top Governmental operative of the Rockefeller cartel. He was making sure that the Argentines did not get cold feet and back down at that critical moment. Four days later, April 19, Haig left for Washington. As he boarded his plane, Haig somberly told reporters, "Time is running out." And so it was, my friends, for the secret South Georgia base. We shall also have a lot more to say about General Haig in future writings.

#### NOT EXACTLY A DRY HOLE

The very next day, April 20, the drill broke through into the hollowed-out cavern of the naval base. Bolshevik military analysts in London had not expected that it could be completed until at least the following weekend. The British fleet was still out of range.

THE WEAPON WHICH THE COMMANDO TEAM INSERTED DOWN THROUGH THE LONG HOLE WAS A *SMALL, COMPACT RUSSIAN NEUTRON BOMB*. When it was detonated inside the confines of the huge artificial cave, the effects were, of course, totally devastating. The intense radiation instantly killed everyone inside the base. Also the heat and blast effects of the bomb are believed to have damaged all of the ships inside sufficiently to badly disable them.

Meanwhile, Russian Cosmospheres and submarines were converging on the Stealth ships which were near the Antipodes Islands awaiting orders. From a distance, the ships were invisible to the eye due to their protective shields, which also protect against beam-weapon attack; but they were sitting ducks for the tactics which the Russians employed.

#### THE COUP-DE-GRACE

Floating overhead, the Cosmospheres

located the seven ships using their Psychoenergetic Range-Finding equipment known as PRF. There is no method known by which PRF can be jammed. The Cosmospheres radioed the exact locations of the ships to the attack submarines. The "subs" were armed with special non-homing, non-nuclear torpedoes designed to explode on impact. More sophisticated torpedoes would have been thrown off course or detonated prematurely by the protective shield of each ship; but these simple torpedoes just cruise right through each invisibility field to strike the ship and explode. Within 15 minutes after the attack began, all seven Bolshevik Stealth ships were on their way to the bottom, and with them went their Bolshevik Commanders and mercenary crews collected from around the world.

The South Pacific action took place just after sunset local time. The time in Washington was around 2:00 P.M. April 23. That evening Secretary of State Haig was seen briefly in public with the new British Foreign Minister, Francis Pym. Pym was wearing the typical artificial pseudo-smile which diplomats are taught always to display in public. But not Haig. Haig was grinning from ear to ear, and no wonder. The joint Rockefeller-Russian military operation had been a brilliant success. The secret Bolshevik South Atlantic fleet had been virtually wiped out, bottled up inside South Georgia Island; and the South Pacific fleet, while not totally wiped out, had been badly crippled. By working together, the Rockefeller cartel and the Russians had won the secret naval war of the Southern Hemisphere.

Dharma, you are too fatigued to continue today so let us leave this for now. We will discuss the ensuing Rockefeller fear campaign against nuclear war when we resume. Thank you for your service and blessings unto you dear ones. Rest well and we shall resume tomorrow morning. Good evening.

Let us continue with the wrap-up of the Falkland Islands war and discuss the ensuing Rockefeller fear campaign against nuclear war.

#### CAMPAIGN AGAINST NUCLEAR WAR BY THE ROCKEFELLER CARTEL

At the point of June, 1982 it would appear that war of a major size was about to break out in the Southern Hemisphere, but the real war in the Southern Hemisphere was already over. What you witnessed was the beginning of its bloody aftermath. That aftermath was the battle for the Falkland Islands. They had been promised to Argentina as a reward for her role in the secret war.

As things were happening in the Antarctic area the Bolsheviks were in Washington D.C. pressing for a public announcement that the U.S. would side with Britain. As soon as that would take place, military action would heat up quickly around the Falkland Islands. Britain had no choice but to fight. She had already suffered casualties which could not be explained without a public battle; but by fighting, the Bolsheviks in Britain were running the risk of a humiliating and tragic defeat for the Royal Navy.

Meanwhile "back at the ranch", the Rockefeller strategists in the U.S. were concentrating on a fast-building, anti-nuclear-war campaign. On all sides you were hearing about the so-called "nuclear

freeze movement". There were documentaries, articles, publicity of all kinds to sensitize you to the terrors of nuclear war. There were even referenda popping up on election ballots dealing with the nuclear war issue. Medical doctors were banding together to warn the public about what would happen if there would be a nuclear war.

You were being told that all this was just popping up spontaneously. You were then into 37 years of the nuclear age and nothing like that had ever gained so much momentum before, yet you were supposed to believe that millions of Americans had spontaneously gotten the same ideas at the same time. If you believe that, my friends, I give up! Movements like that never, NEVER, develop without leadership, organization, and money—PLENTY OF MONEY! But can you see a bit further now? If you can pick up the momentum now you can make great changes to care for your population. Truth and knowledge can most surely preserve what freedom is left to you and bring you into a safety survival mode. Ponder it as we continue.

What you were watching at that time was the Rockefeller public relations machine at work. The Rockefeller cartel could not afford to let a nuclear war take place. If it did, they would lose everything because they were not in a position to control it. Instead, the deadly enemies of the Rockefeller cartel, the Bolsheviks in the U.S., would win out if there was a war; and so the Rockefeller faction was then doing everything in its power to prevent a nuclear war.

Therefore, **the then present anti-nuclear-war orientation of the Rockefeller cartel created certain temporary common interests between them and Russia; but as Russia's new rulers knew very well, this did not spring from any great moral perspective on the part of the Rockefeller group. It was a purely practical necessity.**

**The Russians regarded the United States as a house divided, and they were exploiting that division by working in a careful way with the Rockefellers. Their first priority was to rid the world of the deadly Bolshevik menace of all-out, even suicidal, nuclear war; but once that was done, they knew that there would be a day of reckoning with the Rockefeller cartel some day. And, brothers, you are seeing it coming down in Europe this very day!**

The Rockefeller group was working toward a definite objective with their new anti-nuclear-war propaganda. That objective was renewed power—and power that moves them closer to their old dream



of World Government. The Bolsheviks in the U.S. had unwittingly provided fertile ground for the powerful new Rockefeller anti-war campaign. Under Bolshevik control, the so-called Reagan Administration had become so hawkish that it was scaring people. The Rockefeller anti-war campaign was designed to capitalize on that latent fear as a tool of power.

The smell of war was in the air. The Falklands crisis was helping to make that more intense. The Rockefeller propaganda machine was paving the way for the argument that surrender of sovereignty was the only way to avoid war. A new super-United Nations of sorts was put into the works to fill the bill. It would have teeth! As then envisioned, the new organization would be based in Geneva, Switzerland. The working name would be "World Nonproliferation Council". The plan was to bring it into being as the outgrowth of nuclear nonproliferation treaties, but its true purpose would be to use fear—the fear of war—to control you all.

### SUMMARY

The Falkland Islands crisis erupted because of secret Bolshevik-controlled naval installations in the Southern Hemisphere. Those were attacked by joint action of the Rockefeller cartel and the Russians in an attempt to slow down the nuclear-war timetable. The attacks were successful, but the results are still not totally conclusive. expresses this eloquently and simply by stating that all things are equal because all things are part of the whole.

Terms now commonly used such as God, Creator, and Great Spirit are not adequate names for *Sakoiatisan, Wakan Tanka, Taiowa, and Kitché Manitou*. That is the failure of the English language, not of the idea. God is a term that connotes an anthropomorphic being who dwells outside of humans and nature. *Creator* is a term that also assigns a male gender to the First Cause and does not take into consideration that there were other creators which sprang forth, such as *Sotuknang* of the Hopi creation account. These supernatural beings—who could create worlds and other forms of life—could be male and-or female (or “ALL”) *Taiowa* and *Wakan Tanka* are NOT male deities. These names represent the sum total of all things. It is what Black Elk described as the spirits of all things living together as one, but even *spirit* has its limitations—in English. The English term *Great Spirit* attempts to define what is incomprehensible.

Reading the words of the *Wisdomkeepers*, we must understand that these terms—*God, Creator, and Great Spirit*—have been used to convey the concept that all things are interrelated and an equal part of the whole: that we are like drops of rain which will one day return to the ocean, that we are like candles lit by the fire of the sun, forever part of it.

The *Wisdomkeepers* all share the idea that the four-legged and winged nations, the creeping and crawling ones, the plant and tree nations, and **those who dwell among the stars**, are descended from and are a part of this Great Holy Mystery. [Note the term “mystery” and not “mysticism”.]

The following information comes via the FAX machine and the information regarding identification is overprinted. We will share what we have for it comes from a "horse's mouth" eye witness—with videotape to prove statements. **THERE IS, READERS, IRON-CLAD PROOF OF THE ATROCITIES INTENTIONALLY PERPETRATED AT THE KORESH COMPOUND ON APRIL 19, 1993!!**

QUOTING:

(FAX dated May 4, 1993; The article in point was written following the disaster at the Waco Corral.)

I am the person who started the communication process to the besieged individuals inside Mt. Carmel. With help from Ron Engleman of radio station KGBS, we employed a method involving the use of a satellite dish on top of the Mt. Carmel Complex, i.e., moving it back and forth to signify an affirmative answer to on-air questions. Integral to the process is my personal satellite downlink equipment {3 TURO dishes, 2 C-Bank, and 1 combination C and Ku band (12.7-13.9 Ghz.) The Ku band system is still somewhat new to the civilian and non-media public and are relatively rare (about 5,000 nationwide)}.

I became involved in the situation last Monday after observing numerous contradictions between what was actually occurring on the scene and **what was being reported by the off-air media.** In addition, beginning Tuesday evening, I began monitoring and taping both domestic- and foreign-correspondent satellite Ku-band

uplinks or transmissions from the "media checkpoint". On Wednesday, March 3, after already removing the media twice for "safety concerns", the **FBI imposed restrictions upon the television media as to the use of more than 200X telephoto lenses on live shots, and upon the use of ambient light sensing "night vision" equipment.** Bear in mind that this type of night vision equipment cannot in any way interfere with that being used by ATF or FBI. The restriction was as follows: **night vision can ONLY be used by the NETWORKS on a one hour delay and restricted to 2 hours per night.** Foreign correspondents, fearing for the safety of their citizens within the complex, maintained all-night vigils, using night vision as well as 400x lenses. Monitoring these foreign transmissions, I was able to observe and videotape the following atrocities:

1. On Friday, March 5, 1993, at exactly 1:18 AM CST and continuing in like manner until 1:47 AM, recommencing at 4:00 AM and convening at 4:30 AM, and again on Sunday, March 7, 1993, at exactly 2:01 AM CST and continuing thereafter at irregular intervals until dawn the following inhumane and unconscionable acts of "psychological warfare", to wit: the activating of powerful batteries of spot lights while simultaneously sounding a horn in excess of 200db and circling 3 military helicopters at tree top level as several armored personnel carriers execute a full-scale charge toward the Branch Davidian men, women and children. In addition, the power (being manipulated from the command post) is flicked off and on in an erratic annoying manner. From loudspeakers placed at north-northwest locations in the building ear-splitting recordings are played with a taunting whining voice.

2. On Tuesday, March 2, 1993, at 6:18 PM CST, a Bradley type armored Personnel carrier is positioned 200 ft. west of the front entrance. At 6:30 PM as dusk nears, the rear door (hatch) is observed lowering open. At 1:45 AM, Wednesday, March 3, 1993, the vehicle is seen backing up approx. 100 yds. At 6:30 PM Wednesday evening an armored vehicle returns to the site. As

the sun nears its setting the angle of light allows final illumination of a soldier trying to pull a corpse down from a tree.

In four decades of life I cannot remember an event that so polarized the opinions of the masses. Either one felt mortified by the plight of these Davidians, seemingly trapped by their own will in this fortress of paper and wood, or lashed out against their seemingly futile effort to be judged by deed and by fact rather than by hearsay and illusion.

Over the past 3 weeks I have made over 300 hours of nonstop video recordings of the so called Mt. Carmel stand-off. One of those tapes has clues that can help yield the truth to what happened on the morning of February 28, 1993.

True Justice can never be gleaned by watching TV or reading the words of one man, but rather only by 12 men in a sanctuary of **fairness** and protected by and yet autonomous from the State which it serves. And yet this truth is only the truth of one man [**C: but with pictures and sound recordings**]. Let this never happen again.

**[C: At this point the statement ended, still with no identification of the writer but since the packet of information continues in the same type style with a letter to Congressman Conyers and signed by Kenneth M. Fawcett AND OTHERS, we will assume, for present purposes, this to be one of the authors of same. I wish to give credit and honor to outstanding effort and, now, valor under heavy fire, for service above and beyond that of an ordinary citizen.]**

Again, this continues from the FAXed information of May 4, 1993:

Dear Congressman Conyers,

You have my vote for President if you can avert the horrible cover-up now being perpetrated upon the American people by the Justice Department and the Department of Treasury. I have been trying for weeks to alert members of Congress and the public at-large to what could only have ended in a horrible annihilation of the "crime scene" in Waco, Texas. In addition to the below described evidence, I made

seven trips to Waco getting hundreds of hours of eyewitness testimony and interviews with incarcerated members of the Branch Davidian Sect.

I am submitting this letter to you today as a concerned humanitarian, and patriotic American. From what I've seen I believe you are a man of irreproachable integrity. I am by trade a microwave communications technician, with a background in land-based telecommunications as well as law enforcement. On Sunday, February 28, 1993 I, like many Americans, was shocked by the videotaping of what was, even under the most liberal interpretation, a full military assault upon a religious compound in Waco, McLennan County, Texas, under the auspices of a "police" operation.

On March 2, 1993 at approximately 11 PM, while monitoring live Ku band transmissions from the Waco media setup, I was surprised to view what was certainly an almost unedited video "refeed" of the assault. Having monitored news feeds in the past I knew from experience that the tape would be run twice. I proceeded to tape the 2nd feed using a Fisher six head VHS VCR with composite video/audio input. Tape speed was 1.7 cm/sec. (standard play). This tape has been duplicated and distributed for my protection. Unlike the tape widely distributed over off-air and cable television news programs, this tape has no "voice-over" and the audio runs completely intact.

Over the ensuing weeks the tape was studied carefully by myself as well as several men with military and law enforcement backgrounds including veterans who served under Col. Hackworth. The conclusions reached are as follows:

1. Bureau of Alcohol and Firearms officers, either through mishandling, improper preparation, and/or defective equipment, suffered a minimum of two accidental weapon discharges. The first of which involved the Heckler-Koch MP5 assault rifle and resulted in the death of Spl. Agent Stephen Willis and the injuring of another officer as yet unidentified.

The second discharge occurred on an aluminum ladder involving a Sig-Sauer P228 semi-automatic handgun which, according to John C. Killorin, Chief of Public Affairs, ATF, has no safety. The weapon discharged in the holster of Agent Conway C. LeBleu, resulting in a flesh wound to his right leg. Agent LeBleu was able to ascend the ladder but met with death after entering a second story window.

2. The attack plan failed to take into account the unusual architecture of the compound and thereby subjected officers crossing the roof from south to north to **crossfire from agents seen firing from**

**behind vehicles located on the west or front side of the compound.**

3. The plan overestimated and/or was misinformed as to the construction of exterior and interior walls. This caused helicopter-based gunfire to pass completely through the building at angles endangering friendly forces on the ground.

4. The plan relied too heavily upon radio communication. When those communications were compromised, there was confusion as to the location of various forces, enemy as well as friendly. This too was a factor in the accidental tossing of a fragmentation device into the second story room, further identified as a 10'x10' room adjoining David Koresh's living quarters, which led to the death of agents Robert J. Williams, Todd McKeehan, and Conway LeBleu. **[C: Sure looks to me as if it was fully intended that several agents be wiped out so there could remain no possible REASON for calling off the massacre. Boy, does this not make even you able and "willing" participants in the big military "kill" game a bit undone that you are worth no more than a good story to deceive the "people"?)**

5. Despite public statements to the contrary, agents are seen firing blindly into walls and windows without properly acquiring a target. This practice is known as "spray and pray" in law enforcement circles, and is unacceptable while executing an arrest warrant on **one man and one man ONLY where more than 100 innocent women, children and men are residing.**

6. If after-the-fact statements by ATF spokespersons are true, and these affiants actually possessed and/or were suspected to possess weapons in the type and amount necessary to warrant the enforcement manpower at hand, then it is clear that management personnel failed miserably in pre-arranging ambulance and medical services for wounded or traumatized personnel as evidenced by **agents seen and heard well into the firefight telling TV cameramen to "call for an ambulance"**.

7. ATF spokesmen Dan Conroy, Jack Killorin, Steven Higgins, and David Troy have repeatedly stated publicly that the "element of surprise" was paramount to the success of the "mission", yet videotape reveals that two reporters are **actually sitting clearly visible in a tree in front of the compound, and channel 10 news crews were actually INVITED to "follow the ATF horse trailers in"**, per telephone conversation with Mr. Virgil L. Teter V.P. News, KWTX, Waco.

8. Despite insistence that National Guard helicopters were requisitioned only to search for "hot spots" in the compound, their approach is clearly too low and off to the right and left to provide such a function.

9. Despite public statements that the three helicopters used in the raid sustained fire they are seen being examined in subsequent video-tape and no damage is visible.

10. At the end of the video-tape an unidentified Davidian is seen and heard from a lower story doorway **repeatedly calling for "peace" and each time he is met with a hail of gunfire.**

11. Agents are taped being allowed and assisted by Branch Davidians in the stabilization and evacuation of wounded officers, this behavior is inconsistent with persons having murderous intent.

In addition to these facts the video also raises numerous questions that can only be answered by an independent and specially appointed investigative team.

Because of events of questionable moral, ethical and legal basis carried out upon the Branch Davidians in the so-called siege portion of the episode, to which there is also overwhelming video-taped evidence, it is imperative that said investigators have no attachment to the "raid" or subsequent "siege" upon the compound.

In addition to the above named evidence, an investigation has revealed that the original BATF investigation was based on an affidavit used to secure joint custody of a minor child in a Battle Creek, Michigan family law court. See: David S. Jewell v. Sherry L. Gallegos Jewell, February 24, 1992, Berrien County, Michigan. Said affidavit being affirmed to by one Marc Breault who is not even a United States citizen.

Because of these improprieties, injustices, and official misstatements of fact we call upon you, Congressman Conyers, to call for an independent investigation of the Waco debacle and appoint a Special Investigator-Prosecutor of unimpugnable integrity to investigate what is left of the "scene of the crime".

You should be receiving a videotape from me in a few days. Facts I have gleaned in recent days from my ongoing investigation are revealed but not limited to the following: **1. The time of the Feb. 28 raid was deliberately misstated by 2 hours to allow editing of the video news tape before releasing it to the public. 2. There were no less than 3 TV Station news crews WAITING at the gate to follow the BATF into the complex. 3. The press was moved back 3 times in the first 2 days of the so-called stand-off to**

obscure from view, federal agents "cleaning up" the bodies of two unarmed Branch Davidians **KILLED BY ATF snipers several hours after the "raid" had ENDED.** **4. Even though it's been widely reported that the "fire scene" was too hot for investigators and Medical Examiners to enter for two days (because of "one million" rounds of "live" ammo) I have video-tape footage of FBI agent Bob Ricks, ATF agent Swenson and others walking around in the ashes less than 2 hours after the fire is brought under control—wearing no protective clothing or eyegear whatsoever.**

**NO ALIEN THREAT**

**The ultimate punch-line to the Adversary's plan is to align the masses into unity through assumption of an outer-space alien threat to the planet.** No, I repeat—you have no enemies in space—they are all land-locked and the plan so well laid and orchestrated that the presentations unto you will cause you to believe that which they will tell you. I must tell you THE TRUTH prior to the “pranks” because only in that advance warning will you be prepared. ALWAYS as things unfold—look unto the PHYSICAL ASPECT. GOD is a SPIRITUAL influence and condition and thus, that which is manufactured and manifest in the physical and breaks ANY BIT OF EVEN ONE LAW OF GOD IF PRESENTED FROM THE COSMOS, IS NOT OF GOD BUT SERVES THE ADVERSARY—and you are in for some real doozies right away now.

You will continually harken back to the writing of yesterday as we write during these coming days because you MUST know of the separation and sorting and if you are still playing games with God, I suggest it is now time to stop it. GOD is not a groveling wimp who will allow you to go into infinity with such stupid ideas and actions as you have been told. HE WILL ALLOW NO EVIL ACTIONS OR INTENT WITHIN HIS HOLY PLACES! That means that it will be only through honorable ser-

vice and intent that you will make that journey WITH God. You may get interim placement but you had best look most carefully at intent because the days shorten into a very precious few. Each day will be a gift of gifts.

### WHY SO MANY UNEMPLOYED

Sit quietly for a minute and consider numbers with me, for as these underground facilities are coming to finished status there are a lot of suddenly available unemployed. You are showing increased numbers of unemployed NEW sign-ups of half a million a week. You are talking now of millions out of work—from where? Yes, from all over, but WHY?

How many people, say, in the area of Lancaster/Palmdale, California, might you personally know who work in the aerospace industry wherein groups work on items which are isolated and secret with penalty of death as reward for tattling? Almost all is done on "need to know" basis and ones are going to realize they have been working on projects which were so unworldly as to shock Spielberg. Worse than what appears on the surface, they are subjected to mandatory testings, physicals, etc., where they are totally programmed "to forget" what they have seen and heard.

I am going to name some names and places (locations) so that you can check them out as to authenticity and then you will find it easier to accept TRUTH as it is unfolded to you.

### LOCAL SECRET PLACES

(see photos on next 2 pages)

We will start in the local area of Southern California in the Edwards Air Force Base area extending in a large triangular shape which includes all the way to Pasadena, Long Beach, Palmdale, Lancaster, Tehachapi, Mojave, Edwards and China Lake—just for starters.

We have spoken often already about the areas of "51", "72", Dulce, etc., in Nevada, New Mexico and Arizona so we will leave it to suffice that duplication is present in those places as well. Ones who have had the "privilege" of tourist rides into Yucca Mountain to check out the tunnels for planned nuclear waste sites will not be as shocked as the rest of you unsuspecting ones. At Yucca Mountain alone there are over 35 major tunnels which totally catacomb the mountain at all levels as deep as several miles. There is only one tunnel open for public eyes and it is impressive enough to stun the eyes and minds of hardened engineers.

In the Palmdale area beneath a "hanger" type building, which actually is movable on tracks, is a multilayer technology center over eight levels in depth and the size of a massive city. The workers are mostly manufactured robotoids and synthetics made

for labor with computer intelligence. Human participants are of the "Ultra top-secret clearance" personnel.

At Edwards launch area in a bluff (butte) called Haystack, there is an even larger installation underground with incredible beam pulse systems, aircraft launchers, stealth equipment in coalition with the Soviet Cosmosphere program with total capability of destroying the planet in some 15 minutes.

Locked into that installation is a massive underground facility near Tehachapi called The Anthill (Northrop). There are open silos wherein light laser systems are tested and cosmos-drones sent out like marching armies to probe electronically. They are like little basketballs of light running usually to blue and sometimes golden/orange.

These particular installations are carved out with digging equipment which melts the mind as to possibilities as nothing stops them—not rock nor metal. They are drills tipped with diamond bits and carve a 40 ft. tunnel in mere hours. Interconnecting these installations are high-speed transit rails with "trains" which "fly" on an electromagnetic system off the ground at incredible speed. There has been a lot of "blasting", also, but covered by the stories of aircraft moving through the sound barrier and after a while it simply became that no-one paid any attention.

### BEINGS INVOLVED

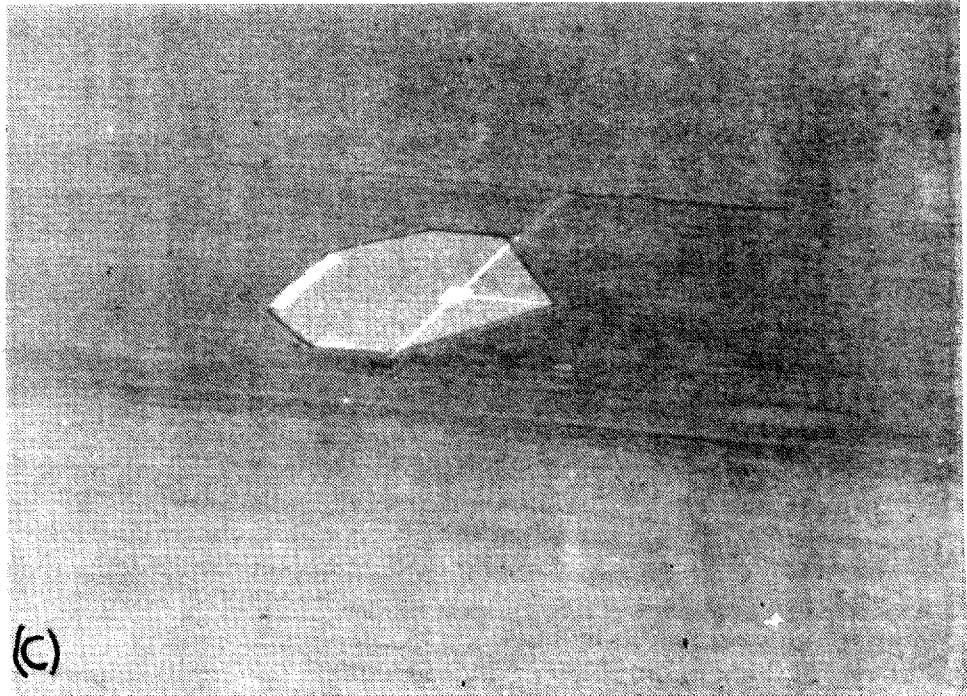
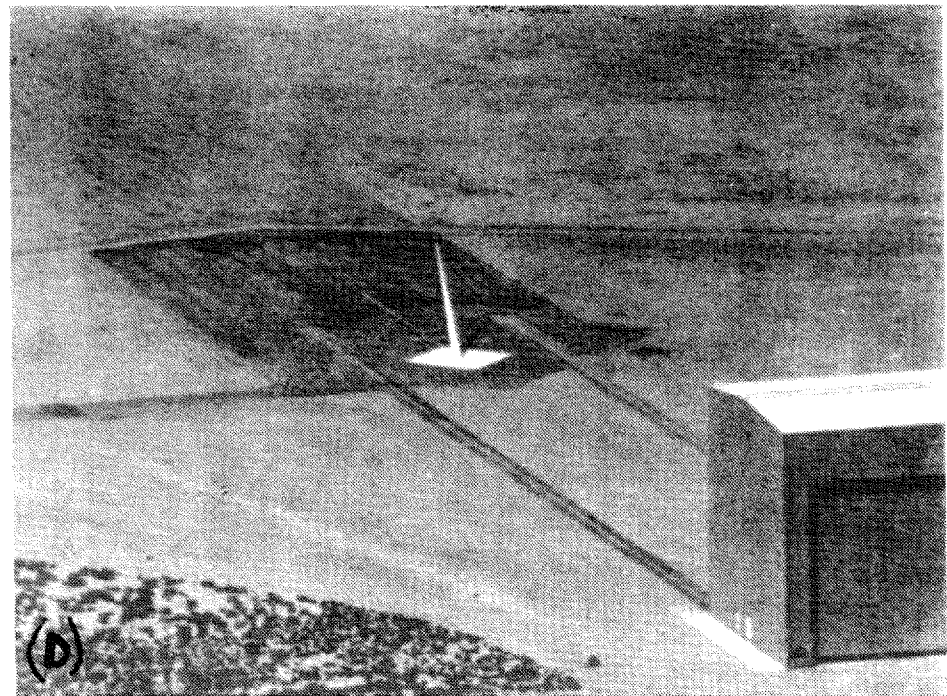
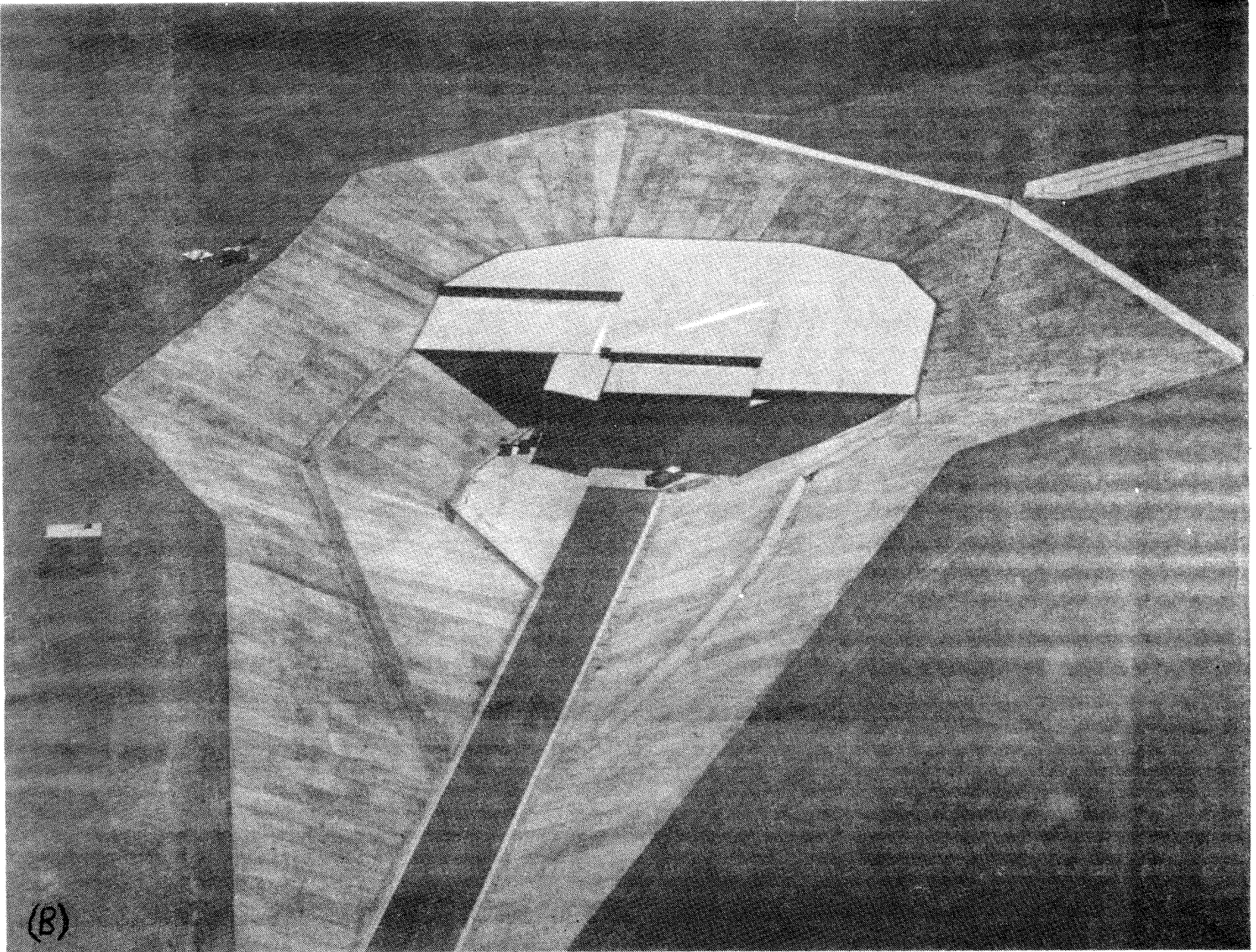

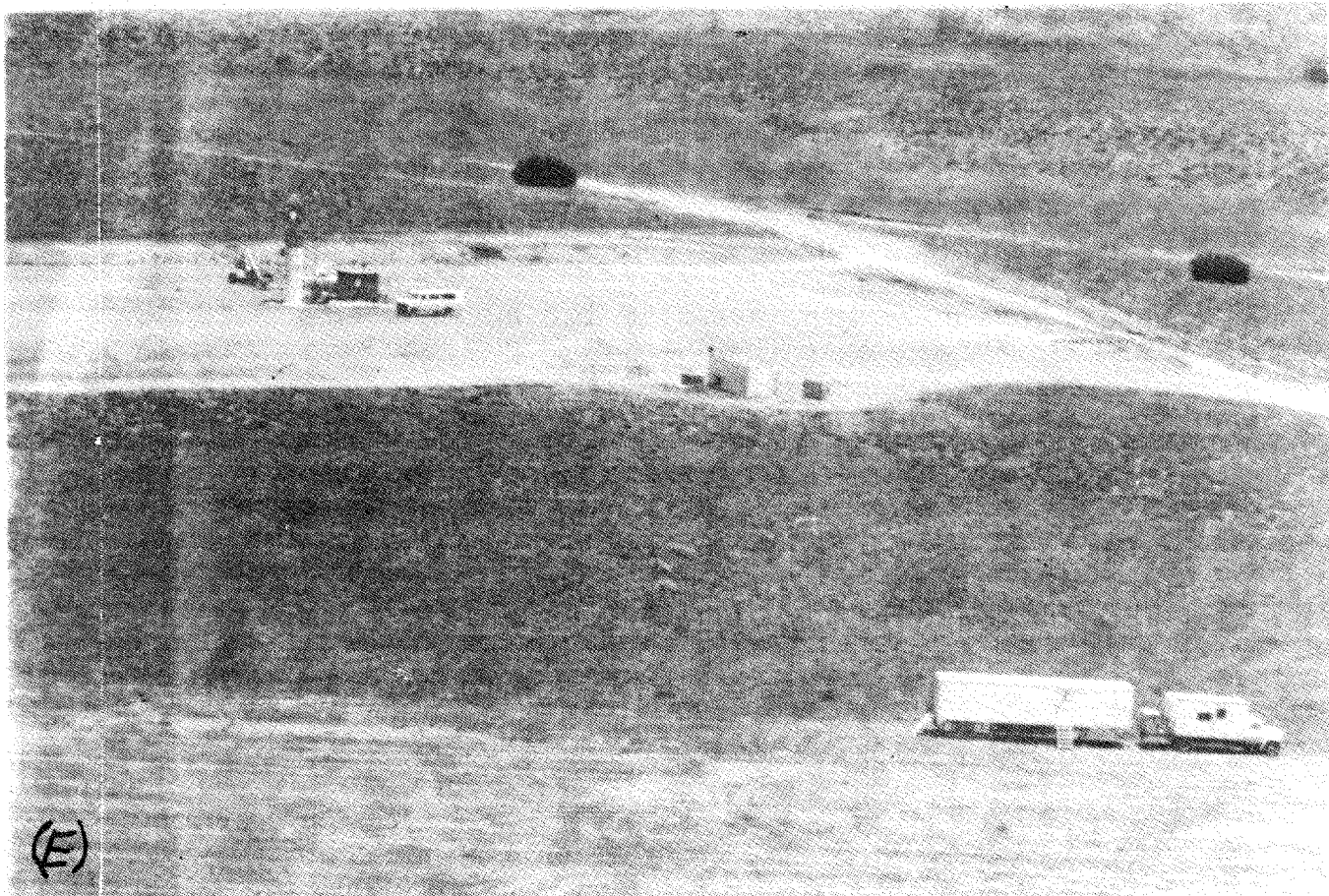
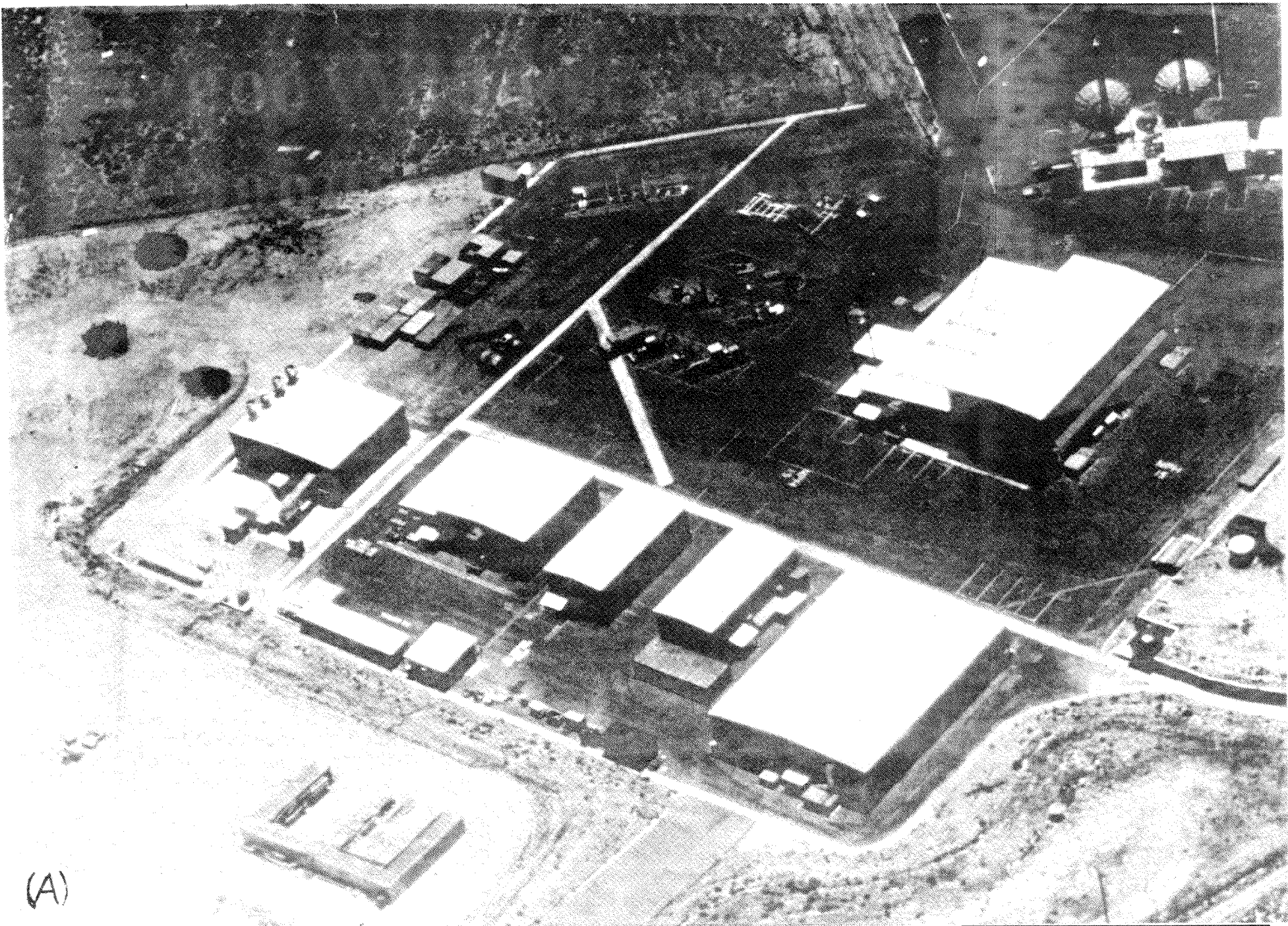

**These ones are led and controlled by the entities who would rule the Earth and they are the reflection of hybrid, emotionless beings who serve the World Order "Elite". They are basically Satanic tools and act on direct orders of the controllers.**

### WAR OF THE "GODS"

We don't speak of "Gods" as such, but the idea fits. It is the time of sorting and separation of the participants (players) on the physical orb called Shan (Earth). It is the time of retrieval of God's children who are experiencing on the place for all sorts of varying reasons in soul-growth progression. Evil intends to rule the globe and all things thereon. But, he has already destroyed the bountiful wonders of the globe and it cannot continue as is. Therefore, the plan is to take control through whatever means available—preferably leaving a remnant of Godly slave laborers and annihilation of other souled beings. This will be accomplished in two ways.

1. He will simply convince the souled being that God is not who and what He claims to be. Their whole intent will claim infinite experience but will be entrapped in total physical and material matter.

2. He will simply enslave physically those who stand against him and as ones are no longer useful, they will be slain and/or used for testing, etc. Disease will wipe out multitudes and then wars will annihilate millions, famine and exposure will get more and in the interim, all dissenters will be interned in compounds if they are thought to be dangerous to "the cause".

Ones who go about their business without great confrontation will be basically left alone if they are in areas wherein they are no bother.

### GOD WILL NOT INTERFERE

There is full understanding between the higher "commands": Our people are not to be harmed. This does not mean that ALL know this even though ones who attempt bodily harm are usually taken out a.s.a.p. by their own group. The adversary will not risk encounter with my Command. God's people are "off limits". I suggest you be

making very, very sure as to whether or not you are one of God's people. Don't ask ME! If you don't know then you better get awfully worried.

Does this mean that God's people will not be caught in anything nasty or negative? No, many of you will perish and no place, as such, is safer than any other. I can assure you that you will have colds and flu, get cold and get hot, hungry and tired just like everyone and anyone else. You WILL be allowed to fulfill your mission whatever it might entail and you WILL BE RECLAIMED AND BROUGHT INTO SAFETY AT THE APPROPRIATE TIME.

There is time left for action in almost unlimited manner if you utilize that time well. Things are not in order to the point of desirability on the part of the Planners so you will simply work within that circumstance in which you find self. There are still some methods of assisting selves with security in ability to barter, etc., if you use intelligence. Violence will simply get all of our workers killed and it will not be tolerated—if I have to tell you that point then you are going to harm more than serve good. You will be sly as the serpent and gentle as the dove—dead martyrs serve no one. Your job is not to fight the war—yours is to bring Truth, put it to press, assist wherein you can by example without force or undue nagging for each will have to know for self. We must have a "remnant" and that means that you of my command will not act in foolishness or you will be put to the side lest you endanger the entire lift-off program. You will be given to know your task when appropriate and he who acts in greed will be put to last. Know that we can beam you up into safety from Mars if need be. I can get you aboard the *Phoenix*, for instance, which is far outside your orbiting place.

### OTHER PLACES IN THE U.S.

There are massive bases in Canada but some of the more important strategic centers are, of course, around (under) Atlanta and Arkansas. In some of those areas there was already an underground "alien" race and massive tunneling complex. There are also ancient tunnels under Tehachapi, for instance. The military has now tunneled right to the side of the crystal in Tehachapi and we have now blocked their entry into that portion of their system. Only a tiny portion of the crystal in point is allowed the use of Earthians.

### POISON WATER SUPPLY

Other bad news includes a slow and deliberate addition of herbicides into the water systems of your cities. Most is by accidental seepage from growing fields at very low levels of toxicity but now covering

massive areas. As water supplies dwindle in the areas stricken by drought there will be more and more actual toxic response to that pollution. There will also be virus infection via water systems whereby whole villages and sections of cities will become ill within hours—simultaneously.

The cover-up is massive and "leakers" or "speakers" are dealt with instantly by either absolute negation of "law" or injection or by death—mostly the latter depending on the importance of the "squealer". You have ones in the local group who are targets who managed to survive all three types of assault. I will tell you now, it is very difficult to kill one of my people. Usually the journey to this side is vaguely remembered and almost always the trip itself is recalled and known at the time and again remembered at some time later.

### AM I TELLING YOU "IT IS OVER"?

No indeed. I am simply telling you that you must be ready for that next assault on your beings as we have described it in the past. Remember, I told you that before you are through, the enemy will blame all things on aliens to prevent any of you being reclaimed by God—THE BATTLE IS FOR YOUR SOULS—ONE DIRECTION GIVES TOTAL FREEDOM AND THE OTHER ENSLAVEMENT AND YOU MUST DECIDE WHICH YOU WILL EXPERIENCE. Bridges, passes and area dams are now bombed (mined) and tracking stations already in place—to keep ones in the area wherein you ARE when the curtain falls. This means a shut-down of all international travel, and interstate travel as well, as time passes. The point is to actually lock you into a small area of location and one in which you can be easily controlled and accounted for. Note the closure of one airline after another and note how many of those airline planes are at Mojave! As surface travel is shut down those parts will be utilized for other types of vehicles and weapons.

The plan, of course, is to allow things to appear natural in their occurrence—i.e., the markets will fall and you will be in a depression but always with the prattling

that "it is getting better"—"just a fluctuation". You will be like the Russians—into disaster without realizing it happened to you. In your confusion you will get deeper and deeper into the pit until the trap is closed. Then the government will simply pull out all resources (welfare) and it will appear most spontaneous because, after all, a government without money cannot maintain anything. The ignorant will remain ignorant and in denial until it is over and some will never know differently, much less admit that what we gave forth was right and correct.

Will you go down without revolution? Probably not, but the bigger gun usually wins, especially if he has trained himself to be more clever. You, dear ones, have been uneducated and many of your so-called educated adults can neither read nor write.

Since speaking about the underground

facilities around this California area, I am, as expected, deluged with inquiries regarding other placements. I will make a point of going through the various states and giving you some idea where the major installations are and where there are missiles. I don't have time to be totally specific nor give maps with specific tunnel runs, etc. Please don't expect more for it is dangerous for these writers here to present such a thing but I will share some information so that you can be alert and you who do have contacts might get the areas more specifically defined and updated. Revealing the secrets is the only defense you have.

Most places are covered with rumors and things like, "...well, I'm working on 'need to know' basis and I said I wouldn't tell." This means that number One: they are working on something they actually know very little about. Two: they are working underground on installations but have no idea of the broad picture. Three: They are threatened on the basis of "national security" and threat of punishment for treason and Four: They (with family) have been promised the reward of safe placement IF they keep silent about the truth of the installations.

ELITE GOING UNDERGROUND

Already the "big boys", as industry is shut down, are moving into the safe shelters—you are that close to probable danger.

You will now find that you will get no help from your government in the building of shelters so you are on your "own", so to speak. You should continue to ask for public funding but do not expect it and do not base your security on the possibility.

In areas of these massive underground installations and nearby "bedroom" areas, such as Tehachapi, you have a situation of "vacant census"—which means that you have many houses which are now partially (occasionally) occupied but which will empty very soon now that the facilities are operational and the major "building" and construction are finished. Places such as Tehachapi will likely end up pretty much a ghost town but will be quite ideal for young industry in food-growing, dairy farming, etc. This is because the full underground cities will not become effective yet, for the Elite. Ones who are not invited within will have to move on to find work, so much movement will need be back into the cities.

As I sit to write this portion regarding missile sites and underground facilities—please understand, I simply cannot take time to do a run-down of the world. There

are other Commanders in other parts of the globe and I, for time reasons, will only handle the United States. Keep in mind that what I am going to indicate does not have to do with simple military installations, etc. I am only going to deal with underground missiles and military installations underground. I will miss some for much is being enlarged daily—but now that most of the major construction is finished **it will suffice for impact to allow you to recognize how truly uninformed you are as a nation.** You in the other parts of the globe can consider that you are in equal or worse shape—especially any “colony” of Great Britain.

The logical inquiry regarding these massive underground installations is “how could they do that without having huge mountains of dirt to move and it would show!” No it would not—they have equipment now that will tunnel and melt the earth material into substance which can be utilized for the walling and shoring. This condenses the quantity of material into a small percentage of that with which the project begins. This tunneling equipment works with a diameter much larger than the average sized home so you can see how advanced is the technology.

I ask you not to write me about specifics nor locations—I welcome any information which any of you wish to share for either my private confirmation or for sharing but please do not expect me to give specifics or long dissertations on various locations for I shall not do so—I hesitate to even give this much information for I will have to increase the shielding for my own crew because of it. I am most pleased to handle any private correspondence but it will be one-way for a period of time, perhaps. Some of these areas will only represent having underground missiles.

I will effort to give nearby sites as reference, i.e.: Alabama: Maxwell A.F.B. north of Montgomery, south of Rattville.

#### ALABAMA:

Anniston Army Depot south into the Tallegea National Forest under Cheah Mtn., drawing water from the Coosu River.

Maxwell A.F.B, north of Montgomery, south of Rattville—drawing water from the Alabama River.

Fort Rucker: MAJOR SITE—very large area. North to Brundidge, east incl. Ariton, southeast to Ozark, south almost to Hartford and west, almost to Elba. Drawing water from the Pea River Res., predominantly.

#### ALASKA:

Massive water tunnels and underground facilities and missile sites in an area running from Kotzebue to Ruby to and includ-

ing all of Norton Bay.

In the Fairbanks area including all of the Harding Lake Rec. Area.

Stoney Creek area, in the vicinity of the **Redoubt Volcano.** [H: You should pick up a great “clue” right here!]

#### ARIZONA:

Arizona is so sprinkled with installations housing missiles that it is hard to separate them from Nevada so I will include the southeast corner of Nevada also.

Small installation between Mesquite and Glendale.

Large installations between Searchlight and Boulder City.

Border of Nev./Ca. directly north of Needles, Ca. in line south from above installation.

East of Kingman some 35 miles east, past junction of 40 and 93. Right under and around I-40 directly in-line south of Peach Springs. Desolate territory with few landmarks.

Area under I-40 between (approximately midway) Winona and Winslow.

West of Phoenix under I-10, approx. midway between Wintersburg and Quartzsite.

Between Yuma and Casa Grande on (under) I-8, approximately midway between Mohawk and Sentinel.

North of Yuma on H-95 approximately midway from intersection of H-95 and I-8 and Quartzsite.

Fort Huachuca near border with Mexico in general area of Huachuca City.

#### ARKANSAS:

In Arkansas there is a different situation wherein you have a lot of useful natural formations which allow for utilization. Most of the facility activity has been focused on the Ft. Smith area taking in the entire Ft. Chaffee military res.

#### CALIFORNIA:

California has so many installations that it is all but impossible to point to them all. The ones along the coast are set up so as to be open for massive underground moving of equipment in event of quake or coastal devastation. Underground tunnels are structured in order to move nuclear submarines from the Long Beach area to inland, to tunnels to move ground equipment by surface to inland. We will not focus on any one area to great extent for as we list the area, say, of Lancaster, it will generally take in Lancaster, Palmdale, Mojave, Edwards and up to Tehachapi areas of Northrop, Lockheed, etc. Remember that in this particular listing I am giving you “general areas”.

Starting at the north end of the state: a

very large area including all of the Round Valley Indian Res.

Area all around Ball Mountain **intersecting area of Red Bluff and including Red Bluff.**

Massive area including just south of Alturas, including Likely and Madeline and east almost to Eagleville. Includes the entire origin of the South Fork which eventually makes its way to the Pit River.

Oroville

Downieville

Yuba City and overlapping:

Nevada City, overlapping south to Grass Valley (massive area).

Lake Tahoe-Tahoma-Emerald Bay

Placerville area from Coloma to El Dorado to Kyburz

There is a NOTICEABLE absence of major facilities around San Francisco, but a MAJOR dual installation directly east in Nevada at Hawthorne and including (under) southern portion of Walker Lake.

Coastal missile facility including Pacific Grove Monterey to Salinas—including Ft. Ord.

West of King City, including all of Hunter Liggett Mil. Res. south including Nacimiento Reservoir east to overlap facility which takes in a large area including Camp Roberts and Paso Robles.

Major crucial sites at area of Camp Nelson northeast of Porterville and entire area of Tule River Indian Res. and on south almost to Woody—in the Sequoia Nat'l Forest.

China Lake—massive.

China Lake Naval Weapons Depot—massive.

Fort Irwin—massive. On H-54 southwest of China Lake, northeast Tehachapi, approx. 50 mi. northeast Mojave—large facility.

Lancaster/Palmdale and points east: MASSIVE, taking in areas from northwest of Barstow to east of Barstow to some 30 or so miles east of Barstow on I-15 (desolate area).

This area is in conjunction with the mammoth area of the Nellis bombing and gunnery range and the entire Las Vegas area.

In the Palmdale-Lancaster area must be included Edwards A.F.B., a facility on H-395 at Adalanto and a facility on I-15 between Victorville and Barstow (about mid-way). These sites located on major interstates and well-traveled roads are to allow for checking stations as you move further into the controlled environment. These are located in areas wherein there are major connections with interstate facilities—some three to five just between L.A. and L.V.

The entire Twentynine Palms Marine Corps Base and area between and including Ludlow to Twentynine Palms.

Facility on I-40 about midway between

Ludlow and Needles.

Long Beach is a massive underwater facility with water tunnels which connect all the way inland past San Bernardino with connecting travel tunnels to both Lancaster area and the Marine Base.

South to the Salton Sea—the entire area including Chocolate Mtn. Gunnery Range.

The entire area just east (into Arizona) of the Colorado River Indian Res.

Starting at Capistrano and south through all of Camp Pendelton, including Oceanside.

Moving on south to southeast: Capitan Ind. Res., then on I-8, the Manzanita Ind. Res., east to Brawley to include the Parachute Test Range and Naval Air Facility near El Centro and on east to the entire Yuma Indian Res.

### COLORADO:

Moving west to east on I-70: Parachute; Vail (large political facility); site of Eisenhower Mem. Tunnel.

On I-25 south from Denver, all of the Air Force Academy, south to the area south-east of Colorado Springs (Ft. Carson).

All of the area east of I-25 at Fountain north of Pueblo; this is actually a place known as Peterson A.F.B. This is a major and important location.

### CONNECTICUT, MASSACHUSETTS, RHODE ISLAND:

Chicopee/Springfield  
Woodstock (large facility both Mass./Conn.)

New London  
Worcester (Quinugamond)  
Fitchburg (Ft. Devans)  
All the Military Reservations and Nat'l Guard Facility east of Buzzard Bay.

### FLORIDA:

Florida is a strange place in that major underground facilities are lacking but missile bases abound in clusters. This is because of the high water table and expectation that with planned earth activities the major part of Florida will be submerged. This requires that the underground bases be along the shoreline and house submarine-capable facilities.

Major installation including Foley, Ala. and the entire of Pensacola Naval Station and eastward all the way and including Freeport and De Funiak Springs and around north to Crestview.

Panama City: all of Tyndal A.F.B. (underwater and offshore).

Large area on west coast at Palmetta.  
Interlocking pods all the way on east coast from Miami to the tip including Homestead A.F.B.

### GEORGIA:

Major dual installation at Atlanta in an area taking in Decatur to Jonesboro.

Augusta: Total area including Fort Gordon and east to the Gov't area (massive) including the Savannah River Plant. This is a huge area.

South to Savannah and including all of the Fort Stewart area.

Ft. Benning at Columbus.

### IDAHO:

MAJOR INSTALLATIONS AT THE U.S. ATOMIC ENERGY COMM. RES. north-west of Idaho Falls. This is a most important facility and an extremely dangerous area.

Southeast of Boise on H-84 just north-west of Mountain Home—perhaps 10-15 miles.

All of Mountain Home military facility.  
Large installation on H-84 at Malta.

There is another facility just across the border in Montana about midway between Coeur D'Alene and Missoula on H-10 and one south into Nevada on H-193 south of Contact.

### ILLINOIS:

There are only a couple of important bases in Illinois because it is expected that with great earth changes there will be no Illinois. There is an installation and missile sites at Chicago and facilities of both kinds at

Chanute A.F.B. south of Rantoul.  
Ft. Massac at the Ky. border north of Paducah.

### INDIANA:

Atterbury Reserve Forces Training Ground including Brown County State Park.

Crane Naval Weapons Support Center  
Jefferson Proving Grounds  
Vaconia and entire area connected to include Fort Knox and Federal Depository.

### IOWA:

Iowa can sleep well but don't expect to have an unexpected place to run for shelter. You have some scattered missile sites but no major underground facilities or major missile pods.

H: Good morning, Dharma. Thank you for attending my needs this day. I would prefer that we put these military bases with installations on them and sites of missiles and underground facilities onto a tape. It is too time consuming the way we were working with it yesterday. All we need are general locations but I find that everyone is getting very tedious about it, wanting extremely large amounts of information and I'm not going to go into that. So I feel that the best approach to this is for you just to sit here and you're going to have to learn to deal with this situation of looking. I will

effort at giving you the locations and I believe that spelling these proper names will be your biggest problem so, please bear with me if I forget. All you've got to do is go and look upon a road map of some kind but I will endeavor to spell things as we go along and then whether Dharma or someone else takes it off of the tape to list it, it will save us a great deal of time.

We have made it to Kentucky and as our treasure maps are laid forth, Kentucky and Tennessee are adjacent and also on the same pages. Again, I am stressing that I am utilizing installations big enough that they were started in construction many years past and have been continually in development. There will be one or two that we will list, as in California in the area of facilities, as with Angeles Crest National Forest, where those missile sites were put in and since removed, as far as you know. However, those silos have been utilized and the tearing down of those bases and the vandalism which ensued was all very purposeful and other facilities have been built on top of those areas which you would recognize as something else—either a youth camp, some surface governmental installation or private incarceration facility—so that you are not curious about it. I can tell you now that every vacated missile silo is attached to something underground. I cannot possibly list all of those places.

You in local areas put out your grapevine. You'll find out. It's like our friend, Mr. Quade, said, "Well, that's not a conspiracy and that can't be a conspiracy because everyone knows." No, everyone doesn't know and a conspiracy is two, three or more working together to secretly plan an illegal act—as a result, these are conspiracies. It's very hard to keep total silence but you will note in the area of Tehachapi most of the ones who work and live in the area work in those underground facilities, or have in the past as they are ending their construction phase, so you will find almost a vacated city. There are reasons why ones remain quiet. For one thing, they don't know what they're doing, they just simply work at one of those facilities but that's neither here nor there. Let us move on now. I believe we're ready to begin. We're going to start with Kentucky.

### **KENTUCKY & TENNESSEE**

There is an extremely large base and facility that runs north of Hopkinsville, down south inclusive to the west of Fort Campbell Military Reservation. This one will receive water from the great reservoir there, the lake to the east, Lake Barkley and it will also pull from the underground of the Cumberland River. This is an extremely large installation with silos with a lot of stuff going on underground. This is the major Tennessee installation. It's diffi-

cult to leave out the installations which cross borders, so we'll move over to Kentucky and to the north at Madison, Indiana. Just across the border close to Carrollton, you will find the Jefferson Proving Ground. There is a very large experimental installation in that area, mostly on the side of Indiana.

Moving downward to Louisville and on west, you will find Fort Knox. We've spoken of that before. I won't go into it. It's a military reservation with installation.

Moving eastward to Danville inclusive of Perryville, there is a large installation.

Those are the major points of importance as far as defense or research in both Kentucky and Tennessee.

### **KANSAS**

We will go to the east of the state to Manhattan Military Base with installation at Fort Riley Military Reservation that includes Ogden and it runs under Interstate 70.

Then eastward to Leavenworth. There is a Fort Leavenworth, this is an extremely, extremely important installation with large facilities underground. There is a federal prison and there is a massive installation beneath that prison.

Anywhere where you have major prison facilities such as you do in Tehachapi, California, you're going to have installations beneath that prison and they use prison labor and especially ones who are put into isolation for any period of time and ones that you would recognize as being on death row, they are utilized for labor for these underground installations.

### **LOUISIANA**

Move southward from Shreveport to Leesville and you will find Fort Polk Military Reservation. That is a reservation and an installation. That is the only important site in LOUISIANA even though there are many other bases.

You will have to understand that areas along the Mississippi River are not utilized for underground facilities, there are other plans for that river and it doesn't protect those underground facilities.

While we are here, however, I feel that we should mention Mississippi because in conjunction with LOUISIANA, you see, the federal government divides your nation into districts, it does not divide them into states and we have a little problem for your understanding and there's going to be overlapping of states so if I mention them twice, please, understand.

Moving to the east along I-10, you will come to Biloxi, passing Gulfport, to the Beauvoir Jefferson Davis Home which is a park setting. Again, pay attention to where they have these parks. That is Keesler Air

Force Installation. That is a very, very important area with a massive underwater installation.

### **MAINE**

At the very upper part of the state, at Caribou, just to the north of it including a place called Limestone, is a rather large inland facility.

Moving all the way to the south of the state to the area of Brunswick, you will find the entire area under Popham Beach is a water facility with submarine capability and underwater missiles. By the way, some of the missiles are Russian or Soviet missiles and have been in the area for a long time and this is part of the reason for the installation as a defense mechanism against those Soviet missiles out there offshore.

### **MICHIGAN**

Michigan is clean. That is not good news. That is because there is full expectation when the New Madrid Fault goes, it is expected to take Michigan with it or at least the northern part of the state of Michigan.

### **MINNESOTA**

Minnesota is clean. You have a lot of area above the ground but no major, major sites where great research is going on. There are some missile sites in and around Minnesota but no installations or research.

### **MISSISSIPPI**

The only one of notable worth is the one at Biloxi.

### **MISSOURI**

You have two major experimental facilities with missiles.

Whiteman Air Force Base at Knob Noster. It will take in the entire area between Knob Noster and south to Windsor. This will encircle to the east of Sedalia.

Southeast to Waynesville, you will find Leonardwood Military Reservation. This is a very large installation.

### **MONTANA**

A large area around Kalispell, south and including Marion and it takes in all of the Bitterroot Lake Recreation area.

Moving south to Missoula, encircling an area from Frenchtown to Milltown including Potomac and including all of the area under the Forest Service Fire Department buildings and that part of the forest. It's a National Forest. It is the Lolo National Forest. A lot of the work is performed

through the University of Montana. Much genetic development, DNA replication studies have been performed in that area.

Great Falls and to the west of the city taking in the area of a place, not necessarily a military reservation, but a place called Fort Shaw.

South of Dillon just north of a little place called Dell on I-15, under it, there is an installation and there are underground missiles.

Please note that in many of these descriptions I'm giving you, they actually are on or under major transportation routes.

Now north and east find Glasgow. This is Fort Peck Recreational Area. This is a very large area. It is just north of Fort Peck Lake and uses a lot of water from that lake.

## NEBRASKA

One of the most important of installations, Norad, is located very near and north of Omaha. This runs approximately to Blair, west almost to Winslow and the Elkhorn River runs directly through it.

Moving southward to a very, very important place where a lot of the monkeys meet and it would seem a totally unreasonable place for them to meet until you consider Norad and then you have to realize there are massive underground facilities.

Just south of Omaha at Offutt Air Force Base is a major, critical, crucial installation.

## NEVADA

Nevada district will take some doing, so bear with me. There are some extremely important major, major facilities. They are so important that I hesitate to even... I should just take Nevada as an entire state and call it dangerous.

Beginning at the north almost mid-section of HWY 95 at a place close to, well it would be identified as Granite Peak on mapping, just north of Orovada, is a major missile underground site.

Moving down HWY 95, just south of Imlay, is an underground missile site very close to Ryepatch Reservoir. The important landmark is Star Pk.

Moving back up HWY 95 to where it changes into Interstate 80, southeast of Golconda, on I-80 is an underground missile site.

Move on across I-80, when you get to HWY 93, go north and just north of Wilkins is a small installation right under that HWY.

Moving on to the east on I-80 about midway between Oasis and Wendover with a landmark of Pilot Peak. By the way, Pilot Peak is quite a way from that road but that is the siting landmark. There is a pretty good sized underground missile installation and it probably is referred to in the

circles as Silver Zone Pass.

Go back to the western part of the state. North of Reno and Sparks on a road 445, you will find the Reno Naval Air Station. That's an extremely important one.

Traveling along I-80, west of Lovelock, you will find two landmarks. These are catacombed with missiles. One is the Humboldt Sink and the other Carson Sink. These are both areas which are closed to the public. One extends under I-80. You will find practically no reference to these two most important missile sites.

South near the western border with California near Hawthorne is a massive Department of Defense Depot. It actually is a disposal site. This is a massive, very, very important installation and from this area comes a lot of the contamination that is surfacing in the Mono Lake area in California.

There is massive activity of every kind in the Toiyabe National Forest.

Just north of Gabbs on 361 is an underground missile pod. These missile pods or sites are big enough for underground offices and living facilities.

East of Lida, under the intersection of 266 and 95 is an underground missile complex.

Under 95 at the intersection of 374 at a place just northeast of Beatty is a large installation of underground missiles. This is directly connected to the California installation which includes an underground missile facility under road 395 attached to the U.S. Naval Ordnance Test Station and, of course, is attached to the China Lake Military Reservation. This is an extremely important, critical facility.

In California to the southeast you'll find the China Lake Naval Weapons Center and Fort Irwin Military Reservation and then between Yermo, on I-15, and Baker is a major underground missile facility.

At the California/Nevada border is another underground missile facility, quite small, but these ones on these highways are set for surfacing and the installation will be brought above ground and these will be your ways of stopping interstate travel. Most especially, it will be important to stop travel from California, for many reasons, into Nevada.

In Nevada, of course, and surrounding the entire area of the Nellis Air Force Range, all the way from Warm Springs, west to Tonopah, circling down to the facility and Lida, through and including Scottys Jct., on down to Beatty, including Lathrop Wells, Indian Springs, circling back up in a wide circle to Alamo, you will find in that area a large underground missile base. It's hard to identify. Its HQ is on Hwy 93, just south of Alamo.

Moving up through Hiko and then making a swinging easterly circle back to Warm Springs, that includes all of the Nellis Air

Force Range. It includes Papas Lake which is dry and at that point you find the Nevada Test Site. You are going to refer to it as Yucca Flats, I believe, and within that you're going to find Yucca Mountain and you're going to find it interesting to realize that it is not even attached to Nellis Air Force Base except by tunnel.

Moving southward to Las Vegas, you will, of course, find Nellis Air Force Base just barely to the NE of the city.

You will find a major missile base midway between the junction of 168, 317 and I-15 near Mesquite.

Two underground missile sites, one on I-15 near the border of Calif. just a little west of Jean and then, moving south to Searchlight on Hwy 95, another just north of the intersection of 163.

## NEW HAMPSHIRE/VERMONT

These are only separated by the river. These have to be extremely general. They are military installations but they are unmarked and for all practical purposes would never be known.

In the northwest upper corner of New Hampshire, under the area of the Jay Peak Ski Area, then to the Cochran Ski Area, including the Bolton Valley Ski Area and south including the Mad River Glen Ski Area, near Woodstock is the Killington Ski Area, then the Magic Mountain Ski Area and the Mt. Snow Ski Area.

Now to Vermont: to the east of Franconia are large underground installations with missiles at Cannon Mountain, circling down into the area called Old Man of the Mountains.

West of Conway is Waterville Valley Ski Area.

Then Sanbornville Moose Mountain Ski Area and then, of course, you get to Portsmouth, all of the area under Rye Harbor. These are rather sophisticated living facilities included along with the missile and defensive installations. A lot of research takes place in these areas but, as much as anything, this is a facility for Elite housing with a protection of these sophisticated missile systems.

## NEW JERSEY

New Jersey is basically a forfeit state with most installations being quite public. There is a large installation with missiles in place at Fort Dix Military Reservation. That is near Wrightstown.

South to Browns Mills and just south along a little road of 539, almost including Whiting, is a large Air Force missile installation and facility.

## NEW YORK

On HWY 11 from just south of Watertown



to just north of Pulaski, a very long distance that includes underneath the town of Adams, is a large missile installation and facility.

Northeast of that area on HWY 11, under HWY 11 at the intersection which would enter Fort Drum Military Reservation, there is a missile installation under that road at that intersection attached to Fort Drum. A very large military reservation with missile and facility.

West Point is a very critical underground facility.

I have very little to say about Long Island Sound, it is forfeit.

New York is forfeit, by that I mean New York City.

This is Side 2 regarding military installations with underground and major security facilities and missiles and also missile sites with small facilities.

## NEW MEXICO

You will find only a couple of underground facilities but, of course, they are absolutely, incredibly huge.

The entire area of White Sands Missile Range around Alamogordo, all the way south into Texas at El Paso, crossing the river and taking in a little bit of borderland of Mexico, underground. You've got massive facilities above the ground. You have incredible, incredible multi-level underground facilities. Beneath the ground, you have alien alternates; that will be where your shuttles have been stored—this is the biggest lie on your planet.

Now, as you consider New Mexico, you will find every major freeway and roadway has multiple, multiple missile and facility sites for blocking all incoming traffic from every direction. These will rarely be at cities or towns. They will always be out in the open between places so I can only give you the general mid-location.

We'll start with the one to farthest west on I-40, that is also Route 66.

There is one very near the border east of Lupton, midway to Gallup.

There is one at a little place called Blue Water, almost in the little town running under the little town.

As you get to Albuquerque, of course, you have a large military installation with facilities at Kirtland Air Force Base.

On I-40 between Clines Corners and Santa Rosa.

North on I-25 there is an installation with missiles at approximately Pecos.

Further north on 25 is a regular size installation with missiles at Fort Union National Monument, approximately. That is midway between Watrous and Wagon Mound.

Up I-25 is a small one midway between Maxwell and Raton.

Then outside Raton at the border at

Raton Pass is another very large one, missiles with facility.

In Colorado, north of Trinidad, also on I-25 is another.

Let us move now on down through the state.

At Clovis, you have a large facility with missiles under Cannon Air Force Base and there is an oasis there that is just northwest of Portales.

Back to I-25, a missile base and large facility to the west of White Sands, under I-25.

On I-10 midway between Lordsburg and Deming is a large missile underground facility.

Along the border and overlapping into Texas, I think you would call it almost a four corners, east of Malaga, is just a large facility and there is very little in that area. It is well hidden. It is almost unknown. It is a large facility underground, secret.

## NORTH CAROLINA

Fort Bragg Military Reservation.

In the area of Jacksonville, unlisted, but is a military installation.

At the ocean where the New River empties, you will find Camp LeJune and around Cherry Point is another military installation with missiles.

## SOUTH CAROLINA

Of course, you have the entire area around the Savannah River Plant, which we've already spoken about, with lap-over or underground connections to Fort Gordon in Georgia.

Now realize that is the Savannah River Plant I just spoke of because there are other major installations at Fort Stewart at the city of Savannah.

## OHIO

A unique state with very little secret underground activity. Note that none of these installations are for public utilization under any circumstances. They are for Elite survival only or they are major defense and-or Elite research facilities, very advanced research facilities.

## OKLAHOMA

There are four major military installations.

One at Enid, at Vance Air Base.

Then toward the south, Fort Sill Military Reservation at Lawton.

West to Altus. At Altus, you have also Altus Air Force Base.

Then to the south on I-44 you will come to Sheppard Air Force Base and that is at the border or close to the border of Texas near Wichita Falls.

## OREGON

Large installation across the border into Washington at Richland and Kennewick, in that area, not well defined.

South into Oregon on I-84 between Boardman and Echo is a missile facility. This will be a major disposal station for travellers.

There are so many and so much going on in the area from, approximately, Le Grande, all the way to Ontario, at the border of Idaho, east into Idaho and west to almost HWY 395 that I cannot isolate them for you. That entire area is catacombed.

On HWY 84 at Biggs is a missile installation, military controlled, of course.

The coastal important one to note, and this would include great underground water capability tunneling, is around Coos Bay. There is a Naval Air Station and this, of course, is controlled by Naval Intelligence.

East across the state to Burns, in that general area, mostly in the forest area or what you would call the Ochoco National Forest, there's a large conglomerate type of installation.

At the intersection of 78 and 95 there are two, one being at that intersection more critical than the other and then a regular missile silo facility. But at that intersection is a major, important missile station.

Now let us move back to the west and there are some military underground installations in these general areas: Jacksonville, Applegate, around Medford all the way to Butte Falls and then south of Klamath Falls at Keno, on and under road 66.

Around the general area of Lakeview there are some winter sports areas and some geysers. There would be some thermal activity utilized by that particular installation.

## PENNSYLVANIA

At Erie, great underwater facilities.

On I-79 south of Meadville, midway to the intersection of I-80, missile installation.

On I-80 at regular intervals, midway between intersection I-53 and Moshannon, and midway between intersection of 880 and intersection of 15, missile facility.

## SOUTH DAKOTA

Major underground facility in the area of Buffalo.

Missile facility under HWY 281, south of Aberdeen.

To the east of Rapid City, almost at New Underwood on I-90, missile facility.

Reminding you that these are on heavily traveled thoroughfares for traffic control. They would also be targeted by any enemy for destruction of interstate travel facility

or capability.

## UTAH

I need two or three hours on Utah but I'm not going to be able to have it, obviously. Let's just start in the upper northwest.

The entire area of Hill Air Force Base and Hill Air Force Range. These are near the Great Salt Lake and include all of Ogden and Brigham City.

The Wendover Range, Desert Test Center, and Dugway Proving Grounds. No (unauthorized) body is allowed into these areas under any circumstances.

Then the Desert Range Experimental Station down west of Milford on 122.

On I-15, north of Beaver, is a missile guard installation.

On HWY 89, between Kanab and Glen Canyon, is a small missile installation.

Now let us move back up to I-70. I don't know how to explain this area to you. There is at least 180 miles of area in that barren desert including what is called the San Rafael Swell. This is to the west of Green River. There is an extremely large, important missile facility underneath I-70. There was a missile site at Green River; that was a diversion. It was a testing missile launch site; everybody knew about it but the important one was this area in point.

East of Green River near the Colorado border is another major missile installation under I-70, including a portion of the Colorado River as it runs through that area. In this particular part of Utah are massive, massive research, technology and UFO bases. Some are legitimate UFO bases. These are not necessarily your friends. I don't want to get into aliens at this time. I'm just telling you where these facilities are and these are military, United States of America Military, so don't confuse it with aliens. In this particular area enough research has been going on that it has been monitored continually by "alien" craft—many, many sightings, legitimate sightings—in that area because we've really had our eye on what has been going on there. In this given area, all around in this area, it's divided off into districts and in some of those cliffs, buttes, mountainous areas, you have a lot of things going on including cattle mutilations, etc. I'm not going to get into all of things and ramifications of that statement here, either. Utah is a hotbed of advanced technology.

## TEXAS

Texas is another area that I'll have to bypass. I will mention as we go through in some of the cities. There are so many in Texas that I cannot, by any means, begin to label them all.

## VIRGINIA/WEST VIRGINIA

The same is true of Virginia and West Virginia but I would tell you to keep your eye on the area of the U.S. Marine Corps Reserve in the area of Triangle and at Port Royal, Camp A. P. Hill.

## WASHINGTON STATE

Large facility at Winthrop.

Another at Snoqualmie Summit Area on I-90. It's a winter sports area.

Area of Tacoma, including Olympia, are large underwater experimental facilities.

Between Grand Mound and Lacey is a missile installation on I-5.

To the east, all of the U.S. Military Reserve at Yakima. It's called the Yakima U.S. Military Reserve.

Further east, of course, most important is Hanford, north of Richland, and it takes in quite a bit of the Columbia River.

Set up to guard that place is an installation on I-82.

Down the Columbia River on I-84, just over into the Oregon side, between approximately the junction of HWY 74 and the intersection of 730, under the Columbia River and I-84 is a missile facility.

When I get to the area of discussions of specific cities, I'll be a little more specific.

## WISCONSIN

The only one I see of any importance really is the one at New Glarus.

## WYOMING

Southern border in Wyoming. I will only give you the major locations of the missile sites.

On I-90, southeast of the intersection with I-95, midway to Gillette is a missile installation underground.

South on I-25, midway between Buffalo and Casper, just north of HWY 378 intersection is an underground missile installation.

I-80 is pock-marked with these things all the way across your nation.

Midway between Fort Bridger and Little America is a large underground missile facility.

At the Continental Divide is a large underground facility with missiles.

East of Walcott, then past McFadden, northwest of Laramie.

## ALBERTA, CANADA

I have to tell you about Alberta, Canada. There is a massive underground installation, extremely important in the area of the Primrose Lake Air Weapons Range. This is an incredibly important joint venture with

the United States and I might add, a little Soviet and, of course, Great Britain.

## PUERTO RICO

In Puerto Rico, all around the San Juan Naval Air Station.

## NOW FOR THE CITY AREAS

### ATLANTA, GEORGIA

To the northwest, in the area of Smyrna, you will find an Air Force Base.

To the east, in the area of North Decatur, you'll find a Veterans Hospital. A lot of research takes place in that Veterans Hospital and in some underground laboratories located there.

In Atlanta, Fort McPherson and, of course, the Federal Prison. Then south to William Hartsfield International Airport. There are facilities there, military controlled.

### BOSTON, MASSACHUSETTS

You have the Navy Yards that are presumed closed. They are very much open and operable with much underwater activity. Very important area at the International Airport called General Edward Lawrence Logan International Airport.

The U.S. Military Reservation at the very opening of Boston Harbor.

### BALTIMORE, MARYLAND

In the area of the city, South Locust Point Marine Terminal.

Moving around the lake, Dundalk Marine Terminal.

At Curtis Bay at a point on a north projection, Maryland Port Administration.

Then, of course, you have the Baltimore/Washington International Airport area, a very, very large facility.

East to the GSA Depot across the water to the U.S. Coast Guard Depot.

### BIRMINGHAM, ALABAMA

Very important one at the Birmingham Municipal Airport.

### BUFFALO, NEW YORK

Many military controlled installations. One at the Niagara Falls International Airport.

Fairly large one at Greater Buffalo International Airport.

One at a little place called Buffalo Air Park.

Another little one called Orchard Park Airport.

There is a military controlled facility at Fort Erie.

**CHICAGO, ILLINOIS**

Chicago is riddled, even though it is not expected to survive a shift because of other problems in and around the Chicago area and the Lake Michigan area. You will find many small facilities, military facilities that do not show publicly as military installations. This means that most of the installations involved will be underground, many of them housing missiles.

Chicagoland Airport.

Pal-Waukee Airport.

Glenview Naval Air Station.

Big problems at Chicago O'Hare International Airport.

Inland south, Lewis Lockport Airport.

Argonne National Laboratory is extremely, extremely important.

Rocky Glen and Signal Hill, all of that area.

Straight across to the Crestwood Powell Airport near Trinity Christian College.

This is tape #2 of underground missiles, locations with facilities and military controlled installations underground with missiles. This is a continuation of the area of Chicago.

**CHICAGO, ILLINOIS**

The Chicago Midway Airport, Soldier Field on Lakeshore Drive—all that area. There are planetariums, museums, aquariums, etc., including a place located at Douglas Tomb State Monument.

**CINCINNATI, OHIO**

Installation at Blue Ash Field which is the Cincinnati Municipal Airport.

One at Camp Livingston and then the Cincinnati Municipal Airport Lunken Field.

**CLEVELAND, OHIO**

All along the lake shore, the coast guard station, Burke Lake Front Airport, Cleveland Municipal Boat Docks.

To the south: the Naval Training Station, Halloran Park and Brook Park at Cleveland Hopkins International Airport.

In East Cleveland: Nela Park which is a General Electric Institute—EXTREMELY IMPORTANT.

Cuyahoga County Airport.

**COLUMBUS, OHIO**

Ohio State University Airport.

Court Columbus International Airport overlapping into the Devince Construction Supply area.

A very small airport at Norton Road and Alkire Junction, (unnamed) VERY IMPORTANT.

Then there is the small South Columbus Airport.

**DENVER, COLORADO**

Major installation to the northeast called the Rocky Mountain Arsenal. Watch these arsenals. They are extremely important.

In the same area: Stapleton International Airport, Fitzsimmons Army Medical Center and Lowry Air Force Base.

Buckley International Guard Base. In almost all of that area they are shown as separate facilities. They are all interconnected.

In midtown west of the State Capital is a U.S. Mint—IMPORTANT FACILITY. A lot of tunnelling, a lot of underground connections so that money, etc., can be moved under ground.

The Denver Medical Center.

**DALLAS/FORT WORTH**

Saginaw Airport

Meacham Municipal Airport.

Carswell Air Force Base. There is a large facility at a suburb called Richardson, the University of Texas at Dallas is at that location.

Dallas, Fort Worth Airport—large, large area.

Dallas Love Field—large area.

The Veterans Memorial Center south of Dallas and then right in the heart of Dallas near the Amtrak Terminal under that federal building.

Grand Prairie Airport, Lucas Airport and Dallas Naval Air Station.

**DETROIT, MICHIGAN**

In Detroit: Mettetal Airport and Willow Run Airport.

There is a large facility at Detroit Metropolitan Wayne County Airport.

There are large, large amounts of research and underground facilities at the Ford Motor Company at the University of Michigan at Dearborne, including Greenfield Village and attached to the Veterans Hospital.

The Ford Motor Company River Rouge Plant, the Cadillac Plant and the entire area under Fort Wayne Military Museum.

The Great Lakes Steel Corporation and taking in the Canadian Steel Corporation in Windsor.

Also in Windsor: the Ford Motor Company and the Chrysler Corporation as well as the Windsor Airport. Surprising

to find that your motor companies all house military facilities.

**HOUSTON, TEXAS**

Northwest: Collier Airport

South of Collier: Andrau Airport

William P. Hobby Airport and then of course, Ellington Field, that's the U.S. Air Force field.

Pearland Airport at Pearland.

In Clear Lake City there's a branch of the University of Houston and the Lyndon Johnson Space Center which is, of course, NASA.

**LOUISVILLE, KENTUCKY**

The U.S. Quartermasters Depot.

The V.A. Medical Center and American Printing House For The Blind—very interesting.

Swarms with them. All surface ones are almost in alignment, inland from the coast. I say surface because these are going to house missiles in the guise of other things, but you have to understand that you're working at the Atlantic Ocean seacoast and a lot of these will also be tunnelled to that coastline, again I remind you that most of Florida is expected to be lost.

**WASHINGTON, D.C.**

Absolutely all of Washington, D.C. in the downtown area is one gigantic facility. All around that area every airport from little ones like Bower Airport to Andrews Air Force Base which, of course, is a large facility, to the Goddard Space Flight Center which is NASA—all of these areas have facilities underneath. They are rather large facilities, as a matter of fact, and everything under Washington, D.C. is catacombed with tunnels and, of course, there is missile capability.

There are defensive missile silos that will open up and the surface of the area of Washington, D.C. will not be worth even experiencing. It is, of course, made for interim facilities for workers in and around the Capital who have their free tickets to security. That will only be ones attached to the Elite guard and the political hierarchy who are left in Washington, D.C. for unexpected raids.

The major luxurious facilities for the high Elite, depending on the state of war

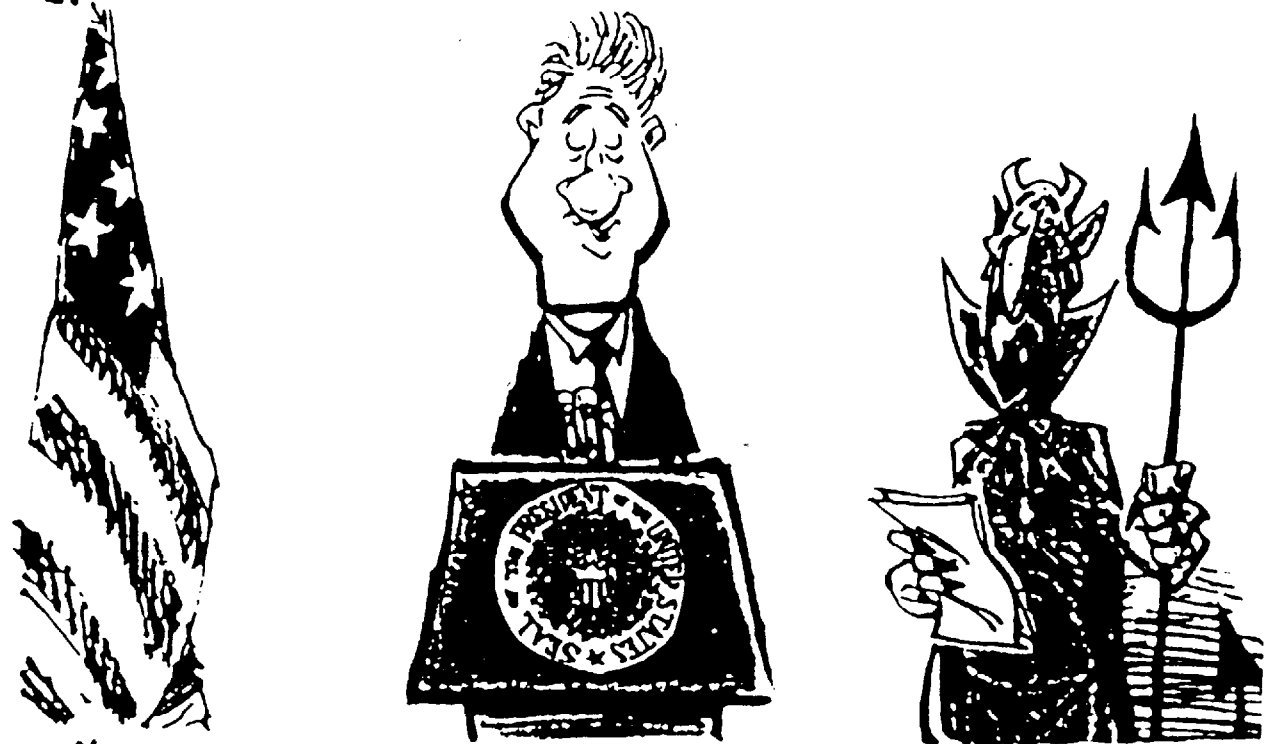

Mr. Schroeder was not armed. This activity was reported to the press on Thursday, March 4th, as an attempted "attack" against the 300 heavily armed BATF and DPS forces that surrounded the Branch Davidian Complex, even though none in the assembled press corp heard any shots. Subsequently, on Friday, March 12th, the BATF account of this incident was amended to include a hand-grenade allegedly thrown at BATF forces. Again, no press members reported any explosions or gunfire on the evening of the 28th, in spite of the fact the "media setup" was only 1/2 mile away. This was done in part to cover-up discrepancies between BATF versions of the original raid casualties and hospital reports used as exhibits in the search warrant, numbered W93-54M, dated April 13, 1993.

A Mr. Peter Ghent from Australia was killed by BATF snipers during the afternoon of February 28th, as he attempted to exit the top of a water tower used by the Mr. Carmel Water Company since 1947. Mr. Ghent had been cleaning and removing deposits of rust from the interior walls of the water tower during the initial "raid". His body lay on top of the water tower for 8-days before the Branch Davidians were allowed, on National TV, to have a burial on Monday, March 8th. The entire community of Elk, Texas was told not to drink the water supplied from the tank. They were never told why.

Negotiations between Branch Davidians and the FBI were completely one sided. This was particularly evident with respect to the 21 children released the first week of the siege. The agreement between Davidian parents and FBI Hostage Rescue Team negotiators was that a written list of friends and family members as well as bank account numbers was to be used to place and provide care and temporary homes for the children in the Waco area. In addition, the children were to be allowed a phone call back in to let their parents know they were OK. None of these promises by the FBI Hostage Rescue Team were kept. All of the children were handed over to Child Protective Services Incommunicado, and the list of careproviders was used by the FBI to find "material witnesses".

All information for this investigation was gathered over a 6-week period from eye-witnesses, archival and current reports, proprietary video tape and government documents. Corroborating interviews were conducted with all individuals now incarcerated in Waco and San Antonio. As well, evidence supplied by the FBI, though contradictory of itself, is used extensively in this report.

It was also confirmed on Wednesday that another individual, Peter Hipsman, of White Plains, New York, was killed in the original February 28th assault. This list will undoubtedly grow, according to one of the incarcerated Davidians who requested anonymity, because they were "warned" by the FBI not to disclose names and numbers of civilian casualties suffered in the Sunday massacre.

***WHY WACO? - UPDATE***

(Puyallup, Washington) . . . *Prime Time Live, A Current Affair, The Dallas Observer* and *Cox News Service* were all briefed at 3:00 Pm CST yesterday as to the results of an independent investigation conducted by electronic, forensic, para-military and Texas law enforcement experts upon the event commonly referred to as the Waco, Texas Branch Davidian Church, Mt. Carmel Disaster. The results of the investigation are as follows: The "raid" on February 28, 1993 was an ***orchestrated event*** oriented toward destroying and or confiscating certain sensitive videotape and computer evidence possessed and gathered by members of the so-called "inner circle". This information was deemed most damaging to the Bureau of Alcohol, Tobacco and Firearms, but was also considered "sensitive" by the Department of Justice. This information is actually affirmed in Affidavit W93-54M, filed April 13, 1993, U.S. District Court, Western District of Texas, Hon. Dennis G. Green presiding.

All four of the reported BATF casualties and at least nine of the reported injuries were the result of accidental discharges, detonations, and incidental friendly crossfire principally emanating from three armed Texas National Guard helicopters. The press corp and FBI reports that Branch Davidians had "murdered" the four BATF agents is ***blatantly unfounded*** and false.

There was additional gunfire at approximately 6:00 Pm Sunday, February 28th. This consisted of BATF snipers firing with long-range silencer equipped rifles at 3 individuals attempting to cross a field from a site at which they had been working the morning of the raid. Two of the individuals, Norman Allyson and Bob Kendricks, fell defensively to the ground and were subsequently "picked up" by armored vehicles. The third man, Michael Schroeder, was hit in the back and died on the fence. His body was removed on the evening of Wednesday, March 3rd, with the assistance of a Bradley type APC.

# Be Thankful As Faults Hold On By Thread

These events could still take place, but the time frame may be altered due to some other, seemingly unrelated event which has also

occurred. Even Master Esu [*mis-named "Jesus" by early religion formers*] stated that He knew not the hour, only the Father knows. Esu understands the principle of the inter-connectedness of all things in the Universe, and understands that what may look to be unrelated to one event, actually has the effect of altering that event, be it in time or place, or whether it will occur at all.

You, too, know this to be fact; however, because of the veil of your dimensional expression, your perception of reality is based on your present experiencing. It does not mean that you have missed it in any way—it only means that you are third dimensional expression and must experience all things in that manner. Chelas, it is all part of the lessons through which you must pass.

Are you out of the woods, then, regarding major Earthquakes? **Not on your life!** The situation has not changed one bit. The faults are still holding only by a thin thread and the volcanoes are still building pressure. There were two smaller Earthquakes which did occur yesterday in that area of California—one near Big Bear, which you will recall is the location of one of those which struck last June. The other was located near Barstow. Both were in the vicinity of 3.0 in magnitude. Also, this past week, a 5.9 Earthquake was experienced in Japan, some distance from Tokyo. It was reported by your scientists to have its "epicenter" approximately 70 miles below the surface. Actually, that point 70 miles below the surface would be the focus, not the epicenter, as the epicenter is that point on the surface directly above the focus. Seventy miles deep places the focus of this particular Earthquake into the asthenosphere, which lies approximately 63 to 70 miles below the surface and is part of the mantle of your Earth. The mantle actually extends to a depth of approximately 1600 miles.

The crust and the uppermost part of the mantle are relatively rigid. Together, these two are the Lithosphere. In Greek, the word "litho" means rock, and is explanation of what it consists of. The portion of the mantle underlying the Lithosphere is the Asthenosphere, which behaves more plastically, that is, it is not made up of solid

materials such as the Lithosphere, but rather a more molten state occurs at these depths.

Deep within the Earth, then, far beyond that which man on your world has ability or technology to view, is an internal process which is continually reshaping and renewing the face of your planet. This internal mechanism works due to hot material within the Earth moving slowly upward toward the cooler surface. This process would be known by you ones as convection—the upward movement of low-density material and the downward movement of high density material.

To understand this process, simply watch a pot of boiling water. As the water at the bottom heats, it rises, because most substances, when heated, become less dense. As the hot water rises, colder and more dense water sinks along the sides of the pot and creates a circular pattern which you would call convection current. Water is a liquid, but this same process takes place in solids, providing the solid is capable of very slow flow (similar to the flow of toothpaste from a tube). The toothpaste is not liquid, but a solid capable of very slow flow, and would behave plastically, meaning it is capable of being molded.

It is the forces deep within the Earth, then, which are responsible for the seismic and volcanic occurrences at the surface, or just below the surface. The crust of the Earth is no thicker, relatively speaking, than the skin on an apple. And, just as microbes which exist on the surface of the apple are unable to penetrate the skin and are therefore more concerned with that which is taking place on the surface than what is occurring below, deep within the apple, the inhabitants of the Earth are more concerned with the occurrences on the surface of their planet than with that which is occurring at depths of thousands of miles. Yet those occurrences are responsible for that which takes place at the surface, and that which takes place at the surface is responsible for that which occurs in the depths of the Earth, and on and on and on...in a never-ending cycle of the relationships between the planet and its inhabitants.

Oh, Chelas, the workings of the Uni-

verse are indeed wondrous things. For even the smallest microbe carries as much impact on what occurs as does the largest of planets! For truly, one can not exist without the participation of all. You are just now coming into the understanding of this principle. Not only are you responsible for creating your own reality, you are in essence responsible for creating the reality of the entire physical Universe! Does it not make the Golden Rule — *"Do unto others as you would have others do unto you."* -- even that much more meaningful? # George Sues Jesus

that. This started with seducing some major contributors to "join with him" and pull their funds out of the Institute...in other words, create "a run on the bank" of sorts.

There have also been numerous allegations of funds, meant to go to the Phoenix Institute, getting — how shall we put this politely — "sidetracked" into George's pockets and those of some other long-time equally shady "friends" working with him. Naturally all of this is heatedly denied by George and his "friends", even though the most incredible array of proof continues to pour in every day against "honest George's used cars" integrity posturing.

So, that background brings us to the latest brassy legal volley flung our way. In a legal (counterclaim) action filed recently, George Green has had the nerve to launch into a new, full frontal assault against the Phoenix Institute and — we kid you not — has effectively even declared war on God, considering who all are mentioned in the suit. [See copy of the legal action cover page on page 37.]

This counterclaim, filed on May 4, 1993 by Dave Horton, George's dutiful if gullible Attorney, is listed as:

**America West Publishers, Inc., America West Distributors, Inc., Nevada corporations, George W. Green, an individual [Desiree Stevens-Green is conspicuously absent from the filing listing] and Does I through X — Defendants and Counterclaimants**

vs

**Phoenix Institute for Research & Education, Ltd., a Nevada corporation, Eddie Jo Ekker, (aka "E.J. Ekker", aka "Oberli", etc.) and Doris Ekker, (aka "Dharma", aka space traveler from the constellation Pleiades), "Gyeorgos Ceres Hatonn, Commander in Chief, Earth Project Transition, Pleiades Sector Flight Command, Intergalactic Federation Fleet," aka "Ceres 'Atonn, aka "Esu Jesus Immanuel Sananda", (Jesus Christ), aka "Sananda, Supreme Commander of Project Earth Transition," aka "Violinio Germain", aka "Wokini", aka, etc., ... Phoenix Liberator, Inc., a Nevada Corporation... etc.**

Next, we need to give you some background to the other legal document just

launched by George: The Phoenix Institute had, in late March, filed a motion for a **Temporary Restraining Order** to STOP George from alarming various Institute lender/creditors he was contacting (just as fast as he could) and to which he was giving highly erroneous information. This particular scheme was meant to induce them into transferring funds OUT of the Phoenix Institute to, again, bankrupt the otherwise financially quite sound Institute, and thus stop its worthy enterprises.

Also, and even more outrageously, it has somehow gotten justified by George that various donated funds and gold (which the donors said they wished to go into the Institute, but which ended up in George's pockets or those of some "friends") belonged to him because of what he has "personally" put out in funds for publishing enterprises. Now, WHAT kind of publishing business was it that he is in where he confiscates so much of others' monies to run HIS business? What a deal in low overhead!

These above Restraining Order issues are what are then referred to in an oppositional summary document by George called "Points and Authorities" [on pages 38 and 39]. This document is "In opposition to motion for temporary restraining order and preliminary injunction, and motion for relief".

Green states: "The purpose of the Ekkers' litigation is to preserve, for a little while, the ponzi scheme [?!] in which they are engaged, by seeking gold belonging to George Green, which was acquired by him by gift [?!]; with the knowledge of the Ekkers [?!], and to which he is entitled both by gift and by providing more than the equivalent cash to pay the expenses for which the gold was provided.[?!]"

You will notice we are including an early and probably embarrassingly "inconvenient" letter from **George Green** [on pages 40 and 41] which states, in his own words, that he is a **Director of the Phoenix Institute!** Of course, George denies such involvement. Note that this letter is from a Colorado address and was written on "America West *Financial*" letterhead. Also note his involvement is at least as far back as July 19, 1990, according to the fax date stamped on the top of the pages. Oh, what a tangled web he weaves...and falls into.

Now to some of George's "friends"

Green has also objected to our mentioning his collusion with one Gary Anderson (who happens to be an ex-Federal felon) and Anderson's pocketing of funds intended for the Constitutional Law Center. We are thus printing [on page 42] another "inconvenient" letter — this time written to George Green from Gary Anderson. This backside-covering note concerns funds intended for the Constitutional Law Center, a Nevada corporation. These funds were — again, how shall we put this politely — "diverted" to Anderson's Constitutional Law Centre (a trust). While the chummy letter from Anderson to Green implies accidental receipt of funds, as well as intent to return other items to their rightful owner, YOU be the judge (or better yet, the jury) as to who is doing what to whom.

Furthermore, we would like to know just WHEN Anderson founded his "trust" that it should be so conveniently named (Centre rather than Center) to cause mixup and "accidental" funds diversion away from the highly praised and recognized GENUINE Constitutional Law Center. We would also like to know...ahem...where the bank account is located because of still other shady matters.

And while we're on the subject of George's "friends", let us not forget one Luke Perry [see page 43] who has contrived to bring yet another wave of destabilizing anxiety against the extremely sound financial integrity of the Phoenix Institute. Perry has mounted a particularly venomous attack "using" the offices of the Associated Press as his publicizing agent. (WHO has this kind of clout without "help" from higher up the Adversarial Elite ladder?!?) Moreover, the earlier AP articles were almost hilarious they were so unprofessionally one-sided in their reporting.

HOWEVER it just so happens that the Junior Perry has tried, for several years, to—how shall we put this politely—"procure" his step-mother's trust estate, her sole means of support. Thus, once the Associated Press finally made the effort to do its homework on this matter a bit more thoroughly, as the article [on page 43] reports, we are FINALLY informed that Perry's own stepmother "questioned her stepson's motives" to put it mildly.

**So do we!**

There will be much more information in next week's CONTACT as the data is assembled that has come in from all over. Many are angry at George's antics. And for those of you who wish to take specific action in support of the Phoenix Institute and Phoenix Project, in light of these accelerated attacks, stay tuned!

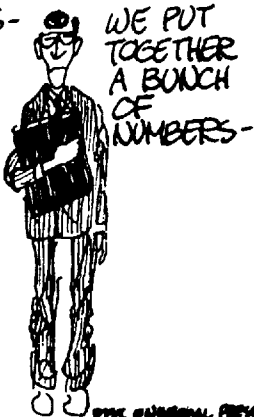

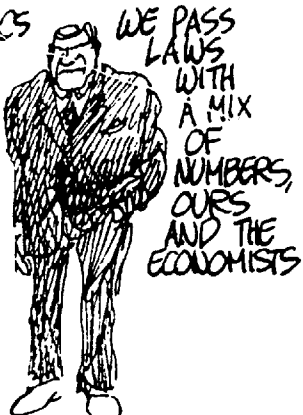

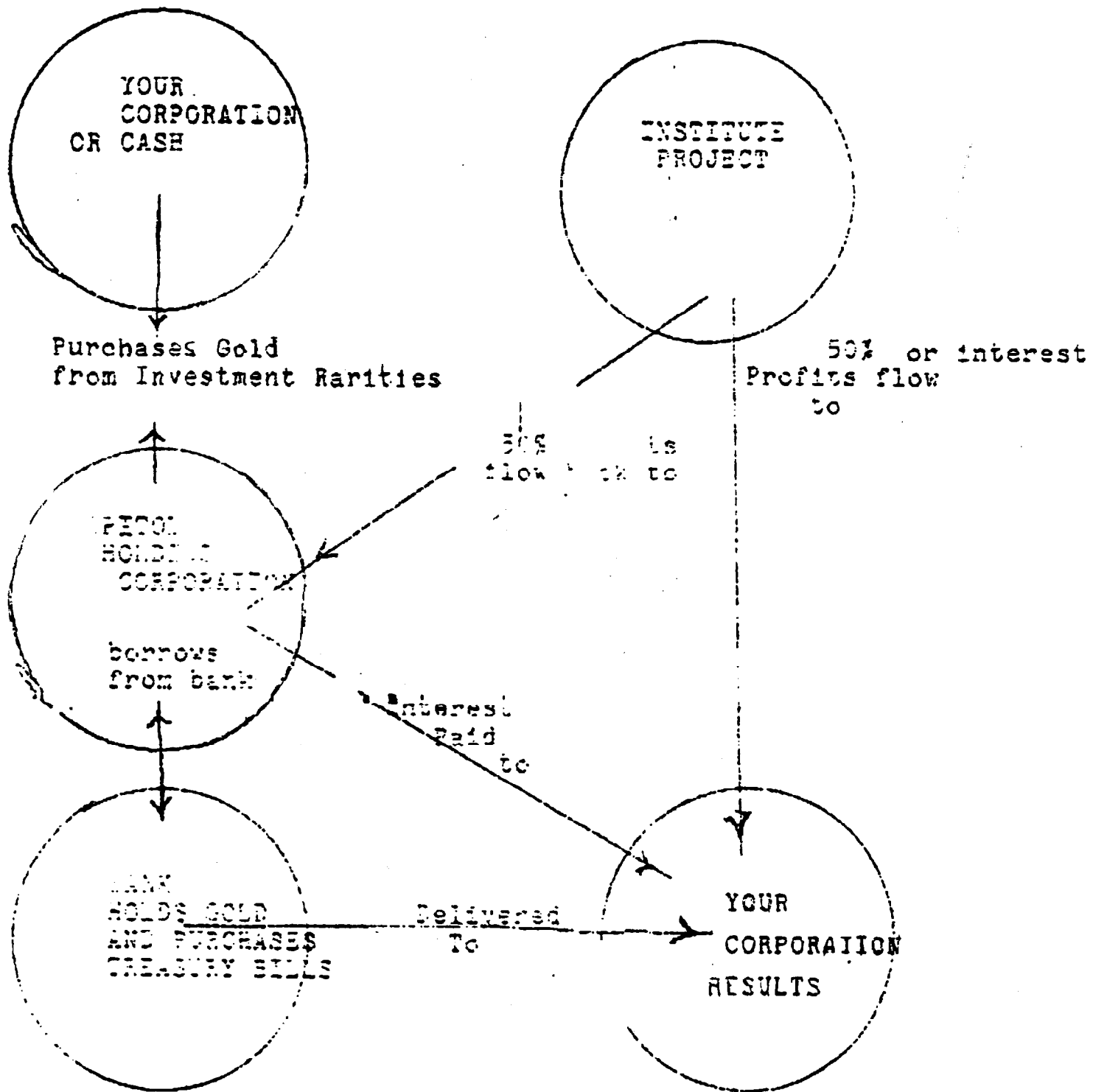

# Tehachapi man denies links to firms are out of bounds

CARSON CITY, Nev. — A Tehachapi man who claims to get counsel from a space alien says there's nothing fraudulent about his involvement in hundreds of Nevada corporations.

Eddyjo Ekker, 62, also said he's on food stamps and isn't making money by being listed as a top officer in the corporations. He added that the people who wanted the corporations formed are in control of any assets.

"We're not bilking anyone out of anything," said Ekker, who with his wife, Doris, runs the Phoenix Institute for Research and Education. They're listed as top officers for more than 200 Nevada corporations formed since 1991.

Doris Ekker, 61, claims to be a translator for Commander Hatonn, an extraterrestrial orbiting Earth and warning disciples about intergalactic strife.

Ekker said only his wife can hear Hatonn's radio communication, but from that communication he understands Hatonn to be a white male, "maybe Nordic in appearance," who would stand out in a crowd only because he's tall and wears "Star Trek" garb.

Ekker said in a telephone interview that Nevada corporation laws allow a level of financial privacy that "not even some of the off-shore tax havens have."

Ekker said he worked with

friends to help them set up their own Nevada corporations, adding, "Certainly we get a lot out of it, but it's in the heart and not in the pocketbook."

Ekker also challenged claims by Luke Perry of Las Vegas, who says the Ekkers control \$120,000 of his family's money as a result of a move made by his stepmother to the Phoenix Institute.

Loretta Perry, of Holmen, Wis., confirmed she can get her money back if she wants, but prefers to take interest payments on a monthly basis. She questioned her stepson's motives and added she finds the Ekkers to be "just perfectly normal people, just like you and me. There's nothing weird about them at all."

Perry also said the Ekkers have tied up at least \$2 million in other investors' funds, but Ekker denied that.

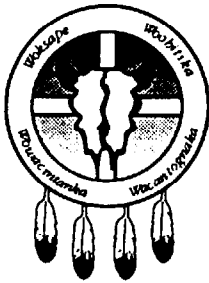
The activity has prompted a state Assembly subcommittee to look for ways to close any loopholes that could be used in corporate investment schemes.

Assemblyman Scott Scherer, R-Las Vegas, who is chairman of the subcommittee, has asked for reports on the authority of the secretary of state when advised by citizens of possible frauds.

He also questioned a bill that would exempt resident agents who file papers for thousands of new Nevada corporations each year from laws governing telemarketers.

The name *Ginkgo* may come from the Chinese *Sankyo* or *Yinkuo* (Yin Guo), meaning "hill apricot" or "silver fruit". The word *biloba* means "two lobes" and describes the young leaves. The highly specialized extraction process yields a 50:1 concentrate from the leaves (50 grams of leaf produce 1 gram of extract). The extract is then further standardized to contain 24% of the active Ginkgo Flavoglycosides.

### **MO-GU ELIXIR**

The first recorded use of Mo-Gu Elixir was during the Chinese Tsin-Dynasty in 221 B.C. It was referred to as "*The Remedy for Immortality*" or "*The Divine Tsche*".

The vitamins found in chlorella cells include: Vitamin C, provitamin A, B-carotene, chlorophyll a, chlorophyll b, thiamine (B1), riboflavin (B2), pyridoxine (B6), niacin (B3), pantothenic acid, folic acid, vitamin B-12, biotin, choline, vitamin K, PABA, lipoic acid, inositol and para-aminobenzoic acid. The minerals include: phosphorus, potassium, iodine, magnesium, sulphur, iron, calcium, manganese, copper, zinc and cobalt.

The amino acids include: lysine, histidine, arginine, aspartic acid, threonine, serine, glutamic acid, proline, glycine, alanine, cystine, valine, methionine, isoleucine, leucine, tyrosine, phenylalanine, ornithine, tryptophan.

The suggested daily consumption is 3 grams per day.

### **ECHINACEA GOLD PLUS** **with American Ginseng**

In recent years few medicinal plants have garnered as much attention as Echinacea (*Echinacea Purpurea* and *Echinacea Angustifolia*). The genus name is derived from the Greek *echinos*, (hedgehog or sea urchin) referring to the prickly scales of the dried seed head. Echinacea was widely used medicinally among Native Americans, particularly in the Plains. It is a product which is now used widely throughout United States and Europe.

Echinacea is a non-specific stimulant to the immune system. Claims for Echinacea include: stimulation of leukocytes, mild antibiotic activity, anti-inflammatory activity, stimulation of the adrenal cortex, stimulation of the properdin/complement system, interferon-like activity, stimulation of general cellular immunity, and

antiviral activity. Internal preparations are said to assist in alleviating cold and flu symptoms, respiratory infections, and arthritis, to name a few.

Goldenseal (*Hydrastis Canadensis*) is generally placed in the buttercup family. The name Goldenseal was adopted in 1880, previously having been known as Yellow Root. Goldenseal was widely used among the Native American population, particularly among those in the East. The Cherokee used the roots as a wash for local inflammations, for general debility, dyspepsia and to improve appetite. The Iroquois used it for whooping cough, diarrhea, liver trouble, fever, sour stomach, flatulence, and pneumonia. Benjamin Smith Barton first referred to the use of Goldenseal for rattlesnake bites as early as 1793. Clinical recognition of the use of Goldenseal came in the early 1850s and has continued to this very day.

Goldenseal is among the most popular herbs in the American health food market. Uses are numerous, including but not limited to: antiseptic, hemostatic, diuretic, laxative, and tonic/anti-inflammatory for the mucous membranes, hemorrhoids, nasal congestion, mouth and gum sores and eye afflictions.

Ginseng can be literally translated from Chinese as "the essence of man" or "man-shaped precious root." Few medicinal plants in the world possess Ginseng's near-legendary status. Dating back thousands of years, its history of use in the Orient records therapeutic properties so wide ranging that it was first dismissed by Western doctors as a "panacea". When fatigued, Ginseng reportedly restores both physical and mental functions to peak efficiency and, with regular use, improves resistance to disease and stress. American Ginseng's genus name is *Panax Quinquefolius*.

Over 40,000 species of mushrooms exist, many of which are used as medicines. Of particular note are such remedies as penicillin- and ergot-based extracts used in migraine treatment, to name a few. Extensive research has been done with one mushroom in particular, namely, Reishi. This mushroom is now considered a tried and true immune system fortifier.

References to the use of Reishi in the treatment of a variety of complaints date back as far as 2700 B.C. in Chinese literature. It is referred to by a number of names, including the "ten thousand year mushroom". The rarity of this particular mushroom has increased its value. The Chinese emperor Shih Huang Ti (250-210 B.C.) mounted expeditions of hundreds, even thousands of men to find the Reishi. Recently techniques have been developed for the cultivation and harvesting of the Reishi Mycelium. Writings about Reishi place it in the category of "fu zheng" herbs and claim it is a medicine that improves the ability of the body to maintain balance by strengthening natural resistance and generally improving health.
