I am most grateful to a reader who

has written the following:

"My next door neighbors are leaders in the anti-nuclear movement here in Alaska. ... . It is reported that all the major U.S. cities (and possibly all cities with 10,000 or more citizens) have a Soviet nuclear bomb of 20 megatons aimed at them. A 20 megaton bomb will blast a crater 3/4 of a mile wide and 800 ft. deep. Without considering that air will be sucked out of shelters within a radius of 20 miles from epicenter, how is it possible to survive a 20 megaton within the crater in a shelter under 10 ft of dirt?

Hatonn says that everyone will survive in a shelter under 10 ft. of ground but reports on a 20 megaton bomb say that everyone within a 50 mile radius will die. Moreover all the plants in a much larger radius (also depending on winds) will be contaminated for an unknown period of time (maybe decades) and pests will infiltrate the lands and bring disease and death to walking survivors even hundreds of miles away.

This is why nuclear activists don't believe a nuclear war is survivable and why they believe fallout shelters are merely a placebo, therefore a lie.

I personally question coming out of a shelter following a nuclear attack and finding all plants inedible and swarms of hungry disease infested pests racing towards me.

George, I hate to see powerful allies like our nuclear activist friends turned off with information that's not compatible with proven facts (i.e. what a 20 megaton bomb will do). The question becomes "if I can't believe this, how can I believe anything else I read in the Journals?"

I personally check my truth meter and accept that what feels right. Most of what I read in the Journals feels right to me or I wouldn't continue reading and supporting them. When I'm questioned on some points like the nuclear survival issue I simply don't have a reasonable response. Maybe only humane little bombs will be used and 10 feet of dirt and one week in a shelter will be more than adequate for survival, I don't know. Yes sir, delighted to respond. What would the activists have you do? Would they perhaps prove from whence this "proven" information comes? Could it be another great lie in cover-up to keep you blatantly helpless? JUST WHAT DO THEY PROPOSE DOING ABOUT IT?

Further, I suggest everyone reread the material. I did not say that everyone "would" survive--I did say "everyone *could* survive" in a good sturdy shelter with only 10 feet of dirt--less if the dirt is compressed.

This is for several reasons but I shall give you one to chew on. To inflict the kind of damage of which you speak you would have to have a "GROUND DETONATION" which is most highly non-probable and totally impractical on the part of the enemy. An air detonation does more damage to the most people--if unprotected in shelters--and that would be the point. Therefore, you are not likely to have many, if any, ground detonations because that kicks up radioactive dust particles which would blanket your world--and your enemies are not that stupid. Plus, the neutron bomb will be-

come the bomb of choice--this bccause it kills life but preserves physical buildings, factories, etc. and yet a well built shelter is indeed safe during the early days of such attack.

If the shelter has adequate closures--no air will be sucked out. And, if the detonation is air instituted, it will not dig such a crater-especially if a neutron bomb. If it is accidentally detonated on the ground you still have only an 800 ft deep hole measuring 3/4 of a mile. Well, couldn't you just maybe place the shelter outside the radius of the expected detonation and hookup by a tunnel system? Further, even if the facts are absolutely truth regarding the over 10,000 population targets--aren't these simply good reasons for spreading out and being in a nontargeted area? They can't hit everything! The point will be to maintain the planet to its best advantage for later use so the planning is careful indeed.

As to plants and insects. Yes there would be devastation on the surface in total amounts in some areas--but for instance, if you have underground protected greenhouses you will be able to grow even if the ground is contaminated. ALL ground will NOT be contaminated nor will all ground water but surface water probably will be intentionally contaminated. A corporation never dies, it just gets a new president. No bank accounts are held in probate, etc. I simply cannot take the time to give a full lecture on "how to", I can only basically tell you what is available and you ones must do some of your own homework--the people on my staff are busy some 20 hours a day. We will continually try to make available information and perhaps we can begin to have regional meetings, such as Freedom '90 just past, and allow these subjects coverage with handout materials to cut expenses and travel. We also have to remember that it is most expensive to even remain in operation, much less cover all these necessary facets. Please bear with us until we can better serve you.

I would like to herein share some insight and I shall simply quote from one in the real estate business for years and years and utilizes dozens of corporations personally. His input is valuable for consideration and perhaps states the situation more clearly than can I. He speaks of close "family friends" sharing your business, etc., as well as friends and that is excellent--also, if incorporated. But suppose you have no willing members and the estate is messed up and, and, and---:

IF YOU CAN'T PLAN YOUR OWN DEMISE, THEN PLAN TO BE IM-MORTAL. Jack Miller

In lieu of finding that trusted friend with whom to entrust the management of your financial affairs, consider an operating corporation as an alternative. Think for a moment of how a corporation really operates. Shareholders choose Directors (so you can pick a group of savvy people to make the broad policy decisions and to develop long term strategies for the deployment and investment of your assets). Directors hire Thus, the actual Officers. implementation of these policies will be taken care of in your absence. As the principal stockholder, you can control the Board with your vote, and thus the selection of Officers too. Once you're satisfied, you can leave your proxy with an agent who will oversee your interests. This not only provides for future continuity of income for yourself and your heirs/or favorite charities. It also relieves you of any day-today management chores you don't like TODAY.

It's not as hard as you think. INCORPORATE! I recently had a chance to visit one of the retail outlets owned by Hughes Property Management, Inc. That's a company started by Howard Hughes. Although he died in March, 1976, his company lives on, earning tremendous profits. Oh, you might know it by its 'trade name', 'THE SANDS' (Nevada). It is a casino on the strip in Las Vegas. It still employs lots of people, pays taxes, is still growing and competing while it adds to his

estate for the benefit of his (apparently millions of) heirs. Because it's an operating business, it can offer a variety of methods by which heirs can benefit. They can become employees and managers, specialists, leasing casino operators, booking agents, accountants, lawyers, financial advisors. They can sit on the Board of Directors and/or serve as Officers with a basket full of fringe benefits. Or they can just be stockholders living off their dividends. It provides great flexibility.

Hatonn: Oh, you say, "Well, I'm not Howard Hughes--I just have a little bit of retirement and some property of not much value." Good--you only need (1) (ONE) person to serve as "everything" important in your Nevada Corporation and the owner of the corporation is never divulged to anyone unless you do it yourself and then they can't "prove" it. That means you control the stock, the business, etc., and have an arrangement whereby you have a "run my business until I die" constraint if you choose.

Basically all those who retire should form a corporation and use the framework it provides for meaningful work, recreation, estate planning, a source of dividend income outside the limitations set by depression and early death, etc. That is reason enough to get yourself or your parents incorporated-in Nevada--even if there are not valid business reasons why this would seem to make sense. But there are. Everything from fringe benefits to pay medical insurance costs, fantastic Defined Benefit Pension Plan tax shelters at their age, incorporated hobbies, and a sense of real self worth for them and for you. And think a minute-who would you get for executor of your estate and walk the assets through probate, etc? Is it not your family members usually?

Then put them on your Board of Directors and set up non-voting stock, etc. There are many ways to handle the details.

What guarantees that Nevada will stay flexible and out of the grips of the Cartels? Because it is where the boys of the Cartels set up their business interests--there and offshore. Further, it probably will fall to the system but you will have perhaps bought a little security and stability in the meanwhile.

# LETS TALK "PRIVACY"

How can you insure maximum privacy, anonymity and protection of your assets?

One way to maintain the privacy and anonymity of ownership or control of your assets is to have those assets in a corporation whose ownership is difficult to detect. You can increase this privacy by not actually owning the stock of the corporation, while still having as much control as you desire. (John D. Rockefeller once said that the secret of his success was "owning nothing but controlling everything".) And if anyone should know, it would be David Rockefeller.

One way to achieve this control without ownership the is "Endorsed-in-Blank" technique. To understand how this works. you must understand that stock certificates are very much like checks. The registered owner can "endorse" the back of the stock certificate and give or sell that certificate to a third party in much the same way that the recipient of a check can sign it and pass it on to someone else. Usually this endorsed certificate is then submitted to the corporation's corporate secretary who issues a new certificate in the new owner's name.

HOWEVER, and this is VERY IMPORTANT, <u>until the endorsed</u> stock certificate is submitted to the corporate secretary, the corporation's STOCK REGISTER will show the stock belonging to the original shareholder and the stock certificate will generally state that it is only transferrable on the books and records of the corporation.

Therefore it is quite possible to issue a stock certificate to a third party who immediately endorses the certificate and hands it to the ultimate owner (or some other third party). This person holds on to the certificate and does not submit it to the corporate secretary. In the meantime anyone who examines the share register will see that the original owner is still a shareholder in the corporation.

There is added flexibility in the use of the Endorsed in Blank technique as well since the decision as to who the new owner will be can be made at any time by the person in possession of the endorsed certificates, depending upon the legal famifications.

This technique can work very well with the Warbucks/Red Inc. strategy (see PRIVACY IN THE FISHBOWL regarding corporations). This would be where Red Inc.--your home state corporation (and you would need a second corporation in your home state in this instance)--has all its assets encumbered bv Warbucks--the Nevada-based corporation. Bv using the Endorsed in Blank tactic, you can make it very difficult for anyone to find out who the real owner of Warbucks is...and, if you do things just right, then it doesn't matter who the real owner is, because it is not reflected as "vou".

As a matter of fact, Nevada law can make even the tracking down of a corporation's share register tedious in the extreme. The register does <u>not have to be kept in</u> <u>Nevada</u>. The Nevada offices of the corporation must <u>merely keep</u> <u>a record of WHERE the register is</u> <u>located</u>. Further the locations can shift at random with a simple notification and if the notification happens to cross investigators in the mail--so be it.

This is just one little example of how to utilize the tools. Obviously if you are retired and simply are running hobbies and family business of personal nature for the benefits under incorporation--you won't do all this other "stuff". Remember, these bits of information are going to the most sophisticated of business owners and to the least of the interested public. We cannot cover it all and you must be selective as to that which can be utilized.
