The Falkland Islands Crisis-- A Few Details They Didn't Mention

(Editor's note: It was 10 years ago in April and May that Great Britain and Argentina entered into a little altercation over some tiny, barren islands in the South Atlantic. The news media had us all saying the situation was little more than "a tempest in a teapot" over ownership of some cold and wind-swept real estate that hardly seemed worth the effort.

In JOURNAL #13, SKELTONS IN THE CLOSET, pages 155-181, Commander Hatonn painted a slightly different picture of the affair. It seems a few little details were left out of what we were told about the event. We are reprinting the Falkland Islands story below because it would be well to keep in mind that the same underlying forces behind that outrageous deception are behind today's, too--only with ten years more practice. And for those readers following the recent LIBERATOR outlay of secret underground military installations and their functions--well, here's a few more to add to the collection under the heading of "your tax dollars at work.")

To give proper placement of background, you must return in your memories back to April of 1982. Move back to the Falkland Islands and South Georgia Island and the war between Argentina and Great Britain over these barren, wind-swept wastelands. Or, were they? Oh, dear ones, what you have not been told would fill mammoth volumes and we haven't time for that. I am going to give you information which is well-known in certain circles but hardly known at all to the populace—you the people. A few have come into this information; enough to confirm the truth of my writings at any rate.

On the surface the whole incident represented a dispute between Argentina and Great

Britain over those barren islands. **But surely you have learned by now, that nothing is as it seems.** You are told exactly that which you are to believe and you diligently go about following the orders.

The so-called Falklands crisis was just the visible tip of a giant military operation. During the month of April 1982, fierce naval battles were taking place, not only in the South Atlantic but also in the South Pacific.

The hostilities were very effectively kept under arrest by wartime censorship on all sides of the dispute (and yes, the U.S. was most certainly in the dispute).

On April 30, a total naval and air blockade of the Falklands by the Royal Navy began. At the same time a counterblockade had been declared by Argentina in the same area.

To be effective, a blockade must be imposed over a period of time, but the Royal Navy didn't have sufficient time. Winter was coming on in the South Atlantic, and the British supply lines were overextended. Having traveled so far, however, Her Majesty's navy could not simply drop the blockade and sail away in a few weeks time without drawing blood from Argentina. As a result the British would be forced to undertake military operations very quickly no matter how risky they might turn out to be.

There was also another reason why the Royal Navy had no choice but to engage the Argentine forces in combat. That reason was that the Royal Navy had already suffered losses in secret combat that same month. Only when publicly admitted fighting erupts would the British dare to admit that they had already suffered great battle losses. And further, to obtain that cover-

story, the British had no choice but to sail into combat; but in so doing, they would be risking even heavier losses on top of those already sustained. In short, Her Majesty's navy sailed directly into a trap.

THE SPANISH ARMADA

The events which unfolded in the South Atlantic carried strange, ironic echoes of your past. For weeks you had been hearing countless commentators referring to the British task force as an "armada". The British of all people ought to have been very uneasy with that description. The original Spanish Armada some 400 years ago was renowned as a seemingly invincible fighting force, but it came to grief in a naval disaster so complete that it changed the course of history—and it was none other than the English navy that destroyed the Spanish Armada.

The original Spanish Armada put to sea in 1588 during the reign of England's Queen Elizabeth I. The Armada was an invasion fleet carrying thousands of crack fighting men to invade England. They were met by the daring sea dogs of Sir Francis Drake. Drake and his small fast ships turned the tables on the Spanish Armada by changing the rules of battle. The English fleet was equipped with new longer-range guns, and it stayed upwind and out of reach. From there the English pounded, smashed, and shattered the big ships of the mighty Armada. When it was all over, barely half the Spanish fleet was left to limp back to port. Drake's defeat of the Spanish Armada was a shock to the world. It opened the door for England under Queen Elizabeth I to start its expansion into a truly global empire.

Four hundred years later, history seemed to have come

full circle. Queen Elizabeth II witnessed the dismantling of the world empire whose heyday began under Queen Elizabeth I, and now the cultures of England and of Spain were once again in confrontation. Once again a so-called armada was preparing for invasion, but this time the armada was British, not Spanish. Four hundred years past Sir Francis Drake was the hero of the day; today, the ghost of Francis Drake would once again be on the scene.

Please note that the South Atlantic war zone was at the eastern end of the Drake Passage around the southern tip of South America. The defeat of the Spanish Armada four centuries ago broke the back of Spain's naval supremacy, and now it appeared that the defeat of the new British armada might very well break the back of what remained of the once glorious Royal Navy.

MILITARY SECRET OF SOUTH GEORGIA ISLAND

When the Falkland Islands crisis began in early April it looked at first like a mere tempest in a little teapot. For a century and a half since 1833, the Islands had been controlled by Great Britain. During that entire time, British sovereignty over the Falklands had been disputed by Argentina. There had been countless threats by Argentina to seize the Islands, which it called the Malvinas, but the threats had always come to nothing in the past and Britain had never even gotten very concerned over them.

The Islands are four times as distant from Argentina as Cuba is from the United States, and they are not much of a prize, it would seem, under any circumstances. After over 150 years of occupancy, the Falklands are home to fewer than 2,000 British settlers and

a great number of sheep and some lovely penguins. In short, the remote Falkland Islands would hardly look like something to fight over, and yet there you were watching another crisis take place. You watched as literal gun-battle war erupted between Great Britain and Argentina and further, without much more than fanfare on your news media presentations.

The Thatcher government was acting as if it had forgotten all about its usual preoccupation with the Soviet threat at NATO's doorstep. Instead, Britain was throwing almost everything it had at Argentina—aircraft carriers, cruisers, destroyers, submarines, assault ships - you name it and if they had it they used it. Luxury cruise ships were even commissioned and turned into troop carriers overnight. Wave after wave of additional assault troops were activated and sent to join the fleet even after it sailed. Ships and submarines were pulled off station from normal NATO duty and sent to reinforce the task force. The initial 40-ship force grew steadily over the ensuing weeks into an armada numbering over 70. Over two-thirds of the entire Royal Navy was already deployed to the South Atlantic off Argentina.

As this was watched in the unfolding, a lot of people were asking: What's this fight really all about? The most popular answer suggested in the major media was "oil". Vast deposits of oil were known to exist under the continental shelf between Argentina and the Falklands (or so it was projected) and that had been espoused for well over a decade. In no way could it explain the timing of the sudden military offensive by Argentina, and oil explained even less about the Argentine seizure of South Georgia Island.

South Georgia Island is some 800 miles east of the Falklands with no known oil deposits anywhere near it; and compared to South Georgia, the Falklands are quite an island paradise. South Georgia Island is covered with rugged mountains, treacherous valleys, glaciers, and semi-permanent snow. Most of it is uninhabitable. On top of all that, Argentina had absolutely

no legal or historical claim to South Georgia Island. In that respect it stood in sharp contrast to the Falklands.

In your early 1830s the Falklands were occupied for a while by Argentine colonists. In 1833 the British expelled them and took over the Islands. For that and other historical reasons, Argentina argued that the Falklands actually belonged to Argentina, not Britain.

But no such argument was possible for South Georgia Island. It was always controlled by Britain, never by Argentina or Spain. The Argentine seizure of South Georgia Island looked even more unreasonable from a military point of view. Argentina's leaders were military men and they thought in military terms and this should be a great clue to you readers. They were well aware ahead of time that far-off South Georgia Island could not possibly be held for long. By seizing it they were setting themselves up to absorb a military defeat, as the Island was retaken by Britain. So the question was: Why did Argentina's military junta bother with the seemingly worthless South Georgia Island at all?

The answers to all those questions were, of course, military, not political or economic. **South Georgia Island possesses an enormous military secret! It is a giant underground installation buried under the mountains at the northwest end of the Island. The real reason for the so-called Falkland crisis was this secret installation, together with two other similar installations which I will also describe in a moment.**

The secret military complexes had been in existence for many years; they were not new. What was new was an accelerated nuclear war timetable of the American Bolshevik war planners in Washington D.C. For the prior two months reports of details of that war plan were leaking out as quickly as they could be verified.

The plan called for NUCLEAR WAR ONE to erupt by September of the year 1982. It was that fast-approaching nuclear war threat

that caused the so-called Falklands crisis to erupt when it did.

What was actually taking place was a coordinated effort to spoil part of the Bolshevik grand strategy for the coming nuclear war. The mutual enemies of the American Bolsheviks in the U.S.—namely, the Rockefeller cartel—and Russia's new rulers in the Kremlin were behind the crisis. They were trying to ruin Phase #3 of the "PROJECT Z" war plan which has since been revealed. [*Described later in this narrative.*]

That phase was to be world domination by the American Bolsheviks after both Russia and the United States had been destroyed in NUCLEAR WAR ONE. The key to this plan was the existence of secret weapons stockpiles in various places around the world!

The American Bolshevik military planners in America were working with other Bolshevik agents in key military positions of other countries to set off war. Having done that, they intended to ride out the nuclear holocaust they had caused, safe and cozy in Government war bunkers! When the warring nations would finally lie smoldering and exhausted, the Bolsheviks would leave the shattered remains of their host countries. They would rendezvous at the secret weapons installations and bring their weapons into the open. They would confront the world with the only remaining fresh, up-to-date powerful military force on earth; and using that military power, they would become the undisputed rulers of the world. They planned to do all that, and they planned to pave the way for world domination by setting off NUCLEAR WAR ONE within mere months of that April—remember, September!

The Rockefeller cartel and Russia's new anti-Bolshevik rulers were working together in a race against time to try to head off the Bolshevik war plan.

The Bolsheviks in the U.S. were already benefitting from war preparations which were started by the Rockefellers long before. It had only been about three years since the Rockefellers were dislodged as

the prime movers of the United States Government by the Bolsheviks. Since that time the United States Government had been a house divided, torn by internal power struggles between rival Bolshevik and Rockefeller factions. But prior to that, the United States had been dominated for decades both economically and politically by the four Rockefeller brothers.

In 1961 the Brothers launched a new long-range plan for world domination. It was a two-pronged strategy, half visible and half secret, which has been described prior to this writing. It was a plan for the United States to arm to the teeth in secret while appearing to disarm gradually. Without repeating all the details, the basic idea was grandiose indeed, yet simple. By deliberately appearing weak, the Rockefeller-controlled United States would maneuver itself into a nuclear war with Russia. Then the secret weapons, including superweapons, would be unleashed to smash Russia and take over the world.

When they set the grand plan in motion in 1961, the Rockefeller Brothers were looking ahead to a nuclear war by the late 1970s. Their military analysts concluded very early that the war being planned would have very different effects on the Northern and Southern Hemispheres. Both superpowers, the United States and the Soviet Union, are located well up in the Northern Hemisphere; so are the other full-fledged nuclear powers—Great Britain, France, Red China, and India. By contrast, the strategic targets for nuclear war in the Southern Hemisphere are relatively few and far between. In other words, it was expected that the coming nuclear war would be essentially a Northern Hemisphere war.

In an all-out nuclear holocaust it is known that serious radioactive fallout would gradually spread to affect even areas not initially hit by war. But there are limits to how far the war clouds can spread. It was discovered long ago that there is very little mixing between the air of the Northern and South-

ern Hemispheres. In the northern half of your planet, cold air from the North Pole works its way southward toward the equator, then it works its way back to the north as warm air. A mirror image of this process takes up the southern half of the planet. Northern and Southern Hemisphere air meet in the equatorial zone, but very little of the air changes places.

The military conclusion is this: The coming nuclear war could ruin vast areas of the Northern Hemisphere for generations forward; but if the calculations are correct, the Southern Hemisphere could escape virtually unaffected by the war. This was surely music to the ears of the four Rockefeller Brothers. A quick look at the globe of the world shows why this would be a reasonable calculation. The Rockefeller cartel has dominated Latin America ever since World War II. As discussed in prior publications, Nelson Rockefeller solidified the cartel grip on Latin America during the war. He accomplished this as so-called "Coordinator of Hemispheric Defense" for then-President Franklin D. Roosevelt. So that takes care of the South American continent and its natural resources.

Then let us turn to the African continent. There, too, Rockefeller control was already in effect over wide areas of Black Africa, especially south of the equator. All this was thanks to the efforts of John D. Rockefeller III, as previously detailed elsewhere.

Looking around the globe, the most important remaining land masses from the standpoint of world domination are **AUSTRALIA AND NEW ZEALAND**. Thanks to World War II, both were wide open to the Rockefellers.

The Rockefeller Brothers decided to establish secret military installations in the Southern Hemisphere for use after the coming war. By this means they expected to become the masters of the surviving southern half of planet Earth; after the Northern Hemisphere gradually recovered from the nuclear holocaust, the Rockefeller empire would be able to pick up the

pieces. In this way the third generation Rockefeller Brothers expected their family dynasty to inherit the Earth.

In order to control the Southern Hemisphere militarily after the war, some means would have to be available to project military power onto any land mass. For example, revolts against Rockefeller domination would require troops—not a blast from the beam weapons on the Moon (another very interesting story).

The most critical factor for postwar military domination of the world was found to be a **NAVY!** A minimum of two secret naval fleets would be required—one based in the South Atlantic, the other in the South Pacific. Since the reserve naval fleets were to be kept secret until after the Northern Hemisphere nuclear war, they could not be built in existing shipyards. New construction facilities had to be built and they had to be hidden. To hide an entire shipyard is no small task; they take up a lot of space. On top of that, it was essential that the ships remain hidden after they were built. The best way to achieve that was to combine the shipyard and naval base into one over-all secret installation. Finally, the secret naval installation had to be invulnerable to nuclear attack; otherwise if its existence were ever discovered prematurely, the secret navy might be wiped out.

The combined requirements for secrecy, space, and protection against attack were formidable; but one day in 1959, while all these plans were still in the early stages of development, the answer presented itself. During a so-called banking trip to Sweden, David Rockefeller was given a tour of a unique hidden naval port. The port is hollowed out from solid granite cliffs which come right down to the water. The entrance to the port is a gigantic hole in the side of the cliff which can be sealed off with enormous steel doors. Inside this big doorway, on the water a huge cavity has been hollowed out to accommodate ships.

The Rockefeller Brothers and their military advisers decided that a bigger, more secret, bet-

ter protected version of the Swedish hidden port was just what they wanted. A survey of candidate sites was then initiated. The site survey covered coastal areas throughout the Southern Hemisphere. Many areas were rejected very quickly because the topography was wrong. Other areas were rejected because they were too close to the equator. Still others had to be ruled out because there were too many people living nearby, making the desired level of secrecy impossible. Finally, it was essential that the sites chosen for the secret naval installations be totally secure politically.

At last the sites for the secret naval installations were selected. In the South Pacific extreme southern New Zealand was selected. New Zealand would be extremely important during a coming war.

In order to obtain the necessary space, the secret New Zealand naval installation had to be divided up into two sites located close together. One is at the extreme southwest tip of South Island where the mountain range known as the Southern Alps comes down virtually to the water's edge. The other part of the installation is built into the northwest tip of Stewart Island, which is off the tip of South Island. The Stewart Island facility is hollowed out within a rise known as Mt. Anglem.

The New Zealand location met all the requirements. Ever since World War II the government of New Zealand has been tied even closer to the United States than to Great Britain. The location is far from the equator, and the installations are buried deep under mountains, protected from nuclear attack. They are also too deep to be reached by particle-beam attacks, and the New Zealand site is well situated to command the entire South Pacific.

In the South Atlantic an even more perfect site was found. That site, my friends, is **South Georgia Island**. It is located perfectly for naval domination of the entire South Atlantic. The tall rugged mountains provided a perfect location for the secret installation at the northwest tip

of the 100-mile long island. It is controlled by Great Britain whose government, like that of New Zealand, was willing to cooperate; and South Georgia Island was virtually uninhabited except for a whaling station on the northeast coast. The whaling station was some 50 miles away from the secret new installation which was being built, but Britain took no chances. In 1965 the whaling station was closed down. Since that time there have been no inhabitants on South Georgia Island except for a few dozen alleged Antarctic scientists.

Construction of the secret naval facilities—two in New Zealand, one on South Georgia Island—began in the early 1960s. The techniques were adapted from those used previously to build other large underground facilities, such as the NORAD installation inside Cheyenne Mountain, Colorado (there are others well protected underground but we shall not go into those presently). However, these installations and techniques were adapted in radically new ways to achieve construction access directly from the sea instead of overland. In this way, the sheltering mountain was left undisturbed in appearance both during and after construction.

The cuts in the mountain side which were necessary to let ships in and out were kept as small as possible and were well camouflaged. Like the Swedish hidden naval port arrangement, the entrances to the secret installations can be sealed. When sealed, the entrance is virtually impossible to detect unless you know exactly where it is; and unlike most large construction projects, there are no tailing or piles of leftover rock lying round to attract undue attention. The man-made caverns which house the secret naval installations are enormous, but all the rock and debris was disposed of at sea.

Once the secret naval facilities were built, they had to be outfitted for ship construction and dockside storage. **The fake disarmament of the United States during the 1960's contributed greatly to this task. From 1961 to 1968 one man**

played a pivotal role in this elaborate Rockefeller scheme. He was then-Secretary of Defense Robert McNamara. All through the 1960's McNamara presided over the public paring back of America's visible military power. This included the closing down and dismantling of entire shipyards. What you were not told was where all that shipyard equipment went afterwards. Where it went, my friends, was to the new secret installations which were being outfitted in New Zealand and South Georgia Island!

The secret naval installations have been used as duplication facilities to reproduce certain ships and submarines designed and built here in the United States. As Defense Secretary Caspar Weinberger told Congress, "It is cheaper to build two ships at a time." That is most especially true if the second ship is an exact duplicate of the first. This has become even more true in recent years through the use of computerized manufacturing techniques.

The secret naval fleets which have been built at the secret installations are made up of duplicates—EXACT DUPLICATES of certain other ships and submarines. They are all nuclear powered—nuclear "subs"; nuclear cruisers; nuclear destroyers; and yes, nuclear aircraft carriers, at least three of them. A secret twin was built for the U.S.S. Nimitz, for the U.S.S. Eisenhower, and for the U.S.S. Carl Vincent. All have been financed through the gigantic cost overruns, so called, that you constantly hear about in the Defense Department and can't find anything about due to above top secret designations; all three carriers have been provided with a full complement of aircraft whose manufacture was financed in the same manner.

The ships of the secret American Bolshevik naval fleets are all duplicates of other nuclear-powered vessels. Even so, **the secret naval ships possess one key difference.**

The so-called "Stealth Program" may not be too effective with the planes, etc., you

have been allowed to witness but, oh my, lots of interesting things go on with things you aren't given to witness.

There was developed a type of electromagnetic invisibility shielding. This technique makes an object invisible from a distance by distorting light waves in its vicinity.

A whole new fleet of Phantom warplanes went into crash production under a top secret shield. They utilize this principle; and all of the secret American Bolshevik navy ships have already been outfitted with similar Stealth-field equipment! The Stealth principle is actually easier to apply to ships than to airplanes because there is more room for the powerful equipment that generates the force field.

After NUCLEAR WAR ONE, the secret Stealth navy of the American Bolsheviks would be light years ahead of any other navy left on earth. It would be perfect for the intended role of world domination. The Rockefellers set it all in motion long ago—but about 1979 they lost control of the United States Military. Now it is the American Bolsheviks who are in control, and they are most surely bent straight ahead on war.

Now don't go about forgetting about the Nazi war machine also in the Antarctic— isn't this just about as much intrigue as you can take at one sitting?

SECRET NAVAL WAR OF THE SOUTHERN HEMISPHERE

As we move along and to make things clear, we shall discuss the referred to "PROJECT Z" I mentioned in the previous chapter. It is the new Bolshevik three-phase strategy for NUCLEAR WAR ONE. However, since it didn't come off on schedule I feel we will not be misleading if we stick with references to the area of the Antarctic. The most skeletons to arise from the dead to getcha are all parading around "under" and "within"

the Southern Hemisphere and that, after all, was the subject of this Journal. I do have trouble keeping to one subject for all facets are so intertwined.

The plan in 1982 was that of an elite group of American Bolshevik military planners by which the U.S. would strike the first nuclear blow, followed by all-out thermonuclear war with Russia.

After having set off the holocaust, the Bolsheviks in the U.S. and in certain other countries planned to ride it out safely in comfortable war bunkers already in place and well stocked with luxuries. Finally, after NUCLEAR WAR ONE fizzled out in stalemate, they planned to leave behind the ashes of the U.S. and her allies. Activating Phase #3 of their grand strategy, they planned to unveil their secret weapons, especially their secret naval fleets. With these they planned to conquer and rule what would be left of the world. The United States as you know it would be long dead and gone; but in the eyes of the Bolsheviks themselves, this outcome would constitute victory for many reasons.

Up to April of 1982 the nuclear war timetable was still on track. They were still shooting for nuclear war to begin by September of that year. Actually this continued right to the date set of September 17, 1982.

What saved you is that the Bolsheviks were running as fast as they could toward war; but, the Bolsheviks are not the only runners in the race. They have two deadly enemies, both of whom are equally determined to trip up the Bolsheviks. One enemy of the Bolsheviks in the U.S. is the Rockefeller cartel; the other enemy is the new anti-Bolsheviks ruling class in Russia: and now these two mutual enemies of the Bolsheviks are pooling their efforts in certain ways.

The new anti-Bolshevik coalition is now much more firmly established but in 1982 it was still quite new and was working between the Rockefeller cartel and the Russians. The January 26, 1982 meeting between Haig and Gromyko in Geneva, Switzerland, was a turning point in the formation of this coalition.

It is now a reality, and is responsible for the so-called "Falkland crisis" which dominated the headlines in April and May of that year. It should be emphasized that the new relationship between the Rockefeller cartel and Russia fell far short of a true alliance, at least at that time. They have very major disputes to be settled between them, but they called a truce between themselves to deal with the mutual deadly enemy—the Bolsheviks in America.

The first priority of the Russians and the Rockefellers is to slow down the Bolshevik preparations for imminent nuclear war. If they could do that, time would be on the side of the Rockefeller cartel in certain political movements. A slow-down in the nuclear war timetable will also give more breathing space for additional anti-Bolshevik actions to be implemented.

The joint Rockefeller-Russian planners decided by mid-February of 1982 that military action against the Bolsheviks was essential very quickly. No other type of action had any hope of taking effect fast enough to prevent nuclear war by the end of the summer.

The exact details of the "PROJECT Z" war plan were not known to either the Rockefellers or the Russians, but the general outlines were known to be pretty well outlined and set-up.

It was decided that military action should be devised that would undermine Phase #3 of the Bolshevik war plan—that is, the Bolshevik-controlled secret naval installations and fleets in the Southern Hemisphere should be attacked and crippled. By working together, the Rockefeller cartel and the Russians were able to devise an attack plan which neither could have carried out alone. The Rockefeller group, who built and originally controlled these bases, provided detailed intelligence about the best way to attack them. The Russians with their enormous military machine provided the muscle to actually carry out the attack.

It was essential to devise a scheme that would enable both secret fleets in the South Atlantic and South Pacific to be attacked. Survival intact of either fleet would leave the Bolshevik war plan still workable.

Military analysts concluded very quickly that a direct assault on the New Zealand facilities was out of the question. There was no combination of commandos, frogmen, or other military force which could possibly keep an attack secret from the outside world. Any attack on the New Zealand bases would set off the very war which the Rockefellers and Russians wanted to prevent.

But the situation in the South Atlantic was a different matter. In a way, the greatest asset of South Georgia Island was also its Achilles' heel. The extreme isolation which protected the secrecy of the South Georgia base also made a covert military assault feasible. The key lay with Argentina and her long-standing claims to the Falkland

Islands.

THE FALKLAND ISLAND WAR

The Rockefeller cartel had dominated all of Latin America for decades. Cartel operatives were sent to Argentina to work out a deal with the government military junta there. The historic dispute over the Falkland Islands was to be used to provide a ruse, a military cover, to enable the South Georgia base to be attacked. The Argentine generals were not told everything about the situation by any means, but they were told enough to make clear what they were to do.

As an inducement to cooperate, the Argentine leaders were promised handsome rewards. They were guaranteed that after the shooting was over, the Falkland Islands would remain in Argentine hands. This guarantee included the promise of covert military assistance as needed against the Royal Navy. And, to bolster the troubled Argentine economy, it was promised that the Rockefeller cartel would help develop the immense offshore oil reserves. With those combined promises of military glory and financial rewards, the Argentine military junta agreed to the plan.

So, backing up to March 19th, Argentina carried out Act One in the joint attack plan. A group of Argentine scrap-metal merchants, of all things, landed at the abandoned old whaling station on South Georgia Island. Supposedly they were there to dismantle the old buildings and carry them off to sell. While they were at it they also raised the Argentine flag over the work-site. The British, always nervous about South Georgia Island, promptly reacted exactly as expected. The British Antarctic survey ship "Endurance" put 22 Marines ashore to clear up that little misunderstanding.

They drove off the scrap merchants and promptly tore down the Argentine flag. The incident provided the exact desired excuse for the Argentine Junta to bring the simmering 150-year-old Falklands dispute to a boil. From time to time in the past,

Argentina claimed that South Georgia was part of the Falklands because it is administered that way by Britain. That argument was very flimsy but it then came in most handy indeed. It was nothing new to hear that claim from Argentine leaders, so there was no hint of what was really afoot.

During late March, Argentine military forces started assembling for an assault on the Falklands. The British command thought there was nothing new for Argentina had carried out threatening maneuvers in the past many times. It was believed that they were about to do it again; but on April 2 Argentine forces did the unexpected. After many past false alarms, this time they actually invaded and seized the Islands. All Argentine public statements emphasized the long-standing historical claims to the Falklands themselves; but just for good measure, the next day a small Argentine force also seized far-off South Georgia Island. The force was so small that it gave the appearance initially that it was just a side show from Argentina's point of view; however, the small contingent of 22 Royal Marines were overpowered and bundled off the Island along with a group of 13 alleged scientists. That was a moment of pay-off in the joint Rockefeller-Russian attack plan.

"SPUDDING IN"

Thanks to the elaborate distraction staged by the Argentine forces; a special commando team got onto the Island totally undetected. Based on the detailed Rockefeller information about the base, the team moved to the location on the mountain directly above the cavernous secret base. Special high-speed drilling equipment was set up by the Rockefeller members of the team while the Russian members concentrated on military defense. By late that same evening, April 3, the military high command in London finally learned what was really taking place. The secret South Georgia base was under attack by virtually the only means possible. The joint Rockefeller-Rus-

sian team were drilling a shaft down through the mountain toward their hollowed out cavern inside. It was only a matter of time until their drill would break through the ceiling of the giant hidden naval base. Once the hole was made, the next step was obvious. The Rockefeller-Russian team would put a weapon of some kind through the hole. The best guess was that it would be probably nerve gas—it just doesn't pay to "guess".

The shock waves that went through the highest levels of British government on the evening of April 3 can hardly be described. The Thatcher government, like the so-called Reagan Administration in America, is Bolshevik controlled. Well, the Russians told you they would rule the world and it might very well be done without firing a shot!

That was why Margaret Thatcher always said, "Me, too." any time the Reagan Administration said it would do anything to Russia. Please note that it hasn't changed very much. What of the Stinger missile "sting" in Florida and the "I agree and support the U.S." in Panama this past December? Both governments are party to the secret nuclear war plan in complete betrayal of the people of their respective countries, and on the evening of April 3 they suddenly discovered that their precious war plan was in deep, deep yogurt, I believe you call it—amongst other terms.

Immediately the Thatcher government started assembling a naval armada to sail for the South Atlantic. Haste was their order of the day. The drilling on South Georgia Island was proceeding around the clock. The best estimates were that the drilling would break through into the roof of the naval base in about three weeks, on or about April 24—but it is a very long drive from England to Antarctica on the best of ships. If help did not reach South Georgia by then, the secret installation might be doomed. The forces stationed at the installation itself were unable to defend themselves under the circumstances. Their mighty naval ships were ships in a bottle.

They did not dare open the bottle to sail out and fight because the Russian commandos were armed with far superior technical and nuclear weapons. (Who do you think might be the closest allies to the Nazi undercover workers?) We are talking about ones who do not care greatly for the Jewish element, much less the Zionist-affiliated Jews. To open the blast-proof entrance doors would be suicide.

On April 5, just two days after South Georgia Island was seized, some 40 naval ships began moving out of British ports. The same day Lord Carrington was sacked as Foreign Minister. He was forced to resign because he had assisted the Rockefeller attack plan by downplaying the Argentine attack preparations. Even the evil don't have any way to count on their own.

That same day, April 5, New Zealand, the home of the other secret naval fleet, broke diplomatic relations with Argentina. The two hidden New Zealand facilities had been placed on "Red Alert" (no pun intended). As a precautionary measure, all submarines at the twin base were ordered to sea. Several surface ships were already at sea undergoing "sea trials", but that still left seven major ships inside the hidden twin naval base including one of the nuclear aircraft carriers.

On that busy day of April 5, Argentina's Foreign Minister, Costa Mendez, was at the United Nations in New York. Come on readers, go look it all up in the records—don't just stand off and accuse me of insanity—go look and find for yourselves.

Mendez was alarmed by the deployment of such a large part of the Royal Navy. Costa Mendez hurried to Washington to seek reassurances from certain U.S. officials. Of course he got them!

For the next two weeks or so the news was filled with stories about the allegedly slow movement of the British fleet while negotiations went on. That was only a cover story. The Royal Navy was actually joining up and paddling as rapidly as possible toward South Georgia Island. If the task force arrived in time to save the secret base, a major battle was likely. The

official stories about "slow movement" of the British armada were intended to give a cushion of time for that battle. If need be, the fleet would have several days to retake South Georgia Island, then it could move on to arrive near the Falklands on the announced schedule. In that way the crucial importance of South Georgia Island would be hidden and the big secret preserved.

It was initially expected that advance elements of the British fleet would reach the vicinity of South Georgia Island within two weeks. That would have been soon enough to attack the joint Rockefeller-Russian commando team and stop the drilling before it was completed. But Russian Cosmospheres and submarines made a shambles of the plan.

A KEY SHIP DESTROYED

Key advance elements of the South Georgia attack contingency left Ascension Island early April 14, two days before it was announced officially. Shortly after they did so, they ran into trouble. Russian Cosmospheres and attack submarines closed in on a single ship which was critical to the planned counterassault on South Georgia Island. The Cosmospheres bombarded the bridge and combat information center of the ship with neutron radiation. In moments the ship was without any command, its communications and radar silenced. Then a Russian "sub" closed in and quickly finished off this key British ship with torpedoes. It broke apart with secondary explosions and sank rapidly. So far as was known, there were no survivors.

That unexpected shock in the mid-Atlantic produced two results, both very important: First, it caused a slowdown in the race toward the South Atlantic by the British armada. The task force had to be regrouped into a configuration better suited for an enroute defense, but that cost valuable time. Public announcements from London about the progress of the fleet reflected the slowdown. The timetable for arrival on battle stations near the

Falklands started stretching out longer and longer. All this bought extra time for the joint commando team on South Georgia Island. And so the drilling continued.

The other result of the sinking was equally important. Word was flashed to the South Pacific Stealth navy to prepare for possible action. It was obvious that the Russian Navy was getting involved in the Atlantic, which meant that the Royal Navy could be in big trouble. During the dead of night, early April 15, the seven Stealth ships put to sea from their twin secret bases in southern New Zealand. They deployed to a secret operational headquarters area in the Antipodes Islands, 450 miles southeast of New Zealand. Their electromagnetic shields were operating to provide protection from attack. These shields make it impossible to communicate with the outside world or even to see it. But once they arrived at the Antipodes, the Stealth ships hooked up to buoys equipped with shielded communication cables to the Island headquarters. The Island headquarters, in turn, was in constant touch with the South Georgia base by way of a transoceanic cable around the tip of South America. The deployment of the available ships of the South Pacific Stealth fleet was exactly what the joint Rockefeller-Russian planners had hoped for. The ships had been flushed out from their essentially invulnerable hiding place in New Zealand!

The British ship's sinking of April 14 was also followed by other events. On April 15 the Argentine Navy started moving out of port. The same day, Alexander Haig arrived again in Buenos Aires. Supposedly he was there as a diplomat, but in reality he was there as a General, dealing with Generals. Haig was the top Governmental operative of the Rockefeller cartel. He was making sure that the Argentines did not get cold feet and back down at that critical moment. Four days later, April 19, Haig left for Washington. As he boarded his plane, Haig somberly told reporters, "Time is running out." And so it was, my friends, for the secret

South Georgia base. We shall also have a lot more to say about General Haig in future writings.

NOT EXACTLY A DRY HOLE

The very next day, April 20, the drill broke through into the hollowed-out cavern of the naval base. Bolshevik military analysts in London had not expected that it could be completed until at least the following weekend. The British fleet was still out of range.

THE WEAPON WHICH THE COMMANDO TEAM INSERTED DOWN THROUGH THE LONG HOLE WAS A SMALL, COMPACT RUSSIAN NEUTRON BOMB. When it was detonated inside the confines of the huge artificial cave, the effects were, of course, totally devastating. The intense radiation instantly killed everyone inside the base. Also the heat and blast effects of the bomb are believed to have damaged all of the ships inside sufficiently to badly disable them.

Meanwhile, Russian Cosmospheres and submarines were converging on the Stealth ships which were near the Antipodes Islands awaiting orders. From a distance, the ships were invisible to the eye due to their protective shields, which also protect against beam-weapon attack; but they were sitting ducks for the tactics which the Russians employed.

THE COUP-DE-GRACE

Floating overhead, the Cosmospheres located the seven ships using their Psychoenergetic Range-Finding equipment known as PRF. There is no method known by which PRF can be jammed. The Cosmospheres radioed the exact locations of the ships to the attack submarines. The "subs" were armed with special non-homing, non-nuclear torpedoes designed to explode on impact. More sophisticated torpedoes would have been thrown off course or detonated prematurely by the protective shield of each ship; but these simple torpedoes just cruise right through each invisibility field to strike the ship and explode. Within 15 minutes after the attack be-

gan, all seven Bolshevik Stealth ships were on their way to the bottom, and with them went their Bolshevik Commanders and mercenary crews collected from around the world.

The South Pacific action took place just after sunset local time. The time in Washington was around 2:00 P.M. April 23. That evening Secretary of State Haig was seen briefly in public with the new British Foreign Minister, Francis Pym. Pym was wearing the typical artificial pseudo-smile which diplomats are taught always to display in public. But not Haig. Haig was grinning from ear to ear, and no wonder. The joint Rockefeller-Russian military operation had been a brilliant success. The secret Bolshevik South Atlantic fleet had been virtually wiped out, bottled up inside South Georgia Island; and the South Pacific fleet, while not totally wiped out, had been badly crippled. By working together, the Rockefeller cartel and the Russians had won the secret naval war of the Southern Hemisphere.

CAMPAIGN AGAINST NUCLEAR WAR BY THE ROCKEFELLER CARTEL

At the point of June, 1982 it would appear that war of a major size was about to break out in the Southern Hemisphere, but the real war in the Southern Hemisphere was already over. What you witnessed was the beginning of its bloody aftermath. That aftermath was the battle for the Falkland Islands. They had been promised to Argentina as a reward for her role in the secret war.

As things were happening in the Antarctic area the Bolsheviks were in Washington D.C. pressing for a public announcement that the U.S. would side with Britain. As soon as that would take place, military action would heat up quickly

around the Falkland Islands. Britain had no choice but to fight. She had already suffered casualties which could not be explained without a public battle; but by fighting, the Bolsheviks in Britain were running the risk of a humiliating and tragic defeat for the Royal Navy.

Meanwhile "back at the ranch", the Rockefeller strategists in the U.S. were concentrating on a fast-building, anti-nuclear-war campaign. There were even referenda popping up on election ballots dealing with the nuclear war issue. He has published information which has jeopardized his life on many occasions which indicates that ALL OF YOU NEED THE INFORMATION. We are going to take up again the San Luis Obispo Connection in the order of the documents sent to me. This is going to be dealing with the

LAST FLIGHT OF KAL
007

We have written on this subject several times but I believe this deals more directly with persons involved and is worthy of repeating information at any rate. Thank you, R.R., for your sharing. We will reprint exactly as given to us.

QUOTING:

Incredible as it may seem after nearly nine years, the sabotage and destruction of Korean Air Lines Flight 007 has gone completely undetected and unresolved by the people of the world. This act of terrorism was so

simple and foolproof that it could have, and indeed probably has, been repeated many times. The following explanation is, in all probability, precisely the way it was accomplished.

007 left New York City on August 31, 1983 on the first leg of its journey to Seoul, South Korea. Its midpoint stop was Anchorage, Alaska. There it stopped to refuel and possibly disembark passengers and cargo. While at Anchorage airport, 007 removed several tons of cargo destined for Seoul, Korea and added four extra tons of fuel. Remember this extra fuel as it is an important factor in the plan. If 007 had taken the shortcut across Kamchatka and Sakhalin Island, as has been alleged, it would have used six tons less fuel.

In the early morning hours of September 1, 1983, 007 left Anchorage **fourteen minutes behind schedule**. Remember this fourteen minutes, as it also is an important factor.

Meanwhile, Korean Airlines Flight #15 (015) arrived at Anchorage, approximately one-half hour after 007. KAL 015 left Anchorage, approximately one-half hour after 007. **KAL 015 left Anchorage about six minutes early**. This also is an important factor.

When 007 left Anchorage, it was noticed that it was ten degrees off course. If 007 would have continued on this course, without correction, it would have taken 007 across the Kamchatka Peninsula and Sakhalin Island. This was a diversion and was to establish radar tape records to prove that 007 flew over Russian territory. It was NOT advantageous nor desirable to send 007 on an intelligence mission across Russian territory. 007 had neither the electronic capabilities for performing an intelligence mission nor the capability of avoiding detection and apprehension. 007 was substituted by a U.S. intelligence-gathering aircraft, an RC-135, in the following

manner.

The RC-135 is the U.S. Air Force version of the Boeing 707 and is very similar to KAL 007, which is a Boeing 747. The RC-135 has a payload of 45 tons of the most advanced, incredible electronic equipment ever devised. It is capable of any kind of communication transmission and reception, radio and radar jamming, stealth capability, radar false imaging, and computer functions that would make the movie "Star Wars" appear to be a stone age production. It also carries devices which can distract and divert incoming missiles and laser devices which can prematurely explode incoming missiles. Although it is fiction, the book "Flight of the Old Dog" accurately describes these systems and the author, an Air Force intelligence officer, attests to their reality.

RADAR "BLIP" AS
COVER

It has been established that somewhere between the coast of Alaska and the Kamchatka Peninsula, 007's flightpath was intersected by an RC-135. This is not entirely correct. 007's flightpath was intersected by TWO RC-135s. The two RC-135s left their base at Shemya, in the Aleutians, flying in very close proximity or, in Air Force language they were "stacked". In this condition they would appear as one "blip" on a radar screen and therefore assumed to be only one aircraft!

When the RC-135s intersected the flightpath of 007 all three aircraft appeared as one "blip" on the radar screens of the international radar network. At this point, the pilot of 007, Captain Chun, made an announcement on the intercom, something like this: "**Ladies and gentlemen, this is your captain speaking. One of our instruments is indicating a discrepancy in our cabin pressurization system. Although we want to assure**

you there is absolutely no danger, as a precautionary measure, we will descend to a low altitude where cabin pressurization is unnecessary, while we check out the problem. Please fasten your seat belts. The seat belt light is on. Thank you."

Under the camouflage of one radar "blip", 007 descended from approximately 30,000 feet to approximately 1000 feet. At that altitude it was below the radar network. Then 007 made a course correction and turned back toward Route 20, which was its original intended commercial air route between Anchorage, Alaska and Seoul, Korea. This route does not fly over Russian territory. While flying at these very low altitudes, 007 used up tremendous amounts of fuel. This was the reason for the extra four tons of fuel in the first place.

Meanwhile, the two RC-135s, flying "stacked", as one radar "blip" continued along 007's original misguided direction toward Kamchatka. After about ten minutes, when 007 had descended to the low altitude and was off the radar, one of the RC-135s turned off and continued on its mission and returned to its base at Shemya. This left the other RC-135 continuing along 007's misguided path over Russian territory. For all intents and purposes the RC-135 was now 007.

The real 007, flying under the radar, reached route 20 and intersected the path of KAL 015. The departure times of the two airplanes allowed 015 to catch up to 007. Remember, 007 left fourteen minutes late and 015 left six minutes early. Under the radar shadow of 015, 007 ascended to their flight plan (Route 20) to Seoul, Korea. For all intents and purposes that "blip" was only KAL 015. For all intents and purposes the "blip" over Russian territory was 007.

In the event (and of course in the mind of Captain Chun) that the RC-135

was not detected or apprehended, this is what would have happened. The RC-135 would continue on its mission across Kamchatka and Sakhalin and on across the Sea of Japan. There it would intersect Route 20 and merge with 015 and 007. The three airplanes would again appear as one radar "blip". Then there would be a repeat performance of what happened earlier. The RC-135 would descend to a very low altitude to where it was off the radar, turn and return to the base at Atsugi, Japan. The two KAL airplanes would then separate into two radar "blips" and proceed on to Seoul, Korea as if nothing unusual had happened.

Instead this is what actually happened. At a precise, predetermined point, the RC-135, posing as 007, now over Sakhalin Island, still over Russian territory, but close enough to the Sea of Japan to fake a crash in international waters did this: It turned off all its short-range radar jamming equipment, radar false imaging and turned on its strobe lights. In essence it was saying, "Here I am! Right over here! Come get me!"

FAKING "CRASH" LOCATION

The Russian fighter plane in the vicinity intercepted the RC-135, identified it, and backed off several miles and fired its heat-seeking missiles. To avoid sucking debris from the anticipated explosion into its jet engines, the Russian fighter turned off and prematurely announced, "The target is destroyed". With its advanced technical capability, the RC-135 neutralized the incoming missiles with its laser devices, dropped a simulated explosive charge, and rapidly descended toward the Sea of Japan to fake a crash. It dropped some debris and some human body parts and, under the radar, flew on to the base at Atsugi.

Simultaneously, flying in the radar shadow of KAL

015, KAL 007 was destroyed by a bomb in its cargo hold, detonated by a radio signal. 007 was over the Kurile Trench and descended five miles down into the Pacific Ocean where it will never be found. There it lies today. **[H: This portion of the story is not quite correct as you will note if you have been reading the JOURNALS. Flight 007 was not destroyed until AFTER it had been accompanied to a landing site and crew and passengers removed—they reside in several various places of incarceration in Russia to this day! Before you say this is impossible, I would harken you to attend the MIA-POW scenarios going on right now regarding Russian-held U.S. people. There were some IMPORTANT persons on that plane both that were intended to be killed because of their knowledge and some because it was desirable to have them on the aforementioned bases off-planet. There are multitudes of "missing" scientists and Elite—some poorly covered by replicas—some just missing following announced death, etc. Casey is a good example in point. NO—I am NOT joshing you!] [See JOURNAL #44, Vol. II in the TANGLED WEBS series for more on KAL 007.]**

The following paragraphs are included to provide details to fill in some "holes" and to correct some discrepancies and tie together any loose ends. Several discrepancies exist. First of all, in order to sucker the Russian fighter into shooting at it, the RC-135 turned on its "strobe" lights. Outside of the Continental United States, Korean Air Lines did not use "strobe" lights. It used "blinking" lights. Another discrepancy was the variation in time between the missile firing and the explosion on 007. Yet another discrepancy was the last radio transmission indicated that 007 was not experiencing any abnormal condition.

Several hours after the crash it was announced that 007 was forced to land on Sakhalin Island and the passengers and crew were all safe and sound. The purpose of this was to call off and discontinue any air-sea search and rescue mission. This was to allow any debris to sink into the ocean and disguise any evidence of what might really have happened. All the accounts which place 007 over Russian territory are wrong as presented. It was never desirable nor advantageous nor necessary to have 007 overfly Russian territory.

The magazine article "The Last Flight of 007" by Fletcher Prouty and the book "Explo 007" by R.B. Cutler are the most accurate. Both of these accounts have some holes and discrepancies in them. The purpose of this report is to fill in the holes and correct the discrepancies in these otherwise well researched reports.

The political ramifications and reasons for this disaster were necessities, either real or imagined, of the Reagan Administration and high-ranking U.S. Government officials.

One William P. Clark (Justice) was the connection and the central figure in this event and was (is) powerful second only to Henry Kissinger.

Don't get all hung-up on what are seemingly variations and discrepancies in details of this story. Remember that in the operations of such blatant intelligence operations—it is hard to find the pieces and get the players all together to present the "whole". PROJECT PAPERCLIP: THE NAZI INFLUX

QUOTING:

There is a definite connection between the "New World Order" of Adolph Hitler and the "New World Order" of George Bush. It is right there in San Luis Obispo County, California.

Project Paperclip is the operation where the U.S. Government brought hundreds of Nazi scientists, doctors, intelligence agents, and military personnel to America after World War II. They were integrated into aerospace and munitions industries, medical science, military and intelligence agencies. Following are excerpts from PROJECT PAPERCLIP by Clarence Lasby, THE TORBITT DOCUMENT by William Torbitt, THE NAZI CONNECTION TO THE JOHN F. KENNEDY ASSASSINATION by Mae Brussel. They may be somewhat out of context, so the reader is cau-

tioned to study the original texts. **[H: I also urge you to get SKELTONS IN THE CLOSET, a PHOENIX JOURNAL.]**

When it was obvious to Hitler they would be losing the war against the USSR, all top Nazis made detailed plans for two years on how to proceed next.

Speer met with Dornberger, at Peenemunde, the missile and rocket factory run with Werner von Braun, and instructed him in "the dispersion of functions throughout the Reich". Translated, that meant "get ready to come to the U.S."

...The British did win a token victory: over the protestations of von Braun, they convinced their ally to relinquish any claim on General Dornberger; they considered him a "menace of the first order" who deserved to be "left on the dust-heap." As one Englishman explained to his American friend, the military commander of Peenemunde "will ever have in mind the desirability of returning to a resurrected Reich carrying with him the knowledge accumulated by the German rocketeers while working under Allied patronage." The Americans were not anxious to import the enemy general. After listening to monitored conversations between Dornberger and fellow inmates of detention centers, they concluded he had an "untrustworthy attitude in seeking to turn ally against ally" and that he would be "a source of irritation and future unrest" among the Germans if he were sent to America. One American general quipped that "We may trade him to the Russians for a dish of caviar." But His Majesty's government had plans of their own; they imprisoned him for two years hoping to find some legal basis to place him in the dock at Nuremberg. Only upon his release in 1947 was Dornberger free to accept a contract under Project Paperclip—which led eventually to the directorship of Research and Development at the Bell Aircraft Company.

...In the transfer of the Nazi rocket scientists, the services of Adolf Hitler's intelligence agency was used extensively and

Shaw, von Braun, Dornberger and the others began a very close association with the Nazi agency and its commander.

The *Brunesnachrichtendienst*, better known as the Federal Intelligence Agency or FIA, is largely dependent on the CIA, which subsidizes and controls it. The director in 1963 was Reinhard Gehlen, a former ex-Nazi colonel "repatriated" in August, 1945 by Allen Dulles, who at the time headed the OSS in Switzerland and was in charge of American intelligence activities in occupied Germany. See the book REINHARD GEHLEN, MASTER SPY.

From 1932 until 1945 Werner von Braun was Adolf Hitler's most dedicated Nazi rocket scientist. As a matter of fact, given a few more months time, von Braun's "Buzz Bomb" and V-2 rocket in 1945 could have turned the tide and forced the allies to seek something less than total victory over the Third Reich. An enthusiastic Nazi, Von Braun's V-2 rocket had killed thousands and thousands of British Isle residents and the sound of the approach of the V-2 was terrorizing the entire English countryside.

In 1945, as the Russians were approaching Von Braun's rocket headquarters, he and 115 other of his Nazi rocket scientists escaped with valuable papers and traveled west in Germany until they could turn themselves in to the Allied armies in the west. Later the same year, Von Braun and the 115 other German scientists were removed to Fort Bliss, Texas, where they remained until 1950. In 1950, Von Braun and the others were moved on to the old Redstone Arsenal in Huntsville, Alabama, where they remain to this date.

Von Braun, immediately upon arriving in the United States, made close personal friendships with J. Edgar Hoover and Lyndon B. Johnson, and the relationship remained close with Von Braun working with Hoover in security in the Tennessee Valley Authority and the Redstone Arsenal and later, beginning in 1958, they worked together in the security of the National Space Agency. 1958 was the year that Lyndon John-

son, as majority leader of the Senate, helped to push through the National Space act.

In March 1944 the Gestapo learned that von Braun had expressed in public a defeatist attitude about Germany's chances in the war, and a desire to design a spaceship rather than a weapon. Voracious in their demand for control of the V-2 program, the S.S. leaders used this information, together with a trumped-up charge that von Braun had Communist leanings, to imprison him for two weeks in a Gestapo cell in Stettin.

Von Braun was a highly visible "hero" so he was sent to NASA at Huntsville, Alabama where he worked on rockets. Dornberger was a convicted, sentenced war criminal and required a lower profile, so he was sent to Bell Aircraft where he worked on the spaceship program. One of these, a nuclear powered TAV (trans-atmospheric vehicle) operates at Area 51 in the Mojave Desert in Nevada. **[H: Among several other places.]**

As America stood on the threshold of World War II Hoover continued a friendly relationship with the Nazis who dominated Interpol, the Berlin-based international secret police. He had been obsessed with the "Red Menace" since 1919 when he became head of the Bureau's General Intelligence Division. Heinrich Himmler, Reinhard Heydrich, Arthur Nebe and other fanatical Nazis were active in Interpol. Even after Hitler occupied Czechoslovakia, Hoover ignored all evidence of Nazi death squads and atrocities and cooperated with the boys in Berlin. As France fell, Hoover exchanged lists of wanted criminals, enclosing autographed photographs of himself. It was not until three days before Pearl Harbor that he called a halt—and then only because he feared his image might be tarnished.

When the war had been imminent Roosevelt charged Hoover with ferreting out Nazi spies in the Western Hemisphere. Two escaped his notice. As early as 1933 Gestapo agent Dr. Hermann Friedrich Erban recruited Errol Flynn as an intelligence source. Erban went

on to become a naturalized American citizen, but never abandoned his loyalty to Hitler. Flynn went on to make "Santa Fe Trail" in 1940, co-starring with Ronald Reagan, and the two paired up for "Desperate Journey" in 1942. **[H: Just to sort time and space a bit—you will recall that Errol Flynn continued his escapades right into the Cuban war playing with Castro.]**

During this pre-WW II period, Reagan also worked for the FBI as an intelligence agent. As J. Edgar Hoover had already demonstrated Nazi sympathies and later inserted 642 Nazis into aerospace military, and government positions, the question is WHOSE government was Reagan working for? Reagan's enthusiastic use of the "King Alred Plan", CSTI, FEMA and REX 84, leaves little doubt. Hoover's FBI-Division 5 and the CIA carried out the assassination of John F. Kennedy. George Bush was a CIA "asset" at that time. He became Director of Central Intelligence.

REINHARD GEHLEN

Richard Nixon's political career brought him inside Nixon's 1960 campaign for the presidency. In 1969 he showed up in California with a high-tech firm called TCI that held classified Defense Department contracts. His translator for German projects was Helene van Damme, Governor Ronald Reagan's appointments secretary. Von Damme is currently U.S. Ambassador to Austria, next door to the Nazis homeland.

In 1968 Reinhard Gehlen withdrew to his chalet in Bavaria. The chalet had been a gift from Allen Dulles. **[H: Interesting???)**

Richard Nixon "couldn't remember" he was in Dallas, Texas on November 22, 1963. **[H: How many of you "old timers" can forget where you were on the day Kennedy was killed in Dallas? Especially if you had been IN DALLAS? Well, so was Bush and now you have the situation coming unfolded as to WHY the Watergate break-in—there were pictures and documents**

in the Democratic offices to be used as "gunfodder" which proved the presence of BOTH on that fateful day.]

But Nixon had also accumulated strong connections with members of the crime syndicate, the Vatican hierarchy, defense industries and known Nazis. He knew them all.

What if he lost after those seventeen years of preparation? Would there be a back-up team for the future? Could the Pentagon or Reinhard Gehlen visualize leaving the entire United States presidency to chance elections?

Remember what happened to Senator Robert Kennedy on the eve of his primary victory in June, 1968? They can't get that close to losing it again, you know. With both Kennedys gone, Nixon finally made it.

The Nazi rocket scientists are on management levels also in the munitions and aerospace industry. Walter Dornberger, the Nazi general, left the space agency in the 1950's to become a high official in Bell Aerospace Corporation and he was followed by over 30 of the Nazi scientists to control level in the corporations manufacturing munition and aerospace material. This still left well over 60 of the scientists at command level in NASA.

This is the nomenclature of the assassination team. That is the way John F. Kennedy met his death in Dallas.

At the top was Johnson, Hoover, Bloomfield, Nagy, De Menil, Prio, Jenkins, Hunt, Baker, Jones, McWillie, Von Braun, Cohn, Korth, Connally and Murchison.

L.M. Bloomfield was in overall charge responsible only to Hoover and Johnson.

The second layer of participants with supervisory and working assignments under Bloomfield and the first group were Walter Dornberger, ex-Nazi general, Guy Bannister, Albert Osborne of ACCC, E.E. Bradley of ACCC, Morris Dalitz of Las Vegas, Major General John B. Medaris, Robert McKeown, Igor Voshinin, George Boune, Peter Gregory, Maurice Gatlin, Sergio Arecha Smith, Lee Harvey Oswald, William Seymour,

David Ferrie, T. Gonzales, Manuel Garcia Gonzales, Layton Martens, Gordon Novel, Walter Sheridan, William Dalzell, Paul Raigorodsky, Joe Bonanno, Dimitri Royster of ACCC, Alex Carlson, George Mandel, Brock Wall, Clay Shaw, Joe Cody, Jake Kesloff, Mike McLaney, Ruth and Mike Paine, and Igor Vagonov.

Another of the Nazi space scientists who worked with the cabal was Walter Dornberger. He had been the commanding officer of Werner Von Braun while both were working for Adolf Hitler's rocket program. During the time period involved, Walter Dornberger was a directing officer in the Bell Aerospace Corporation along with Fred Korth. The former Nazi rocket officer was directly in charge of the assignment of Michael Paine to Bell Helicopter Corporation, a subsidiary in Fort Worth, Texas. Paine's assignment was to provide a place for Marina Oswald during the approximate eight months prior to November 22, 1963. He provided for Marina to live with his wife, Ruth.

The Warren Commission required planted evidence sometimes in order to divert from Lee Oswald's links to the Defense Department, assisted by Ruth and Michael Paine.

Michael Paine's occupation at Bell Aircraft is with the Defense Department. This job requires security clearances, so what would the unlikely Oswalds be doing in his home? Oswald, the "defector"?

Paine's boss at Bell Aircraft as Director of Research and Development, was none other than the notorious war criminal General Walter Dornberger.

Dornberger was supposed to be hung at Nuremburg for his war crimes, slave labor and mass murders.

The British warned the U.S. not to let him live because even after the war he was conspiring for another one. As stated, "Dornberger is a menace of the first order who is untrustworthy. His attitude will turn ally against ally and he would become a source of irritation and future unrest." *Project Paperclip*. Clarence Lasby.

The very first call to authorities after the gun went off on November 22, 1963, was from an employee at Bell Helicopter who suggested "Oswald did it". Police never located the source of both Oswald addresses that day.

In 1988 Bush, the Republican presidential nominee, chose as his running-mate Indiana Senator Dan Quayle. When a memo from the FBI head J. Edgar Hoover, was found, stating that "Mr. George Bush of the CIA" had been briefed on November 23rd, 1963 about the reaction of anti-Castro Cuban exiles in Miami to the assassination of President Kennedy, Bush's aides denied he was this George Bush. We wrote about this connection in, I believe, TANGLED WEBS, VOL II. But allegations continue that Bush is concealing long standing ties to the CIA and to Cuban exiles such as Rodriguez.

Reports are that earth movements are being felt and registered in almost as constant a measure in New York and the full length of the Mississippi River. Remember the preparations of NASA and FEMA for plans for handling tidal waves and rerouting of the Mississippi?

The next article comes from a San Antonio, Texas newspaper via the *New York Times*, *Los Angeles*:

Two weeks ago, one of the largest earthquakes in California history slammed through the Mojave Desert, leaving one person dead, hundreds injured and scores of scientists astonished and shaken.

Astonished because this earthquake did weird things, like setting off earthquakes more than 500 miles to the north, ripping across four existing faults to make a single larger fault, and helping give rise to a new tectonic system that is shearing California away from the rest of North America and nudging it toward Alaska.

And shaken because the nation's most dangerous fault, the San Andreas, just got more dangerous.

Having examined their preliminary data, scientists now say the twin earthquakes that struck on June 28—7.4 (upgraded to 7.5) on the Richter scale of ground motion near Landers and a magnitude 5.6 (upgraded to over 6) near Big Bear—significantly increased the likelihood that the south part of the San Andreas will soon generate a magnitude 8 or greater (10 to 12) earthquake, popularly called the "Big One".

Precisely how soon, they cannot say. **[Strange thing is that I am now being denounced and assaulted because YOUR SCIENTISTS HAVE PLACED A PHOTON BELT ENTRY TO OCCUR RIGHT ON JULY 25TH, 1992—WHICH HAS SOMEHOW BECOME "HATONN'S PHOTON BELT". PINPOINT A PHOTON BELT ON JULY 25 AND CAN'T PREDICT THE "BIG ONE" WITHIN YEARS WHEN BOTH ARE MAN-CAUSED?] Four years ago the U.S. Geological Survey estimated the probability of a huge quake's striking the southern end of the San Andreas Fault at 60 percent in 30 years (they have said this for about 40-50 years). But in interviews last week, most scientists said they expect it to happen much sooner.

"Most of us have an awful feeling that 30 years is wishful thinking," said Dr. Allan Lindh, director of USGS Seismology Branch in Menlo Park, Calif. "Everyone agrees that Los Angeles and San Bernardino should treat this like a final warning. It's like when you clean up camp. It's time to make that last pass through our cities, homes and lives and act as if the damn thing will happen tomorrow."

Dr. Lucille Jones, a leading expert on the southern San Andreas at the USGS office in Pasadena, Calif., said: "This is a wake-up call. I think we're closer than any 30 years. It could be two years or five years or longer. But that doesn't mean people should panic this week. I ask them: 'What are you willing to do for the next two years? We have a higher hazard.'"

Scientists usually take each other's claims with reserve until they have been reviewed by independent experts and published in a scientific journal. The California seismologists have only just begun to analyze the data from the June 28 earthquakes and have not had time to write any papers. But they at least are taking their results seriously.

Scientists at the agency, Jones said, have bolted down bookcases, put Velcro on computer equipment and double-checked water supplies, batteries and backup power systems.

The southern end of the San Andreas Fault has not ruptured for over 300 years, Jones said. When it does, the shaking will be many times stronger than the Landers earthquake and could last up to three and a half minutes. The Landers quake lasted 32 seconds.

Such a catastrophic earthquake could devastate cities like San Bernardino, Riverside and Palm Springs, which are within 20 miles of the San Andreas Fault, said Dr. Thomas Henyey, director of the Southern California Earthquake Center at the University of Southern California.

But Los Angeles and San Diego, which lie farther west, could also sustain serious damage if the shaking lasted three minutes. Some older structures on soft soils, built before strict building codes were adopted, won't be able to handle that much shaking, Henyey said.

So geologists and seismologists are feeling a sense of urgency as they crawl over the newly ruptured faults to find out what happened and what is likely to happen next.

In the meantime, they are trying to solve mysteries about the recent quakes.

Defining Our Criminal Government

DE FACTO vs. DE JURE

You ones in the world, in every instance around your globe, have "de facto Governments"—not de jure.

GOVERNMENT: DE JURE: The system of polity in a state; that form of fundamental rules and principles by which a nation or state is governed, or by which individual members of a body politic are to regulate their social actions. A constitution, either written or unwritten, by which the rights and duties of citizens and public officers are prescribed and defined.

GOVERNMENT DE FACTO: A government of "face". A government actually exercising power and control, as opposed to the true and lawful government. A government not established according to the constitution of the nation, or not lawfully entitled to recognition or supremacy, but which has nevertheless supplanted or displaced the government de jure. A government deemed unlawful, or deemed wrongful or unjust, which, nevertheless, received habitual obedience from the bulk of the community.

USURPATION: The unlawful encroachment or assumption of the use of property, power or authority which belongs to another. An interruption or the disturbing of a man in his right and possession. The unlawful seizure or assumption of government to supreme power by force or illegally, in derogation of the constitution and of the rights of the lawful ruler.

The many books and articles in patriot libraries give mute testimony to the definitions of words just given. These definitions as used, came from BLACK'S LAW DICTIONARY.

MORE SINISTER EVIL

The usurpation is not isolated to any one department or agency only but has saturated

the totality of government. But there is a more sinister evil than mere usurpation and the two following words bring that element into clear focus. (Thank you, *The Connector*, July, 1992.):

SWINDLING: Cheating and defrauding with deliberate artifice. Usually applied to a transaction where the guilty party procures the delivery to him, under a pretended contract, of the personal property of another, with the felonious design of appropriating it to his own use. The acquisition of any personal or movable property, money, or instrument of writing conveying or securing a valuable right, by means of some false or deceitful pretense or device, or fraudulent representation, with intent to appropriate the same to the use of the party so acquiring, or of destroying or impairing the rights of the party justly entitled to the same.

FRAUDULENT CONCEALMENT: The hiding or suppression of a material fact or circumstance which the party is legally or morally bound to disclose. The employment of artifice planned to prevent inquiry or escape investigation and to mislead or hinder the acquisition of information disclosing a right of action; acts relied on must be of an affirmative character and fraudulent... The test of whether failure to disclose material facts constitutes "fraud" is the existence of a duty, legal or equitable, arising from the relation of the parties; failure to disclose a material fact with intent to mislead or defraud under such circumstances being equivalent to an actual "fraudulent concealment." Fraudulent concealment justifying a rescission of a contract is the intentional concealment of some fact known to the party charged, which is material for the party injured to know to prevent being defrauded; the concealment of a fact which one is bound to disclose being the equivalent of an indirect representation that

such fact does not exist.

Without going into great detail, the words just shown and defined give one some legal perspective by which to judge those that use such devious tactics to achieve their goals. The acting government of the U.S., certainly, fits those definitions down to the last jot and tittle, almost as though these job descriptions were written just for them.

EXPRESS-NEWS, Saturday, July 18, 1992:

FDIC BOSS PREDICTS MORE BANK FAILURES. Taylor denies 'December Surprise' theory.

AP: OKOBOJI, Iowa—Strong profits for the banking industry this year have only delayed another round of large failures, the chairman of the Federal Deposit Insurance Corp. said Friday.

But William Taylor again denied [**H: Anytime they DENY, pay attention!**] there is a conspiracy to put off the bank closings beyond November's election. Taylor also said Congress may have to increase the \$30 billion it already has provided for bank failures.

"Low interest rates may make things look better, but they will not sustain unsound institutions. There are a number of banks that won't survive," he said.

Taylor spoke at the annual meeting of the Iowa Independent Bankers, an organization of community banks with assets ranging from \$10 million to nearly \$600 million.

Last year, as Congress was acting to shore up the bank insurance fund the FDIC predicted it would close banks with about \$80 billion in assets this year. But Taylor told the bankers that so far banks with only about \$22 billion in assets **had failed**.

"We are behind schedule on this macabre objective," he said.

The brighter than expected performance so far this year has led some economists and politicians to allege a Bush Administration conspiracy to delay bank failures until after the election—a theory popularly known as “The December Surprise”. [H: Title gleaned from “October Surprise” in which Mr. Bush was a major operative in the holding of hostages in Iran until after elections.]

“I’m here to tell you that bank failures have indeed been delayed and perhaps a few avoided by low interest rates and other factors. But there has indeed been no effort by the

agencies I know to delay the closure of insolvent banks”, Taylor said.

A law that takes effect in December authorizing regulators to accelerate bank seizures could raise closures toward year-end.

Taylor said about 80 banks, representing \$25 billion to \$30 billion in assets, already fail to meet the new standards.

“The ‘December Surprise’ is like the surprise that comes down the chimney at the end of the year. It may be a surprise to some, but not to those who have been around,” he said.

BANKER MAY HELP ANSWER QUESTIONS ON IRAQI LOANS (Peter Matius)

Headline: *The Atlanta Journal/The Atlanta Constitution*, June, 1992. [H: This is a bit outdated but it fits right in with what is unfolding TODAY.]

Christopher Drogoul has the reputation of a man who answers a question with a riddle.

But since FBI officials raided the Atlanta bank office he managed in 1989, Mr. Drogoul himself has been the enigma.

Federal prosecutors say the Atlanta bank manager “silently picked the pocket of a major Italian bank” by masterminding \$5 billion in secret loans used by Iraq to rearm in the years leading up to the Persian Gulf conflict. **Mr. Drogoul, 40, approved the loans while he was manager of the Atlanta branch of Italy's Banca Nazionale del Lavoro (BNL).**

Today, Mr. Drogoul is expected to plead guilty in federal court in Atlanta, even as Congress convenes a hearing in Washington on whether to seek a special counsel to investigate the administration's prosecu-

tion of the BNL case and its policies toward Iraq.

Unambiguous answers may be all that stand between Mr. Drogoul and decades in prison.

But more than his personal fortunes are at stake.

Lawmakers trying to unravel the BNL scandal have raised questions about the Reagan and Bush Administrations' secret support for Saddam Hussein before Iraq invaded Kuwait in August 1990.

Rep. Henry Gonzalez (D-Texas) questions whether those secret policies were affected by personal interests of administration officials. Recently, he released a memo showing that President Bush waived conflict-of-interest rules for 11 Cabinet-level officials so they could help set policy toward Iraq in 1990.

CASUAL ABOUT DETAILS

The answers to Mr. Gonzalez's questions may lie with Mr. Drogoul, a slender, curly-haired, 6-footer born in New Jersey to a French father and German mother. He studied in France and graduated from Temple University in Philadelphia, acquiring several languages along the way.

As a banker he was known more for aggressively seeking new business than for driving a hard bargain. He was considered casual about details and seemed to crave the approval of his subordinates, associates recalled.

Paul von Wedel, Mr. Drogoul's top assistant at BNL, recounts that after signing a particularly important loan agreement, the Iraqis showered him and Mr. Drogoul with gifts. Mr. von Wedel opened one box and blurted: “My kids will love it. A G.I. Joe watch!”

Mr. Drogoul, flushed with embarrassment, quickly corrected his assistant. The face on the Swiss watch was that of **Saddam Hussein—not G.I. Joe.**

Mr. von Wedel says that during the late 1980's he saw a gentle man turn into “a ruthless, compulsive liar, who cheated and deceived everyone” and has agreed to testify against

him.

Often those who speak out about Mr. Drogoul today have something to gain from undermining his credibility, while those who know him best keep their silence.

For example, Bruce Kirwan, a former attorney for the bank, called Mr. Drogoul a con man in court last April and said his insistence on cooperating with the FBI was “the ultimate act of someone who thought he could still con the world.”

On the other hand, his public defender, Sheila Tyler, does not return phone calls.

NO PLEA BARGAIN

And his wife, standing last week with a toddler on her hip in the front yard of a \$200,000 home in Avondale Estates, would not talk about her husband. Mr. Drogoul recently filed for protection under federal bankruptcy rules to keep creditors from seizing their home.

Mr. Drogoul, who is charged with 347 counts of fraud and conspiracy, told U.S. District Judge Marvin Shoob to expect him to offer a detailed explanation of the loans today. He has no sentencing agreement with prosecutors.

That means Mr. Drogoul is pinning all hopes for **leniency on how favorably Judge Shoob, an appointee of President Jimmy Carter, views his statement.**

“The fact that he is pleading guilty is not surprising, but it is shocking that there is no sentencing agreement,” said Edward Tolley, who represents another defendant who reached a negotiated plea.

In April his bond was revoked and he was jailed, in part for his own protection. Judge Shoob said: “If there are other people involved [in the Iraqi loan scheme], he might be better off in a safe place rather than where he is on the outside.”

Mr. Drogoul's road to protective custody in the Atlanta Federal Penitentiary began when he was named head of BNL's Atlanta branch in 1984.

TRUTH = FREEDOM

A SECRET SET OF BOOKS

Under his direction, the Peachtree Center branch office loaned nearly \$2 billion to finance **agricultural** exports to Iraq.

According to prosecutors, Mr. Drogoul recorded the Iraqi loans on a secret set of books because they far exceeded the official limits imposed by BNL headquarters in Rome.

Until whistle-blowers called in the FBI, it had been a relatively simple matter to fund the Iraqi loans by borrowing money on the world market and paying it back as the Iraqis repaid their loans.

Immediately after the scandal broke, Mr. Drogoul was a model of cooperation with both his superiors and prosecutors.

At the bank's request, he immediately flew from Europe, where he was on vacation, to BNL's offices in New York. Then he hired the law firm that the bank recommended. Finally, with the blessing of that firm, he waived his rights against self-incrimination and told the FBI his role in the scheme.

In an interview earlier this year with *Il Manifesto*, a Communist newspaper in Italy, he said it was his "impression" that former BNL general director Giacomo Pedde knew of his loans to Iraq. But when asked if Mr. Pedde or others knew the details of his scheme, he said: "Not everything... but they knew the general direction."

And when asked to comment on the Bush Administration's knowledge of the Iraqi weapons program financed by BNL, Mr. Drogoul said, "I never understood why in Washington they tell us not to do this or that in our relations with Iraq when the State Department and the Commerce Department and even the **White House examined all of the licenses of exportation and approved them.**"

So, what have we here? Could this be the reason the Agriculture Building in Baghdad is THE specific building of choice under siege by the "inspectors"? You have to recall that the massive loans for arms, etc., were funnelled out of the United

States as AGRICULTURE LOANS! Would it not be likely that very important documents regarding same would be housed somewhere in Iraq's "Agriculture Department" buildings? Ponder it!

I release you now to shore up the loose objects and mat the computers. If necessary, someone should perhaps make a trip into the city to make sure all instruments are latched down. I do not see enough care being taken with our project equipment. Thank you.

NORA'S RESEARCH CORNER

ATON AND AKHENATON (PART I OF A SERIES)

ATON, the One Creator God, was recognized by Akhenaton in the 14th Century B.C.

Akhenaton was known as Amenhotep IV, King of Egypt, prior to his change of worship from Amun-Ra to Aton. Amun-Ra was the reigning sun-god worshipped by former royal households and the established priesthood. Apparently Akhenaton decided to move the royal household and administration from Thebes to Akhentaten to break with the old religion of Amun-Ra. The archaeological digs at Tell El-

Amarna in Egypt are the sight where Akhenaton had his new administrative city (Akhentaten) for about 15 years. The dates of his reign have been fairly accurately set at between about 1375 and 1355 B.C.

Akhenaton had tried to reform the religion in Egypt, aimed at the extirpation of the cult of Amun-Ra, removing names from monuments, etc. His movement failed. The powerful priesthood of Amun-Ra hated him, and his "neglect of Egypt's empire" antagonized the army. There is some speculation that the king and his wife, Nefertiti, were murdered. In any event, Akhenaton's reign came to an abrupt end. Soon after Akhenaton's death his memory was thoroughly removed and the capitol was returned to Thebes.

Nefertiti and Akhenaton's children were all daughters. Therefore, when the king died it was a son-in-law, Tutanhaten, who became king. He made peace with the priests at Thebes, and changed his name to Tutankhamen. He is probably best known by the name, "King Tut."

Because the "memory of Akhenaton and Aton were removed from the records of Egypt," it was not until the archaeological find at Tell El-Amarna that much was known about Akhenaton and Aton (at least in the West). The site of Akhenaton's administration was discovered in 1887. It yielded about 355 letters and cuneiforms documents, as well as some new naturalistic forms of Egyptian Art, which broke with the old stylized art forms of Egypt.

The argument still rages among scholars as to the nature of Aton. Many still believe, or interpret the information to show that Aton was a new sun-god that Akhenaton attempted to use to overthrow the reigning "gods of Egypt".

Unfortunately, some of the writings and art works found at Akhentaten (Tell El-Amarna) do not clarify the issue for everyone. "It is not possible to gather precise information as to belief or doctrine," according to Anthony S. Mercatante in his book, *Who's Who in Egyptian Mythol-*

ogy, "Incense was burnt several times a day and hymns were sung to the god, accompanied by harps and other instruments. The offerings to the god consisted of fruits and flowers. There were no animal sacrifices. The worship was joyous, and the surroundings pictured by the artists of the period were bright and cheerful."... "Variant spellings (of Aton) are Aton, Adon and Eton."

There is a carving on a stone stele showing Akhenaton and Nefertiti giving offerings to what appears to be a representation of a sun, an orb with rays extending out to the earth(?) ending in hands holding the ankh (sign of life in Egypt) and with an uraeus at the base of the orb. There is no information as to the artist, the meaning, or the date of the art work. It is an unusual representation, and appears to indicate, from other Egyptian symbology, that the "sun" or "god" or "Aton" is wise and life-giving. Unfortunately, the resemblance to the sun leads many to conclude that Aton was another sun-god! In addition, a "Hymn to Aton", also found at the sight, has elements which support this conclusion, although not decisively. Anyone studying the art and its meaning needs to keep in mind that the written language was very primitive during Akhenaton's time. The hieroglyphs and art had to tell the story.

Barbara Mertz, who received her Doctor's degree from the Oriental Institute at the University of Chicago, spent many years in travel and study in preparation for writing her book, *Temples, Tombs and Hieroglyphs, The Story of Egyptology*. She states that one of the fore-runners of Egyptology, and especially the expounder of the hieroglyphic language, was James Henry Brested, who wrote a major work on the subject. Brested called Akhenaton "the first individual in history" and "gave Akhenaton the distinction of being founder of the world's first monotheistic religion. Brested has been accused of overenthusiasm; some scholars loathe Akhenaton as much as Brested admired him." (end quote)

In their article on Akhenaton, the *Encyclopedia Judaica* concludes..."at best, Akhenaton's 'Monotheism' (including the Hymn to Aton which resembles Psalm 104) was a form of Monolatry. After Akhenaton's death, the old religious order triumphed and Atonism was effectually stamped out."

One of the subjects of much debate is the physical form of Akhenaton, which shows slender shoulders, a protruding tummy and heavy hips. Akhenaton's images, and those of his family, are more true to life than all the stylized images of kings that preceded him. Unfortunately, the true images of the preceding and succeeding rulers are not available for comparison. Nevertheless, his family is very attractive and the art work reveals a loving family group.

The controversy over Akhenaton and the "Aton" appears to have grown more heated since Barbara Mertz and James Henry Brested. Cyril Aldred in his book, *Akhenaton, King of Egypt*, discounts much of what the former two said. The copy of the book I was able to borrow had notes scribbled in it throughout—obviously someone else objected to Aldred's conclusions. There are uncommon reasons why the subject is so controversial—and yet not too well known except among Egyptologists for the most part.

Some questions I personally encountered while reading about the Tell El-Amarna digs are:

1. If, as Brested credited Akhenaton with, "the distinction of being the founder of the world's first monotheistic religion" is true, where does that leave Moses and the Israelites? A most difficult question because of the dates and because of those administrative letters found at Tell El-Amarna. According to Ussher's chronological table of dates in the *Oxford Bible Concordance*, Joseph was in Egypt about 1729 B.C.; Moses was born in Egypt about 1571 B.C.; the children of Israel left Egypt about 1491 B.C.; and the conquest of Canaan

(Palestine) took place between 1491 and 1427 B.C. This means there should have been some knowledge of the Twelve Tribes of Israel in Palestine and among the rulers of the surrounding areas well before the time of Akhenaton in 1375 B.C.—100 years after the “conquest” of Canaan by the “Israelites”. Also, since the Biblical account says Moses was raised by a daughter of the King in Egypt; and prior to that Joseph had been the King’s Visier; and there had been quite a fuss when the children of Israel left Egypt—there should have been some record somewhere giving an account of these happenings in Egypt.

There was no record of Joseph, Moses or the Hebrews anywhere in Egypt prior to Akhenaton. Also, the administrative letters between rulers at the time of Akhenaton make no mention of the Israelites or of the Hebrews. The letters are from rulers as far away as Babylon and all the places in between. In fact, Egypt was ruler of Palestine at the time of Akhenaton — having their vassals in place there—although there were some problems and all was not well. Nevertheless there are substantial and serious questions about Biblical accounts—and the problems have not been dealt with by those who should be about the business of the truth. The very foundation of the story of the Israelites crumbled in 1887!!

So—if Egypt was in possession of Palestine at the time of Akhenaton (1375 B.C.) how do we know? There are administrative letters to tell us from the Tell El-Amarna. There were complaints from other rulers asking for Akhenaton’s help with money and armies. The fortresses in Palestine had been neglected during Amenhotep III’s reign and needed strengthening. A fierce band of desert raiders, called Habiru, were causing problems—appar-

ently, from available reports, Akhenaton was not a man of war.

There is more to discuss about the finds at Tell El-Amarna which I will take up again. Before leaving the subject of Aton and Akhenaton you need to have the “Hymn to Aton,” ascribed to Akhenaton and apparently found at Tell El-Amarna. It is the interpretation of Brested found in Barbara Mertz’s book, followed by Psalm 104 (from the Bible) for comparison:

Aton Hymn

When thou settest in the western horizon of heaven
The World is in darkness like the dead....
Every lion cometh forth from his den,
The serpents they sting.
Darkness reigns....
Bright is the earth when thou rises in the horizon....
The two lands are in daily festival,
Awake and standing upon their feet....
Then in all the world they do their work.
How manifold are all thy works!
They are hidden from before us.
On thou sole god, Whose powers no other posseseth.
Thou didst create the earth according to thy desire, being alone:
Men, all cattle, large and small;
All that are upon the earth.

Psalm 104

Thou makest darkness and it is night,
Wherein all the beasts of the forest do creep forth;
The young lions roam after their prey; they seek their meat from God....
The sun riseth, they get them away
And lay down in their dens.
Man goeth forth unto his work.
And to his labor until the evening....
Oh Lord, how manifold are

thy works!

In wisdom hast thou made them all;
The earth is full of thy creatures.

Dr. Mertz sees the above as being “two examples of a literary tradition which flourished throughout the Near East over a vast span of time!” She later writes some phrases from Syria and Nubia where “Aton is God also”:

“Their tongues are diverse in speech, and their forms and their skins likewise;
For thou, Divider, has divided the peoples.”

It appears Aton was known to more people than we in the West have known! Also, it appears the writer of the above phrase may have been one dispersed from Babylon at the time the tower of Babel was put down. Unless of course there was no Tower of Babel as we are told.

If you are able to obtain some books to read on Aton and Akhenaton I suggest you read from several authors, in order to draw your own conclusions. Aton and Akhenaton are a controversial subject among scholars and authors. Obtain as many early books as possible.
