

The instructions here are something that I have personally used over the last fifteen plus years. If you follow the instructions explained here, it will work and you will have food to eat. This initial financial outlay can be considerable-but in subsequent years the cost is relatively small. When you consider growing your own food rich in nutrients, the cost should be secondary. The charts within this article hold a wealth of critical information-by all means, USE THEM. Even the most sophisticated gardener can learn from the information contained within them.

SIZE UP YOUR PROPERTY

An obvious first step is to survey your property Well, dear readers, the time for putting off to see what the most reasonable location for a garden starting with a garden as small as 10 feet x 10 feet is not unreasonable. I would recommend, however, that larger would be more desirable. For the purposes of this article. I use the hypothetical garden space as 20 feet x 80 feet, which is a pretty goodsized garden for a small family. When you start planting more than a quarter acre, then you've got something which will keep you tied to it with a ball and chain.

If you only have an area where there is a lawn, consider pulling it up and planting a garden instead. In difficult times you won't want to eat the lawn-or perhaps I should say: you may want to eat the lawn but a garden will look a lot better.

In times of drought, a small, intensively grown garden is highly desirable as the yield is very high and it requires less water than traditional farming methods.

"No one should control more arable land than he can maintain in a high state of productivity, the four great factors of which are good seed, suitable moisture, abundant available plant food and rational tillage. In a large majority of cases where failure, or partial failure of an abundant crop is observed the meagre results are due to a partial lack of one of these four fundamentals." [Isaac Phillips Roberts from Ten Acres Enough.]

SEED

Once you've decided to put in a garden, then you need to choose what you'd like to grow-always keeping in mind the specifics about your particular geographical region and the time of year. GET YOUR SEED ORDERED ONCE YOU'VE GIVEN SOME CAREFUL CONSIDERATION TO IT, AND THAT WAY THE SEEDS CAN BE ON THEIR WAY TO YOU WHILE YOU COMPLETE OTHER ASPECTS OF THE GARDEN PREPA-RATION. ORDER SEED FIRST, THEN PRE-PARE THE SOIL. ALSO, ORDER NON-HY-BRID OR SO-CALLED "HEIRLOOM" OPEN-POLLINATED_SEED. With this type of seed, which is rare in this country, you may replant year after year after year using seed from your own crops. Most seed at grocery stores, hardware stores, and most seed companies are hybrid-which means that you can only use the seed for one growing seasonand then you need to repurchase seed for the next year. THIS IS SOMETHING YOU WANT TO AVOID IF AT ALL POSSIBLE. PLAN ACCORD-INGLY AND ORDER NON-HYBRID SEED-IN THE YEARS AHEAD YOU AND YOUR FAMILY'S LIFE COULD DEPEND ON IT! HIGH-YIELD GARDENING-RAISED BEDS

"...ere long the most valuable of all arts will be the art of deriving a comfortable subsistence from the smallest area of soil. No community whose every member possesses this art can ever be the victim of oppression in any of its forms."

Once you've identified the location for your garden, then the work really begins. This article will concentrate primarily on raised-bed gardening, which is referred to by various names. The beds generally are rectangular in overall shape, varying in width from 3-5 feet across and whatever length you determine but if the shape of your particular piece of land is such, the beds can take on curves or even become circular. The finished beds are elevated above the ground, anywhere from six inches to a foot high. But let's begin with soil preparation, because without that there won't be any food for the table.

Closely spaced plants shade the soil and each other, offering some relief from the heat. Hot Interplanting taller and shorter crops shades the lower level planting. Lath or other Temperatures shading structures are easy to set up to cover a whole bed. Raised beds drain very quickly and alleviate soggy soil conditions. Too Much Water Birds and rabbits can be kept at bay by covering beds with curved frames draped with **Animal Pests** plastic netting. You can get in and out easily, but the wild creatures can only gaze instead of graze. Raised beds overcome problem soils. You can create ideal growing mediums inside the **Problems** with beds by blending soil, sand, manure, peat moss, and other amendments. You can also Plant Growth tailor the soil to meet plants' specific nutrient needs. Because beds are never walked on, and Soil plants have a soft, deep area for excellent root development, which encourages strong, Conditions


Spectacular yields depend first on soil conditioning that can readily meet the heavy demands of close planting, carefully timed successions, and a growing season stretched to its absolute limit.

I will assume that most of you putting in your first garden will <u>not</u> go to the trouble of having your soil actually "tested". But if you do, keep in mind that most plants thrive on a pH range anywhere between 6.0 and 7.5. A good rule of thumb would be: Assume your soil is very poor and needs amending with nutrients and organic matter. It is essential to have organic material in the soil, such as manure, compost, minerals, or combination amendments which loosen the soil to allow for retention of moisture and healthy root growth. If you are purchasing manure, be sure it is "aged" 6 months to a year-otherwise you'll end up with a lot of weeds and grass seed in the garden. Most bagged manure at nurseries is sterilized and aged. In many rural areas manure is readily available from local ranchers and is generally advertised in the want-ads, and often will be delivered for a fee. Larger gardens can require quite a few cubic vards of manure and it is considerably less expensive in bulk-however the danger comes in not knowing if it is "aged", and that can really make the difference if you end up with a huge pile of grass or weeds in your garden.

Go out to the area you've chosen as a garden spot and carefully examine and feel the soil. Here is one guide which may be useful to you.

The next intermediate step will be to till the soil. Many gardening purists insist on digging by handbut I have found over the years that a rototiller can be a good friend indeed.

There are a variety of excellent books available on the subject of raised-bed gardening, and most go into great detail about double-digging the beds by hand while adding various soil amendments. The instructions I am providing here are geared for those of you readers who have never planted a garden, aren't particularly interested in digging a quarteracre plot by hand but would still like to prepare some soil in which to grow food without killing yourself in the process.

Tilling is best when the soil is somewhat moist but not soaking wet. Many types of tillers are good; I prefer Troy-Bilt. Very dry soil is difficult to breakup and the tiller will tend to "buck". If you are starting your soil preparation during the summer months, you may have to heavily water the garden area over a period of several days and then wait for it to partially dry out. Somewhat moist is bestsoggy wet is not.

Once you've tilled the soil so that the top foot or more is loose, then you are ready to begin adding the necessary soil amendments to properly build up the soil. Here are some guides for your assistance.

And It's...

CLAY If other kinds of particles are present in quantity, such soil can be classified as a stony clay, gravelly clay, sandy clay, or silty clay.

SANDY Depending on the size and texture of the particles, such soil may be classified as gravelly, coarse, medium, fine, or loamy sand.

MUCK or PEAT Peat is not fully decomposed. Muck is the same soil in a more advanced state of decay. It tends to be waterlogged and lacking in lime but rich in nutrients such as nitrogen

LOAM A mixture of sand, silt, and clay, this close-to-ideal soil combines the best qualities of light and heavy growing media. Depending on the kind and size of the particles that predominate, a sample may be categorized as a coarse, sandy medium sand, fine sand, silty. stony silt, or clay loam.





ANALYSIS OF RECOMMENDED ORGANIC SOIL AMENDMENTS

N, P and K refer to the three main nutrients plants need: NITROGEN for green growth and in compost piles to speed decomposition, PHOS-PHORUS for root growth, disease resistance, and production of good fruits, vegetables, and flowers, and POTASH for strong stems, vigor ous roots and increased disease resistance. Plants also need HUMUS which is provided by decomposed organic matter such as compost and manure. For information on the application rates for organic fertilizers when a soil test is not used, see the Fertilizer Program Table which follows this table.

NITROGEN

Cottonseed Meal

3-5% N 2% P 1% K Lasts 4-6 months. Use up to 10 lbs/100 sq. ft. Fair source of nitrogen. Especially good for citrus and azaleas because it has an acidifying effect on soil.

14% N ~2% P ~0% K Lasts 12 months. Use up to 4 lbs./100 sq. ft. Highest nitrogen source. Slow releasing: no noticeable results for 4-6 weeks.

Fish Meal

10.5%~N-6%~P-0%~K Lasts 6–8 months. Use up to 5 lbs./100 sq. ft. Good combined nitrogen and phosphorus source.

PHOSPHORUS

Bone Meal

3% N 20% P 0% K Lasts 6 months to 1 year. Use up to 5 lbs./ 100 sq. ft. Excellent source of phosphorus. Especially good on roses, around bulbs, and around fruit trees and flower beds.

Phosphate Rock

33% P Lasts 3-5 years. Use up to 10 lbs./100 sq. ft. Very slow releasing.

Soft Phosphate

18% P Lasts 2-3 years. Use up to 10 lbs./100 sq. ft. Clay base makes it more available to plants than the phosphorus in phosphate rock, though the two are used interchangeably.

POTASH

Kelp Meal (Seaweed)

1% N 0% P 12% K 33% trace minerals. Lasts 6 months to 1 year. Excellent source of potash, iron, and other minerals. Reportedly, the proper amount of trace minerals in the soil may mean only one-half the fertilizers will be needed for the same growth and yield! Kelp meal is also a natural fungicide. Use sparingly (up to 1 pound per 100 square feet per year) because it contains growth hormones.





Wood Ashes

1-10% K Lasts 6 months. Use up to 1-2 lbs./100 sq. ft. Ashes from wood are high in potash and help repel root maggots. Ashes also have an alkaline effect of the soil, so use them with care if your soil is already alkaline. Black wood ash is best.


Crushed Granite

3-5% K Lasts up to 10 years. Use up to 10 lbs./100 sq. ft. Good slow-releasing source of potash and trace minerals.

Greensand

0%N 1.5% P 6.7% K Use interchangeably with crushed granite.

SOIL pH SCALE



A pH reading tells you the relative acidity/alkalinity of the soil. Most vegetables will grow well in a range from 6.0 to 7.5. 6.5 is probably the best all round pH. In extremely acid or extremely alkaline soils valuable nutrients are tied up and thus unavailable to the plants. An acid soil can be sweetened by the addition of dolomite lime. An alkaline soil can be brought closer to neutral by compost or manure. Compost has a buffering effect on soil, correcting both acid and alkaline conditions.

SOIL MODIFIERS

Dolomitic Lime

A good source of calcium and magnesium to be used in acid soils. Do not use lime to "sweeten" the compost pile; it results in a serious loss of nitrogen. You can discourage flies and odors with a layer of soil.

Gypsum

Gypsum is not needed by organic gardeners. It is normally used commercially in soils made impermeable by excess exchangeable sodium. "Clodbuster"

15% Humic Acid 5.5 pH Lasts 1 year. It is crushed "rock" deposits made up of ancient plant and animal remains. Helps make soil less alkaline and releases nutriments tied up in the soil. Use up to 1 lb./100 sq. ft.

Crushed Eggshells

High in calcium. Especially good for cabbage family crops. Help break up clay and release nutriments tied up in alkaline soils. Use up to 2 lbs./100 sq. ft.

Manure

A good source of humus in the garden. Nutriment levels depend on proper handling and the amount of straw or sawdust present. Large amounts of bedding may add up to 2 years to the decomposition time.

















THE TWELVE MOST VERSATILE AND PRODUCTIVE HERBS

FIRST GROUP



Oreganc

ST. LOUIS thyme.



This tremendously productive annual imparts a unique flavor to sauces, stuffings, soups, salads, and meat dishes. Good bets are the compact 18-inch-high BUSH BASIL and the larger-leaved LETTUCE LEAF, which is great for drying. Other recommended varieties are FESTIVAL SWEETS, DARK OPAL, and LEMON, which is strongly favored by The Liberty Herb Farm in Maine, because "it makes wonderful herb vinegar and is excellent with fish and salad." BASIL SPICY GLOBE (48) is a spacesaver.

The most frequently mentioned variety of this tomato-mate and meat stew and saladenhancing herb is the tender evergreen GREEK form, which grows to 18 inches or more. According to Carol Hildebrand of Casa Yerba in Oregon, GREEK is best for long-cooked dishes, while the 16-inch-high ITALIAN oregano excels in quickly pepared soups and salad dressings.



SECOND GROUP This grassy, bunching, 12 to 18-inch-high perennial member of the onion family is endlessly useful as a flavoring agent in sauces, soups, and salads of all kinds. Many herb growers also recommend garlic chives, which combine the flavor of mild garlic and chives.

Thyme is superb mixed with soft cheeses and as a seasoning in stuffing, salad dressings,


gravies and sauces, and egg and meat dishes. Marilyn Hempstead of Fox Hill Farm in Michigan reports that both ENGLISH and LEMON thyme "offer a big return for the space." The ABC Herb Nursery in Missouri recommends the "really high-yielding"



An extremely hardy perennial, French sorrel grows 2 to 3 feet high. Its tart green leaves are high in vitamin C and make a tangy addition to salads or are tasty cooked together with other greens like spinach or cabbage. This herb also is the star of a famous French soup.



Unusually prolific and adaptable, this 2 to 2¼-foot-high seit-renewing perennial is tasty as a solo tea or added to tea and other beverages. It also contributes a pleasant subtlety to vegetable and fruit salads. Lemon balm attracts bees for better pollination of other garden plants.



Taylor of Taylor's Herb Gardens in California and by Anna Smith of Country Herbs in Massachusetts, who cited its "tremendous yield" and suitability for most cooking purposes.

Though not as sweet as the curly form, flat-leaved parsley is recommended by Kent



A perennial herb that blends well with eggs, soups, gravies, stuffings, fish, and meats, sage comes in several varieties, some quite ornamental. The yard-high HOLT'S MAMMOTH is favored by one southern herb farm because it is fast growing and doesn't die back. But a better choice in intensive gardens might be DWARF SAGE - a 12-inch-high form that is less likely to be winter-killed in northern areas.



The French form of this anise-flavored, 21/2-foot-tall perennial is the most superior. According to Fairman Jayne of The Sandy Mush Herb Nursery in North Carolina, French tarragon loses no flavor "even when grown under very intensive conditions." Much more flavorful fresh than dried, this herb makes a delightful vinegar and is superb in tartar and other white sauces, and with fish, cheese, eggs, and cauliflower.

Hardy and self-seeding, this fernlike annual attracts honeybees when allowed to mature

to 2 or 3 feet. Dill needs just 8-inch spacing on all sides. If harvested young, it can be interplanted with cabbage, carrots, cucumbers, lettuce, and onions. Dillweed is a tasty addition to cheese or tofu dips, soups, salads, and creamed entrées. It's also a staple in

THIRD GROUP



Upright forms of this elegant tender perennial are often recommended, but North Carolina grower Fairman Jayne says the most productive variety for small spaces is the foot-long creeping HUNTINGTON CARPET rosemary. North of Virginia, rosemary must be protected over the winter or taken indoors. WATERING YOUR GARDEN

Once again, don't be a slave to the garden unless you want to be. We live in a modern age and one in which, thank God, there are digital, battery-operated automatic timers which you can attach directly to your faucet and garden hose system. It is possible to program up to 4 waterings per day with a quality timer, which is well worth the expense in the time it saves you. Keep in mind, while the timer waters the garden, you can go somewhere else.

Just a few tips—while it is true that overwatering is a common problem, underwatering is a real mistake-particularly in the very beginning of germination. DO NOT LET THAT NEWLY PLANTED SEED DRY OUT-EVER. If you are watering several times per day by hand, you will literally be able to tell when enough is enough. If you are using a timer, which I DO recommend, you'll just have to play with it a bit to get it "just right". But under no circumstances let the seed dry out. I cannot emphasize this enough: It is better to overwater, if you the Conscious Presence. Besides, the raised-bed method of gardening will be more forgiving of a bit of overwatering than will a regular, hardpack farming method.

Also, they do have plastic Y adaptors to allow for two hoses, and thus, two sprinklers off the same water line. My only point here is that over-work isn't necessary to get results that you'll be delighted with.



GENETIC ENGINEERING OF FOODS TRANSFERS ALLERGENS

From the March 14 issue of the (Los Angeles) DAILY NEWS, [quoting:]

WASHINGTON-Researchers said Wednesday that they had the first solid evidence that proteins that can cause potentially serious allergic reactions could be transferred to crops through genetic engineering. Scientists at the University of Nebraska at Lincoln said tests proved that soybeans modified with genes from Brazil nuts to produce a nutritious protein found in the nuts also produced proteins that set off a strong, potentially deadly allergic reaction in people sensitive to Brazil nuts. The finding confirms early suspicions that transferring genes to food plants posed such risks.

Critics of moving genes to food plants from other plants, animals and organisms say the research indicates that tighter regulation is needed to protect the of the NEW YORK TIMES by the February issue of the public. [Just who might provide such regulation??our totally corrupt government, perhaps?] But proponents of the technology and federal regulators say the largest drug companies, pleaded guilty yesterday to findings indicate that the current system of mostly voluntary monitoring and reporting is sufficient to guard the public against potential risks from the food supply. [Oh, sure!]

The Nebraska researchers used blood serum from nine subjects known to have a Brazil nut allergy and compared how it reacted with extracts from Brazil nuts, conventional soybeans and the modified, or transgenic, soybeans. All of the samples reacted to the nut extracts. Eight of the nine reacted strongly to extracts from the genetically altered soybeans and none reacted to the conventional soybeans.

"Since genetic engineers mix genes from a wide array of species, other genetically engineered foods may cause similar health problems," [Rebecca J.] Goldburg [senior scientist with the Environmental Defense Fund] said. "People who are allergic to one type of food may suddenly find they are allergic to many more.'

CHERNOBYL SPAWNS MONSTER RODENT

radioactive pollution. "These are the most contaminated animals I've seen anywhere. They're living on radioactive materials," said Ron Chesser of the University of Georgia in today's edition of New Scientist journal. Radioactivity and other pollutants usually trigger mutations in animal genes, which weaken the species by killing its members off before they can reproduce. But a species of the vole rodent is breeding healthily and producing ever stronger offspring beside the Ukraine's Chernobyl plant, which exploded in 1986, spewing out radioactive poison in the world's worst nuclear disaster. Chesser and other scientists examined the vole's genetic makeup and found it was mutating at an incredible rate. [Maybe this is a big breakthrough for our next genetically engineered "food".]

DRUG MAKER ADMITS IT CONCEALED FLAWED TEST RESULTS

This article was reprinted from the 11/29/95 issue HEALTH FREEDOM NEWS, [quoting:]

The Warner-Lambert Company, one of the nation's criminal charges and agreed to pay a \$10 million fine for hiding from the Food and Drug Administration faulty manufacturing processes used for several drugs, including Dilantin, the widely prescribed epilepsy treatment. Also, the company's former vice president for quality control, Allan H. Doane, was indicted yesterday on criminal charges that he was involved from 1991 to 1993 in trying to hide the failures of the drugs to pass quality tests during that two-year period. He faces and ran a so-called constitutional court that issued penalties of as much as 19 years in prison and \$1.25 million in fines. Yesterday's admission of guilt by the company stemmed from a two-year-long grand jury investigation of violations that took place from 1990 to 1993. The corporate fine is one of the largest ever imposed on a brand-name manufacturer, as the FDA has traditionally levied rather small fines. [To a major drug company like Warner-Lambert, \$10 million is strictly petty cash.] Yesterday's action is part of a long-running investigation of fraudulent manufacturing processes by drug companies. [It is hard to believe that this investigation was very comprehensive.]

Dr. David Kessler, the Commissioner of the FDA, said yesterday: "Concealing and failing to report test results on drugs has the potential to compromise public health and safety. The FDA is committed to vigorously enforcing this nation's vital public health laws." [Of course, most of the laws are designed to protect the

CRITICIZE FOOD AND GO TO JAIL!

This article is also from the February issue of HEALTH FREEDOM NEWS, [quoting:]

Farm industry lobbyists in 11 states have passed "food slander" laws. These probably unconstitutional laws are aimed at suppressing criticism of perishable foods by safe food activists. The laws ban criticism unless based on "sound science", which is never defined! In fact, activist criticism usually focuses on chemical residues or contamination, not on the properties of the food itself. Frustrated farmers, who may lose sales after an Alar scare or an anti-rBGH boycott, are caught between consumer demand for safe food and the chemical-intensive methods of conventional farming. Farmers will bear the costs of prosecuting "food slander' lawsuits. They have essentially agreed to take the heat for the chemical industry!

The problems that trouble food activists, i.e., animal health, environmental contamination, and chemical residues in the human diet, are predominantly a result of agricultural chemical use, not problems with the food itself. Few people will deny that agricultural chemicals harm the environment and human health. But it is difficult to prove their long-term effects, as these chemicals have had less than 50 years to accumulate in the environment and food chain. "Food slander" laws would outlaw the criticisms that inspire the public to demand further research! These laws must be repealed, and farmers must be told that consumers want safe, organic and sustainable agriculture.

"CONSTITUTIONAL COURT" **GROUP INDICTED**

From the March 17 issue of the RENO GAZETTE-JOURNAL, [quoting:]

TAMPA, Fla.—A man who called himself a patriot warrants for state and federal judges was among 11 indicted on conspiracy and obstructing justice charges. The group, composed of people from Tampa, Central Florida, Arizona and California, is charged with sending threatening communications to prosecutors, jurors, clerks and judges, and even proposing punishment by hanging. Some members plotted to kidnap federal judges, try them for treason and sentence them to death, prosecutors allege.

Other group members declared war on the United States. A 48-page indictment issued Friday charges that Emilio Ippolito, 70, and adherents of We the People and other groups let their interpretations of the U.S. Constitution carry them too far. The indictment accuses all 11 of conspiracy and various groups with specific acts of obstructing justice.

In August of 1994, Hillsborough County Chief Judge Dennis Alvarez asked federal prosecutors to get involved "to avert the very real possibility of personal injury or death," after he and other local judges received arrest warrants from Ippolito's court. [As a judge, it's not hard to see why he might have wanted their efforts halted!]

According to the indictment, an ensuing investigation did not deter Ippolito and his associates. They maintained they were natural citizens exempt from jurisdiction of the United States, its laws or courts. Prosecutors contend the group has wreaked havoc in the judicial system during the past two years. [What about the havoc wreaked upon the American judicial system by the Khazarian/Mishpuckas who have controlled it for the past 65 years?] Troubles began when some group members created their own court: The Constitutional Common Law Court. That "court" began issuing arrest warrants and cease and desist orders to judges, law officers, jurors and others for their role in the prosecuting some group members on various charges. The created court threatened officials with charges of treason—punishable by hanging, or more specifically, being "shot at high noon".

At one point, a group member allegedly proposed assembling a group of armed deputies, arresting a federal judge and holding him as a "prisoner of war" in exchange for the release of a federal prisoner. At another point, one reportedly said, "It's time that...they try one of the judges, or whoever, and we hang him. I think that you're gonna get a bunch of respect in a hurry."

The FBI, Florida Department of Law Enforcement, Internal Revenue Service, postal inspectors and other agencies logged letters, calls and statements made at meetings to come up with Friday's indictment.

[The next details come from the March 20 issue of THE ORLANDO SENTINEL, quoting:]

During the hearing, FBI agent Robert Carroll testified that an undercover IRS agent attended and recorded citizen's court sessions in Orlando, providing much of the key evidence.



A ROSE BY ANY NAME

Stop it—I weary of your picking and poking over things which are absurd. If your name is George Hornblower and it is changed by someone named Paul, does it mean you are no longer George Hornblower? Saul of Tarsus labeled my being Jesus AFTER I was no longer in the "Holy Land". Moreover, the one Paul, who thought better to call himself that than remain with Saul (of Tarsus), probably because he feared the tar and feathers, did-in the Christian "movement". With friends like "Paul the Apostle" I certainly needed no enemies. If you don't believe me, especially you women who seek equal rights, read the edicts he handed down in my name. Paul was no friend of mine; he was one of your first REAL "mattoids". Esu here to continue our reconstruction of Truth.

UNTO CAESAR

I certainly expect you to be as careful this day as I efforted to be in those days long ago. There were those who tried to compromise me with the Romans or the Judaists by asking what I thought about the payment of tribute. I replied, pointing to the effigy on a coin, if I had one, and told them to render to Caesar the things that are Caesar's and to God the things that are God's. I answered then as now: "Blessed thou art, Simon Bar-jona, for flesh and blood hath not revealed it unto thee, but my Father which is in heaven." Now what actually did such a statement mean? Could the entire statement be misconstrued and out of context? It would seem to me that the theological tone seems to brand it inauthentic. For example: "All Things are delivered unto me of my Father, and no man knoweth the Son, but the Father; neither knoweth any man the Father, save the Son, and he to whomsoever the Son will reveal him." and "Why callest thou me good? There is none good but one, that is God." Good, beloved ones, meant "perfection". It mattered not whether I be a Christ or a heathen-I certainly knew the language even if the note-keepers did not.

Taken all together, the words of which I supposedly am attributed must supply much less than unequivocal answers. Even the projections of my enemies could not attribute to me such dogmatic formulations and apparently they could come to no definite conclusion about the nature of my person. I find that it is quite interesting to note that to this day there is no conclusion regarding my being. The question itself seems to be a fallacy resulting from dogmatic bias.

Thus they arranged it so that my last words are not the cry of a despairing man but the beginning of the nice Twentysecond Psalm, and the man who prays in these words is not a rebel against God, but one who lives and dies at peace with God. Well, precious ones—it matters not a whit who I was—it matters greatly WHO I AM!

It certainly seems more than a species can do to tear yourselves away from the beliefs as poured forth upon you in order to continue control over you. I guess it takes some very compelling reasons to make you abandon the belief that there is a reality at the base of these moving episodes and speeches. I was a Man and I tried to always reveal myself in the purity of my soul and in my struggle with unexpected realities. The struggle culminated in no finished awareness nor dogma for that matter. In the face of terrors, in the face of my mounting disappointment, all that was left me was my prayer-"Thy will be done." WHAT WOULD YOU HAVE DONE AND SAID? THAT ALONE BECOMES FAR MORE IMPORTANT THAN THAT WHICH I DID AND/OR SAID. FOR THAT WAS MY PATH-WHAT MIGHT YOURS BE?

Case No. 229531 AEW was served on Johnny Cochran by sub-serving Patrick McKenna, investigative employee of Johnny Cochran at Cochran's office at 3:00 p.m. on September 21, 1995 by Robert L. Brock. Two other disinterested witnesses were present. Patrick J. McKenna stated that he accepted the service and would give it to Johnny Cochran.

Robert L. Brock and the two disinterested witnesses observed McKenna hand the lawsuit to Barry Scheck, Cochran's associate in the O.J. Simpson case.

Scheck and McKenna were observed walking into a conference room where other lawyers were seated and the statement was made that they were going to study the lawsuit until the arrival of Cochran who they expected to arrive momentarily.

On September 22, 1995, a Declaration of Mailing was sent to Johnny Cochran at his office address by Rick Martin-U.S. Certified Mail Receipt No. Z 710 890 686.

On September 29, 1995, the clerk sent me a notice that "when substituted service is made a Declaration Michael Antonovich. of Mailing must also be included."

On October 2, 1995, Rick Martin again signed an Affidavit, Declaration of Mailing for the Court's record.

along with a copy of the Summons and Proof of Service and Affidavit of Robert L. Brock was Filed-Endorsed and entered by the Clerk of Kern County.

that a hearing was set for Friday, February 9, 1996 at 8:00 a.m., Department 7, Re: Failure to Enter Default on Defendant, Johnny Cochran. But if parties are in compliance five court days prior to hearing no appearance is necessary.

On January 29, 1996, eleven days prior to the hearing I personally filed an Entry of Default properly filled out on the proper form and a County Clerk inspected it and stamped, dated and signed the document and entered it in the court file. There were two clerks present at the time and they both inspected the documents. I I have no record of Mr. Cochran ever being personally asked them if everything was proper and alright and if anything further was needed. They both assured me that everything was proper and I would not have to appear on February 9, 1996.

notice to me, this notice was not mailed until the next day, Wednesday January 31, 1996. I checked my P.O. Box on Saturday, February 3, 1996, after the mail was delivered and the notice had not arrived.

I received the notice on Monday, February 5, 1996. The notice, which was unsigned, stated that, "Default cannot be entered because the original Summons must be returned and filed before Default can be entered."

This is very clever corruption committed by the court and clerk, but is normal procedure by the "unelected judges" operation.

They had it set up now so I could no longer comply by filing the "Entry of Default" five days before the hearing. This trickery necessitated that I appear with only a few days notice at the hearing at 8:00 a.m. on Friday February 9, 1996, which was impossible to do. The clerk was well aware that I lived almost a 1000 miles distant and that the severest snow and ice storms in years were in progress in Oregon and Northern California making it impossible to make an appearance.

This notification from the court that I received on Thursday March 7, 1996 indicates that Arthur E. Wallace held a hearing on March 1, 1996, and I at no time was noticed that such a hearing was scheduled to take place. The dirty tricks of "trick and device" that "unelected judges" have been guilty of for over three decades is hereby set out and recorded by their evil depravity. It is this vile, unconscionable usurpation of the courts that has degraded and destructed the American judicial system. After falsifying the facts and destroying court documents the Kern County Court Clerk and Arthur E. At this phony hearing of March 1, 1996, of which I had no knowledge of whatsoever, Arthur E. In this document ordered by Arthur E. Wallace he violates every law of American morality and ethics by knowingly lying by stating that the Kern County Court Clerk returned incomplete documents to me on January 30, 1996, and no corrected or completed documentation has been submitted as of February 29, 1996

First, all of the documents were completed and filed properly with the Kern County Clerk's Office.

Second, I sent copies of all these files which are all contained in my records to the County Clerk on February 7, 1996.

All of these documents were sent to the Kern County Superior Court Clerk by Federal Express on February 7, 1996 and received and accepted by Kern County employee G. Medina the next day, February 8, 1996. Copy attached hereto.

These documents were actually held in the hands of Arthur E. Wallace and the Court Clerk and discussions of the contents of these documents took place between them and other specific persons.

The only issue at all before Arthur E. Wallace is the issue of ordering a Judgement in favor of the Plaintiff, Gary L. Wean.

The only plausible reasoning for Arthur E. Wallace and the Kern County Superior Court Clerk to compact, combine and conspire to such a serious judicial crime would be for money.

CLERK'S CERTIFICATE OF MAILING

Because of the treachery of these people the following is the situation the citizens of California and America face. The number of Representatives permitted to California is dependent on an official Census of that State. Most scientists prefer to ignore cranks. Trying to enlighten them or their followers, scientists say, is like trying to write on water. [H: Then these scientists should try to enlighten "scientists" and see how far they get in that closed world of gotcha.] Besides, scientists believe they have more important things to do. Carl Sagan, Cornell's distinguished astronomer, sees it differently. He has become the fugleman [H: You wont find that word in your quick reference dictionaries. It means: One who leads or sets an example in anything. Why do writers have to show their own ego by utilizing such unheard of terms? Even "pseudo science" is some obscure term meaning "false science" of which there are so many forms as to be overwhelming.] of a growing band of experts now convinced that the rising flood of superstition and pseudoscience is too damaging to society to be ignored. How can political leaders vote intelligently on proposals to control nuclear weapons, to fund basic research, or to reverse environmental degradation if they and their constituents can't distinguish good science from bad?

[H: In your world of "science" it is all but impossible to distinguish even what is meant in any category. You have "military" science, "religious" science, and on and on with such things as "military intelligence" and Judeo-Christian as accepted valid terms. They are not even correct. If you have the oxymoronic play of words ON one another-you come out with total opposites within the same term. If it is "religious" it CANNOT be "science". "The Demon-Haunted World" is a stirring defense of informed rationality. Few believers in crank science escape Sagan's withering blasts. Let us name a few. Christian Scientists who would rather let their children die than give them insulin or antibiotics. Creationists who think God made Eve out of Adam's rib. Fools who ignore sound medical treatment to be "operated" on by Philippine psychic "surgeons". Ignoramuses who waste money on homeopathic drugs diluted until no molecule of the original substance remains. Does the water "remember" the drug's properties? [H: I'm sorry that this writer has so sorely misrepresented the actual writings of Dr. Sagan but he, too, is pretty hard on all possible deviations from his own perceptions. Once you have introduced, for instance, the DNA/RNA structure of a molecule into a DRIA water-bath, you have it there forever. What I dislike is the absolute narrow observations of book readers interpreting a great and insightful man's work. It begins to sound like a typical hatchet-job to me. On the other hand, Sagan leaves himself open for such blasts because of his own narrow perceptions of possibilities.] Sagan devotes hilarious paragraphs to his friend John Mack, Harvard's peculiar psychiatrist who treats patients he firmly believes have been abducted and often abused by aliens on UFOs. An embarrassed Harvard can't fire him because he has tenure. There are 10 times more astrologers in the United States, Sagan reminds us, than astronomers. Are astrology books and newspaper columns as harmless as fortune cookies? Recall the sad spectacle of our past president and his first lady scheduling important meetings on dates set by their West Coast star gazer. Orange County declared bankruptcy last year because its treasurer made stupid investments recommended by a mail-order astrologer.

Other offers covered by Sagan include the supposed stone face on Mars; the ridiculous crop-circle hoaxes; J.Z. Knight's profitable channeling of Ramtha, a 35,000year-old Cro-Magnon warrior who lived on the newly sunken Atlantis; the fake shroud of Turin; bleeding and weeping statues of the Virgin Mary; Big Foot and the Loch Ness Monster; spontaneous human combustion; poltergeists; perpetual motion machines; ESP and psychokinesis; dowsing; auras; Scientology; Lysendoism; pyramid and crystal power; the Yogic flying of Transcendental Meditators; faith healing; facilitated communication with autistic children-the litany is endless.

The most tragic result of scientific ignorance, skillfully detailed by Sagan, is the current mania for sentencing innocent parents and pre-school-teachers to prison, sometimes for life, solely on the basis of false memories of childhood sexual abuse fabricated by incompetent, self-deluded therapists and social workers. The false memories often involve horrible cannibalistic rituals in Satanic cults that the FBI has declared nonexistent. Another prime example of how scientific ignorance can thwart justice, too recent to be in Sagan's book, was the inability of O.J. Simpson's jurors to comprehend the accuracy of DNA blood testing. [H: Ah, here again is the fatal flaw in Dr. Sagan's perception-he fails to recognize the EASE in cloning DNA-RNA in blood for any and all purposes. Mostly I AGREE with his perceptions on all these many topics which are totally foolish and actually foolhardy in recognition. 

Note, please, that the old "Hebrew tradition" is not even included therein.

Next, "...the science of earthquake prediction would be employed for the remainder of the initial scenario." What earthquake prediction? Where? When? How? Who? and, Why? Why indeed, if there is no such thing!? LeMesurier, this wondrous new leader, then cooly details some of them as follows:

- "1. The restored Messiah must reappear on Jerusalem's Mount of Olives at the time of a great earthquake.
- "2. He must enter Jerusalem from the east, escorted by a procession of rejoicing followers dressed in shining white.
- "3. Visiting the tomb of his spiritual ancestor, Kind David, he must emerge in suitably-perfumed royal robes as the great monarch returned.
- "4. Supported by a popular rising, he must proceed with his followers to the Temple Mount, there to be enthroned, anointed, and crowned king of the New Israel."

Ah, but you might say: "Surely no thinking person would expect such a program to succeed, given the large number of determined Catholics, Protestants, and skeptical Jewish observers who might give opposition.'

To the contrary, this resistance has been carefully calculated-AND DISMISSED!

"The massed forces of the Old Age, however, will be unable to check their headlong onrush. In large measure they will go on to destroy each other in a massive, mutual venting of long pent-up aggression ... !"

What sort of a program would be offered to satisfy the "spiritual" needs of those living under this regime? As expected, the leader, LeMesurier, rightly notes that it will not be the traditional Christians:

"The new mission to the youth of the world, then, will be

ready developing ideas and values upon which the New Age rectifying social injustices." is to be founded. Those ideas and values will not necessarily be the traditional Christian ones.... For the wisdoms of all ages and cultures will be called upon to surrender their most precious secrets, and the collective human psyche will add to it yet further wisdoms that have so far never even been expressed.... It is for the soul of Man that the New David will have to fight ... "

Can you go back to the beginning of the above quotations and pick out the "for sure" losers? You must note, however, that the plan is to cause you to do exactly these things in this New-Age One-World Religion. This will mean giving up the most important one thing in all of LIFE-your soul, as the NEW demands are brought down around your hapless selves. So, I guess we have to concede that Mr. LeMesurier is right for the wrong reasons. It is staged so that, certainly enough, the "wisdoms of all ages and cultures will be called upon and they WILL surrender their most precious secrets." The Apostle John was clearly shown this in the course of his Patmos Island vision. But what makes a man named John's vision any better or worse than your own nightmarcs?

"And after these things I saw another angel come down from heaven, having great power; and the Earth was lightened with his glory. And he cried mightily with a strong voice, saying, Babylon the great is fallen, is fallen, and is become the habitation of devils, and the hold of every foul spirit, and a cage of every unclean and hateful bird. For all nations have drunk of the wine of the wrath of her fornication, and the kings of the Earth have committed fornication with her, and the merchants of the Earth have waxed rich through the abundance of her delicacies." Rev. 18:1-3"

You nice citizens of the world might well note that "old" Babylon has moved location!

I hope you readers do not err in thinking this LeMesurier (of whom you never heard) is alone in his projections. Note the following statements: His books have received the benefit of major publisher support [while the True word of God is turned away by EVERY major publisher] in both the U.S. and in places such as England, Germany and "you name it". It was a MAJOR book club selection in England. Books revealing the cover-ups and lies, even of Earth-bound actions, get banned and removed from shelves in stores and libraries and certainly are not allowed onto the "Best Seller" list through the hands of major publishing houses as are within the Elite control

Major New Age conferences have been held on this very theme. One such conference was reported in a matter-of-fact style in September, 1983 New Age Journal. Appropriately entitled "Facing Apocalypse", it was attended by 125 activists of the Jungian persuasion. It was organized by Robert Boznak, a Jungian analyst from Sudbury, Massachusetts. Its premise was that the vision of a cataclysmic ending of the world is itself a menace. The conference was held in an incredibly elegant hall that formerly served as a millionaire's mansion at Salve Regina College in Newport, Rhode Island. Some of your better known were in attendance.

I must point out, as well, that the infamous Humanist Manifesto, also bears this theme. Look at the preface to Humanist Manifesto II; it states:

"As in 1933, humanists still believe that traditional theism, especially faith in the prayer-hearing God, assumed to love and care for persons, to hear and understand their prayers, and to be able to do something about them, is an unproved and outmoded faith. Salvation, based on mere affirmation, still appears as harmful, diverting people with false hopes of heaven hereafter. Reasonable minds look to other means for survival.'

Reasonable minds? Does this mean that if you have a shovel and call it a spade and speak some truth by tainting the intent you can call up your personal scenario of Universal Law in any manner you so choose? What about RIGHTNESS? SALVATION, BASED ON MERE AFFIRMATION, IS AS FAR FROM THE truth AS IS THE MANIFESTO ITSELF in its total stupidity of assumptions.

This thought is further reinforced within the body of the Manifesto itself:

"Promises of immortal salvation or fear of eternal damnation are both illusory and harmful. They distract humans from present concerns, from self-actualization, and from

Let us now look at some interesting projections. Interesting? Yes, for why in the world does "the ending" need become that which is "projected"? If you are writing your script as claimed-then why not write it to disclaim and refuse such dastardly trials and tribulations? You are given instructions in scenes which cause collective thought which focuses on fulfillment of that which is desired FOR YOU TO PROJECT. This is necessary for the adversary to "win". The adversary "loses" anyway but you can easily be lost in the storm of confusion and limitation. If Man-projected limitations can be brought to bear, soul manifestation will fall into the hands of the controllers. The battle is truly for souls, readers-YOURS

One can easily see where the area of that which is called "Jungian" archetypes and acting out an end-time drama is an area in which occultists, atheists, and agnostic humanists can find a great and common ground. What means "humanist"? This means a total separation of the "physical human" from the "spiritual reality" and, worse, it is supposedly accomplished through the higher spiritual self which indicates two mutually exclusive states of being in total opposition, one to the other. At best that HUMAN experience of any given sequence will be around no more than a century and that will be pushing your old clocks. I do not well abide the term "human" as in this context for "human" indicates "Higher Universal Man". I would prefer, as related to physical man, "lloman", meaning lower limited Man.

Let us continue to investigate the confusion mess. The occultists of all New Age persuasions could easily support such a person-figure because they believe it is "their Christ" as they quite bluntly define it. The atheist could participate because he would feel it would contribute to the furthering of human progress on the planet, with people being discharged of their ideas of a coming deity for once and for all. The Humanists could participate because it would further the aims of their manifesto. In fact, maybe the Humanists and the New Agers are really not so far apart! In the 1973 Humanist Manifesto II it reads, "...we stand at the dawn of the new age." Well, readers, EVERY DAY you stand at the beginning of a "new age". Many recognizable New Agers and occultists appear as signers of the 1973 document, including Isaac Asimov, Archie Bahm, and Lester R. Brown of the World Watch Institute. Likewise, the 1933 original Manifesto was not without occultist input. Olive L. Reiser, a Lucis Trust activist, par excellance, appeared as a signer to that original declaration. This is all tangled up within the New World Order and Global Plan 2000 and One World Government as further projected forth under the United Nations via such as Donald Keyes. You are even going to find Reiser entangled in the West Coast "Simpson" murders. Shocking? No, not once you KNOW the Plan.

But let us backtrack a bit and refer to your old book of the Bible, Daniel, and see that he warned that the coming world dictator would not come initially with GUNS. The angel warned him instead:

'And in his estate shall stand up a vile person, to whom they shall not give the honor of the kingdom; but he shall come in peaceably, and obtain the kingdom by flatteries." Daniel 11.21

It comes right down to the real question being not whether there will be flatteries, but what form will they take? The central "flatter" the anti-christ and his followers employ is the same as that consistently employed by Satan in all past times; "thou shalt be as gods". From THE HOLOGRAPHY BOOK, by Jeff Berne, 1980.


