PAT ROBERTSON ADVOCATES STONING FOR UFO ENTHUSIASTS

In a recent pronouncement, television evangelist and head of the Christian Coalition, Pat Robertson, advocated death by stoning for UFO enthusiasts.

Freedom Writer magazine, in its July/August [1997] issue, mailed today, disclosed Robertson's statement. *Freedom Writer* is published by the Institute for First Amendment Studies, a group that monitors the [political] right.

Robertson used the news of the July 4th Mars landing to promote his extreme beliefs. A segment on the July 8, 1997 broadcast of *The 700 Club* featured news of the Mars Pathfinder mission. Employing the historical event as a starting point, the program delved into the

possibility of the existence of UFOs and space aliens.

While Robertson viewed the space program with suspicion, on a more serious note, he launched into a diatribe against those who entertain the existence of space aliens and UFOs. He said, in a rambling discourse, that if such things exist, they are simply demons trying to lead people away from Christ. According to Robertson, the threat is so serious that people who believe in space aliens should be put to death by stoning—according to "God's word".

"The *Bible* says the Earth belongs to man, but the heavens belong to the Lord," Robertson said.

"He has given us the Earth. He also warned, way back when Moses was writing down not only what is the *Ten Commandments*, but *Deuteronomy*, which is almost the Second Law.

"Here is what he said to the children of Israel about this whole matter:

"If there is found among you, within any of your gates which the Lord your God gives you, a man or a woman who has been wicked in the sight of the Lord your God, in transgressing His covenant, who has gone and served other gods and worshipped them, either the Sun or Moon or any of the hosts of heaven which I have not commanded you, and you hear of it, then you shall inquire diligently. And if it is indeed true and certain that such an abomination has been committed in Israel, then you shall bring out to your gates that man or woman who has committed that wicked thing, and stone to death that man or woman with stones." (*Deuteronomy* 17:2-5, NKJV)

"Now, that's what Moses said to the children of Israel about those who worship the Sun and the Moon and the hosts of heaven, because these things, at best, are lifeless nothings, or, if they are intelligent, they're demonic. And, yes, there is a host of heaven. There are angels and there are fallen angels. There is no question about it.

"Can a demon appear as a slanty-eyed, funny-looking creature? Of course he can, or it can. Of course they can deceive people. And if they can lead somebody away from the true God, or away from Jesus Christ, anyway it happens, it doesn't matter, you will lose your salvation. It doesn't matter how they get you. The question is, did they get you, and under what guise?"

"This is man in rebellion against God, who refuses to take God's Law. And God [*Not Aton!!—Maybe Jehovah?*] says, 'My covenant says you won't do this. And if I find anybody in Israel'—which is his pure nation—'If I find anybody in Israel that's doing this sort of thing, then I want you to take him out and dispose of him.'

"It's a clear violation of God's word."

Skipp Porteous, *Freedom Writer* publisher, commented: "As the founder and chairman of the Christian Coalition—a group dedicated to becoming the most powerful political force in America—Robertson's extreme ideas need to be taken seriously, for they not only negate pluralism, but condemn to death those who dare to believe differently."

POISONING WATER

Excerpted from *THE MODESTO BEE*, 6/16/98: [quoting]

A new report from federal scientists reinforces fears that California is poisoning its water in an effort to clean its air.

Lawrence Livermore National Laboratory scientists found that MTBE, a chemical widely added to California gasoline since 1992 to cut toxic auto emissions, has contaminated groundwater at more than 10,000 sites, persists longer and spreads faster than plain gasoline and may prove a "cumulative contamination hazard" as it builds up in groundwater.

Groundwater provides 40 percent to 60 percent of the state's water supply.

Despite concerns raised by the report released last Friday, state water officials say their hands are tied: The federal Clean Air Act requires the use of chemicals such as MTBE—a suspected human carcinogen—to cut smog and other pollutants. What they can do, they say, is try to keep buried gasoline storage tanks from ever leaking MTBE.

But that effort, too, promises to come at a cost: Hundreds of independent gas station owners, mostly in rural areas, are expected to close next year because they can't meet a December 22 deadline—set a decade ago—to replace or upgrade underground tanks.

In the Modoc County town of Likely, population about 200, John Abbate already has shut his gas station and yanked the tank. He said he couldn't afford the \$40,000 upgrade.

"Little mom-and-pop operations are in very serious trouble," said Abbate. [End quoting]

This really isn't about cleaning up the air. If the elite really wanted to clean up the air or the ground and water, one of the highest priorities would be to stop the nuclear bomb testing and the use of nuclear energy. Pollution is big money, if you follow the money trail.

GLASS STRONGER THAN STEEL

From *POPULAR MECHANICS* magazine, July 1998: [quoting]

Scientists, perhaps acting more like alchemists, have mixed up a new metallic glass alloy that could be the multipurpose material of the future.

Promising improvements in products ranging from electric transformers to golf club heads. Metallic glass not only is stronger than normal metals, but also holds its shape better.

"Metallic glass is at least 10 times more elastic than metal," says Todd Hufnagel, a Johns Hopkins University researcher.

Metallic glass forms when molten metal cools without crystallizing. Like window glass, atoms arrange themselves randomly. But metallic glass is neither transparent nor brittle.

The alloy could also offer new military applications, such as armor-piercing bullets. [End quoting]

ULTRA-TENSILE STEEL FOR TIRES

From *POPULAR MECHANICS* magazine, July 1998: [quoting]

Steel cord is replacing polyester as the reinforcement material of choice in the body plies of passenger car tires for the first time, says Goodyear.

The global tire manufacturer has developed a super flexible Ultra-Tensile Steel wire about twice as thick as a human hair (.007 in.). Six of them wound into a cord are so strong that they take the place of four individual polyester cords, which saves weight. And the Ultra-Tensile cord is 40% stronger than conventional steel wire used in tire belts. Goodyear claims 30% better treadwear.

Look for these all-steel tires in popular car sizes under the Aquasteel and Eagle F1 Steel model lines in regular and run-flat Extended Mobility Technology (EMT). On a related note, Goodyear says its new IMPACT (Integrated Manufacturing Precision Assembled Cellular Technology) manufacturing is 135% more productive, 70% faster and 43% more precise than today's processes. Bottom line: better tires. Goodyear's objective is to eventually use EMT to eliminate spare tires in 75% of all vehicles. [End quoting]

Sure would be nice not to have to lug around that spare tire. But they've been telling us for decades they were going to make tires so that we wouldn't need the space anymore.

YELTSIN PRESENTS NEW PUBLIC IMAGE

A Russian lawmaker has formally asked the nation's top investigator to look into whether President Boris Yeltsin has been replaced by a double, a newspaper reported Thursday.

Deputy Alexander Saly said the president's appearance and actions have seemed suspicious since his 1996 re-election, the daily *Moskovsky Komsomolets* reported.

"The difference between the pre-election Yeltsin and the post-election Yeltsin simply jumps out at you," the paper quoted Saly as saying.

Since his second inauguration, Yeltsin has fired most of his old staffers and installed new ones, the Communist Party deputy was quoted as saying.

Yeltsin used to hide his left hand, which is missing two fingers, but now displays it freely, Saly said.

And, Saly suggested, Yeltsin's daughter has become the president's official "image" maker—to advise the "new" Yeltsin how to walk and talk like the original, the newspaper said.

Saly, a member of the lower house of parliament's committee on elections, said he has backing within his party but acknowledged that the support from the leadership has not been particularly vocal.

The newspaper did not say when Saly filed

the request, or whether the investigator, the general procurator, has responded.

No one answered the telephone at Saly's parliament office late Thursday. A duty officer at the general procurator's office said he had no information about the report.

"Of course there are more than a few people in this world who see flying saucers every day, who contact the spirit world, who try to catch ghosts in their hands," the paper editorialized. "But usually, they are not deputies in the State Duma who write legislation and take part in the country's political life." [End quoting]

FDA ATTEMPTS TO COMPEL DESTRUCTION OF BOOKS

On Natural Herbal Supplement Stevia

"Freedom of the Press embraces the circulation of books as well as their publication." —from Judge's ruling in *Bantam Books v Sullivan* [1963]

DALLAS—May 26, 1998—In an unprecedented move, US Food and Drug Administration officials threatened legal action against Texas-based Stevita Co., importers of the sweet-tasting herbal dietary supplement, stevia—for distributing books and literature about their product.

The latest volley in a bitter battle has been fired at Texas-based Stevita Co. by federal Food and Drug Administration officials. The FDA, an agency of the federal government, is responsible for upholding the *U.S. Constitution* which guarantees freedom of speech and expression. This responsibility was drawn into question on May 19th when FDA Compliance Officer, James R. Lahar faxed a letter to Stevita Co. addressing the destruction of 2,500 books he deemed "offending", at a cost to the company well in excess of \$10,000. The letter further threatens that investigators will conduct a current inventory and "witness the destruction of the cookbooks, literature, and other publications for the purpose of verifying compliance" upon visiting Stevita Co. for a fourth time this year.

One of three books in question is *The Stevia Story—A tale of incredible sweetness & intrigue*, by Linda Bonvie, Bill Bonvie and Donna Gates with Foreword by James S. Turner, Esq. Ironically, Chapter Four of the book the FDA wants to destroy is titled: "What's wrong with the FDA?" An attempt to strongarm critics into silence—similar to book burnings in Nazi Germany? Oscar Rodes, President of the Stevita Company said the FDA ordered the action because the books contain general information that includes history, usage and scientific studies regarding stevia.

Currently, Federal law requires stevia herbal products can only be marketed as dietary supplements without any mention of having sweetening power.

NATIONAL HATE CRIMES WORKING GROUP, WHITE HOUSE CONFERENCE

In preparation for the first ever White House conference on hate crime held on November 10, 1997, the president said: "As part of our preparation for the new century, it is time for us to mount an all-out assault on hate crimes, to punish them swiftly and severely." This cabinet level conference on hate was attended by the country's top leaders: the president and vicepresident, the attorney general, most cabinet members, and a whole array of law enforcement representatives.

Mr. Clinton announced new federal initiatives to prevent and punish hate crimes. The initiatives focus on: expanding federal hate crimes legislation, ensuring effective enforcement of hate crimes laws, promoting information collection systems on hate crimes, and educating the American people.

IT'S NOT JUST FOR KIDS

From *Focus On The Family*, July, 1998: [quoting]

Charles Hobdy was once a business manager. He had a good job, made good money. Then he found drugs.

"I'd get a paycheck and then go spend it on drugs," he says. "Every dime of it."

Jeff Gordon was a corporate vice president. He also had a nine-year cocaine habit. When he received a job promotion and transfer, his friends gave him a significant going-away present: a package of cocaine.

Neither Charles nor Jeff fits the Stereotype of a drug user: They are not poor, they are not unemployed, not homeless. They are educated and successful. Jeff did not consider himself an addict; he was a "casual" user.

But there's no such thing as casual drug use. Here are some other lies to put to rest:

* Only kids abuse drugs.

* Drug abuse is primarily a problem of the poor inner-city neighborhoods and not of middle or upper-middle-class homes.

* Drug abuse is a "victimless" crime.

* "Good" Christians never have problems with substance abuse.

FACE REALITY

Consider this: According to the National Institute on Drug Abuse, if every worker between ages 18 and 40 were tested for drugs on any given day, between 14 percent and 25 percent would test positive. And according to the U.S. Department of Labor, each substance abuser costs a company \$9,660 per year.

"It's time to face facts," says Milton Creagh, the anti-drug speaker featured in Focus on the Family's "Masquerade" video, who encourages viewers to "take off the mask" about drug abuse among children and teens.

"In some ways the drug problem [among adults] is getting worse simply because it's an issue we don't discuss," he says. "I usually talk about illegal drugs, but if you add the legal drug of alcohol, then we've got a major abuse problem."

"When it comes to adults, we have an additional problem in that there are seniors abusing prescription drugs, which, again, people don't like to talk about, but it's reality," he says.

Focus on the Family has produced a new video with Milton, which addresses adult drug abuse. Called "Face Reality," it is intended to be used by:

* corporate executives, human resource departments and other groups that need a tool to help address adult drug abuse.

* physicians and therapists, church ministries, and other groups working with adult and family issues.

* family members and friends of adult substance abusers.

"By and large, when we talk about the drug problem, we don't talk about adults, we talk about kids," Milton says. "Usually, when we talk about drug prevention or early intervention, we're either talking about children, or we're talking about stopping drugs at the border."

"But we don't talk about intervention strategies or drug prevention regarding adults," he says. "Believe it or not, some people begin using as adults."

And make no mistake, he warns. Even "casual" substance abuse is everyone's problem.

"If I leave my home this afternoon with my kids in the car and a driver under the influence hits us and kills one of my children, the question is not, 'Was this his first time getting high?' It's irrelevant to me whether it was his first time or it was his 500th time. The relevant issue to me is that I've lost a child." [End quoting]

Probably why the elite don't publicize this hidden drug problem is because there is too

JUDGMENT TIME FOR STATE BAR

Restriction by governor on dues has group facing insolvency

The State Bar of California is in a jam, and not even the lawyers who belong to it are rushing to defend it.

As cop, tax collector and lobbyist for a profession held in low esteem by the public, the nation's largest state organization of lawyers has managed to offend practically everyone—chief among them Gov. Pete Wilson, who in fall stripped the bar of its authority to collect dues.

As a result, the bar has laid off most of its employees, stopped taking calls about incompetent or dishonest lawyers and is about to run out of money.

Wilson, a lawyer himself, is untroubled by the prospect. In vetoing the dues bill last October, the Republican said that the bar was "bloated, arrogant, oblivious and unresponsive" and that it meddles in liberal causes such as same-sex marriages, reduced drug penalties and racial diversity in law schools.

Now, whenever Wilson gets on a plane, "every lawyer gets on a conga line to high-five him for his efforts to reform the bar," Wilson spokesman Sean Walsh said. "There is no more good will left in the Legislature or the Governor's Office for the Bar."

The bar "got so big and so arrogant, that it deserved the dumping", said Joseph J. Malandra, a 28-year lawyer who has a one-person general practice in San Francisco.

He complained that he has to pay the same dues as the big firm, high-income lawyers, as well as escalating prices for the 12-hour, state-mandated, continuing-education course, a requirement he called useless.

The bar, with 160,000 members, is a victim of both its own missteps and problems not entirely of its own making.

Its mandatory membership rule, contained in the California Constitution and shared by many other state bars, was only a minor annoyance for most lawyers 15 years ago, when dues were under \$200.

But dues soared to \$458—more than twice the national average—after the bar, under pressure from the Legislature, overhauled its volunteer-run system of disciplining lawyers by hiring professional investigators and judges.

The bar's biggest political blunder was probably its endorsement of an unsuccessful bill that would have allowed bigger damage awards in medical malpractice cases. The move

only antagonized the medical profession and the insurance industry, which lobbied Wilson to veto the dues bill.

The governor's antagonism for the bar dates back to at least 1982, when as a Senate candidate he was censured by a bar group for threatening to lead a recall of the state Supreme Court if it overturned a crime initiative.

More recently, Wilson got angry when a bar commission that evaluates candidates for the bench gave an "unqualified" rating to his most recent Supreme Court nominee.

Two weeks ago, Wilson announced his terms for saving the bar. Among them: reducing dues to \$295 a year and transforming the bar's policy-making board into a body appointed by the governor. Wilson said the bar's functions should be limited to admissions, discipline and education, and it should drop political advocacy.

But bar leaders, joined by Democrats in the Legislature, rejected the proposal, saying that the dues cut would be crippling and that the change in the board would end the bar's 71 years of political independence.

"There is no place for politics in the administration of justice," said Marc Adelman, the San Diego lawyer who is serving a painful one-year term as bar president.

The bar's chief legislative ally, Assemblyman Robert Hertzberg, D-Van Nuys, said the impasse will probably continue until a new governor takes office next year.

In the meantime, the bar has virtually shut down its lawyer discipline system. Nearly 500 of the bar's 620 employees have gotten layoff notices, most effective next Friday. By mid-July, it said, the bar will run out of money and halt practically everything but testing and admission of new lawyers. [End quoting]

I'm glad to hear they are getting their actions cramped, but I'm not holding my breath for any real reforms until the whole ratpack of politicians are thrown out—just another fracas between the mobsters and we usually lose

SUICIDE PREVENTION

From *THE MODESTO BEE*, 6/16/98: [quoting] DEAR ANN LANDERS: I am an attorney who fights psychiatric malpractice. I've seen many families agonize over deaths that could have been prevented. While we have been told that no one is to blame when someone takes his or her own life, many deaths could be averted if mental health workers, physicians and families would simply stop, look and listen.

The American Foundation for Suicide Prevention says up to two-thirds of the people who commit suicide each year saw a medical doctor within a month of their death. Half of those patients killed themselves with medicines prescribed by their doctors. While the suicides of teenagers and members of minority groups are a serious problem, few people realize that fully one-third of all suicides are White men over 50.

Suicide is not a random act. Members of the medical and mental health communities must take notice of the changes that occur when a person is becoming suicidal. Physicians should be as aware of the symptoms of life-threatening mental illness as they are of signs of physical illness.

Families can be lifesavers, too. Seventy-five percent of all those who commit suicide give friends and family members some warning. If you see the danger signs, please take them seriously, and get help for your loved one right away. Those symptoms include:

1. Depressed mood or a dramatic loss of appetite and energy.
2. Talking about death and dying. Saying such things as "You'd be better off without me."
3. Demonstration of extreme anxiety, agitation or rage.
4. Excessive drug or alcohol use.
5. Planning for suicide, such as paying of debts, changing wills or giving things away.

The more we know about suicide, the better able we are to help potential victims seek another alternative. —Skip Simpson, Dallas

Dear Skip Simpson: You have written a letter that could save lives. If only those who are considering suicide could keep repeating to themselves "And this, too, shall pass"—and believe it, they just might crawl out of that deep, dark hole. [End quoting]

With a little more awareness many probably could be saved.

CITIZENS CAN SUE FEC

'WELCOME MAT' OUT FOR THUGS

Almost 400 rapists, murderers and other convicted criminals were allowed into Canada last year under special permits granted by Immigration Minister Lucienne Robillard.

According to the immigration minister's annual report tabled in the Commons, 4,059 minister's permits were issued in 1997. Of those, almost four of every 10 went to convicted criminals.

Opposition MPs and Tory Senator Donald Oliver were outraged that Canada is laying out the "welcome mat" for so many convicted felons.

"We should be keeping criminals out, not letting them in," Oliver said. "Is this the type of people we should be welcoming to Canada?"

Reform MP Deepak Obhrai said minister's permits for convicted criminals should be banned outright.

"These permits should not be allowed," Obhrai insisted.

'RIGHT TO KNOW'

Reform MP John Reynolds called on the minister to make public the details and names of these individuals so Canadians can assess for themselves whether they deserve to be allowed to come to Canada.

"Why don't we have a right to know who they are?" he asked. "Maybe there's a good reason they should come to Canada, but how do we know some of them aren't pedophiles. We don't even know where they go once they get here."

Robillard's report showed a total of 1,497 permits were issued to criminally inadmissible people, a decrease of 4.8% from 1996... [End quoting]

We speak of things great and things small and yet we cannot seem to resolve and merge the two greatest Truths of the universe—Spiritual Truth (Goodness) with Philosophies of LIVING, which are also only valid as Truths of Goodness. Why? Because Man wants always to hold power and control, wealth and position above all things and those things come with that which PURCHASES those false strengths. This segment of the series may seem somewhat fragmented to you, the reader, as the subject matter will, seemingly, jump around the map a bit. Go with it. We are dealing here with huge segments of time and the purpose is to pinpoint a few key historical items that may trigger some insight. With that in mind, let's start with another writing from Hatonn, this one from *Will The Real Anti-Christ Stand Forward, Please*: [Quoting]

GILGAMESH

Now, please harken up and hear me. The “tribes” of “Shem” which the modern “Jews” claim as their claim to the label “Shemite” (Semite) were the tribes actually from that

which were recognized as the “Bird Tribes”. You can, if you make the effort, find a historical being by the name of Gilgamesh who went in search of immortality. So many tales, in subsequent millennia, of demi-gods or heroes claiming such a status who have likewise gone to search for paradise on Earth, Raptures, MAGIC solutions to problems, etc., in an effort to reach the Celestial Abode of the REAL God(s)—come DIRECTLY from this “character”.

The epic adventures of Gilgamesh's search for immortality have become more useful than anything presented by the “Holies” (which are in no-wise HOLY) in searching TRULY for the Kingdom of God and immortality. However, this was denied by the LAW OF THE KING and therefore became mythology—in which belief got you DEADED.

I suggest, however, that the very tales of Gilgamesh have served the true adventurers and subsequent “searchers” and “seekers” to find the ancient landmarks by which the Land of the Living could be reached—and the way to it ascertained. Oh, indeed there are ones around today who retell the ancient history but they are ridiculed out of circulation.

Ah, indeed there exist the ancient geographic landmarks and the sought-for TUNNELS, corridors, air locks and radiation chambers—AND THE BIRD-LIKE BEINGS (not because they looked like birds but because they could fly and used craft that could soar within, to and from, the heavens within the COSMOS). They were and are referred to as Eagles. The remains are all right there to be seen and studied—except that they are now being destroyed as rapidly as possible.

It became confused through the centuries of passage as to EXACTLY where the truth resided about these “people” of the clouds, etc., but that is because this character, Gilgamesh, made more than one journey in his search. Much of this information is within the records of ancient Sumar. That is NOT, however, the ONLY

place—GOD IS BRILLIANT AND WOULD NOT LEAVE YOU WITHOUT THAT WHICH YOU NEED IF YOU BUT REACH OUT AND TAKE IT. You will find, however, that the ancient land to which we here refer was called Tilmun. IT WAS ALSO KNOWN AS THE “PLACE OF THE SHEMS” (Riders of the Clouds!). I have often told you that I am not anti-Semitic (Shemitic), that I AM A SEMITE (SHEMITE).

Well, the myth goes that Gilgamesh culminated in the Land of Tilmun, an Abode of the Gods and a place of the Shems. It was there that he encountered an ancestor who had escaped mortality and had found the mysterious “plant” of eternal living. It is also there where other divine encounters, as well as events which affected the course of human history, occurred in LATER MILLENNIA.

There is historically recognized a place which was thought to be the *Duat, or Stairway, to Heaven*. What was actually recognized was the walkway to the CRAFT which landed there. Gilgamesh's first destination was to another place called the “Landing Place” and this was located on what was called (and records indicate identification as) “Cedar Mountain”. There was in ancient times a forest identified as Cedar Forest. The Sumarians constantly referred to a Cedar Forest, Cedar Mountain and even Cedar Land. Tilmun was only ONE such place whereat was a “Spaceport”! It was called “a place from which the Gods could scale the skies”.

Now it is going to get touchy, readers. There were found to be not only landing ports but at least two types of craft which used the ports. One type were “rocketships” which operated from Tilmun which the Sumarians called a MU, a “Sky Chamber”. However the “Nefilim” had a type of craft from which came a GIR (command module)—which the Egyptians called *Ben-Ben*. This command module could detach from the larger craft and fly in Earth's

skies. This was the MU.

The ancient peoples saw the GIRs in silos and often in flight but what they depicted in artform were more frequently the “Sky Chambers”—that which you would in today’s lingo refer to as UFOs. Jacob’s vision, for instance, included viewing of a Sky Chamber and referenced in mythology as Ishtar’s Flying Wheel which was also well-described as Ezekiel’s “Flying Wheel” of fire.

Drawings of these craft are scattered all about and around the River Jordan across from the ancient city of Jericho. It was this very type of craft utilized by Gabriel to take up Immanuel from the river at “baptism”. In that very location other things happened which are not offered to your INQUIRING minds—such as Elijah (prophet) being carried off heavenwards in what was described as a fiery Whirlwind—AT THE VERY SAME LOCATION.

WINGED GODS

Because of the capability of the “visitors” to walk or fly—the visitors were almost always depicted with “wings”. There is more to this than meets the eye in its original perception. Due to the high “frequency” makeup of the “visitors”, part of the directional propulsion system for mobility was accomplished with garments which would actually appear to be a type of “bat” wing. The transient “visitors” were more holographic in presentation than condensed MATTER which you would call density of flesh and bone. The structure was present but unnecessary. This did, however, cause early “depictors” (artists) to show “wings” to their “Eagles”. You can easily trace these very beings back into the history of the Judeans and even the Christians. There were fully recognized beings called Cherubim and ANGELS (literally meaning: MESSENGERS) of the “Lord”.

So, if you locate Tilmun you will have the location of that which was referred to as a “spaceport”. The Cedar Mountain was the location of the “landing place”, which was also referred to as the “Crossroads of Ishtar” or, the airport of the Gods. Gilgamesh knew of the latter and thusly headed first for that place.

Time quickly passes when you are having all this FUN so the challenge to ongoing seekers is to find where in the world are these places. Well we will let Tilmun go for the minute and look at possibilities for the Cedar Mountain.

There is one place to be predominantly considered and that is the area in Lebanon in which grow the giant cedar trees. There is a smaller place on the island of Cyprus where the cedars grow but it is hardly large enough to be considered. This is because of the proximity of “Lebanon” to other landmarks and known historical references.

Actually, the only place throughout the Near East which has such massive trees is in the mountains of Lebanon. These massive and majestic cedar trees can reach 150 feet in height and were and are repeatedly extolled in the Bible. Their uniqueness was known to the ancient peoples from the earliest times. (Remember that we are here referring only to the places of the East and Middle East. We aren’t even begun on the places in your modern recognition wherein the ANCIENTS still reside!)

Please refer to your history as offered in your *Bible*, to which you cling tenaciously, in which the Cedars of Lebanon are continually referred to as blessed and were utilized for the building of wondrous temples (god’s houses). Go look. You will find reference in *First Kings* in the chapters dealing with the building of the Jerusalem Temple by Solomon. At that time in history this GOD was referred to in the language of the region and day, as YAHWEH. The “house” was to be a place of abode while Yahweh would be staying in the area. It is said that Lord Yahweh suggested that the house be simply built of cedar as there were no substances recognized to match the flying craft.

This good old “Lord” knew all about the cedars and frequently employed them in his allegories, comparing rulers or nations to the cedar trees. Assyria, for instance, was called “a cedar in Lebanon, which had fair branches and a shadowing shroud and was of high stature—where waters nourished it and subterranean streams gave it height.” That is, until one day, it is said, that in wrath Yahweh toppled it and smashed its branches. Wouldn’t it be great to know all of THAT story? Further, it seems that MAN couldn’t cultivate the wondrous CEDAR and every effort failed to this day.

Could it be, readers, that THAT particular CEDAR only grew/grows in the “orchards of God”? and was planted for your use but not your understanding? Try the ancient REDWOODS, as well, as you look across your nations.

The forest in which grew the cedars extended many leagues and was tended and overseen by “Fiery Warriors” from “above”. Does any reader REMEMBER the Anunnaki? Ah, but you had better check on the Anunnaki for they BE YOUR ANCESTORS! IT IS AGAIN THE TIME OF THE ANUNNAKI!

WHAT HAPPENED TO GOOD OLD GILGAMESH?

Well, he found the “landing place” but like most ungracious visitors on Earth place, he thought he would just go in, take what he wanted and thus and so. It happens that the only one who was permitted to actually be within the place described was the King of Tyre. This gentleman was also given a ride in the “fiery stones” which flew as “Cherubs”. He, therefore, decided he would call himself a “flying god”. You can trace back his very statement about the incident: “A god I am. In the abode of the Deity I say, in the midst of the waters.” Throughout history—his EGO got the better of him. In fact there is a whole dissertation in the *Bible* about the king who tried to grow a cedar. Your Old Testament reports that he “carried off the twig to a land of commerce”, and planted the seed “in a city of merchants”. Such a land and such cities of merchants didn’t need to be sought for far in distance. Along the coast of Lebanon, from where Anatolia begins in the north to Palestine in the south, there were SEVERAL Canaanite (later to call THEMSELVES “Jews”) coastal cities whose wealth and power grew with their international commerce. Best known from biblical narratives were Tyre and Sidon; centers of trade and shipping for millennia, their fame reached its peak under their Phoenician rulers (Khazars by definition in the unfolding).

RUINS TO PROVE PASSAGE

There were ruins buried under a “mount” since its destruction by ASSYRIAN invaders. As a matter of fact, UNDER these ruins lay ANOTHER city which was a northern outpost of the Canaanites which was a border of the Hittite empire. Now, readers, this was uncovered in 1928, so don’t give me the old “It can’t be so!” And Uh-oh! The uncovering discovered the ancient city of Ugarit. Included in the “find” was a very large palace, a temple to the god BA’AL (called “The Lord”), and a whole variety of artifacts. Now we all know that Mr. Ba’al is not a very nice person to have around and is my very own ENEMY. The real treasures which were found, however, were clay tablets inscribed in an alphabetic cuneiform script written in a “Western-Semitic” language akin to biblical Hebrew. The tablets, whose contents were first presented by a man named Charles Virolaud, described the customs, life and gods of the Canaanites.

SO WE MOVE WITH THE “ELs”

It seems that at the head of the Canaanite pantheon was a recognized supreme deity called *El*. No, I do not refer here to little mystical elves who are supposed to do all the work in the New Age Movement. There ARE very definitely little life forms of EVERY LIVING THING which are the energy forms of that creation—human’s is called SOUL.

Let me not get ahead of myself here, so let’s continue about “El”. El became accepted in biblical Hebrew as a generic term for “deity” and it stemmed from the Akkadian word “Ilu”, which literally meant “Lofty One”. In the Canaanite tales of gods and men, however, El was the personal name of an actual deity who was the final authority of all affairs, be they divine or human. He represented the father of the gods, as well as *Ab Adam* (“father of men”); his epithets were The Kindly, The Merciful. He was “creator of things created” and the “one who alone could bestow kingship”. A stela (inscribed stone) found in Palestine depicted El seated on his throne and being served by some younger deity, probably one of his many sons. Ah, but depicted was El in a headdress which was conical and horned. That may well have been depicted as the mark of the gods throughout history in the ancient Near East but is false, for the cone and the horns were NOT either. Moreover the emblem of that day (not to be confused with the “emblems” of which we have spoken as being of the Secret Society) was of an omnipresent Winged Globe—or representation of the “Planet of the Gods”.

In those ancient days El was a representative of a deity of Heaven and Earth. There is still the honored title or label given to the “elders” of the Sky People and are used as Mr. or Sir would be utilized in your day, i.e.: *RaphaEL*, *MichaEL*, *GabriEL*, and thus and so. At that time, because *EL* was somehow not around very much, he is supposedly to have been in some kind of semi-retirement and quite aloof from daily affairs. Perhaps this is from whence comes the assumption that God (even though you pray for help on daily matters almost exclusively) is not supposed to ever actually respond!?!?. Now, let us consider how the

“aside” stories begin to defile the very existence of such as EL. IT IS NOW WRITTEN IN HEBREW TEXTS: *“There he sat in his pavilion, receiving emissaries, holding councils of the gods, and trying to resolve the recurring disputes among the younger gods. Many of these were his own children. El had at least 70 offspring it is said. Of them, thirty were by his official consort Asherah; the others, by an assortment of concubines or even by human females. ONE POETIC TEXT TELLS HOW TWO FEMALES SAW EL NAKED AS THEY WERE STROLLING ON THE BEACH; THEY WERE COMPLETELY CHARMED BY THE SIZE OF HIS PENIS, AND ENDED UP EACH BEARING HIM A SON.* (By the way, this tale of interesting but inaccurate revelation was extolled far and wide and ended him up depicted as a penile giant with wings on a Phoenician coin.) I can quite well assure you that being mostly etheric in form—a penis is of NO CONCERN among the Sky People, large, small or otherwise!

I find it interesting that you are forbidden, if you be Christian, to divert attention from the “Holy (which it is not) Book”. How then do you think history got completely distorted from onset? Man, even back then, tried to place GOD in his own image where the penis was his prized possession if a male and envied by all others (women).

Get this next offering: El’s principal children were three sons and one daughter: the gods Yam (Ocean, Sea), Ba’al (Lord) and Mot (Smiter, Annihilator) and the goddess Anat (She Who Responded). In names and relationships they clearly paralleled the Greek gods Poseidon (God of the Seas), Zeus (Lord of the Gods) and Hades (God of the Lower World). Ba’al, as Zeus, was always armed with a lightning-missile, the bull his cult symbol. Remember the myths: When Zeus fought Typhon, it was his sister Athena, goddess of War and Love, who alone stood by him; and in Egyptian tales, Isis alone stood by her brother-husband Osiris. So it was when Ba’al fought his two brothers, his sister-lover Anat alone came to his help. Like Athena, she was on the one hand “The Maiden”, often flaunting her naked beauty and on the other hand the Goddess of War, the lion a symbol of her bravery. The Old Testament called her Ashtoreth.

Now it begins to look pretty suspicious, does it not? It becomes quite EVIDENT that from time beginning for your species—the ENEMY of TRUTH IN LIGHT was put aside for the LIE of that which would present negative attitudes and human physical expressions to your people. Were these REAL? OF COURSE! This element of life-experience moved right on into the Egyptian acceptance.

The links to Egyptian prehistorical recollections and beliefs were no less obvious than to those of Greece. Osiris was RESURRECTED by Isis AFTER SHE HAD FOUND HIS REMAINS IN THE CANAANITE CITY OF Byblos.

Likewise, Ba’al was brought back to life by Anat after he was smitten by Mot. Seth, the adversary of Osiris, was sometimes called in Egyptian writings “Seth of Saphon”; Ba’al, as it shall come to be seen, acquired the title “Lord of Zaphon”. Egyptian monuments of the NEW KINGDOM—which paralleled the Canaanite period—depicted the Canaanite gods

as “Egyptian” deities, calling them Min, Reshef, Kadesh, Anthat, and so on. You will find the SAME tales applying to the SAME gods, but under different names, throughout the ancient world. And so it goes right up through TODAY.

So where did the myths come from? From the ancient tales which were in the beginning—from the Ancient Sumarians. Not only are there tales of Man’s search for immortality, but also of love, death and resurrection among the people and the “gods”. These ancient teachings also fill the Old Testament **but it was not until later that the Talmud would be presented by MAN as from the El-ders of Zion in Protocol, for the resurrection of the original false “RELIGION” of what came to a people who were not, but called themselves, “Jews”.** How think you that the translations COULD NOT be tampered and made fitting for a planet which would fall to the lordship and controlling ownership of the physical expression? It has ALWAYS been thus. It certainly did not require much imagination to label a man by another name than his own and offer REVELATIONS which would destroy or bring under TOTAL control of the Adversary to God Creator, the nations of the planet.

It is from the ancient tales that comes the fact of the history of the area of the Negev, for instance. One such text tells the tale of DANIEL (El’s judge and Daniel of the Old Testament.) This was reference to “greater Canaan”. This was a righteous chieftain who could not beget a rightful heir. He appealed to the gods, it is told, to give him one, so that when he died, the son could erect a carved statue in his memory at KADESH. From this it is surmised that the area of the tale’s events was where southern Canaan (*the Negev*) merges into the Sinai Peninsula, for it was there that Kadesh (The Sacred city) was located.

So we move into historical relevance. Kadesh was encompassed in the territory of the biblical Patriarch Abraham; and the Canaanite tale of Danel is indeed replete with similarities to the biblical tale of the birth of Isaac to the aging Abraham and Sarah. Much as in the Book of Genesis, where you read in the Canaanite tale that Danel, getting on in years without a male heir, saw his chance to get divine help when two gods arrive at his dwelling. This picture is getting “testy” now, is it not? “Forthwith...he gives offering to the gods to eat, gives offering to drink to the Holy (who were certainly NOT) Ones.” The “divine” guests—turned out to be El, “the Dispenser of Healing”, and Ba’al (representative of the “Devil”). They stayed with Danel a week, during which he overwhelmed them with his supplications. Finally Ba’al approached El with his (Danel’s) plea. And so it went.

As we write more on this particular subject we will find that the Creator GOD was recognized in goodness and AS the “Sun”. There was, indeed, another lesser one called the “Moon God”—KNOWN AS “SIN” (actually in Sumarian it was called by the name Nannar). [End quoting.]

*Time present and time past
Are both perhaps present in time future,
And time future contained in time past.*

Let’s change the pace (and historical sequence) for a moment and consider this Sufi story, as presented by Idries Shah in *Tales Of The Dervishes: Teaching-Stories Of The Sufi Masters Over The Past Thousand Years*. [Quoting:]

THE SNAKE AND THE PEACOCK

One day a youth named Adi, The Calculator—because he had studied mathematics—decided to leave Bokhara and seek greater knowledge. His teacher advised him to travel southwards, and said: “Seek the meaning of the Peacock and the Snake;” something which gave young Adi a great deal to think about.

He travelled through Khorasan and finally to Iraq. In the latter place he actually came across a place where there was a peacock and a snake, and Adi spoke to them. “We are having a discussion,” they said, “about our relative merits.”

“This is just what I want to study,” said Adi, “so pray speak on.”

“I feel that I am the more important,” said the Peacock. “I represent aspiration, flight into the heavens, the celestial beauty, and hence knowledge of the higher things. It is my mission to remind man, by mime, of aspects of his self which are hidden to him.”

“I, on the other hand,” said the Snake, hissing slightly, “represent just the same things. Like man, I am bound to Earth. This makes me remind him of himself. Like him, I am flexible, as I wind my way along the ground. He often forgets this, too. In tradition, I am he who stands guard over treasures, hidden in the Earth.”

“But you are loathsome!” shouted the Peacock. “You are sly, secretive, dangerous.”

“You list my human characteristics,” said the Snake, “while I prefer to list my other functions, as I have already done. Now look at you:

“You are vain, over-plump, and have a harsh cry. Your feet are too big, your feathers too well-developed.”

Adi interrupted at this point. “It is only your disagreement which has enabled me to see that neither of you is altogether right. And yet we can clearly see, if we take away your personal preoccupations, that *together* you make up a message for mankind.”

And Adi, while the two opponents listened, was able to explain to them what their functions were.

"Man crawls on the ground like the Snake. He could rise to the heights like a bird. But, just as the Snake is covetous, he retains this selfishness when he tries to rise, and becomes like the peacock, over-proud. In the peacock we can see possibility of man, but not properly achieved. In the Peacock we see it taking a flamboyant turn."

And then a Voice from within spoke to Adi and told him: "That is not all. These two creatures are both endowed with life: that is their determining factor. They fight because each has settled for his own kind of life, thinking it to be the realization of a true status. One, however, guards treasure and cannot use it. The other reflects beauty, a treasure, but cannot transform himself with it. In spite of their not having taken advantage of what was open to them, they yet symbolize it, for those who can see and hear." [End quoting.]

Again, keeping in mind that everything is connected, let me share several segments from differing sources, spanning differing periods. The correlation will become evident when all the pieces are present.

CURSE OF CANAAN

In Eustace Mullins' classic *The Curse Of Canaan—A Demonology Of History*, we read: [Quoting]

Unfortunately for humanity, this was not the end of the matter. Satan, through his children the Nephilim, and also through Cain, had now established a demonic presence on the Earth. His rebellion against God would result in continuous suffering and travail on Earth for centuries to come. The history of mankind since his rebellion is the history of the struggle between the people of God and the Cult of Satan. With this understanding, it is now possible to trace the historical events which reveal the actual archives of the two adversaries.

The *Book of Zohar* stresses the Talmudic legend that demons originated in sexual congress between humans and demonic powers. This offers a reasonable explanation as to why all occult ceremonies stress three things: drugs, incantations (which express hatred of God) [and also invoke a trance-like state], and bizarre sexual practices.

The study of demonology in history discloses answers to otherwise inexplicable aspects of man's history. The torture and murder of children, obscene rites, and mass killings of innocents in worldwide wars, as well as other catastrophes, are phenomena which bear little or no relation to mankind's day-to-day routine of tilling the soil, raising families, and maintaining the standards of civilization. On the contrary, these types of calamities are direct assaults on the normal existence of humanity. Furthermore, they are expressions of the rebellion against God, as attacks on His People.

Because of their extraordinary powers, demons have always attracted a certain number of followers on Earth. "Secret" organizations, which insist on concealing their rites and their programs from all "outsiders" must do so in order to prevent exposure and the inevitable punishment. While they were wandering in the desert, the Jewish tribes worshipped demons and monsters. They revered their mythical monsters, Leviathan, Behemoth, and Raheb, who well may have been survivors of the tribe of giants, the

Nephilim. They also made sacrifices to the demon of the desert, Azazel.

Their mythology developed a certain hierarchy of demons. A Demonarch, who presumably was Satan, ruled over all demons on Earth. He was also known as the Prince of Evil, Belial (the Hebrew Be'aliah, meaning Yahweh is Baal). Next in the hierarchy of demons was Asmodeus, King of the Demons, and his wife, Lilith, chief demoness of the Jews. Lilith is well known today as the patron goddess of the lesbians. [End quoting.]

SCOTLAND

Turning now to a small booklet titled *The Holy Land Of Scotland: The Lost Chapter In The Gospel Of The Grail Tradition*, written by Barry Dunford, we read: [Quoting]

In ancient Celtic 'mythology' Fingal was a Giant, perhaps a descendant of the 'Giants of Old' who were believed to be contemporaneous with the ancient lost Lands of Atlantis. It has been suggested that this Giant race may have possessed an ancient knowledge and technology in connection with the Earth's energy Ley Grid and Chakra Systems.

In *Britain—The Key To World History*, the author, Comyns Beaumont observes: "The famous *Egyptian Book of the Dead*, influenced completely by the epic of the Flood and composed in the name of Thoth (Hermes), in its ritual caused the souls of the dead to undergo a fanciful, final, gloomy pilgrimage to the sacred west, indeed, I contend, to the very scene of the former shambles in Western Scotland, to the legendary Amenta, identified as the tiny island of Staffa, near Iona, in the Hebrides, where the wandering spirits were supposed to be judged by Osiris, and were rewarded or consumed according to their lives on Earth. Staffa lay in the very cortex of the greatest area of destruction at the time of the Flood—water being but one element concerned—and later became the Underworld of the Celts as it was of the Hellenes."

In Glenlyon, Perthshire, are to be found the remains of what are said to have been twelve Fingalian forts. One can but wonder whether the remarkable Glenlyon, with the River Lyon cutting through it, might be the real basis for the fabled "Lane of Lyonesse" linked with the folk history surrounding King Arthur of Grail fame. Certainly there are place names in parts of Perthshire, including *Tirarthur*, near Killin, on the fringe of Glenlyon, which indicate an Arthurian influence and possible origin. Moreover, according to Isobel Hill Elder in *Celt, Druid and Duldee*: "King Arthur, it is said, modelled his Round Table Fellowship on the Table of the Last Supper. As a descendant of Joseph of Arimathea, who led a company of persecuted Christians—Judean refugees, or Culdees—to our shores, the details of those early days would be, to Arthur, family history, for most, if not all of his knights, were of the family of Joseph." [End quoting.]

TYPHOEUS

Shifting our attention now to Zecharia Sitchin's *The Wars Of Gods And Men*: [Quoting]

All this did the Thunder-Stone of great Zeus bring about. And when the two contending

camps heard and saw what had happened, "an horrible uproar of terrible strife rose; mighty deeds were shown; and the battle inclined." The fighting was abating; for the gods had the upper hand over the Titans.

"Insatiated for war," the three Cyclopes set upon the Titans, overpowering them with hand-held missiles. "They bound them in bitter chains," and hurled them into captivity to far Tartarus. "There, by the counsel of Zeus who rides the clouds, the Tital gods are hidden under misty gloom, in a dank place at the ends of huge Earth." The three Cyclopes stayed there, too, as "trustworthy warders of Zeus", to watch over the imprisoned Titans.

As Zeus was about to claim "the aegis", the suzerainty over all the gods, a sudden challenger appeared on the scene. For, "when Zeus had driven the Titans from heaven, great Gaea bare her youngest child Typhoeus of the love of Tartarus, with the aid of golden Aphrodite." Typhoeus ("Typhon") was a real monster: "Strength was with his hands in all that he did, and the feet of the strong god were untiring. From his shoulders grew an hundred heads of snake, a fearful dragon, with dark, flickering tongues. From under the brows of his eyes, in his marvellous heads, fire flashed; and fire burned from his heads as he glared. And there were voices in all his dreadful heads, which uttered incredible sounds": the sound of a man as he speaks, and the sound of a bull, and that of a lion, and the sound of a puppy. (According to Pindar and Aeschylus, Typhon was gigantic in height, "and his head reached to the stars".)

"Truly a thing past help would have happened on that day," the Muses revealed to Hesiod; it was almost inevitable that Typhoeus "would come to reign over mortals and immortals". But Zeus was quick to perceive the



danger and lost no time in attacking him.

The series of battles that ensued were no less awesome than the fighting between the gods and the Titans, for the Snake-God Typhon was equipped with wings and could fly about just as Zeus. "Zeus thundered hard and

mightily, and the Earth around resounded terribly, as did the wide heaven above and the sea and the watery streams, even the nether parts of the Earth." Divine Weapons were again employed—by both combatants:

*Through the two of them,
through the thunder and lightning,
heat engulfed the dark-blue seas;
And through the fire from the Monster,
and the scorching winds and blazing
Thunderbolt,
the whole Earth seethed, and sky and sea.
Great waves raged along the beaches...
And there arose an endless shaking.*

In the Lower World, "Hades trembled where he ruled"; tremble did the Titans imprisoned at the ends of the Earth. Chasing each other in the skies and over land, Zeus managed to be the first to achieve a direct hit with his "lurid Thunderbolt". The bolt "burned all the marvelous heads of the monster, all that were around him"; and Typhoeus crashed down on Earth in his marvelous contraption:

*When Zeus had vanquished him
and lashed him with his stokes,
Typhoeus was hurled down a maimed wreck.
The huge Earth groaned.
A flame shot forth from the stricken lord
in the dim, rugged, secluded valley of the
Mount,
when he was smitten.
A great part of huge Earth was scorched
by the terrible vapor,
In the glow of a blazing fire
did the Earth melt down.*

In spite of the crash and the tremendous impact of Typhon's vehicle, the god himself remained alive. According to the *Theogony*, Zeus cast him, too, "into wide Tartarus". With this victory his reign was secure; and he returned to the important business of procreation, bringing forth progeny by wives

and concubines alike.

Though the *Theogony* described only one battle between Zeus and Typhon, the other Greek writings assert that that was the final battle, preceded by several others in which Zeus was the first one to be hurt. Initially Zeus fought with Typhon at close quarters, using the special sickle his mother had given him for the "evil deed", for it was his purpose also to castrate Typhon. But Typhon enmeshed Zeus in his net, wrested his sickle away, and with it cut out the sinews of Zeus' hands and feet. He then deposited the helpless Zeus, his sinews, and his weapons in a cave.

But the gods Aegipan and Hermes found the cave, resurrected Zeus by restoring his sinews, and returned his weapons to him. Zeus then escaped and flew back "in a Winged Chariot" to Olympus, where he acquired a new supply of bolts for this Thunderer. With these Zeus renewed the attack on Typhon, driving him to Mount Nyssa, where the Fates tricked Typhon into eating the food of mortal men; whereupon he was weakened instead of being strengthened. The renewed fighting began in the skies over Mount Haemus in Thrace, continued over Mount Etna in Sicily, and ended over Mount Casius on the Asiatic coast of the eastern Mediterranean. There Zeus, using his Thunderbolt, shot Typhon down from the skies.

The similarity between the battles, the weapons used, the locations, as well as the tales of castration, mutilation, and resurrection—all in the course of a struggle for succession—convinced Herodotus (and other Greek classical historians) that the Greeks had borrowed their theogony from the Egyptians. Aegipan stood for the African Ram God of Egypt, and Hermes paralleled the god Thoth. Hesiod himself reported that when Zeus came unto the mortal beauty Alcmena so that she might bear him the heroic Heracles, he slipped at night from Mount Olympus and went to the land of Typhaonion, resting there atop the *Phikion* (The Sphinx Mountain). "The deadly Sphinx that destroyed the *Cadmeans*" ("The Ancients"), which featured in the doings of Hera, the official spouse of Zeus, who also connected in these legends with Typhon and his domain. And Apollodorus reported that when Typhon was born and grew to an incredible size, the gods rushed to Egypt to take a look at the awesome monster.

Most scholars have held that Mount Casius, the site of the final battle between Zeus and Typhon, was located near the mouth of the Orontes River in today's Syria. But as Otto Eissfeldt has shown in a major study (*Baal Zaphon, Zeus Kasio und der Durchgang der Israeliten durchs Meer*), there was another mount called by that name in antiquity—a promontory on the Serbonic Sealet that juts out of the Sinai peninsula into the Mediterranean Sea. He suggested that that was the mount referred to in the legends.

Once again, all one had to do was to trust the information given to Herodotus in Egypt. Describing the land route from Phoenicia to Egypt via Philistia (*History*, Book III, 5), he wrote that the Asian lands "extend to Lake Serbonis, near the place where Mount Casius juts out into the sea. Egypt begins at Lake Serbonis, where the tale goes that Typhon hid

himself." [End quoting.]

RETURNING TO THE CURSE OF CANAAN

Turning, once again, to Mullins' *The Curse Of Canaan*, we read: [Quoting]

In *Cabala* [Footnote: *Cabala* appears in various spellings through history, principally "Cabala". Also *Kabbalah*, *Kabala*, etc.] evil takes on a mysterious existence of its own, which its precepts trace back to the physical appearance of life on Earth, or Adam. *Cabala* claims that Adam throws the entire stream of life out of balance, and that the Church, or Christianity, by formalizing the physical existence of the Adamite people on Earth, have become a problem which must be resolved. This is the essence of the basic anti-life principle underlying all *Cabala* and its heir, Freemasonry. These precepts declare that Satanism will achieve its final triumph over the Church and Christianity, thus ending the "dualism" of this world, the struggle between good and evil. In short, the problem of good and evil will be ended when evil triumphs and good is eliminated from the Earth. This program may sound somewhat simplistic, but it is the basic premise of the *Cabala* and Freemasonry.

These anti-life precepts are now to be encountered, and dealt with, in many of the developments of our civilization. The descendants of the Canaanites instinctively hate and actively oppose such progress as technology, urban life, industrialism, and the cultural achievements of humanity. Their basic goal is to return the Earth to the primitivism of its pre-Adamic state, when a Neanderthal type of human roamed at will over an Earth which had no "civilized" aspects to remind him of his primitivism. The end purpose is to "restore" pre-Adamic man, so that Adamite man, as a creation of God, no longer presents an obstacle to Satan and his rule over this world. Thus cabalistic Freemasonry aims for the extermination of life as we know it, culminating in the final triumph of the Canaanite Curse of this Earth. In retrospect, this amazing observation offers an irrefutable reason for the otherwise inexplicable massacres, wars, and human devastation which have been regularly visited upon a long-suffering humanity by the Canaanite conspirators.

[Still quoting, later on:]

In Masonic symbolism, the Rainbow appears as the sacred depiction of Lucifer, the Light Bearer, and it indicates his Brightness. On Masonic diplomas is inscribed the verse, "And God said, Let there be Light, and there was Light." In fact, the use of God's name here is a typical subterfuge whose true meaning is known only to the higher degrees of Freemasonry, the occult degrees, and is an example of the internal deception by which the occult degrees rule the fellow crafts. Lucifer is the true name of the being whom they worship as a god, as their mentor, Albert Pike, made plain in his communications to Mazzini and other Masonic leaders.

The symbols of Freemasonry, to those unaware of their cabalistic meaning, may seem innocuous enough, particularly to the great majority of Masons, the members of the three degrees of the Blue Lodges. They are never

informed that the "All-Seeing Eye" of their symbolism refers not to sight, but to the genitals, the Eye of Hoor, which is the anus, and which signifies the homosexual or bisexual commitment of our present ruling class, the World Order of the Canaanites. "G" stands for both Generation, or the act of coitus, and for Gnosticism. It also glorifies the Great God Baal, and the missing part of his anatomy, the phallus, which according to the legend of Set and Nimrod, had been removed.

[Still quoting, somewhat further along:]

The Masonic points are derived from the ancient Mysteries, the triple degrees of the system correspond to the mysteries of Serapis, Isis, and Osiris. The entered apprentice is referred to the three lights, Osiris in the East, Isis in the West, and Horus, who was master, or living lord in place of Osiris, in the South. [End quoting.]

SYMBOLISM

As we look to *Sex, Symbolism, And The Stars* by Ernest Busenbark, with introduction by Jordan Maxwell, we read: [Quoting]

One type of myth frequently found in Babylonian and Egyptian literature introduces a figure which symbolizes evil in every part of the world. Here the gradual disappearance of the Moon in the last half is represented as being due to its being swallowed by a serpent. In Sun worship the serpent becomes a water dragon or crocodile which swallows the setting Sun as it sinks into the sea.

During eclipses the Chinese rent the air with cymbals, trumpets, and clanging instruments to frighten away the dragon which they believed was swallowing the Moon. It was from this superstition that the ascending node of the Moon was called "the head of the dragon" and the descending node became known as "the tail of the dragon". In India there is a myth which tells how Vritra or Ahi, the serpent of night, was vanquished by Indra, a great Sun god. This myth may allude to the bright light of the Sun overcoming the constellation of the Dragon in the northern heavens.

[Still quoting, a different section:]

In Spain and certain other Spanish-speaking countries, the fear and superstition regarding them is so great that the word "snake" is never spoken. When superstitious natives wish to speak of this reptile, it is indicated by making a wriggling motion with the hands. Yet, serpents were anciently esteemed as guardians of graves, sanctuaries, and households and were kept or represented there—by symbol. They were considered to be the embodiment of wisdom, and the water god Ea, of the ancient Sumerians, was commonly called a "serpent god". They were also identified with sacred groves and tree worship, and ancient tablets and seal cylinders which picture the tree of life almost invariably show a serpent near, or coiled around, the tree.

In China, the dragon is a symbol of clouds, floods, rain, and the gods of water. Clouds are called the breath of the dragon and when it rains, the dragon is said to be in the sky. The dragon is one of the four sacred animals in China and represents royalty, power and sovereignty. The throne upon which the emperor formerly sat was called the throne of the dragon and a yellow dragon was

embroidered on his robe. [End quoting.]

LETTER FROM A READER



"Magnus Ab Integro Saeclorum Nascitur Ordo", truly meaning, "Greater (the God-Lucifer/Satan—same call as Eye of Horus) Than Sacred Integrity Of The Order Of Nature"! The 13 layers of stones stands for the "13 Tribes" (excused by Ezek. 48:13), but in fact incorporating Khazars! We know the meaning of the Roman numerals 1776 and also the May 1st of Adam Weishaupt's Illuminati Order...The 72 stones stand for the Gematric "Abra-ca-Dabra" [.-I=10; ..-Hi=15; ...-VHI=21;-HVHI=26; = 72 — IHVH], "The Great Name of God"...

See *Talmudic Gematria* of Rodkinson's translation, but also the book *May 5th, 2000*. I forgot the author, who confirmed the same as Rodkinson translated about 90 years ago!

THE LOST TRIBES

Turning now to *The Dark Side Of The Force, Part 1: A Historical Overview of the Occult Conspiracy*, by "DEG", which appears in *Interesting Dark Games From The Dark Side*, a Phoenix Journal, we read: [Quoting]


And what became of the ten-Tribed Israelites in Samaria and surrounding areas in the north of Israel? As briefly alluded to earlier, after forty years of taxation and harassment by the Kings of Assyria, in 703 BC these now demoralized people were finally attacked in force and bodily *hauled away* into the Assyrian Captivity, much further north and east from their native lands, and were subsequently *lost* to Bible history. But these same Israelite Samaritans, who were held captive by the Assyrians (who *themselves* descended from Asshur, one of the five sons of Shem) in Gamir, would then be referred to by *secular* historians as the **Gamira** (or Gimira), a host of people from Urartu who, as recorded in the archives of Assyria, had escaped their captors circa 700 BC and fled farther north and then west (later led in 679 BC by a warrior named **Tuespa**). While these Israelites would travel to the shores of the Black Sea known as the Kimmerioi, Cimmeri or **Cimmarians**, a larger body of the Gamira/Israelites were forced to form an alliance with King Esarhaddon when he came under attack by the Medes and Persians from the east. The first group would be later forced out of the Crimea to the region of Lake Van in Armenia (close to Mount Ararat), and from there they would sweep westward across Asia Minor in 645 BC to Sardis, in Lydia (modern Turkey). In the meantime, the second group of Israelites would break into two sub-groups and establish colonies in Sacasene and Bactria, to be known thereafter as the Sakka (or Sacae) and as the Massagatae (later, the Sagatae or **Gauthie**). Driven out of Asia Minor circa 600 BC, the first group now settled in the Carpathian regions west of the Black Sea, to become known as the **People of Ar-Sareth** (*II Esdras 13:40*). A decade later these Cimmarians came in conflict with the Japhetic Scythians, a vastly larger and fiercer tribe of devil-worshippers who drove them further west and north, where they were forced to split into three divisions, sub-groups we know now as the **Celts, Gauls** and **Cimbri**. While the first two would in 390 BC invade and sack Rome, going on to settle by 150 BC in Galacia (early France), the Cimbri would, around 102-101 BC, be defeated in a major battle by the Roman General Marius. By the Second Century AD, the Cimbri would be known to their Roman enemies as the **Teutons**. The name **Teuton** derives from the Battle of Teutoburg Forest in present-day Westphalia, NW Germany, in AD 9, where the Roman General-Governor Varus and his three legions of 15,000 soldiers were defeated by Arminius and his Germanic Cimbri, who had teamed up with their cousins, the Massagetae, or Getae (then known as the Goths, a word meaning "nobly born"). This latter group had settled the country of Gotland (Sweden) but would later become divided into Eastern and Western branches. The **Teutons**, due to their increasing numbers and sibling rivalry, *again* subdivided into smaller groups, among them the: Goths (Ostrogoths & Visigoths), Vandals,

Burgundians, Franks, Alemanni, Angles, Saxons, Jutes, Quadi, Marcomanni, Chatti, Batavi and Suebi, incredible as it all sounds. These Israelite/Cimbri/Teutons were all collectively known as **Arians**, as opposed to the Japhetic Aryans, and thus the confusion between the two races by most historians. But let's get back now to the Jews, and *their* history.

Although it would be much later **excised OUT** by the *King James Version* of the *Holy Bible*, the Sephardic descendants of Shelah would go on to centuries later become the troublesome and bloodlusting **Scribes** and **Pharisees**, the Rabbinical members of the **Grand Sanhedrin**, who would go out of their way to persecute and then crucify Jesus, the Christ, some twenty-four generations later on in time. The founder of Rabbinical Judaism was **Akiba Ben Joseph**. Many of these devil-worshipping people, like King Herod who ruled over them, had the tainted blood of the accursed Edomites and Canaanites flowing through their veins, due to generational intermarriage with these people. In his *History and Destiny of the Jews*, Josef Kastein described Herod as "a bestial and tragic half-caste". As a direct consequence of all the foregoing, these Sephardic "jews", or at least the great majority of them who had further been corrupted by the unholy *Talmud* during their sojourn in Babylon years earlier, from 586 to 538 BC, were destined to be driven among the nations, "a curse and a byword", a truly strange and haunted people referred to in parable by Jesus **SANANDA** as the "evil figs", and as "a generation of vipers". For they were indeed the **Snake People**, a **Serpent Race**, those of the Synagogue of Satan! And Jesus certainly knew full well whereof He spoke. **HE was born a Hebrew-Israelite of Divine origin, from the "stem of Jesse"**, and was most assuredly anything **but a Jew**—as most people have been led to believe since King James I altered the word of God. What's more, eleven of His disciples were of the Tribe of **Benjamin**, and **none of them were Jews either**. Only the man who *betrayed* Jesus was a Jew, a zealot who did what he did for money.

Moreover, Jesus did not come into this world at this time to convince these particular Edomite-Sephardis of **anything**; he came primarily to minister to "the Lost Sheep of the House of Israel", God's Covenant people, those who had lost their identity and were then scattered far and wide across the world. Thus, this **myth** of Judeo-Christianity is an **oxymoron** of the most blatant and blasphemous sort.

Following the destruction of Jerusalem and the now totally debased Temple of Solomon/Herod in AD 70, by the Roman legions of Titus (as *prophesied* by Jesus exactly forty years earlier), there followed the **Diaspora**, or dispersion of the Pharisaic Sephardics and Edomites from this now **unholy** land. And as History records, the badly mauled Jewish survivors fled in all directions: to **Egypt**, where in Alexandria their numbers soon rose to 1,000,000 and their Rabbis intermingled with the evil **Amun Priesthood** (worshipper of the demonic Goat of Baphomet, in their Temple at Karnak); to **Babylon**, where four centuries later (on December 2, AD 499) they would complete the *Talmud*, and thus bring their Antichrist Talmudism into full force during the Dark Ages; to **Rome**, where they would soon take over the slave trade and the money exchanges, as well as set up their own courts—and eventually become a deciding factor in the decay and collapse of the Roman Empire in AD 476 (read Gibbon's 7-volume history) to **North Africa**, where in AD 711 they stirred up and helped pave the way for the Moorish invasion led by General Tarik across the Mediterranean into Spain, resulting in Spain's total mongrelization (and subsequently into Portugal and France from that base on the Iberian Peninsula) and into **Turkey** and **Greece**, where they would come to intermarry with the **Anatolians** then living in Eastern Turkey (descendants of Japheth through his grandson Togarmah, and **his** son Uigur), as well as the **Royal Scyths** living in Western Turkey (descendants of Togarmah's son Basilli). The ancient Greeks wrote of savage horsemen from Scythia (Sarmatia) who devoured strangers and used their skulls as drinking cups. In the



port city of Alexandria in northern Egypt, where then stood a magnificent Library from the ancient world containing over 700,000 manuscripts (purposely destroyed in AD 391 by Roman Emperor Theodosius), the Elders of Zion set up their new Sephardic culture. This became known as the Alexandrian or Utopian Movement, a despotic culture requiring **slavery** in order to maintain its existence.

But when they were forced by Titus on the Ninth of Ab to flee from Jerusalem, indeed from **all** of Palestine, they carried much of their accumulated *wealth* with them, in gold, silver and gems; so these Jews did not arrive in all these far-flung sanctuaries dead *broke*. They were not then, and have never *been*, "poor Jews". In fact, according to the Jewish author, Arthur Koestler, the Jew's "exclusive religion fostered a tendency to keep to themselves and stick together, to establish their own communities with their own places of worship, schools, residential quarters and ghettos (originally *self-imposed*) in whatever town or country they settled."

The "one God" of Judaic Pharisaism, as we

find in Elizabeth Dilling's extremely well documented and illustrated exposé, *The Plot Against Christianity* (1963), was known as the "En Sof"—the unknowable god of pantheistic paganism, as per *Isaiah 14:12-13*. And while they believe that "Metatron" actually *rules* this world, as the "demiurge" of the *Talmud* and *Kaballah*, they look upon the "YHVH" as *their* Lord and Master. According to the *Jewish Encyclopedia*, Metatron is the same as the Persian Sun god **Mithras** (of whom we will have much more to say later on). The YHVH, known to Kaballists as the "Tetragrammaton", can be combined into exactly 72 combinations of letters, resulting in what the **Freemasons** call the "Shemhamforesh", which represents, in turn, the laws, powers, and energies of NATURE. Furthermore, as revealed by the prolific Russian authoress Madam Helena P. Blavatsky, in her massive 1888 occult classic, *The Secret Doctrine*, the YHVH, or Jehovah, esoterically speaking, is "also the Serpent or Dragon that tempted Eve", in other words—SATAN! Thus we find from a very curious source that Jesus certainly *knew* whereof He spoke. [End

IT'S THE IMF THAT'S TO BLAME

U.S. State Department spokesman Jamie Rubin, queried at a press conference on May 15 about the crisis in Indonesia, stated baldly that "the IMF program is not the source of Indonesia's troubles."

We beg to differ. The record shows that whenever the International Monetary Fund comes in with a "rescue package" for a nation, that nation is chewed up by the global financial oligarchy, then spit out—whatever is left of it. That is why, a little over one year ago, Lyndon LaRouche issued a call for "a war of annihilation against the IMF".

Look at a few examples of IMF "success stories".

Mexico: In January 1995, following a near-blowout of the international monetary system when Mexico's peso fell through the floor, a \$50 billion "rescue package" was put together, including some \$17 billion from the IMF.

Conditionalities: The IMF imposed: wage reductions, government spending cuts, interest rate hikes, privatization of the state-owned oil company Pemex, as well as ports, airports, telecommunications, and other companies.

What happened: As of February 1997, twenty-two percent of per-capita production of consumer goods and 29% of production of producer goods were wiped out. Real unemployment doubled, to nearly 50% of the labor force. Manufacturing workers were reduced from 10 to 5% of the total labor force. In August 1997, the government claimed 7% growth in the first half of the year, but close

inspection revealed the statistic to be a fraud. What growth there was, *EIR* showed, was largely due to exports, rather than to any growth in the domestic market.

Russia: For six years, Russia's status as a great power has been stripped away by IMF "reforms". In February 1998, after long negotiations, the IMF agreed to continue its \$10 billion Extended Fund Facility for Russia; \$700 million will be doled out per quarter, until the year 2000, provided Russia adheres to IMF conditionalities.

RUSSIA'S AUSTERITY PLAN IS PRESENTED TO THE IMF

MOSCOW—Premier Sergei Kiriyenko submitted his new austerity plan to the International Monetary Fund on Wednesday in the hope it would earn Russia enough new lending to finance an economic recovery. The IMF's first deputy managing director, Stanley Fischer, said that fund analysts will **need several weeks to study the plan**. Fischer said that in the meantime he will **recommend that the fund release the latest, \$670 million installment of an existing loan held up last week to press Russia to meet the IMF's criteria**. [END OF QUOTING] **How quickly do you people require confirmation?**

Conditionalities: Firing of 10-15% of public sector employees; draconian budget cuts and privatization of state-owned companies; harsh measures against companies delinquent in tax payments; decreasing import duties for goods having no Russian analogues; other secret agreements.

What happened: As of March 1998, mass layoffs of public employees; wage arrears to public employees stand at \$9.6 billion; functions of the State Duma (Parliament) are essentially controlled by the IMF. In 1995, twenty percent of firms were operating at a loss; in 1996, forty percent were. The black market is pervasive; life expectancy has plummeted and the health of the population has deteriorated sharply.

Poland: Poland is such an IMF "success story" that it no longer receives any money from the Fund. But in fact, it has never recovered from the shock therapy of 1990, when in just one month, industrial production fell by 31%, trade by over 50, real wages by 30, and prices increased by 80%. As a result of the deteriorating standard of living during the last eight years, the birth rate collapsed to 1.6 per woman in 1997, the lowest since World War II. More than 50% of families live in poverty.

Thailand: In August 1997, following a massive assault on the baht, the IMF concluded a \$5 billion "stabilization" deal with Thailand, the biggest since the 1995 Mexico bailout.

Conditionalities: \$3 billion budget cuts; 3% increase in the Value Added Tax; establishment of derivatives markets; foreign banks to be allowed to own an even higher percentage of Thai firms than the previous limit of 25%; privatization of more state enterprises; freeze on wages.

What happened: As of May 1998, the IMF money is going almost entirely to pay derivatives losses to foreign speculators. Interest rates are over 20%; liquidity in the

economy has dried up, with warnings that 50% of all firms will be bankrupt soon if that is not corrected; the baht is further weakened; nearly all infrastructure development programs are halted; state-sector industries and banks are being privatized.

Commented Malaysia Prime Minister Dr. Mahathir bin Mohammed: "The baht is still sliding and the Thai economy is still in bad shape after borrowing \$21 billion from the IMF. So, why do you borrow from the IMF, if it is not going to help at all?"

We think he has a point.

HOW IMF METHODS DESTROYED INDONESIA

Since the Asia crisis erupted in Indonesia more than one year ago, the International Monetary Fund (IMF) has ensured that it would lead to the situation we see today, which already has cost the lives of hundreds, likely thousands of innocent Indonesian students and civilians, and brought the once-growing economy of the world's fourth most populous nation to a point of complete economic, financial, and, possibly, political breakdown, ultimately threatening not only China and the rest of Asia, but also the entire global monetary and financial system.

The demonstrations which erupted in early May across Indonesia were triggered by the government's announcement that it was removing state subsidies on vital foodstuffs and petroleum products. Prices for gasoline, public transportation, rice, and palm oil soared overnight, leading to protests that left more than 500 dead. The government action on subsidies was part of the revised April 13 agreement signed in Jakarta by IMF Managing Director Michel Camdessus and then-President Suharto.

THE IMF CREATES PANIC

Last November, the IMF ordered the Indonesian government to close 16 banks that the IMF said were insolvent, including one owned by a son of Suharto, in order, the IMF claimed, "to restore confidence" in the Indonesian banking system. The results were predictably the opposite. A full-scale national banking panic erupted, with citizens demanding cash from their banks.

A confidential, internal IMF memorandum to Camdessus on Jan. 13, which was leaked to the

press, admitted, "These closures, however, far from improving public confidence in the banking system, have instead set off a renewed 'flight to safety'." Citizens pulled \$2 billion worth of funds out in a matter of hours. By the end of November, the IMF move had created a crisis in which two-thirds of all Indonesian banks had had "runs on their deposits", according to the IMF memo. The situation became so critical that the Indonesian Central Bank was forced to pump an enormous sum of new money, a sum equivalent to about 5% of GDP in two months, into the banking system to prevent complete collapse. That flood of new money in turn weakened the rupiah, so that panic on the currency set in by late December, as wealthy Indonesians scrambled to sell rupiah for dollars in mass capital flight.

The latest, "revised" IMF Memorandum of Understanding with Indonesia mechanically imposes the same IMF monetarist dictates that it has used since the 1982 Mexico debt crisis—despite the entirely different nature of the Indonesian crisis. *EIR* has been given a copy of the April 13 IMF agreement by sources inside the Indonesian government, who are justifiably concerned about the deadly medicine being forced on their country. The IMF has demanded a number of basic conditionalities of Indonesia, for it to receive a promised \$40 billion IMF-led bailout package.

Indonesia must keep inflation below 20%, while avoiding an economic recession. In April, inflation was officially at 45% and rising. The country is now in a depression, with Gross Domestic Product forecast to contract this year by more than 10% and rising. Under the new IMF accord, the government must curb state spending to a deficit no more than 3.5% of GDP. (The November agreement called for a 1% deficit.) Germany and France, under the stringent Maastricht Treaty terms, have 3% deficits, and that, only through huge fiscal and accounting frauds.


To control the state budget deficit as an economy collapses is not possible in industrialized nations, let alone in a developing economy such as Indonesia. Every major European economy, as well as the United States, has run deficits in times of economic recession

in order to contain the downturn and speed recovery. The IMF medicine is the opposite. It demands, in effect, that the government worsen the economic downturn in the cause of "stabilizing the rupiah".

To contain the public deficit to 3.5% of GDP, the IMF has mandated that the government slash subsidies on food, petroleum products and electricity. At the beginning of May, gasoline prices rose overnight by 71%, along with similar enormous price hikes for key foodstuffs as well as for public transportation and electricity.

The government must all but eliminate remaining state subsidies by Oct. 1. It must slash investment in state enterprises, including such economically vital companies as the state petroleum giant, Pertamina. Because all this will not be enough to cut the deficit to the level the IMF demands, the state must auction off all its companies which operate in "competitive markets". This would mean that Indonesia's aerospace, electricity, oil, auto, and other infant national industries, which it has labored to establish in recent years, must be auctioned off to private investors. Privatized will be PT Telekom, PT Indosat, a state cement company, and others. **[H: And just WHO do you think will buy up these citizen's industries and make an even bigger killing on them—against them-the-people?]** In the current crisis, this forced privatization will mean that only foreign investors, who may or may not have an interest in sustaining a national economic capacity in Indonesia, will be potential buyers.

Further, the IMF demands that Indonesia abolish certain domestic cartel arrangements and impose "free-market" reforms. This includes the state import agency, BULOG, which organizes import of rice and other necessary foodstuffs. Given the record drought which has devastated Indonesia's rice and other food crops in the past year, to demand abolishing central import purchase of vital food stuffs in favor of free-market mechanisms, is to ensure severe added price rises in critical food necessities. The marketing monopoly organization in the country's important plywood production and export, as well as in sale of cloves and other commodities, are included in the shutdown.



TIGHTENING MONETARY POLICY

All these draconian measures, the IMF admits, will not suffice to fulfill their sated goal of stabilizing the rupiah at 6,000 to the dollar. Before the August 1997 crisis, the rupiah had been near 2,500. Today, it fluctuates around 12-13,000. In order to stabilize the rupiah at 6,000, and thereby make possible repayment of Indonesian corporate and bank debts to foreign banks in Germany, France, Japan, the United States, and elsewhere, the IMF has demanded that Bank Indonesia, the central bank, "tighten monetary policy".

The central bank, the IMF says, must "adjust interest rates as necessary", should the rupiah deviate from the 6,000 level. But to get there will be a labor of Sisyphus. With inflation officially at 45%, the IMF demands that Indonesia "curb the expansion of central bank credit", itself largely a response to the IMF's November bank closings.

Such monetary tightening amid an economic collapse, as IMF economists well know, was precisely what turned the U.S. economic decline of 1929-31 into the worst depression in American history. **[H: Are you still thinking that was some kind of unplanned accident? Sic, sic.]** Moreover, most of the inflation is a result of soaring food prices caused by the drought. As well, with a rupiah devaluation since August of some 80%, the cost of vital food imports (which have to be paid in dollars) has soared for the Indonesian consumer, as have costs of all other imports. **In such a circumstance, to demand, as the April 13 IMF agreement does, that Indonesia "adjust interest rates as necessary to reduce inflation rapidly and strengthen the exchange rate", is tantamount to ordering mass murder of large sections of the population**

On May 21, the new President, B.J. Habibie, clearly aware of the powerful grip of that institution on his nation's economic life, pledged to honor Indonesia's agreements with the IMF. Should that IMF control not be dropped soon by the governments of the OECD which now stand behind it, including Germany, France, the U.K., the United States, and Japan, the consequences will be grave. Indeed, one reason the U.S. Congress reportedly is not likely to grant the requested \$18 billion IMF quota increase so urgently sought by Camdessus, is growing realization that, far from resolving the problems in Indonesia and across Asia, the IMF has worsened the crisis.

[H: So, next; let's look at the topic:]

IMF: 'BANKERS ARE DANGEROUS PEOPLE!'

[Same source of information.]

Hysteria is spreading at International Monetary Fund (IMF) headquarters. Contacted on May 21 by a reporter for Resumen Ejecutivo about the latest Indonesian developments, an IMF official said he could not speak for attribution, but was eager, in fact, aggressively so, to expound the IMF's view on background. The following is a portion of the exchange, which is revealing of the state of mind reigning at that institution: defensive, but ferociously committed to doing whatever is required to

crush opposition to IMF dictatorship.

Q: There are reports that the IMF is now saying that [Indonesian President] Suharto went "too far" in implementing price increases.

A: There was no schedule agreed—with the IMF. The general agreement was that the budget and costs associated with below-market prices had to be resolved at some point, but never had the IMF requested in the agreement that the gap should be filled at once, and immediately. In this regard the decision to raise them at once, was of Mr. Suharto's own making. In this regard, Mr. Suharto went *way* beyond what the IMF had agreed with his own government.

Q: Is the IMF feeling the heat on this, and is that why you're insisting on this point?

A: It's a fact! It's a fact! Why should the IMF feel the heat on this? It's factual!

Q: And you had to pull your people out?

A: Well, everybody did too, Ma'am... To keep Indonesia in perspective: The restructuring of the banking sector which triggered the financial crisis *was urged by the IMF* executive in 1996, as written in public documents. The IMF *urged* Indonesia *urgently* to restructure is banking sector. What Indonesia shows is that we have no leverage whatsoever on a government which doesn't want to do anything. That's the bottom line. That's a fact, and it's proven in the public record. That's the big lesson of Indonesia....

The origin of the crisis, as in Thailand and South Korea, was the private banking sector, as it was in the savings and loans crisis in the U.S. The bottom line is that *bankers* are dangerous people!

[H: But the facts are that the Federal Reserve "system" is what determines the activities of world-wide banking! The Fed controls the IMF AND THE WORLD BANK and is simply bringing ALL banks under the one protocol-manifesto.]

Q: And not the IMF?

A: No. *Bankers* are dangerous people. And until now, we were not in charge of supervising private bankers. That was the job of the Fed and office of the Comptroller of the Currency in the U.S., and in other countries, the central banks. And it is a fact that those central banks have *miserably failed*, for sure. ...proposals now, are to change completely the legal framework of the central banks. To devise an international banking code that can be applied **EVERYWHERE**.

Let me tell you about Korea, to reframe the whole thing. When the IMF did the program urgently in December, in less than a week for them, they had \$6 billion in their coffers. On Dec. 4, 1997. The whole country, the 11th country [largest economy] in the world, had \$6 billion in their pockets, knowing that they owed \$150 billion, and that money was flowing out at more than \$1 billion a day. They were five days away from being completely bankrupt. The whole country! Five days away. Not two weeks or three weeks away, but *five days* away. Indonesia is on a smaller scale than South Korea. Korea was a financial nuclear explosion in the making. And let me tell you: We save the world. We really save the world... and I want you to reflect on that! **[H: I have reflected on that and now I wonder how many of you are like me—ready to barf?]**

If there had been a default situation, what

happens in an economy when you don't pay for your imports anymore? Total trade operations are disrupted. *Petroleum imports stop*. Right away. Less than three weeks later, the strategic stocks of the country are probably exhausted. That means transportation stops in the country. All transportation: ground, air. Air transportation with the rest of the world is cut off, because no planes can land, because you have no supplies in the country. Total breakdown of delivery of goods and services. Total breakdown of transportation of food from rural areas to the cities. To some extent you see that happening today in Indonesia. What else is the next thing that collapses if there are no petroleum imports: Electricity! Maybe 10% of Korea's energy comes from nuclear sources; the rest is from petroleum and coal. They collapse, you have no electricity after two weeks of time, maybe three weeks, electricity collapses completely. You are talking about a whole country going back to the Middle Ages. In less than three weeks.

In the first half of March, the Bank of Indonesia lost \$6 billion in reserves in 10 days, by paying banks \$600 million a day, so they could pay their creditors. But none of the creditors got the money. What was going on? *The rats were leaving the boat, and we couldn't stop it*. This is corruption at its worst—

Q: Are you referring, as did [IMF Managing Director] Michel Camdessus last January, to the need for revolutions like the French Revolution?

A: There are many similarities. ... No one thinks of the French Revolution as a magnificent example of a structural adjustment crisis, but it's a perfect example of a structural adjustment crisis!

A NEW 'FREE THAI' MOVEMENT FORMS AGAINST IMF OCCUPATION

A coalition of business leaders, farm and labor organizations, professionals, and intellectuals in Thailand have come together to defend the nation against a deadly enemy: the International Monetary Fund (IMF). The Thai economy, battered during the last year's speculative attack by the likes of the British-directed George Soros and his fellow derivatives shysters, is fast approaching terminal collapse under the dictates of the IMF's supposed medicine of austerity, usurious interest rates, forced sell-off of state industries to foreign interests, and dozens of similar poisonous policies. A diverse alliance of citizens, with support from at least some of the nation's political leadership, have begun to rally the nation against this destruction, naming the IMF

as the source of the problem. Some of these individuals and groups have compared their campaign to the “*Seri Thai*” (“Free Thai”) movement during World War II against the Japanese occupation of Thailand, and against Britain’s effort to colonize Thailand after the war.

At the founding rally of the “Community to build and Revive the Country” on May 11 in Bangkok, 28 civic groups representing rural doctors, labor, farmers, and other social organizations, were joined by university professors and industrial leaders in denouncing the IMF as the cause of the exploding rate of corporate bankruptcies and unemployment, and for usurping the nation’s economic sovereignty.

At the same time, the three leading business associations, the Federation of Thai Industries (FTI), the Board of Trade, and the Thai Bankers Association, have petitioned the government for a debt moratorium for small and medium-sized firms. The new chairman of the FTI, Tawee Butsumorn, also warned that three out of five of Thailand’s industrial workers could be out of work if the corporate debt crisis is not resolved immediately.

The new “Free Thai” leaders are placing certain demands upon the government, but it is extremely important that the target of their complaints is not the government itself, but the new occupying force, the IMF. In fact, the Prime Minister, Chuan Leekpai, and several members of his cabinet have themselves demanded changes in the IMF policies, even though those policies are staunchly defended by the Minister of Finance, Tarrin Nimmanahaeminda, and the new chief of the Bank of Thailand, Mr. R. Chatumongkol Sonakul. **[H: I’m certainly confident that this latter is true.]** Despite the government’s official adherence to IMF demands, Prime Minister Chuan angrily demanded that his cabinet members solve the crisis of liquidity for Thai businesses, while the Ministry of Industry released a statement, denouncing the Finance Ministry’s failure to provide adequate protective tariffs for the steel industry, as reflecting “a lack of understanding or serious support from the government”.

The alliance of Thai business leaders and social organizations against the IMF stands in stark contrast to the situation in Indonesia, where the brutal austerity imposed under the gun of the IMF has provoked mass demonstrations and anarchistic rioting—but with barely a mention of the IMF, which provoked the breakdown crisis, by the opposition. The Thais know that similar social explosion is possible within their country if the economic dissolution continues. The only way to prevent such anarchy is to identify the real problem—

the failure and bankruptcy of the world economic system under the IMF—while directing all available domestic resources to sustaining the national economy, rather than servicing the fraudulent portions of foreign debt created through speculation and deceit on the world financial markets. **[H: Doesn’t it come quite clear that IF THERE WERE A BETTER WAY AVAILABLE—it would be used to the limits of its value and a whole circumstance could be changed into a positive movement rather than a sure total disaster for all involved?]**

A SYMBOL OF NATIONAL SOVEREIGNTY

The “Free Thai” movement against the World War II occupation by Japan is still the most powerful symbol of national sovereignty to the Thai people. It was led by Pridi Banomyong, a hero of 20th-century Thailand. Pridi created the alliance of intellectuals, business leaders, and military officers who carried out the peaceful revolution in 1932, overthrowing the absolute monarchy and establishing a constitutional monarchy. As Foreign Minister and Finance Minister during the late 1930s, Pridi abrogated the unequal treaties imposed upon Thailand by British and French colonial armies during the previous century. He established protective tariffs, formed a national bank and national industries, and founded Thammasat University.

When the Japanese occupied Southeast Asia, with virtually no resistance from the British military forces controlling their Asian empire, Thailand had no choice but to acquiesce to Japanese occupation. It maintained the semblance of sovereignty by formally allying with Japan. Pridi, however, established the “Free Thai” movement with support from U.S. Office of Strategic Services. His co-leader was the Thai Ambassador to the United States, Seni Pramoj. Pridi, who was also regent for the young King at the time, ran underground cells in the Thai countryside in league with the OSS, while maintaining networks within the government, the military, and among the Chinese-Thai business families in Bangkok.

There were Thai collaborationists, of course, who served as Quislings to the Japanese occupation forces, but following the war, Pridi and his Free Thai movement easily took power. The British, however, were not interested in Thailand’s sovereign rights, nor its development and insisted that, as formal allies of Japan, Thailand must be treated as a defeated enemy. Besides demanding reparations of rice to feed

the British colonies, the British also wanted to occupy Thailand itself. Pridi called for support from his friends in the United States, and the British scheme was defeated.



So mysterious is the object that astronomers do not know if it is a planet, a giant comet, a nearby protostar that never got hot enough to become a star, a distant galaxy so young that it is still in the process of forming its first stars or a galaxy so shrouded in dust that none of the light cast by its stars ever gets through. “All I can tell you is that we don’t know what it is,” Dr. Gerry Neugebauer, IRAS chief scientist for California’s Jet Propulsion Laboratory and director of the Palomar Observatory for the California Institute of Technology said in an interview. [*Key personnel do know but they don’t want us to know!*]

The most fascinating explanation of this mystery body, which is so cold it casts no light and has never been seen by optical telescopes on Earth or in space, is that it is a giant gaseous planet, as large as Jupiter and as close to Earth as 50 billion miles. While that may seem like a great distance in earthbound terms, it is a stone’s throw in cosmological terms, so close in fact that it would be the nearest heavenly body to Earth beyond the outermost planet Pluto. “If it is really that close, **it would be a part of our solar system** [*emphasis mine*],” said Dr. James Houck of Cornell University’s Center for Radio Physics and Space Research and a member of the IRAS science team. “If it is that close, I don’t know how the world’s planetary scientists would even begin to classify it.”

The mystery body was seen twice by the infrared satellite as it scanned the northern sky from last January to November, when the satellite ran out of the supercold helium that allowed its telescope to see the coldest bodies

in the heavens. The second observation took place six months after the first and suggested the mystery body **had not moved from its spot in the sky near the western edge of the constellation Orion** [*emphasis mine*] in that time. “This suggests it’s not a comet because a comet would not be as large as the one we’ve observed and **a comet would probably have moved** [*emphasis mine*],” Houck said. “A planet may have moved if it were as close as 50 billion miles but it could still be a more distant planet and not have moved in six months time.” “Whatever it is,” Houck said, “the mystery body is so cold its temperature is no more than 40 degrees above absolute zero,” which is 459 degrees Fahrenheit below zero. The telescope aboard IRAS is cooled so low and is so sensitive it can “see” objects in the heavens that are only 20 degrees above absolute zero. When IRAS scientists first saw the mystery body and calculated that it could be as close as 50 billion miles, there was **some speculation that it might be moving toward Earth** EM. “It’s not incoming mail,” Cal Tech’s Neugebauer said. “I want to douse that idea with as much cold water as I can.”

Connecting Link: What are the Earth Chronicles about?

Zecharia Sitchin: The first book, *The Twelfth Planet*, refers to the probability that there is one more planet in our solar system. That there are twelve members, counting Sun, Moon and ten planets, not the nine we know of. That people from that planet came to Earth almost half a million years ago and did many of the things about which we read in the *Bible*, in the book of *Genesis*.

But that was not my starting point at all. My starting point was, going back to my childhood and schooldays, the puzzle of who were the Nefilim, that are mentioned in *Genesis*, Chapter six, as the sons of the gods who married the daughters of Man in the days before the great flood, the Deluge. The word Nefilim is commonly, or used to be, translated "giants". And I am sure that you and your readers are familiar with quotes and Sunday preachings, etc., that those were the days when there were giants upon the Earth. I questioned this interpretation as a child at school, and I was reprimanded for it because the teacher said "you don't question the *Bible*". But I did not question the *Bible*, I questioned an interpretation that seemed inaccurate, because the word, Nefilim, the name by which those extraordinary beings, "the sons of the gods" were known, means literally, "Those who have come down to Earth from the heavens".

CL: From the Hebrew word Nafal, which means "fall"?

ZS: Right. Fall, come down, descend. So, what did it mean? This led me to biblical studies and then to mythology and archeology and all the other subjects, including the study of ancient languages, which became my education and avocation. So, my research and my decision to write about it started with a question: Who were the Nefilim?

All the ancient scriptures, the *Bible*, the Greek myths, the Egyptian myth and texts, the pyramid texts, everything, led to the Sumerians, whose civilization was the first known one six thousand years ago. I focused on Sumer, the source of these legends and myths and texts and information. I learned to read the cuneiform Sumerian texts and came upon their persistent and repeated statements that those beings, whom the Sumerians called Anunnaki, came to Earth from a planet called Nibiru. The planet was designated by the sign of the cross and Nibiru meant, "planet of crossing".

The question thus shifted in my research from who were the Nefilim and the Anunnaki, to: What planet is Nibiru? Forced to become proficient in astronomy, I had to learn enough about it to deal with the subject. I found out that the scholars were divided. Some said it (Nibiru) was Mars, which of course was described and known to the ancient people, and others said, no, it was Jupiter. Those who said it was Jupiter and not Mars, had very convincing arguments why it could not be Mars. And those who said it was Mars and not Jupiter had very convincing arguments also.

Being able to go directly to those ancient sources, clay tablets and cuneiform scripts, it

seemed to me that neither was right, because the description of Nibiru and its position when it nears the Sun indicated that it could not be Mars, and it could not be Jupiter. And then one night I woke up with the answer: Of course, it is one more planet that comes periodically between Mars and Jupiter; it is sometimes nearer to Mars and sometimes nearer to Jupiter, but it isn't Mars or Jupiter.

Once I realized that this was the answer, that there is one more planet, everything else fell into place. The meaning of the Mesopotamian *Epic of Creation* on which the first chapters of *Genesis* are based and all details about the Anunnaki, who they were and who their leaders were and how they traveled from their planet to Earth and how they splashed down in the Persian Gulf and about their first settlement, their leaders and so on and so on, everything became clear! The Sumerians had immense knowledge. They knew about Uranus and Neptune and described them and they knew about Pluto. They were proficient in mathematics and, in many respects, their knowledge surpassed modern times. They said, "All that we know was told to us by the Anunnaki." The first book's innovation, its impact, was the realization that the ancient peoples, beginning with the Sumerians, knew of and described and spoke of one more planet in our solar system. It was not a discovery like that of Pluto in 1930 (of which the Sumerians knew six thousand years ago). Pluto was a very interesting astronomical discovery; textbooks had to be revised. But to the average person, the man on the street, it really made no difference. Nibiru, on the other hand was a different story. If Nibiru exists, (and this is the planet that astronomers nowadays call planet X) then the Anunnaki exist.

So the existence of Nibiru is not a matter of just one more globe in our solar system. This is different, because if Nibiru exists, and the Anunnaki exist, then the Sumerian claim that they come back to our vicinity every 3,600 years, at which times in the past they gave us civilization, then we are not alone and there are **more advanced people than us in our solar system.**

CL: What will happen next time around?

ZS: Who knows how they will feel about us when they come back. Will they decide to give us more knowledge again, and more technical advancement and more civilization, or will they decide that we are no good, as happened at the time of the Deluge, and try to get rid of us?

So, the first book, laying the foundation and describing Sumerian knowledge and concluding with the existence of one more planet is really the key to understanding what it is all about. What the tales of *Genesis* are, what the tales of creation are, what our past was, and in a way what our future will be...

Your imaginary 12th planet is more massive than the Earth, but less massive than Jupiter, correct? It's also presently supposed to be many times farther away than Jupiter. How can such an object appear DIFFUSE?

Because it's a brown dwarf, smoldering in a slow burn and emitting a slight glow. See below for some more vintage ZetaTalk.

Humans are aware of heat and light being produced together as fire, the Sun, and elements heated until they glow. Humans are also aware of light being produced without heat, as with fireflies or minerals that are phosphorescent. And of course, there is heat without light, close at hand as in 98.6 degrees. The 12th Planet has both heat and light, generated from within its core. Life on the 12th Planet, which is inhabited by a large hominoid indistinguishable from humans other than by its size, experiences continuous day. Life that has evolved there does not sleep, but rests. The light is diffused in the atmosphere, and returns to the land surface, but emerges from the core to interact with the atmosphere only via the surface of the deep oceans, which cover the majority of the planet's surface. You may equate this to volcanic activity, where the Earth has numerous places both above ground and under the oceans that ooze molten lava. Just so the 12th Planet has places where the molten and churning substance in its core escapes to the surface.

Fires such as go on in the center of suns do not only proceed full bore. Why would they? Do you not have a fire within you that is maintained at a steady temperature? Do you not find that the fire in your fireplace can be slowed by adjusting the damper? Humans do not understand what is occurring within the Sun, a combustion of sorts that ignited because of the pressure of elements following the big bang, during the congealing period. The Sun was not born, lit. It lit as compression continued to the point where a product of subatomic particle collision did not dissipate, but accumulated, and the degradation of this substance is what you are viewing and feeling in your sunlight. This is a simplistic explanation for a complicated process. The 12th Planet has a similar process ongoing within its core, but being composed of heavier substances than your Sun, this process is slowed. You can equate this to mixing medicine into food, rather than taking it directly. This is tolerated because the incident or rate of medicine reacting with a taste bud is reduced, or slowed.

On the 12th Planet, the heat released diffuses in all directions, so the surface of the planet is warm but not hot. Your feet would not blister, but they may feel cool in places where the rock strata do not provide a good passage for heat, should you visit that planet. Light only escapes the core where what is essentially volcanic activity under the water occurs. Of course, this would occur if there was volcanic

activity on the land surface of the planet, but there is little land surface, and this long ago hardened. Volcanic activity would not be on the surface of the Earth, either, should her proportion of water to land be increased. Water is pooling in the low spots, and the low spots have less hardened surface mantle as a barrier. Thin places break, and give release to the pressure from the churning molten core. The oceans of the 12th Planet, therefore, have places where diffused light is rising, and other places where the oceans would appear to you much as your own do here on Earth.

WHERE AND HOW TO FIND THE 12TH PLANET

ORION

Here's a word from the Zetas too. In keeping with a policy to begin alerting the populace to the coming horrendous cataclysms that will strike the Earth in her near future, due to the passage of what is often called the 12th Planet, in keeping with a term made famous by Sitchin for the rogue planet coming back for a **passage in 2003** [*emphasis mine*], you will find a reformed government willing to point you in

the right direction, so you will NOTICE what you have up until now been directed away from. If this makes you nervous, check out the *Troubled Times* content, as these folks have been preparing for your panic, and have some answers. (End ZetaTalk[TM]) ...

POINT OF PASSAGE

From the *Troubled Times*:

The point of passage has been calculated from information on the Orbit and Entry Angle given by the Zetas. The 12th Planet pierces the Earth's orbital plane, it forms a triangle with the Earth and Sun, with the angles given as 139 degrees at the 12th Planet, 23 degrees at the Earth, and 18 degrees at the Sun.

32 DEGREE ANGLE

From the *Troubled Times*:

The closest, most easily recognizable constellation close to the 12th Planet's approach is Orion, high in the winter sky in the Northern Hemisphere. During the summer months of June/July Orion is behind the Sun and comes forth just before sunrise in the Eastern horizon as July fades into August. By January, Orion will be high in the southern sky at about 2200 hours. If you stand looking south, search approximately two thirds of the way towards straight up, and wait for Orion and its highly visible "Belt" to cross the center of the sky. Where the 12th Planet approaches from Orion,

it dips below the ecliptic during the years just before passage to an angle of 32 degrees below the ecliptic.

BRIGHTNESS

From ZetaTalk:

The Zetas have answered a question on how bright the 12th Planet will be as it approaches.

Your hope for an early brightness will not be met, as the 12th is too far away for reflected sunlight up until 6 months before passage. Likewise, it does not grow in size, to where it is obvious that it is not a fading nova at a great distance, until it begins to reflect sunlight. Thus, up until these last few months, **the excuse that this is a faded nova of sorts will be put forth, and even supported by doctored images. Those few who have been watching the path and know they are being fed lies must support each other covertly** [*emphasis mine*], and depending upon the strength of the governments resolve to inform the public to some degree, these individuals may be allowed to present their findings to the public also, in a debate format. However, your best hope of convincing the public in significant numbers will be during the last months, when it is clearly not a nova, and clearly coming closer and on the move.

STAR MAGNITUDE

From the INTERNET, *Troubled Times*:

The Zetas have given that the 12th planet is presently of actual magnitude 2 and apparent magnitude 10. I have done some research to determine what this means for those of us who want to spot it in the sky. I found an explanation of Star Magnitudes on the web. Here are some interesting things I discovered:



Magnitude of Polaris (the North Star) 20, Magnitude of Neptune 8.2, Magnitude of Pluto 13.7, Typical limiting magnitude 5.2.

This page also confirms that diffuse objects such as galaxies appear to be fainter than their published magnitudes.

So, when looking for the 12th planet we are looking for something that gives off as much light as the North Star, but whose apparent brightness is between Neptune and Pluto. Since the dimmest object that you can typically see is 5.2 (this will vary by location), it will no doubt be helpful to have some kind of optics to magnify the brightness.

Another tidbit I gathered from the above page is that five magnitudes of brightness is equivalent to a factor of about 100 in terms of the amount of light received on the Earth. The scale is logarithmic, so, a difference in magnitude of 8 (between the actual and apparent magnitude of the 12th) consists in a factor of nearly 3000. Given the radius of the 12th is 4 times that of the Earth (which would make its radius 2.5×10^{-7} meters. This is just a bit larger than Neptune, practically equal. Since the 12th is 1.8 magnitudes dimmer than Neptune, it stands to reason that the 12th either has a lower albedo, or is currently farther than Neptune, or both. However, it does not seem to follow that its apparent magnitude should be anywhere near 2.0, since this would require an increase in area of 3000.

I have been watching Orion for quite some time now, looking in the indicated region. I do



not think the 12th's actual magnitude is much different than its apparent magnitude, as this is not supported either by experiential evidence or the comparable magnitude of any of the other planets (which, too, give off diffuse light). A magnitude of 10 is reasonable for an object the size and distance of the 12th planet. Given this, it is understandable why it has not been spotted yet—it is dimmer than we think. Magnitude 10 is just beyond the limits of my optics (even with red/IR magnification). I would like to know when the 12th will reach, say, magnitude 9, as I think at that time I should have no trouble spotting it, whether it is diffuse or not. (As it is, stars of magnitude 8-9.5 appear diffuse and hazy to me.)

REDDISH GLOW

From ZetaTalk:

The 12th Planet looks like the fading remains of a dying star, and does not have the pinpoint of brightness of a star. Although the 12th Planet at present is a magnitude 2.0, astronomers should include objects up to a magnitude 10 in their image capture. The image capture results should be passed through a red filter, as most equipment is calibrated to locate the pinpoint brightness of stars, rather than a diffuse glow.

The problem is that the normal eye, even when scanning a photo, would miss it as it is a faint blurr, rather than the pin point expected. Like the insect who camouflages itself against a similar background, and is not seen, this giant will be upon mankind before they realize they have been staring at it all along. Infrared works well, but requires equipment in the hands of few. Red filtering, aggressive red filtering, will bring it to the fore more than anything.

LANDING ON PLANET EARTH

Excerpts from Toubled Times, *Landing On Planet Earth*, by Zecharia Sitchin, pages 260-263, 178, and 201:

In February 1971, the United States launched Pioneer 10. Pioneer 10 scientists attached to it an engraved aluminum plaque. It attempts to tell whoever might find the plaque that Mankind is male and female, etc., and that (Pioneer 10) is from the 3rd planet of this Sun. Our astronomy is geared to the notion that Earth is the 3rd planet, which indeed it is if one begins the count from the center of our system, the Sun. But to someone nearing our solar system from the outside, the 1st planet to be encountered would be Pluto, the 2nd Neptune, the 3rd Uranus, the 4th Saturn, the 5th Jupiter, the 6th Mars—and the Earth would be 7th.

We know today that beyond the giant planets Jupiter and Saturn lie more major planets, Uranus and Neptune, and a small planet, Pluto. But such knowledge is quite recent. Uranus was discovered, through the use of improved telescopes, in 1781. Neptune was pinpointed by astronomers (guided by mathematical calculations) in 1846. It became evident that Neptune was being subjected to unknown gravitational pull, and in 1930 Pluto (was located).

In Assyrian times, the celestial count of a god's planet was often indicated by the

appropriate number of symbols placed alongside the god's throne. Thus, a plaque depicting the god (of Saturn) placed 4 star symbols at his throne. Many cylinder seals and other graphic relics depict Mars as the 6th planet. A cylinder seal shows the god associated with Mars seated on a throne under a 6-pointed star. Ample evidence shows that Venus was depicted as an 8-pointed star. Other symbols on the seal show the Sun, much in the same manner we would depict it today; the Moon; and the cross, the symbol of the Planet of Crossing, the 12th Planet.

Excerpts from *Kingship of Heaven*, by Zeharia Sitchin, pages 246-248:

The (12th) Planet's periodic appearance and disappearance from Earth's view confirms the assumption of its permanence in solar orbit. In this it acts like many comets. If so, why are our astronomers not aware of the existence of this planet? The fact is that even an orbit half as long as the lower figure for (the comet) Kohoutek, (every 7,500 years), would take the 12th Planet about 6 times farther away from us than Pluto—a distance at which such a planet would not be visible from Earth. In fact, the known planets beyond Saturn were first discovered not visually but mathematically.

The Mesopotamian and biblical sources present strong evidence that the orbital period of the 12th Planet is 3,600 years. The number 3,600 was written in Sumerian as a large circle. The epithet for the planet, shar, also meant "a perfect circle" or "a completed cycle". It also meant the number 3,600. The identity of the three terms—planet/orbit/3,600—could not be a mere coincidence. The Reign Periods (a Sumarian text) gives are also perfect multiples of the 3,600 year shar. The conclusion that suggests itself is that these shar's of rulership were related to the orbital period shar, 3,600 years.

Excerpts from *Kingship of Heaven*, pages 242-245:

All the people of the ancient world considered the periodic nearing of the 12th Planet as a sign of great upheavals, great changes, new eras. The Mesopotamian texts spoke of the planet's periodic appearance as an anticipated, predictable, and observable event. "The great planet, at his appearance dark red." The day itself was described by the *Old Testament* as a time of rains, inundations, and earthquakes. If we think of the biblical passages as referring, like their Mesopotamian counterparts, to the passage in Earth's vicinity of a large planet with a strong gravitational pull, the words of *Isaiah* can be plainly understood. "From a far away land they came, from the end-point of Heaven do the Lord and his weapons of wrath come to destroy the whole Earth. Therefore will I agitate the Heaven and Earth shall be shaken out of its place. When the Lord of Hosts shall be crossing, the day of his burning wrath."

The prophet Amos explicitly predicted: "It shall come to pass on that Day, sayeth the Lord God, and I will cause the Sun to go down at noon and I will darken the Earth in the midst of daytime." The prophet Zechariah informed the people that this phenomenon of an arrest in Earth's spin around its own axis would last only one day: "And it shall come to pass on that Day

that there shall be no light uncommonly shall it freeze. And there shall be one day, known to the Lord, which there shall be neither day or night."

The prophet Joel said: "The Sun shall be turned into darkness, and the Moon shall be as red blood."

COMET VISIBLE

From ZetaTalk:

The 12th Planet is now visible to the human eye, though only the educated eye would see it. At the current time the 12th Planet is approximately magnitude 2.0 in brightness, and appears as large as a star as viewed by the naked eye. It does *not* shine with the intensity of most stars, but has a dull, diffuse, glow. It appears to be the last gasp of a dying star, a faint, blurry, reddish glow. Your eye would pass over it if attuned to the pin points that are the stars. A star is intense in the center and rapidly diminishes in intensity toward the edges of the spot you call a star. The light from a star comes from a single point and fans out, the periphery a bit less than the center, increasingly, but the center very intense. The 12th Planet, being nearer, is giving you light rays from its entire surface, so the light has an even quality to it. Its distance cannot be measured, but one will notice that as time passes, no other object passes before it.

Your nearby planets are throwing back at you a familiar light, reflected sunlight, and thus your eyes *recognize* them for what they are. Just as some insects camouflage themselves from those who would prey on them by adopting the coloration of the surrounding area, just so the 12th Planet, *to you*, is camouflaged against the night sky. Its appearance does not look like the familiar objects you set out to identify when you scan the sky—pin points with intense centers that are stars or the scattered brilliance of an exploding star or the distinctive elongated fantail of a passing comet. Where its size at present is akin to a star, and the diffuse light across its surface would indeed have the spread and consistency that your reflecting planets do, there are significant differences that cause you to pass over it rather than explore it in depth.

The composition is not the composition of reflecting sunlight, but is almost exclusively in the spectrum you would call red light. Thus you will do best if you filter *for* red light, and by this we mean filtering *out* all but red light.

Though a large planet, 4 times as large as Earth and thus larger than Mars or Pluto, it is at this time at a much greater distance and thus its *visibility* is not equivalent to Mars or Pluto.

The amateur astronomer may be disappointed until well after the millennium, as the 12th Planet's motions *across* the skies are only visible at this time when repeated images are taken and compared by computer, and here the magnification must be huge. Where the naked eye looks upon the sky, the 12th Planet appears to be standing still. The path of the comet is dead on. It is aiming for your Sun, and you are so very close to your Sun. The Earth's movements to this side or that are slight, in the scheme of things, and give to the comet an almost imperceptible wobble at best. The naked

eye will not see motion in this 12th Planet until well into the year of the cataclysms, just a few weeks ahead. At that time its motion will give it away as being of a comet's nature. During the last few weeks, backyard astronomers will be able to detect motion of the comet across the skies, something a distant star would not do. Those with telescopes and computer software capable of comparing captured and stored images will know otherwise, **but will be silenced or discredited in the usual establishment protective manner** [*emphasis mine*]. This 12th Planet will, however, get consistently brighter, so that an image taken now, compared with an image taken a year from now, would show an increased brightness not expected from a distant star. The naked eye would not capture this. The naked eye will begin to register increased brightness approximately 1 year 7 months before the cataclysms, or late in the year 2001. This appearance will be discounted by most, who will point to the distortions in the atmosphere as a cause or will explain this as an exploding star, the light rays of which are just becoming visible on Earth. Increased brightness will occur gradually, so that without the capacity to register brightness over time, and compare closely the changes, this cannot be proved or even, until close to the end, mentally registered by the observer. High-powered equipment can and has registered this increased brightness. The images must be compared by computer analysis, but the magnification need not be huge, only slight. Here again, this information will not be made public. Quite the opposite. This information will be denied and refuted by those controlling the high-powered equipment needed for proof.

Astronomy is a science based on theory as much as fact, as needs be when one is looking out where one cannot go and measure! Consequently, astronomers essentially make their best guess, and often disagree. How far away is an object? Opinions differ. If one object passes in front of another, there is a solid clue, as the one object is obviously closer than the other. What is the composition of an object? Extruded rays are analyzed against known scientific facts on how matter decomposes, but much scientific fact is as yet not understood by humans. They make their best guess, often so wrong as to be terribly misleading. We are not telling astronomers anything they don't know themselves. There is a science that truly respects the adage—the more I know, the more I know I don't know!

For those discouraged by peering at the sky, and in particular discouraged by the myriad of alternative explanations for what is seen, remember that the approach of the comet is best measured, until the last year before the cataclysms, by the Earth's response to its approach. As we have already explained, the core of the Earth is already responding, and this measurement is recorded in the rising temperature of the oceans, worldwide. The next symptom to look for is increased volcanic activity, and larger and more frequent earthquakes, worldwide. This, surely, cannot be attributed to the Greenhouse effect. It is **when**

the Earth receives red dust from the tail of the comet, as it enters the Solar System and passes between the Sun and the Earth, that denial will no longer be possible [*emphasis mine*]. At this point, however, there are scant days before the cataclysms.


DEEP QUAKES

A *Troubled Times* member shows the exponential increase in deep quakes down to the 600 km level since 1994, using the database provided by a private organization known as The Council of the National Seismic System, working out of Berkeley, CA, which provides earthquake data and answer questions at their web site. Note a depth down to 600 km was taken for this graph, versus a depth down to only 550 km for other pages on this site discussing this issue. This graph is thus more comprehensive, and thus more accurate.

THE SHADOW OF DEATH

Excerpts from *Worlds in Collision*, by Velikovsky, pp. 127-128:

If the eruption of a single volcano can darken the atmosphere over the entire globe, a simultaneous and prolonged eruption of thousands of volcanoes would blacken the sky.



Volcanoes vomit water vapor as well as cinders. Following the cataclysm, the author of *Codex Chimalpopoaca*, in his history of the suns, shows us terrifying celestial phenomena...followed by darkness that covered the face of the Earth, in one instance for a period of 25 years.

In the Ermitage Papyrus in Leningrad...there are lamentations about a terrible catastrophe, when heaven and Earth turned upside down. After this catastrophe darkness covered the Earth. The "shadow of death" is related to the time of the wandering in the desert after the Exodus from Egypt. The sinister meaning of the words "shadow of death" corresponds with the description of the Ermitage Papyrus: "None can live when the Sun is veiled by clouds."

The phenomenon of gloom enduring for years impressed itself on the memory of the Twelve Tribes and is mentioned in many passages in the *Bible*. *Psalms* 44:19: "The people that walked in darkness...in the land of the shadow of death".

VIOLENT WINDS

Excerpts from ZetaTalk:

At the shift, the surface of the Earth will move, in just under an hour, more than a quarter turn. Where massive earthquakes and tidal waves occur when this motion "stops", hurricane force winds, world wide, occur "during" this shift.

During the shift, the atmosphere of the Earth does several things, all at once. It drags along with the Earth, to which it is attracted, being primarily more involved with gravity attraction straight down. Do not the waters in your oceans move with the Earth as it turns? The atmosphere is an ocean too, just lighter and therefore more mobile. It moves as a mass, pushing on air in other places and likewise, itself being pushed. Thus, even in those places on the Earth which are *not* moving, during the shift, being pivot points, the air is turbulent. It swirls, as circular motion in air masses is the response to conflicting forces, as seen in the circular motion of tornadoes and hurricanes.

BOILING EARTH
AND SEA

Excerpts from *Worlds in Collision*, by Velikovsky, pp. 91-92:

The Mexican sacred book, *Popol-Vuh*, the Manuscript *Cakchiquel*, the Manuscript *Troano* all record how the mountains in every part of the Western Hemisphere simultaneously gushed lava... The rivers steamed, and even the bottom of the sea boiled here and there. The *Zend-Avesta* says: "The sea boiled, all the shores of the ocean boiled, all the middle of it boiled."

The traditions of the Indians (also) retain the memory of this boiling of the water in river and sea. The tribes of British Columbia tell: "Great clouds appeared...and such a great heat came, that finally the water boiled. People jumped into the streams and lakes to cool themselves, and died." On the

North Pacific Coast of America the tribes insist that the ocean boiled: "It grew very hot...many animals jumped into the water to save themselves, but the water began to boil." The Indians of the Southern Ute tribe in Colorado record in their legends that the rivers boiled.

Jewish tradition, as preserved in the rabbinical sources, declares that the mire at the bottom of the Sea of Passage was heated. Hesiod in his *Theogony*, relating the upheaval caused by a celestial collision, says: "The huge earth groaned... A great part of the huge earth was scorched by the terrible vapor and melted as tin melts when heated by man's art...or as iron, which is hardest of all things, is softened by glowing fire in mountain glens."

THE HURRICANE

Excerpts from *Worlds in Collision*, by Velikovsky, pp. 67-69:

Manuscript *Troano* and other documents of the Mayas describe a cosmic catastrophe during which the ocean fell on the continent, and a terrible hurricane swept the Earth. The hurricane broke up and carried away all towns and all forests. A wild tornado moved through the debris descending from the sky. The end of the world was brought by Hurakan. From this name is derived hurricane, the word we use for a strong wind.

The theme of the cosmic hurricane is reiterated time and again in the *Hindu Vedas* and in the *Persian Avesta*. The 11th tablet of the *Epic of Gilgamesh* says that 6 days and a night the hurricane, deluge, and tempest continued sweeping the land and mankind perished almost altogether. The Maoris narrate that amid a stupendous catastrophe the mighty winds, the fierce squalls, the clouds, dense, dark, fiery, wildly drifting, wildly bursting, rushed on Creation, ... and swept away giant forests and lashed the waters into billows whose crests rose high like mountains.

The Polynesians celebrate a god, Taafanua. In Arabic, Typhoon is a whirlwind and Tufan is the Deluge; and the same word occurs in Chinese as Ty-fong. It appears as though the noise of the hurricane was...not unlike the name Typhon.

THE HAIL OF STONES

Excerpts from *Worlds in Collision*, by Velikovsky, pp. 51-53:

Following the red dust, a small dust, like ashes of the furnace fell in all the land of Egypt (*Exodus* 9:18), and then a shower of meteorites flew toward the Earth. We are informed by Midrashic and Talmudic sources that the stones which fell on Egypt were hot. Ipuwer wrote: "Trees are destroyed. No fruits, no herbs are found. Grain has perished on every side." In the Book of *Exodus* (9:25) it is written: "And the hail smote every herb of the field, and brake every tree of the field."

The description of such a catastrophe is found in the *Visuddhi-Magga*, a Buddhist text on the world cycles. "When a world cycle is destroyed by wind...there arises...a wind. First it raises a fine dust, then coarse dust, then fine sand, then coarse sand, then grit, stones, up to boulders as large as trees." The Mexican *Annals of Cuauhtitlan* describe how a cosmic

catastrophe was accompanied by a hail of stones. [End quoting]

Art Bell recently told of people calling in to his radio talk-show reporting that a meteor stone came through their roof.

FIRESTORMS

Excerpts from ZetaTalk:

"These fire storms are caused by reactions of atmospheric gasses to the turmoil going on. Petrocarbons are in essence created, due to the flashes of lightning and intense heat due to passage over open volcanoes, and these petrocarbons rain down, afire, at times."

TIDAL WAVE

Excerpts from ZetaTalk:

"Where the Earth, dragged by its core, is shifting into a new, albeit temporary, alignment with the giant comet, its waters resist greatly. Thus the waters slosh over the nearby land, in the direction opposite to the shift. This is lessened by a tendency of the waters directly under the giant comet to rise up to meet the comet. The waters heap up, in what appear to be giant waves. This tends to lessen the sloshing over a shoreline on the comet side, but has no effect on the water's movement on the dark side of the Earth."

THE TIDE

Excerpts from *Worlds in Collision*, by Velikovsky, pp. 70-75:

The slowing down or stasis of the Earth in its rotation would cause a tidal recession of water toward the poles, but the celestial body nearby would disturb this poleward recession, drawing the water toward itself. The traditions of many peoples persist that seas were torn apart and their water heaped high and thrown upon the continents.

The traditions of the people of Peru tell that for a period of time the Sun was not in the sky, and then the ocean left the shore and with a terrible din broke over the continent. The Choctaw Indians of Oklahoma relate: "The Earth was plunged in darkness for a long time." Finally a dark light appeared in the north, "but it was mountain-high waves, rapidly coming nearer". According to the Lapland epic, after the sea-wall fell on the continent, gigantic waves continued to roll and dead bodies were dashed about in the dark waters.

The Hebrew story of the passage of the sea (relates that) the bottom of the sea was uncovered, the waters were driven apart and heaped up like walls in a double tide. The *Septuagint* translation of the *Bible* says that the water stood "as a wall", and the *Koran*, referring to this event, says "like mountains". In the old rabbinical literature it is said that the water was suspended as if it were "Glass, solid and massive".

EXCERPTS FROM EARTH IN UPHEAVAL, TIDAL WAVE

Excerpted from the INTERNET, *Troubled Times*, 6/19/98: [quoting]

Earth In Upheaval by Velikovsky, pp. 51-54: Fissures in the rocks...all over Western Europe, are choked with bones of animals, some

of extinct races, others, though of the same age, of races still surviving. The bones...are mostly broken and splintered into innumerable sharp fragments and are evidently not those of animals devoured by beasts of prey. The Rock of Gibraltar is intersected by numerous crevices filled with bones. The bones are broken and splintered. The remains of panther, lynx, caffir-cat, hyena, wolf, bear, rhinoceros, horse, wild boar, red deer, fallow deer, ibex, ox, hare, rabbit, have been found in these ossiferous fissures. On Corsica, Sardinia, and Sicily the broken bones of animals choke the fissures in the rocks.

The state of preservation of the bones indicates that the animals, all of them, perished in the same period of time. No hardened animal feces were found, indicating that the dead beasts had not lived in these hollows or fissures. No teeth marks of hyena or of any other animal are found in the osseous mass. The bones are those of animals of all ages down to the fetus, nor do they show traces of weathering or exposure.

The extremely fresh condition of the bones, proved by the retention of so large a proportion of animal matter, shows that the event was, geologically, comparatively recent. The fact that animals of all ages were involved in the catastrophe shows it to have been sudden.

EAST AND WEST

Excerpts from *Worlds in Collision*:

Our planet rotates from west to east. Has it always done so? There is testimony from all parts of the world that the side which is now turned toward the evening once faced the morning. The Egyptians pride themselves on being the most ancient people in the world. In their authentic annals...one may read that...the course of the stars has changed direction...and that the sun has set in that part of the sky where it rises today. In the Papyrus Ipuwer it is similarly stated that "the land turns round as does a potter's wheel" and "the Earth turns over".

Plato wrote in his dialogue: "At certain periods the universe has its present circular motion, and at other periods it revolves in the reverse direction." Plato wrote in *Politicus*: "There is at that time great destruction of animals in general, and only a small part of the human race survives". The Chinese say that it is only since a new order of things has come about that the stars move from east to west. The signs of the Chinese zodiac have the strange peculiarity of proceeding in a retrograde direction, that is, against the course of the Sun. The Eskimos of Greenland told missionaries that in an ancient time the Earth turned over.

FIRESTORMS

Excerpts from ZetaTalk:

These fire storms are caused by reaction of atmospheric gasses to the turmoil going on.

NAPHTHA

Excerpts from *Worlds in Collision*, by Velikovsky, pp. 53-55:

Crude petroleum is composed of two elements, carbon and hydrogen. The inorganic theory (of the origin of petroleum states that) hydrogen and carbon were brought together in the rock formations of the Earth under great heat and pressure. The tails of comets are composed mainly of carbon and hydrogen gases. Lacking oxygen, they do not burn in flight, but the inflammable gases, passing through an atmosphere containing oxygen, will be set on fire, binding all the oxygen available at the moment.

The descent of a sticky fluid which came earthward and blazed with heavy smoke is recalled in the oral and written traditions of the inhabitants of both hemispheres.

Popol-Vuh, the sacred book of the Mayas, narrates: "People were drowned in a sticky substance raining from the sky...and then there was a great din of fire above their heads." The entire population of the land was annihilated. A similar account is preserved in the *Annals of Cuauhtitlan*. The age which ended in the rain of fire was called "the sun of fire-rain".

In Siberia, the Voguls carried down through the centuries and millennia this memory: "God sent a sea of fire upon the Earth." In the East Indies, the aboriginal tribes relate that in the remote past "water of fire" rained from the sky. With very few exceptions, all men died. The (Egyptian) papyrus *Ipuwer* describes this consuming fire. "Gates, columns, and walls are consumed by fire. The sky is in confusion." The papyrus says that this fire almost exterminated mankind.

THE SHIFT

Excerpts from *Strangers Among Us*, by Ruth Montgomery, pp. 228-230:

The event itself will occur in the twinkling of an eye, as the Earth slurps onto its side. In

daylight areas, the Sun will seem to stand still overhead. Those who are capable of reaching safety will see the Earth's surface tremble, shudder, and in some places become a sea of boiling water as the oceans pour upon the land.... Picture a giant wave, higher than a ten story building, racing toward shore. Ferocious winds will howl across the land. The stars will seem to swing giddily in the heavens. As dawn breaks the Sun will seemingly rise from the wrong place on the horizon.

THE COMING CHANGES

Excerpts from *Mary's Message to the World*, by Annie Kirkwood, pp. 2-3:

As the world turns and changes direction, many natural occurrences will be deemed disasters.

Mountains will move, seas will be upturned; new lands will come out of the ocean, some of the land which is now inhabited will be inundated and returned to the ocean floor to be allowed to renew. These natural disasters have already started, but in the future they will occur more often and with increasing violence.

CATAclysms

From *Troubled Times*:

I am amazed at the number of people that don't get it. A pole shift is a **very, very bad thing**. To think you will be able to survive by holing up in your bunker for a couple of years and then come out to plant your crops tells me that one does not appreciate the gravity of the situation. A pole shift will cause **permanent** climactic change for any part of the globe. The upset to the global ecology will be **long term**. This is why many species don't make it through. Its not a matter of surviving the shift itself; that, by comparison, is the easy part. For

those counting on the lift, be prepared to be thrown from the frying pan into the fire. A primitive existence may be possible in some parts of the world if you are lucky. By primitive I mean you have breathable air, you have water that won't kill you, and you can scrounge for the little bit of protein that wanders your way, that's it.

If Velikovsky is right, there is little hope of having useable sunlight for a long, long time. Volcanoes are prolific producers of noxious gasses and dust. Expect CO₂, H₂S, NOX, Arsenic, Lead, and many other nasties to climb to toxic levels just about anywhere. Microorganisms will be tossed into the air [which] our immune systems haven't seen for thousands of years. If that is not enough, dust will linger in the upper atmosphere for many years to come, blocking our life giving Sun. This shift is unique for us, the difference is population, we have available to us more knowledge, resources, economies of scale only achievable by many brains with the ability to communicate with one another. We do not have to settle for a 90% or 99% mortality rate. The fittest among us may be able to survive to propagate with primitive preparations, but we do not have to settle for that. We have know-how called technology, some of it appropriate, some not, which can help us to improve our odds if we are willing to shift from being consumers of the fruits of technology and towards claiming it as our own. This may mean that instead of knowing how to use a water filter you may take the trouble to understand its composition and how it works. It may mean that you will have to take the responsibility to learn the fundamentals of ecology so you can rebuild it where Nature can't or won't for your benefit. We do not have to be at the mercy of Nature where we can command Nature.

For those of you who get it, more power to ya. For those of you who don't, food for thought.

AMBROSIA & MILK AND HONEY

Excerpts from *Worlds in Collision* by Velikovsky, pp. 134-138:

In what way did this veil of gloom dissolve itself? Has any testimony been preserved that during the many years of gloom carbohydrate precipitated? After the nightly cooling, the carbohydrates precipitated and fell with the morning dew. It had an oily taste like honeycomb, and was ground between stones and baked in pans. The clouds brought the heavenly bread, it is also said in the *Talmud*.

There was a world fire, says the Icelandic tradition, followed by the Fimbul-winter, and only one human pair remained alive in the north. They fed on morning dew, and from (this pair) come the folk who people the renewed Earth.

The Maoris of New Zealand tell of fiery winds and fierce clouds that lashed the waters into tidal waves that touched the sky and were accompanied by furious hallstorms. The ocean fled. The progeny of the storm and hail were "Mist, the Heavy dew and Light dew".

The Greeks called the heavenly bread ambrosia. It is described by the Greek poets in

identical terms with manna: it had the taste of honey and a fragrance. The *Atharva-Veda* hymns say that honey-lash came down from fire and wind; ambrosia fell, and streams of honey flowed upon the Earth. The grains also fell upon the water, and the rivers became milky in appearance (i.e. lands of milk and honey).

NEW GEOGRAPHY AFTER THE POLE SHIFT

From ZetaTalk:

After the Pole Shift the Earth begins rotating again, with its new poles in the same relative position to the Solar System as today. In other words, whatever part of the Earth is North, magnetically, after the shift, will become the new North Pole. The Pole Shift, with consequent realignment of the poles, will place the new equator over formerly frozen lands. Greenland, Canada, Alaska, Siberia, and Europe will be affected by the new equator. This will not mean that these areas will be lush, right away. The temperate zones, not all that lush to begin with, will find themselves after the cataclysms in a warm state, but with little vegetation. Past cataclysms have regularly rearranged the Earth's geography and climate zones, as the Earth attests. The continents, once one large land mass, were torn apart, temperate or tropical areas suddenly freezing up and covering over with ice and snow that never melts, and frozen wastelands gradually melting and warming to sustain life once again. Mountains in mountain building areas were pushed higher and subducting plates were suddenly slid under the overplate.

THE IVORY ISLANDS

Excerpts from *Earth in Upheaval*, by Velikovsky:

Fossil tusks of the mammoth—an extinct elephant—were found in northern Siberia and brought southward to markets at a very early time. Northern Siberia provided more than half the world's supply of ivory, many piano keys and many billiard balls being made from the fossil tusks of mammoths.

In 1797 the body of a mammoth, with flesh, skin, and hair, was found in northeastern Siberia. The flesh had the appearance of freshly frozen beef; it was edible, and wolves and sled dogs fed on it without harm. The ground must have been frozen ever since the day of their entombment; had it not been frozen, the bodies of the mammoths would have putrefied in a single summer, but they remained unspoiled for some thousands of years. In some mammoths, when discovered, even the eyeballs were still preserved.

(All) this shows that the cold became suddenly extreme...and knew no relenting afterward. In the stomachs and between the teeth of the mammoths were found plants and grasses that do not grow now in northern Siberia...(but are)...now found in southern Siberia. Microscopic examination of the skin showed red blood corpuscles, which was proof not only of a sudden death, but that the death was due to suffocation either by gases or water.

SINKING ATLANTIC

As we have stated, the Atlantic will widen

and the Pacific will shorten. Where the Pacific effect will cause sudden and violent subduction of several plates, which are already subducting, in the Atlantic the effect will be the opposite. A gulf will appear, with plates torn apart and the softer magma under the plates exposed to the cold Atlantic water. Where this will harden the magma, and establish new plate surface, there will be less support for the abridging plates, those that attach however remotely to the shorelines of the Americas, Europe, and Africa. These non-supported plates will sink, somewhat, bringing their formerly above-water land masses down under the water in many places. As an instance, Europe and in particular the western islands of Britain and Ireland will find itself more affected than some other parts of the globe.

WHALES IN THE MOUNTAINS

Excerpts from *Earth in Upheaval*:

Bones of whale have been found 440 feet above sea level, north of Lake Ontario; a skeleton of another whale was discovered in Vermont, more than 500 feet above sea level; and still another in the Montreal-Quebec area, about 600 feet above sea level. Although the Humphrey whale and beluga occasionally enter the mouth of the St. Lawrence, they do not climb hills.

To account for the presence of whales in the hills of Vermont and Montreal, at elevations of 500 and 600 feet, requires the lowering of the land to that extent. The accepted theory is that the land in the region of Montreal and Vermont was depressed more than 600 feet by the weight of ice and kept in this position for a while after the ice melted. Another solution would be for an ocean tide, carrying the whales, to have trespassed upon the land.

But along the coast of Nova Scotia and New England stumps of trees stand in water, telling of once forested country that (has since become) submerged. And opposite the mouths of the St. Lawrence and the Hudson rivers are deep (land) canyons stretching for hundreds of miles into the ocean. These indicate that the land (has become) sea, being depressed in post-glacial times. When did both processes go on simultaneously, in neighboring areas, here up, there down?

DESCRIPTION OF APPROACHING 12th PLANET AND EARTH FLIPPING ON HER AXIS?

Revelation 8:

5 And the angel took the censer, and filled it with fire of the altar, and cast it into the Earth: and there were voices, and thunderings, and lightnings, and an earthquake.

6 And the seven angels which had the seven trumpets prepared themselves to sound.

7 The first angel sounded, and there followed hail and fire mingled with blood [*iron oxide?*], and they were cast upon the Earth: and the third part of trees was burnt up, and all green grass was burnt up.

Regarding saving DNA from animal species, so that these species will continue after the cataclysms.

Excerpts from ZetaTalk:

This is not a human endeavor we would recommend. In the first place, humans are not adept at regenerating a creature from DNA, nor would you be able to store this DNA effectively, given the nature of the cataclysms. The DNA would be spoiled due to neglect, as humans would have so many greater concerns during the Aftertime. In the second place, animals in one form or another have survived repeated cataclysms. Natural evolution takes place, in any case, and the cataclysms only trip the balance this way or that. Without the cataclysms your Earth's animal species would be different, a different mix, and with some species now long extinct still present. But because these extinct species had survived, others would not have thrived, due to competition. Therefore, beyond protecting nature preserves, do not concern yourself over animal survival. Nature looks after her own. [End quoting]

PLANET COVER-UP MECHANISM

Excerpted from ZetaTalk:

Along those lines, as to why the rich and powerful who set the rules would not want the 12th Planet's threat known by the public, is the existing ZetaTalk topic called Impossible Message, at <http://www.zetatalk.com/govmt/g85.htm>, a portion below (Begin ZetaTalk[TM]) The major governments of the world, and we are speaking here of key members of the super powers, and captains of industry already have regular briefings on what the Hubble has viewed and recorded. We are making great strides along project funding trails, but each delay hurts and

disappoints—only, usually, to find timing far better from the higher viewpoint than from our own tabletop ability to see.

Now for the cases heard yesterday in Nevada. States Hide Trillions Of Dollars By Keeping Different Sets Of Books

6/29/98 DR. AL OVERHOLT

From *THE SPOTLIGHT*, 6/29/98: [quoting] *Trillions of dollars are controlled by the politicians and the bureaucrats in little-known county, state and federal "slush" funds in every state in the union and at the federal level. However, through book-keeping gimmicks, the truth about these massive funds (which actually and rightfully belong to the taxpayers) is being kept under wraps—with the willing cooperation of the major media in this country. Yet citizens are being soaked with continuing tax hikes to finance day-to-day state operations even while these hidden slush funds are bringing vast profits to high-level international financial power brokers that benefit from controlling this huge slush fund.*

That's the astounding discovery made by veteran commodity trading advisor and analyst Walter Burien who was a guest on the June 7 broadcast of The SPOTLIGHT's weekly call-in talk forum, Radio Free America, with host Tom Valentine. An edited transcript of the interview with Burien follows. Valentine's questions are in boldface. Burien's responses are in regular text.

You've made some astounding allegations, but these allegations are based on factual information that is actually available to the public if they know where to look and how to look. And you discovered what you did discover quite by accident and it's a remarkable story. Could you give us the background on how you came across this information?

The best way to approach this is to give a chronological accounting of how I became aware of what I call "the biggest game in town" (which goes on across the country).

Let's go back to 1989. I was living in New Jersey and Gov. Jim Florio got elected on a "no new taxes" platform. Yet, as soon as he got into office, there was a \$2.8 billion tax increase, the largest in the state's history. That created the proverbial "(bleep) hitting the fan" and one

of the local radio stations at that time, 101.5 FM, started doing some rabble-rousing with the public for their input on government waste and mis-spending and griping about the taxes.

On the first day I listened to a lot of people talking about examples of \$5,000, \$10,000, etc. The highest figure I heard was \$85,000. I then pulled out the budget report and called the show and read out the billions of dollars that the state was dealing with and I pointed out that the highest figure I heard had been \$85,000 although the budget was in the billions and if there was fraud and waste going on it was taking place on tens of hundreds of millions of dollars.

The radio show host challenged the listeners to start an organization to repeal the tax increase. Two days later 10 of us got together and I incorporated a group called "Hands Across New Jersey" and within about 14 days we had our first rally in Trenton and about 115,000 people converged on the city and just about shut the city down.

During the time of organizing that rally, I started taking a look over the budget revenue and finances of the state. Up until that point I thought I was a pretty sharp cracker and knew what was going on and I always figured that "the boys" were floating 5 to 10 percent of the revenue and not reporting it to the public. When I looked I found out I didn't have the foggiest clue.

The first thing I did was check the budget report and find the total cost of all services. (This was 1989's report.) They had \$11 billion on budget, \$6 billion off budget, a total service budget of \$17 billion. I then checked the "net available" on the budget report. That showed a net available of \$24 billion, 648 million.

Then I asked the question which is the first question that the IRS asks in an audit: "What are the gross receipts?" I started adding that up and I came up with about \$44 billion. I said, "Wait. How can the state have a service budget of about \$17 billion, and showing a net available of \$24.6 billion, yet I was counting about \$44 billion brought in for the year in cash?" I figured those reports had to be available someplace.

And during that rally that followed, I knew about this \$44 billion in cash receipts and the budget of \$17 billion. I briefed the public on the difference between the budget and the gross receipts.

I had about 15 people come up to me and ask if I wasn't afraid of getting "blown away" saying this on the steps of the New Jersey state

capitol building? I said, "No, but if I was one of the boys in a position of trust, I'd give myself about three days. But since I am not one of the boys in a situation of trust and confidence, they are going to start asking how in the heck I figured this out and asking whom I had been speaking to."

After the rally I said to myself that there was too much money not to be accounted for under one book. My father was personnel manager for the state treasury for about eight years and I had a pretty good knowledge of how to get around and through the different state departments.

The director of the budget, at that time, was on vacation until the following Tuesday. I found out the names of his two lowest-level assistants and I got the lowest one of them on the phone first and said, "I'm working on a report for Richard [the budget director] and I have to have it done by Tuesday I need all the figures on the autonomous agency accounts, interest accounts, investment accounts," and he says, "Oh, you want the comprehensive annual financial report." This was the first time I ever heard of that in my lifetime. I said, "Yeh, how can I get it?" He said, "Talk to Bill," who was the next assistant.

I called Bill, and said, "Hi, this is Walter Burien, I'm working on a report for Richard. I just talked to Jim and I need the comprehensive annual financial report."

I got the report that Friday. It showed liquid investment funds of \$188 billion; common stock ownership of \$70 billion; on loan to public and private corporations, \$10 billion; and insurance company equity participation, \$14 billion. This blew me away.

And this was only the state of New Jersey. I realized that day, right on the spot, what was going on. I also learned the definition of syndicated organized crime that day.

Anything that was a cost and an expense on service to the public—the traditional side of the service budget, such as the Department of Transportation, health and welfare, etc.—they left under the budget report and the public footed 100 percent of the bill for 100 percent of the services under the budget report. That was \$17 billion.

Anything that was a profit center-generated revenue (the Port Authority for New Jersey, the New Jersey Turnpike, an investment account, etc.), or which had the potential for generating revenue was totally restricted by statute for no tie or inclusion whatsoever with the budget report. This is what was disclosed on the comprehensive annual financial report.

My question to myself, as I said, was that question that the IRS asks: What are the gross cash receipts? Here's an example of what I discovered: The 1989 figure in the comprehensive annual financial report on page 174, under the Waste Water Treatment Trust Fund, shows a total of all agency funds. On the "cash" line item they have the beginning balance and ending balance. The beginning balance was \$25 billion, 899 million. Their ending balance was \$6 billion, 894 million.

Here is the important part. It shows the additions and deduction, which is the amount of the total cash receipts brought in for the year from all state agencies and departments. The service budget was \$17 billion.

Are you ready for how much cash they brought in for the year? It was \$86,775,380,712. That was for 69 autonomous agencies, the budgetary bases, investment accounts, etc.

I immediately went down to radio station 101.5 and gave it to them. For 45 minutes they read out the bottomline figures. I suggested to the listeners this example: suppose you reported your beginning checking account balance at \$5,000 at the beginning of the year and you put \$40 million through your checking account and you ended your balance at \$3,500. That's the game going on here.

On the comprehensive annual financial report you looked through the spread sheet on total revenues and it listed approximately \$136 billion, but if you look through the notes on the report, you find another additional \$60 billion. On the common stock ownership it listed \$32 billion. But I saw little asterisks that referred to a note and on that note it stated that the accounting and balance was determined on purchase price, not on market value.

In other words, if they bought AT&T stock 30 years ago at \$1.25 a share and it's worth \$3,000 a share now, they still report it at \$1.25 a share. I checked my contacts to find out the true market value and it equated to \$70 billion.

And these guys raised the taxes on the people of the state of New Jersey when they could have paid them back twice the taxes and still had money left over.

If they had combined the entire operations owned by the state government as a whole, they could have dropped all taxation in the state of New Jersey and if they streamlined everything they could have had a dividend check for every person in the state.

No wonder this is dangerous talk.

I started investigating further. Everyone is familiar with the New Jersey state turnpike and the Garden State Parkway. When they wanted to build those authorities they had to put out a measure for voting upon by the public. They said that they were going to put out a \$7.5 billion bond issuance and that they were going to build those authorities and that they would be toll roads until the bonds were paid off.

And until the bonds were paid off, the bondholders would be the owners of that authority. Once the bonds were paid off, the authorities would revert back into the budgetary basis as budgetary groups. They were also restricted at operating for a profit. The public said okay and they built these authorities.

Then what they did was this: say they made a \$400 million profit for the year and the actual payment on the bonds was \$100 million. They made the \$100 million payment for the bonds and took the \$300 million and put it into a bond surety escrow account for future liability payments. They wrote it off as a line-item payment and did not declare it as an asset.

In 1990 when I checked on the total bond liability for the turnpike, it was \$14.5 billion. Guess how much was in the bond surety escrow accounts? Thirty-eight billion. Enough to pay the bonds off three times over.

The same game was being played with all the autonomous agencies and the bottom line is that they are dealing with hundreds of billions of dollars and the control of those billions is what's the motivating factor, not the benefit of the public. The public is kept in the dark, looking off in left field as they are doing business as usual in right field.

So this is going on in other states, too?

Well, after I found out about New Jersey, it dawned on me what the composite total for all

states and the federal government if this was happening all over. I started looking and what I saw floored me.

Take the composite total of city, county, state and federal of common stock ownership. Across the country it comes out to in excess of \$32 trillion. That's 53 percent of the entire open interest of all stocks issued. Take California. This state has in excess of \$2.5 trillion in common stock ownership.

So we really don't have a national debt then?

They can't pay it because they are restricted by statutes.

I understand that and it's amazing.

To explain what's going on I can provide several examples. Everyone has heard of Al Capone, the Chicago gangster. He ran a lot of legitimate businesses including newspaper stands, flower shops, etc. He kept one set of books for those legitimate businesses. Let's equate those to the budget report.

For the other businesses (book-making, prostitution, drugs) he ran through those newspaper stands and flower shops, he kept a second set of books that he didn't want anyone knowing about.

On the comprehensive annual financial report (for the state of New Jersey), the vast majority of revenue groups that the government doesn't want the public digging into is on the comprehensive annual financial report. It's like when you hear about the \$5 trillion national debt under the federal budget; but you don't hear about the \$30-plus trillion in liquid investment funds.

Is this information generally available to the public?

If you know to ask for it. The state auditor generals or the state treasurers offices of the states put the reports out. When I saw these figures 10 years ago, I asked how the public couldn't know about this. But I found that every elected official I spoke to had never heard of the comprehensive annual financial report. The one who did know was Sen. Bill Bradley (D-N.J.).

I showed him the report at a public gathering and he said, "You've got that?" And he said, "See you later." He didn't want to get his picture taken with that report. But other politicians denied knowing about the report.

In Arizona when I got the report for that state, there was a breakfast of county supervisors and former Gov. Evan Mecham was there. I asked him whether he knew of a report that consolidates all of the financial material. He said, "No." I asked him if he had ever heard of the comprehensive annual financial report and he said, "No." Then I produced it and said, "Here it is. This is the same report you signed when you were in office. Here's your signature on the front page." And he said, "Oh I thought you were talking about another year." I said, "Uh-huh."

Do you think he knew what was in the report when he signed it or did some faceless bureaucrat give him the front page to sign and then take it away?

You'll have to give him some sodium pentathol to find that out. Here's another example: every person should imagine himself the state government of New Jersey. Your salary is \$50,000 year and your budget for operating your house is \$3,500 per year. You could audit your budget 100 times over. If you spent \$4,000 this year on your house and you only had \$3,500 allocated, you could go to your neighbor and ask

for \$500. So what's happened is that structure has been created to allow the gross receipts to be totally hidden from the reality of what's reported on the budget report.

I want to congratulate *The SPOTLIGHT* and *Radio Free America* because you are the first news medium to disclose the name of the comprehensive annual financial report to the public.

There is a total news blackout on mentioning of the report. Back in New Jersey I was dealing with hundreds of reporters, but not one newspaper mentioned it. I said: "That's a lot of control." People asked me, "If it's this big, how come we don't hear about it?"

Gov. James Florio appointed 16 editors and reporters to directorships in state government. The guy they pitted against me was Harvey Fisher who was one of the *Bergen Record* reporters prior to the Florio campaign and he was appointed assistant treasurer of the state of New Jersey (even though he had no formal financial background whatsoever). I thought about that.

As a reporter he was making \$35,000 per year. As assistant treasurer he was making \$65,000 a year. I checked his expense account. He had a carte blanche expense account of \$125,000 with basically discretionary funds.

Now I knew that there was a data search department in the state run for four individuals which tied all agencies and departments together. I called up the department and asked for a data search on all key-level directorships and supervisory positions for all agencies, whether they be budgetary or from the autonomous agencies, and they came up with some 3,500 names. Close to 1,800 of these people were former editors or reporters. And if you do a comparable search in other states you'll find that the more money involved you'll find a higher amount of editors and reporters. That's a phenomenal amount of control.

So the media is part of the cover-up here?

Yes, and the comprehensive annual financial reports are sent to all of the major newspapers and editors but they refuse to make one mention of it. It's a cooperative effort going on. Once you know how much money is out there and where it's coming from and where it's going, the game is over. When we went on the air on radio 101.5, a few days later they were being threatened with having their broadcasting license pulled and they almost had to shut down.

People should contact their local newspapers and make a simple mention of the comprehensive annual financial report for their states and ask the papers to show their readers the total revenue shown in that report, whether restricted by statute or the like. It would be interesting to find out how many newspapers will even make simple mention of this.

Always remember the key difference between the budgetary basis and the restricted-by-statute groups. The public has been played as a sap.

In New Jersey alone there's maybe \$80 or \$90 billion that's there. Somebody is handling all of that money in New Jersey and elsewhere and they can use it to make a bundle.

That's right. Here's an example: say that you're a comptroller in California and you're controlling \$700 billion. Say I'm the chairman of Shearson Lehman Hutton banking group. You have \$140 billion with my firm. That will generate about \$10 billion a year for my firm.

You call me up and say: "My brother needs a \$49 million unsecured loan in Argentina for a

sugar cane development energy project," and I'd have a loosely-connected subsidiary company make the loan. Your brother defaults on the loan and walks away with \$49 million and the company writes it off. The payola that takes place here is unfathomable. Any politician anywhere can be paid off anywhere around the world.

Through these investment funds, government has been taking over "private" insurance and medical firms, etc., and the public has no idea that these firms are [effectively] owned by the government. Any corporation can be targeted by these investment funds and totally taken over. Period. And they have been.

As I mentioned, 53 percent of all outstanding stocks are owned by government. The public is looking in left field and all the trillions are in right field. This structure is a virus and it has nothing to do with the interests of the public. It all has to do with financial conquest and the public has to be as naive as possible. TEACHERS AND STUDENTS

Unless you have been a teacher and have had a student finally start to actually THINK, you won't know what I could be talking about in the next few minutes.

We utilize things and sayings, lessons and poetry from ones who make good-sounding prose or rhymes and pay little attention to exactly what is being said and what meaning can be affixed. In this instance the topic is over the little bit of a saying I have recently shared with you as shared from one who cares about us. It is the one about *FORGIVENESS*: I forgive you, and I forgive myself for being caught in the process of change and for our being unable to see each other clearly.

On the surface you might well say "so what!" Or So, what? OR YOU MIGHT ACTUALLY READ IT WITH "MEANING" AND COME OUT WITH, "SAY WHAT?"

The kicker is how do YOU respond and what meaning might a few words hold for you. Most will read the words and consider them a "time out" to gain control over self and put things into some sort of perception and perspective of value to the participants in an interchange. I would point out as example: "If I perceive you have done something to me—I forgive you and drop it." "If I have done something I will rectify what

I can, but will forgive myself for any transgression and drop it." "We will assume we are in the process of some kind of change and are seeing only our own perspective, and certainly not with clarity." The acceptance then allows an individual to move on, accepting the differences in each individual.

We do have a reader who has gone further in thinking about this little sentence and it is worthy of consideration. And, no, every individual doesn't have to go into hours of confusion and confrontation over a sentence written by someone else and is willing to share some thoughts.

However, when a student stops and attends what is offered and then finds a wish to consider a topic more deeply, it is gratifying to the Cohan that there is actual "thinking" taking place somewhere by someone. It can well be like the debate over which came first, the chicken or the egg, and the actual "meaning" is as each perceives it.

wrong should not be forgotten, nor the lesson learned. The akasha has a perfect record of all that has ever occurred. Be it right or wrong.

9. This poem sounds like something from Maya Angelou or one of the New Age poets.

Boy oh boy, and oh boy! If Commander Hatonn gets hold of this and it is read aloud in a meeting, I'm in deep trouble, again, with the author, like I was before when I had to apologize all over the place, for putting brakes on this "team member" stuff.

[END OF QUOTING]

Anyone can read anything into anything any way they choose. Forgiving does not necessarily indicate that a "wrong" has transpired, but rather, there is herein an acceptance that there is human involved and imperfection offers the opportunity to recognize the possibilities of that imperfection.

Perhaps a better term for the "forgiving oneself" might be "release". You cannot forgive anyone until you can forgive self! If the term "forgiveness" is the offensive term, then consider some other term, but ALLOW release of blame for that is what is actually being expressed herein, i.e., "I don't blame you and I don't blame myself... We are involved in ever-changing events and impacts and we simply don't always see each other's point of view, clearly or otherwise."

Indeed all IS changing, as in the author's response—but we are not talking about the ever-changing glory of God's universe. The sentence indicates a recognition of some inability to communicate or function with an "other". "Forgiveness for being unable to see each other clearly," simply addresses the fact that we don't like change and we can't see clearly through our own eyes, much the less through the eyes of another.

Our author of this response says "The time will come when we see clearly and is forgiveness needed for this?" YES. That is, unless you are PERFECTION, which you are NOT, and the things of the Master's teachings were far more encompassing than is an assumption of two people making an effort at understanding and making allowances for the actions of one another.

Let us look at it this way: I forgive you (I don't blame you for not seeing this as I see it); I forgive myself (I don't blame myself for this disagreement because it is alright for you to have your opinion and I to have mine); "We each have a right to have our own perception."

As to forgiveness implying "absolution"—NO, it does not. It may be implied to you—but in actuality it is not to be interpreted in this manner. Absolution indicates a wiping away of something as if it never occurred—FORGIVENESS does not in any way even suggest forgetting or irresponsible actions as being absolved and much the less "forgotten". It does offer that "in spite of our transgressions or cloudy vision and personal opinion, I offer you the right to yours and me to mine without demanding restitution. If "I" have offended, then I shall make an effort at restitution. And, if someone tells you that he/she can or has read the Akashic records and thus and so—, run like heck in the other direction for those records are not open books for the users and eavesdroppers.

Those records as relate to an individual are between that individual soul and GOD—which, after all, indicates ONE and the same.

There are many RECORDS kept, and I personally was called "the Record Keeper" for a very long time in this quadrant of experience. This is far different from what are recognized, usually incorrectly, as Akasha recordings.

In this particular little bit of writing YOU recognize an "imagined" or "imaginary wrong". Perhaps you had too little insight to know that it WAS NOT IMAGINED BUT AN ACTUAL AND INTENTIONAL "WRONG" PERPETRATED. You cannot jump to conclusions out of context lest you make wrong or negative assumptions.

What we might take from this little speaking is that we offer up that we are imperfect and sometimes communications are lacking in both clarity and understanding. Anything that gets you back into communications is worthy of the five seconds it takes to recite it to self, drop the ego tripping, and start again to speak so the other might hear without hostility. In other words: "DROP IT" and, move on, already!

It is good to take time and really pay attention, and then realize that your opinion is only that—your opinion. AND MY OPINIONS ARE, LIKEWISE, MINE. So, I forgive you, and I forgive myself for being caught in the process of change and different perspective on this topic and the fact that we see each other quite darkly at this moment; clarity, if given a chance, will come if we but be understanding and patient one with another.

So, use it or don't use it. The wonder of God is that either way it is quite alright. It indicates that you are no greater or lesser than am I, and likewise I am not greater nor lesser than are you—for a disagreement. Neither do I, nor YOU, become greater or lesser by an agreement. If I be the teacher and you the student, it is pleasant if you find your agreements fall on my blackboard. However, it is not necessarily the point at issue—for the point is that the student is starting to think more carefully about something, and in this instance it is the meaning of "Forgiveness".

What is most often happening in these more current days is that words have little or no meaning left after they have been misused and abused. It becomes so often that people can't communicate because even in a common language there can be so few absolute definitions and that is the tool-supreme of the Evil

gamesmen who confuse, trick, misdirect, misspeak and misdefine so that an individual will surely lose his way if not most careful indeed. Take the word "love" or "sleeping with...". Those terms no longer have a meaning in direct definition. One actually has come to be accepted as "not sleeping with but making love to...". Whoa, that is even worse for what is happening is neither sleeping nor LOVing. It is indicative of a "roll in the hay and actual physical sexual exchanges" which do not represent sleeping or love.

So often poetry rhymes but does not offer correct interpretations, and at best a writing is the direct perception of the one writing. This can be gifted talent or a child making rhymed phrases as in "roses are red and violets are blue"—BOTH STATEMENTS ARE INCORRECT FOR ROSES COME IN ALL COLORS, MOST ESPECIALLY NON-RED, AND VIOLETS ARE NOT BLUE—THEY ARE AS THEIR NAME IMPLIES—VIOLET. But, some violas are quite blue and yellow and white and, and, and.

I would remind all of you that my thrust always has been for you to read, study, think and venture into EVERYTHING you can get in your hands—from all sources. Truth stands after all the other falls away, and a good education into everything offered causes the one TRUTH to be left standing.

I would never even suggest you not read a poem as simple as this little one-sentence phrase. And, if it causes you to think, all the better. However, most things, as with this poem—are only as worthwhile as you make same to be, so if it disagrees with your interpretation as you ASSUME it to be presented—drop it and move on. And, lesson to top the list: Never assume a whole story from the punchline. I could build a thirty-two-volume book tale on what might have happened before the last few words were written in this little ditty. And, it is that very talent that brings forth great writers! So be it for I don't want to whip a weary horse to death.

I note that in your great political arenas a politician doesn't even write his own speeches—he has writers. Every notable has a book written BY A GHOST WRITER that neither expresses the author's attitudes nor his perspective—but that of the manipulators and puppet-masters. 
