Missing Data About Mysterious *Swissair Flight 111* Who Gains & Who Loses?

An uncharacteristically revealing Associated Press release for Thursday evening, 9/10/98, began with the following comments: “Swissair Flight 111 crashed into the ocean off Nova Scotia with such force that **the impact registered at a regional seismic center**, investigators said Thursday. **Only 2 percent of the aircraft has been retrieved** so far, **mostly small pieces** that were floating on the surface of the Atlantic, said Vic Gerden, the chief crash investigator.”

Now, was it the “crash” of an intact airplane upon the water which generated a strong enough concussive pressure-wave to wiggle the seismographs? Or, was the shaking of the seismic instrumentation possibly due to the

blast-wave of a bomb-type explosion—maybe happening while the airplane was still in the air—which would more tellingly account for those many little airplane and cargo fragments and body parts so widely dispersed all over the place? Was this particular news announcement part of a calculated process of cover up, after ones learned a lesson from the inconvenient (to the official story) “double signature” of the seismographic record near the Oklahoma City bombing event? Hmmm.

N. KOREA MISSILE ZOOMS OVER JAPAN

Excerpted from *THE ORLANDO SENTINEL*, 9/1/98: [quoting]

Some experts said the showy test launch might be a ploy to gain leverage in talks with the United States.

Possibly angling for concessions in upcoming weapons talks, North Korea launched a new, more powerful long-range ballistic missile on Monday that crossed over Japan's main island and crashed into the Pacific Ocean.

A Japanese defense official said the test missile appears to have had two stages, with the second projectile probably flying over the northern tip of Japan's main island and landing a few hundred miles off its Pacific coast.

The first stage of the launch apparently dropped into the sea about 180 miles southeast of Vladivostok, Russia, said Defense Agency spokesman Toru Kawajiri.

Kawajiri said the missile was thought to be a Daepodong I, a rocket much more sophisticated than anything the North has previously tested. The Pentagon calls the missile a Taepo Dong I, which is merely a different transliteration.

The launch comes just ahead of the convening of North Korea's new parliament Saturday for a congress expected to anoint leader Kim Jong II as president of the reclusive communist nation.

It also comes as North Korea and the United States are involved in talks in New York about giving the North two badly needed civilian nuclear reactors in return for its suspending efforts to develop missiles and atomic weapons.

Some Korea watchers said the timing was likely a bargaining ploy. [End quoting]

On Art Bell's late-night radio talk-show, one "reliable source" said there were actually two missiles launched and that one was "diverted" from what would have been a particularly volatile target—a nuclear facility in Japan!

SENATORS ASK FBI TO CONSIDER ASSASSINATION

Senators asked FBI Director Louis Freeh Thursday to consider the legality of assassinating Osama bin Ladin and other suspected terrorist leaders. Referring to terrorist leaders, Sen. Dianne Feinstein, D-Calif., asked Freeh, "What is present law with respect to their takedown?" Sen. Joseph Biden, D-Del., said, "I would very much like a legal memorandum from the FBI, stating whether or not the prohibition against assassination of heads of state applies to organized crime units and/or terrorist units."

Freeh said that while the prohibition against killing heads of state is clear, he was unsure about the legality of assassinating others and would study the question.

There was no doubt in the Judiciary Committee hearing who the senators had in

mind: bin Ladin, the alleged mastermind of the Aug. bombings of U.S. embassies in Kenya and Tanzania that killed more than 250 people, including a dozen Americans.

After the hearing, lawmakers stopped short of advocating an assassination attempt on the exiled Saudi multimillionaire and fundamentalist Muslim. But even public discussion of assassination represents a sharp change on Capitol Hill, where the pressure for the executive order prohibiting U.S. involvement in assassinations originated in the 1970s. "I just want to know what the law is," Biden said.

Feinstein said arrest of terrorists is the best option but other "robust" strategies should be considered.

"We have to think in a different way than we thought before," Feinstein said. "It's a very dicey thing to get into a situation where you're going to have licensed hit squads. At the same time we need to find ways to be proactive." [End quoting]

BUYOUT OF AMOCO REUNITES TWO PARTS OF ROCKEFELLER'S TRUST

CHICAGO (Bloomberg)—The buyout of Amoco by British Petroleum Co. (BP) will rejoin two parts of John D. Rockefeller's Standard Oil Trust split apart near the turn of the century by an epochal U.S. Supreme Court anti-monopoly ruling.

BP absorbed Standard Oil Co. of Ohio, Rockefeller's original base, in 1987, when it bought the 45 percent of the company it didn't already own. Amoco is the direct successor of Standard Oil Co. of Indiana, a company created by the dismemberment of the Standard Oil Trust. Amoco's buyout by BP is the latest

consolidation in which parts of a giant sundered by antitrust action will rejoin. Consolidation is well under way among the Baby Bells created when the American Telephone & Telegraph Co. monopoly was broken up in 1984.

"They are all coming back together," said Edward Maran, an analyst with A.G. Edwards & Sons.

Dan Dietsch, an Amoco spokesman, said, "John D. Rockefeller is probably whooping it up in his grave."

The 1909 Supreme Court decision that split Rockefeller's conglomerate came decades after it amassed a huge monopoly and attracted a barrage of criticism for predatory practices.

Standard Oil was huge. It had more than 80 percent of the domestic and export markets for kerosene, a more important product than gasoline or diesel at the time. It refined more than three-quarters of all U.S. crude oil and controlled petroleum transportation along key corridors.

Many years after the Standard Oil Trust was broken up, BP, searching for reserves outside the volatile Mideast, became interested in exploring for oil in Alaska.

As a means of refining and marketing Alaskan crude, BP bought a stake in Standard Oil of Ohio, or Sohio, as the company was known. Sohio disappeared as a separate company after the 1987 takeover.

In 1985, Standard Oil Co. of Indiana became Amoco. Now it is Amoco's turn to be absorbed, though the change won't be as drastic as Sohio's.

The Amoco name will live on as the second half of BP Amoco PLC. In addition, it is BP, not Amoco, that will give up its brand identity in the United States. [End quoting]

ATTORNEYS CHARGE 'COVER-UP' IN CASE OF YOUNGEST-EVER MURDER SUSPECTS

CHICAGO—Attorneys for the city's youngest-ever murder suspects are charging the Chicago Police Department and the State's Attorney with a major "cover-up" in their "rush to judgment" to "railroad" the juveniles to jail.

Attorney Lewis Meyers, co-counsel for an eight-year-old suspect in the murder of 11-year-old Ryan Harris, told *The Final Call* Aug. 23 that police never shared critical information with defense attorneys that would prove their client and a seven-year-old boy could never have committed the crime.

Such information includes eye-witness accounts given to police in the early stages of the investigation and an autopsy report. Ryan was found July 28 near an abandoned building. She died from suffocation and had been sexually assaulted. (See *Final Call*, Vol. 17, No. 43)

The attorneys recently were successful in getting electronic monitoring bracelets removed from the boys' ankles, allowing them to attend public school if they choose to. They had been scheduled for in-home schooling because they would have been confined to the home.

"The only reason why police are now backing off of their earlier statements is because we got involved. The more people come forward, the more they (police dept.) become embarrassed. We hope the State's Attorney will come forward and say they made a mistake, but we are prepared to go the distance," attorney Meyers said.

He said they now have information from witnesses that the girl was seen alive hours after the seven-year-old said he had struck her with a rock, causing her to fall from her bicycle. [End quoting]

One wonders who is being protected at the kids'

expense.

RED CHINA AT WORLD BANK TROUGH





Not a problem for the new Craftsman computer-controlled 3,600-watt generator. It runs only fast enough to satisfy current electrical loads, reducing noise and saving fuel. Its secret: voltage synthesization, a fancy term that means a computer adjusts output to meet changes in demand.

The Portable generator has a 16-pole permanent magnet alternator that produces between 300 and 600 hertz of alternating current, depending on engine speed. A microprocessor collects pieces of the high-frequency waveforms and, with the help of a semiconductor switch, builds a 60-hertz waveform. Alternator speed is continuously adjusted to match output demand, using a tiny electronic stepper motor to position the engine throttle precisely.

In a *Popular Science* test of loads from 100 to 3,500 watts, the engine speed varied from idle to about 3,700 rpm, but the voltage held at between 118 and 120 volts. Frequency ranged from 59 to 62 hertz, as advertised.

With the 4-gallon fuel tank, the generator will run for 29 hours on a 25-percent load, 7 hours on full load. It costs \$1,000. [End quoting]

This sounds like a big convenience and fuel saver, but the price is quite high for most consumers.

BONE PHONE

From *POPULAR SCIENCE* magazine, Oct. 1998: [quoting]

Now that's using your noggin': Unlike other phones for the hearing impaired that amplify sound, the Miracle Phone transmits the sound through the bones in the head to avoid picking up static and background noise. Place the handset against a bony area of the skull, such as behind the ear, and the handset's pulsator creates vibrations that transmit straight to the inner ear to recreate the sound of the caller. Price: \$200. Daewoo Electronics, 120 Chubb Ave., Lyndhurst, NJ 07071. [End quoting]

This sounds like a fantastic invention. There have been many "messy" attempts to assist the hearing-impaired that require fancy surgery and electrical implants. This solution is amazing in its simplicity.

From *GUIDEPOSTS*, May 1998, P.O. Box 1479, Carmel, NY 10512: [quoting]



I've done a heap of living and praying inside this house. It's what folks in Charleston call a single house, because it's just one room wide, with the rooms in a row. My daddy bought this two-story clapboard house in 1940. First I took care of my grandma here, just like she had taken care of me. Then, while I was teaching school, I raised my sister Drew Willie's three kids and some of her grandbabies too. In the '50s, after Daddy died, there were 14 of us in the house, and I was the only one drawing a paycheck!

This old house and the Lord have been good to me; the house for 58 years and the Lord since 1918 when Miss Mabel Holmes, a kindly neighbor lady, carried me as a babe in arms to church. day holds, but I know you hold the day. Please go before me as a leading lamb and behind me as protecting angel." But that Sunday morning last July I never got to say it. I never even heard the porch window shattering. All I know is that around 5:00 A.M. Even so, I felt a jolt of fear as the big man leaped up and pulled off his trousers, then grabbed me and pushed me down flat onto the bed.

Mercy, I thought, and me a cripple, some ninety pounds and near eighty-three years old. My head swam but I didn't fuss or scream. It wouldn't have done me a bit of good because my house stands alone between two church parking lots.

Just lean on the Lord, Mary, I thought, as you always have. Helpless as a newborn kitten, I did something so strange that it *must* have been of the Lord. With that awful man on top of me, I raised my old, tired hands and patted his face. Then I patted his head, cleared my throat and said, "Young man, you don't really want to do

this. You wouldn't do it to your grandmother, would you? And you wouldn't want anyone else doing it to your grandmother. If you were in your right mind you wouldn't even be in my house."

yourself over to the hospital for some kind of treatment for addicts or you sign yourself into the mental hospital in Columbia."

I telephoned my cousin Gloria and she came over right away, along with the police. They insisted on taking me to the hospital but I was all right. Back home I propped myself up in bed again—I needed some rest after that experience! I could hear a police officer talking in the living room. "I don't know who was taking care of that lady," he said, "but I sure would like it if he would take care of me too."

Gloria appeared in my doorway. "Mary," she asked, "would you tell me again the words of that prayer you made up?"

I smiled. "Lord, I don't know what this day holds," I said, "but I know you hold the day. And the night too." Then I settled down for a bit of sleep. In the comfort of the Lord. —by Mary Mack Brown, Charleston, South Carolina [End quoting]

SOME BACKGROUND ON PRINCE BANDAR

Michael Collins Piper, in his book, *Final Judgment: The Missing Link In The JFK Assassination Conspiracy*, on pages 28-29 of the much expanded fourth edition, tells about DeWest Hooker, a personal friend of Joe Kennedy, John F. Kennedy's father:

"Born to wealth and privilege and a descendent of one of the signers of the *Declaration Of Independence*, Hooker had a varied career. Not only did he act on the Broadway stage, but he also modeled in cigarette advertisements. Hooker also served for a period as a talent agent with the powerful firm MCA and was, at a time during the 1950s, one of the highest-paid talent agents in America. Hooker also dabbled in television production and was equally successful.

"However, there was an aspect to Hooker's personal life that made him, to say the least, persona non grata in the entertainment industry: Hooker is unabashedly and frankly anti-Jewish. He will be the first to admit it, no questions asked. A powerfully-built man, Hooker is fearless and not afraid to make his position known.

One of Hooker's proteges was George Lincoln Rockwell, founder of the American Nazi Party. In his memoirs, *This Time The World*, Rockwell credits Hooker as being a major influence on his thinking. In fact, Rockwell dedicated the book to Hooker, along with several others, including Sen. Joseph R. McCarthy and General Douglas MacArthur. Hooker, Rockwell declared, was the one 'who taught me to know the cunning and evil ways of the enemy'."

Piper then tells about a private meeting in Palm Beach between Hooker and his good friend, Joe Kennedy. Piper says: "According to Hooker, 'Joe admitted that when he was ambassador to England he had been pro-Hitler.' However, in Kennedy's words, 'we' lost the war. By 'we' he didn't mean the United States. When Kennedy said 'we', he meant the non-Jews. Joe Kennedy believed that it was the Jews who had won World War II."

Piper then explains how Hooker and Joe made a deal to have Rockwell and others present John F. Kennedy as extremely liberal, so that he could become elected as President of the United States.

Hooker says, "Frankly, as far as I'm concerned, it was my work that got

Johnny Kennedy in the White House." You can read Piper's book, available from *Spotlight* newspaper ads, for more of the details.

Hooker tells of "my secret meeting with Papa Joe Kennedy and his analysis of the One World aim of the elite Jews, the same as mine. He swore to me that he taught the same ideas to Johnny and Bobby Kennedy since they were 6 years old (but he never mentioned Teddy to me; maybe he was too young at the time of our meeting in 1958, but Teddy, today, not to rock the boat, keeps his mouth shut on such matters). Both Johnny and Bobby Kennedy have been assassinated, along with my great friend George Lincoln Rockwell, who collaborated with me and Papa Joe Kennedy." DeWest says that Rockwell was his very best friend; they were the same age and spent a lot of time together. Hooker was also paid by Ghaddafi to come to Libya to advise him on what he knew about banking and other matters.

DeWest says that he thinks the reason he was not killed was because he was a business partner of the Rockefellers. DeWest Hooker was also a personal friend of Benjamin Freedman, a Jew who read the *Talmud* and was so disgusted with it that he changed his name to Freedman. Benjamin Freedman has often been quoted in *CONTACT*. Freedman took Hooker to a Jewish synagogue and had Hooker read some of it (he did not read it all; it was 32 volumes). What the *Talmud* contains had also been quoted in *CONTACT*.

The Swissair crash occurred last Wednesday, 9/2/98. Today is Tuesday, September 8. Today I received some documents and correspondence from Mr. Hooker, written before the crash. He is 80 years old now, with prostate cancer, and wants more of his story told before he moves on.

Hooker worked for Lew Wasserman of MCA and had important contacts, and tells about the time when the Jews approached him to help them gain influence with the Saudis. They offered to put \$100,000,000 in his bank account. At that time, the Saudi Arabian rulers hated the Jews and had control of a tremendous amount of oil. So the Jews wanted Hooker to fly to Saudi Arabia, "show them my \$100,000,000 bank account, and order 100,000 BPD [*barrels per day*] (\$0.25 per barrel to me, equivalent to said \$9,000,000 per year) for the string of gentile refineries they knew I represented. But when my ship got into 'international waters', I was supposed to switch my USA ship's destination and send my ship to Israel. I repeat, they were shocked when I refused because, unfortunately, many of my 'brother goyim' would do 'anything' for that

amount of money, which the 'elite' Jews are very conscious of and profit therefrom."

He explained the deal the "elite Jews" (his term) made with Saudi Arabia. The Jews knew that King Fhad and Prince Abdullah hated Jewish banks and the Jews did not want Prince Abdullah to become the next king of Saudi Arabia, and therefore assume complete power in such an oil-rich country.

So the Jews went to Prince Sultan and made a deal with him to arrange for him to become the next king, instead of his older brother, Prince Abdullah, in return for him allowing the Jews access to Saudi oil. As part of the deal, they made the Sultan's (illegitimate) son **Prince Bandar** [*emphasis mine*] Ambassador from Saudi Arabia to the United States.

Mid-East Realities has an article on the Internet entitled "Bandar Is Honorary Member of Zionist Lobby". Some of you may remember the news stories about when Secretary of State Madeleine Albright first went to Saudi Arabia. The discussions were about what kind of reception she might have, dealing with the very sexist Saudis. The Saudi who she met was Prince Bandar, who expressed strong support for Albright.


The Committee Against Corruption in Saudi Arabia has an Internet site and an article about Bandar bin Sultan's corruption, written some time before the Swissair crash. The article stated: "Everyone in Washington knows that Bandar is playing a political game of influence that he cannot pull off. He is trying to bring the Clinton Administration down and bring his Republican friends to the White House. Thus, **day after day, Bandar is piling up more and more enemies waiting for the right moment to bring him down hard.**" [*emphasis mine*]

The Saudi Embassy confirmed that Prince Bandar was killed in the Swissair crash, originally listed in the list of crash victims as "Alsaud, Bandar". The US media is still nearly totally censoring any mention of Bandar being in the crash, a man who was the Saudi Ambassador in line to possibly become the next king of Saudi Arabia. Bandar met recently again with Albright, and the Committee Against Corruption article also said: "Between 1984 and 1987, Bandar met with Defense Secretary Caspar Weinberger 64 times."

GLOBAL ALLIANCE INVESTMENT ASSOCIATION MEMORANDUM OF DIRECTIVE

The following points and authorities are offered hereby to eliminate any misunderstandings between negotiating parties as relative to the PERUVIAN BONUS CERTIFICATE # 3392-181, originated in 1875 and accepted as United States of America Treasury debt in 1906.

Since this debt was assumed prior to any other agreements involving monetary departments, divisions, or branches of government, this is a bonafide outstanding debt of the United States of America, the U.S. Treasury, the Federal Reserve System, the International Monetary Fund and the central World Bank and/or branches thereof.

The applicable restrictions and limitations in this transaction will apply to all participants. Due to NATIONAL SECURITY considerations no input to change or remand the validity of the debt created by BONUS 3392 will be accepted from the COUNCIL ON FOREIGN RELATIONS, the UNITED NATIONS, or any other entity, foreign or domestic.

As of November, 1997, all records formerly kept (and available for inspection) at the Peruvian Consulate in Los Angeles have been moved to Peru to prevent their possible destruction. Only individuals having appropriate authorization and credentials will be allowed to view them there.

All relevant documents, including the lawful chain-of-title of Bonus 3392, were legally recorded on August 10, 1998 at 8:35 A.M. and may be found at the office of Judith A. Vandever, Clark County Recorder, 500 South Grand Central Parkway, Las Vegas, Nevada 891-55-1510, Book 980810, Instrument 00323.

Because the amount of debt created by BONUS 3392 is so large that the global economy could be brought to collapse through its misuse, agreements have been finalized to allow the hypothecation of portions of the debt (through the use of contracts or deeds of assignment or leasing agreements) pursuant to the following rules and restrictions:

While prior use of the contract/certificate is noted, the parties using it will not be named in this document. Should such parties refuse their cooperation in the future, they may be named.

The contract has been utilized by the U.S. and hypothecated as COLLATERAL for use of the IMF and WB for the support of United Nations activities.

It has been agreed that the United States Federal Government may continue to use these contracts as collateral up to fifty percent (50%) of the accrued value.

The Holder of the contracts will be allowed to utilize the other fifty percent (50%), PROVIDING:

The Holder and its funding parties restrict themselves to single contracts not exceeding fifty billion dollars. (This does NOT preclude the offering of more than one such contract to any one entity.)

To avoid exposure of too large an asset it will be permissible to utilize corporations of common ownership to hold such additional contracts.

Under extraordinary circumstances warranting the issuance of one larger contract, for instance, the purchase of a single property, larger contracts may be issued if care is taken not to exceed the 50% use limitation.

It is anticipated that the Holder will purchase gold equal to the value of its portion of the contract to be pledged as collateral for a line-of-credit. Any "lease" arrangement must be structured to accommodate this requirement. The payment for leased collateral will be applied only to the funds available to the funder (not those of the Holder) and will be one percent (1%) per month for 120 months or two percent (2%) for 60 months.

As a consideration of National Security (as well as Global Security),

transactions WITHIN these guidelines will not be interfered with or blocked by the U.S. or its assigns. The consideration for such noninterference is that none of these contracts will be lodged for collection until such time as there is an additional agreement as to the lodging and honoring, through payoff, of the contracts.

Generally, it will be the practice of the Holder to expect the funder to provide loan capabilities and to purchase the gold as needed wherever there is security and it is NOT required to be housed within the U.S.

The Holder will not directly do business with any national group under sanction by either the U.S. or U.N. There is to be no restriction, however, on other parties or nations conducting business in their normal way. The Holder will conduct itself in the strictest accordance with all applicable laws.



No portion of its funds or assets will be used for purposes of ARMS ACQUISITION, WAR MAKING, OR THE OVERTHROW OR SUBVERSION OF ANY NATIONAL GOVERNMENT. However, the Holder has no way to police the use of funds by any other participating party.


Any abuse of these contracts or this DIRECTIVE will be considered by the U.S. as TREASON.



The U.S., The Taleban And Osama bin Ladin: Another View

I viewed a special report on CBS television within the last two weeks about the rule of the Taleban in Kabul, Afghanistan. According to this television report, the Taleban were a small army originating in Pakistan, who had crossed into Afghanistan at the end of the Afghanistans' war with Russia and taken over the capital city, Kabul, when the Afghanistans were too war-weary to prevent them. The Taleban were shown in the television report as being closed-minded Islamic fundamentalists, who were wreaking havoc on the people of Kabul. Women were not allowed to work outside of the homes; female nurses could not work in the hospitals; women were not given an education; they must be totally covered with a veil outside of their homes, etc., etc. The culture of Kabul had taken a drastic change, and even charitable international groups, such as the Red Cross, could not use women in their public work, although they were not Muslim and were primarily international volunteers. Hospitals were especially hit by the new orders, patients were not being cared for. In addition, the women were totally frustrated, especially those who were educated and capable of making a contribution.

Why do you suppose CBS made such a special report at this time? Was it to make it appear as if the Taleban "deserved" opposition—or what? Were there plans even then to bomb Afghanistan and become TV "heroes" in the sight of the American people?

I asked myself this question after I read an article regarding the U.S. attacks against Afghanistan and Sudan in *The Final Call* newspaper, 9/1/98 issue, by Ahmad-Rufai, International Editor. Mr. Ahmed-Rufai states in this article: [quoting]

A New York-based spokesman for Afghanistan's Taleban Islamic movement had said earlier on Aug. 20 that the group would be willing to discuss handing over Osama bin Ladin, the Saudi billionaire who allegedly planned the embassy bombings, if Washington presented proof that he is linked to terrorism.

Noorullah Zadran, speaking on CNN's *Moneyline*, condemned the U.S. action, saying the military strikes contravened international law and set a terrible example for the rest of the world.

Mr. Zadran said the Taleban movement had good contacts with U.S. government officials—observers noted that the Taleban is a U.S. creation, and that the bombed camps were established by the U.S. during Afghanistan's war with Russia—and was willing to discuss Mr. bin Ladin's extradition if Washington provided "hard evidence" of his links to terrorist activities, including written materials.

Afghan Islamic Press, however, quoted Taleban spiritual leader Mullah Mohammad Omar as saying, "We can never hand over

Osama to America."

Mr. bin Ladin, through a spokesman, Aug. 20 denied to a Pakistani reporter that he had been involved in the embassy bombings.

"I have nothing to do with the bombing of American embassies in Africa, but I urge the Muslims all over the world to continue their jihad against the Americans and Jews," the spokesman, Ayman Al-Zawahiri, told journalist Rahimullah Yusufzai on behalf of Mr. bin Ladin. Mr. Al-Zawahiri, who spoke about an hour before the U.S. strikes, refused to reveal his or Mr. bin Ladin's location.

He said Mr. bin Ladin, who had been in Afghanistan since the age of 19 when he volunteered in the fight to end Russian occupation, was warned by Taleban officials against using Afghanistan to launch terrorist threats.

Mr. Clinton said the timing of the missile attacks was based on U.S. intelligence that a "gathering of key terrorist leaders" was planned that day at the site in Afghanistan. He called the site "one of the most active terrorist bases in the world".

The U.S. strikes involved 75-100 Tomahawk cruise missiles fired by Navy ships in the Red Sea and the Arabian Sea, according to administration and congressional officials. Mr. Clinton said he ordered the strikes based on the unanimous recommendation of his national security team.

But this unanimous recommendation was faulty, according to Shelia Jones of the Shiller Institute.

Quoting economist Lyndon LaRouche, Ms. Jones said the Lewinsky and missile crises are diversionary tactics to distract the president from focussing on the potential global economic collapse.

Citing the impending collapse of Russia's economy, she said the President could reorganize the debt payment system and bring an end to the present IMF and World Bank reign.

"The fear is that the President could call a halt to the entire game plan that will expose globalization and privatization as a smokescreen for the looting of nations by the IMF," she said.

If the president wanted to bomb states who harbor terrorists, he could have started with London, she added, noting that Egyptian President Hosni Mubarak, following an assassination attempt on his life, once registered a complaint with Britain to investigate the groups based in London.

Mr. Clinton offered four reasons for the strikes: evidence the groups were key players in the embassy bombings, a belief they had carried out attacks against U.S. citizens in the past, information that they planned further attacks, and the belief the groups were seeking to acquire chemical and other dangerous weapons.

But Sudanese officials strongly denied that the el-Shifa pharmaceutical plant was used to

make components for chemical weapons. In fact, the U.N. Security Council in January approved supplies to Iraq from the same factory. And Sudan noted that Mr. bin Ladin was expelled from Sudan in 1992 at the suggestion of the United States.

"The Americans told us they did not care where Mr. bin Ladin went after leaving Sudan as long as he did not go to Somalia. To accuse us of links with bin Ladin is an excuse for an unjustified act," said Sudan's Ambassador to the United Nations, Elfatih Erwa.

Phylis Benis of the Washington-based Institute for Policy Studies told the Canadian Broadcasting Corporation that such unilateral U.S. action destroys possibilities of multilateral approaches to solutions that are more effective and more far-reaching.

Ms. Benis argued that the U.S. actions of "striking a fly with a bazooka" did not work in Libya nor did it work in Iraq. She condemned U.S. arrogance of feeling it is above international norms and can therefore act with impunity. (*Askia Muhammad and James Muhammad contributed to this article.*) [End quoting]

Will the U.S. (Clinton's administration) hand over any proof to the Taleban or to Sudan that Osama bin Ladin is a terrorist, and is linked to the African Embassy bombings? If there is actually any proof, why wasn't it discussed with the Taleban and Sudan before the missile attacks? If there is no proof, what does that make the U.S.? The world waits!

If Clinton's advice to bomb Afghanistan and the Sudan indeed came from his "national security team", then Americans must take a close look at who comprises that team and the laws pertaining to it. That "team" could just start World War III, with no justification that agrees with diplomacy, law, the national security, and certainly not world peace. Unfortunately, it must be a top priority with the citizens because the "national security team" will not fade away should presidents come and go—a possibility clearly in our future. Remember Secretary of State Madeleine Albright and Senator Orrin Hatch, along with Great Britain and others, strongly supported the action.

There is no information to the effect that Madeleine Albright even tried to use the good offices of her position to take up the "problem" with Taleban representatives in the United States prior to the missile attack, much less discuss it with the United Nations or the world court. With "diplomats" like this, America can certainly expect a war on her doorstep in the foreseeable future. In fact, with our weakened president, that may also be in the current planning.

Does America set up people like the Taleban and Sudanese in order to take them out later? If we are entering a war mode you can expect all kinds of extreme propaganda against the "other side" to be presented by our controlled media as occurred in World War II.

People here KNOW that there is THE PROBLEM through the IMF and all the trading and currency stripping—but they just can't understand that God hears their prayers and DOES OFFER A SOLUTION AND AN ALTERNATIVE.

I am asking to reprint a few pages from Gerry Spence's book *From Freedom to Slavery*: [QUOTING: Pages 81-93:]

More chilling is the scene we observe every day—the *breathing dead* who believe they are alive. Year after year these breathing dead get up at the same time every morning on the same side of the bed, trudge to the same kitchen, swallow the same brand of bacon and style of eggs for breakfast, drive the same route to work, and wearily enter the same door of employment where automatically they punch the same time clock and perform, like machines, the same mindless task until the same bell goes off

at five o'clock. Then by rote they return home in order to open the same brand of beer, and to watch the news on television that informs them of the same murders and violence, which are balanced against the same insipid sitcoms evoking the same canned laughter. Ha. Ha.

The breathing dead emulate machines. Their work is mechanical. They relate more to the simulated life on television than to their own species. It's safer to love the electronic life and the power to extinguish such life at will. The bargain seems fair. By relinquishing their own lives, which can be petty, puny, and powerless, they acquire a nonlife over which they can exercise complete and final power.

I would rather visit with a corpse than exist with the breathing dead, with those who have never considered a new idea, who worship the same God and vote the same party of their fathers, whose friends believe the same, act the same, look the same, and say the same things that they say. I would find a conversation with a corpse more engaging than one with the breathing dead, whose next words are as predictable as the liturgy of the priest and who, on pain of death, cannot recall the last book they read. All creativity is dead. All discovery is dead. Feeling is dead. Yet, as we observe, they breathe.

Mankind strikes an unholy bargain at birth. The contract reads: "Give me life and I will agree to death." The first freedom, therefore, is the freedom to live in the face of the fear of living and the terror of dying. But such freedom extracts a severe price. The price is pain, the pain of fear—fear of failure, of rejection, fear of abandonment, of loss and of sorrow, and the terror of death. We awaken to find ourselves trapped on a boat floating down an uncharted river with its horrible falls at the end. We possess no map to tell us where we shall face the falls. But we know the falls are there. We know no one ever survives the trip. We are afraid. Yet we cannot get off the river. We can only, moment by moment, attempt to avoid its treacherous rapids, its hazardous back currents, and despite the river's exquisite beauty and its placid bends, often we fail to enjoy the trip, for we know, just ahead, perhaps around the next bend, we shall face the falls, the horrible falls.

Life is the invisible trap. And the invisible tyrant is fear. To many, escape is death. Living death. The trap of the breathing dead is worse than the trap of the coyote whose foot is caught in steel jaws, for the coyote can escape. He need only chew off his foot. But the trap that ensnares the breathing dead tortures beyond endurance, because the trap cannot be seen or touched or even understood. Such traps have no measurable dimensions. When the breathing dead cry out that they are trapped, they are assured that all they need do is work harder, be smarter, compete harder, make more money, and they will, at last, be freed.

Who are these breathing dead? The farmer can be trapped on the farm, trapped by the mortgage that renders him the slave of the banks. The housewife can be trapped behind lifeless, monotonous walls, reduced to slavery to husband and offspring and repressive community mores. The poet, trapped in anonymity, the small-town artist trapped in obscurity, the parent trapped in mindless labor, the child trapped in ignorance and stifled in the great negative mind

mill—all can die in their traps before they have lived.

For all creatures who are caught in traps, a sense of hopelessness prevails. At the workplace the breathing dead are not heard, not acknowledged. They are digits on the balance sheet, and digits are dead. Despite what they think, what they say, what they do, or how hard they work, they remain digits. Their protests are like screaming into the void. At the polls they are digits as well, for no matter whom they vote for, nothing changes. They cannot be freed. At last the trap becomes synonymous with life.

But the state of *nonbeing in being* becomes the supreme pain, for eventually it embodies the realization that one has been cheated of his bargain. The breathing dead live within their own corpses, a horror beyond description, a horror that bears the agony of both murderer and victim and suffers the indescribable pain of the last rejection, of the self against the self.

Alcohol becomes the palliative of choice for the breathing dead. Beer is associated with happiness and is subliminally marketed in place of friendship, as a substitute for love, for sex, especially sex, so that those who thereby escape life through its brown-bottled bubbles are delivered a replacement for genuine joy, and by dulling the senses are delivered a certain quantum of pseudo death. It provides an escape from what appear to be the inescapable traps of life. But the escape is not into the experience of the life but the experience of nonlife. So, too, with drugs.

The deadly consequences of food, the most widely abused substance of the breathing dead, are visible in the bloated bodies of the masses and reflect a nation of the entrapped. For centuries we have herded geese into tight pens, held them immobile, and by use of specially devised rods, stuffed rich grains down their helpless gullets until their bellies bloated and their livers swelled, after which we pulverized the livers to produce a delicacy called pate. In the same way we force-feed geese, the breathing dead force-feed themselves and their children until their guts are distended and their limbs made heavy and stiff like the dead.

Yet many do not so easily succumb. Many strike out in desperate fury. Many strike at anything and everything. They abuse those closest to them, their wives, their children, their subordinates. If they are employers they abuse their workers. If they are police officers they abuse the weaker citizens. If they are judges they exercise their power not in furtherance of justice, but in response to anger, abusing the lawyers who practice before them and the accused who plead for mercy.

Hawking substitutions for living has become a massively profitable megabusiness in America. We are provided a love affair with *Murphy Brown* in order that the sponsor's goods may be subliminally sold in the process. At the same time, we are sold sports cars for sexual potency, shaving lotion for sexual appeal, and shampoo for beauty. Spectator sports provide a substitute for our involvement with our own bodies. Pornography provides an alternative for living relationships, and the pornographic experience mimics necrophilia, since the coupling is with nonliving images on nonliving pages on nonliving screens.

Any commodity that separates people from their lives is in great demand. Television removes the audience from reality. There the mind is redesigned by the electronic god that teaches false wisdoms—that human worth is measured by the amount of money each possesses, that human fulfillment is measured by the numbers of dead objects, gadgets, and things money can buy, most of which are manufactured by the breathing dead themselves in hideous places called factories, where the breathing dead labor with the same low groans and monotonous motions of the machinery. At last, the breathing dead sell their lives an hour at a time to acquire the means by which to buy the stuff of their living death, and when the breathing dead are worn out, like the machinery they mimic, they are written off, cast out, and replaced.

The offspring of the breathing dead are also trapped. Taught by the dead, they learn to say no, not yes, to life, to say no, not yes, to self-expression and exploration. At school most children are not permitted to laugh out loud or cry or make a commotion, because, too often, dead teachers despise any expression of life.

The children's primary experiences, those experiences by which they will make their life's choices and establish their life's values, are not related to clear fishing streams meandering through pristine woods, but to the blood and death and emptiness of life they experience on television. Mindless encounters on the screen waste their lives and dribble away their opportunity for growth. They are forbidden to explore their feelings, for feelings are too dangerous. Their language is not the language of poets but the lexicon of computers. Their heroes are machines and robots and those who emulate the same. They relate more to machines than to peers—to video contraptions that suck in quarters and simulate killing, to driving machines that suck in vast quantities of fuel and carry them endlessly up and down the same streets in a compulsive search for Lord knows what, and to sound machines that in quadruple stereo and exploding subwoofers destroy the ears and deaden the senses.

As are their parents, the offspring of the breathing dead are trapped in the decaying concrete bowels of the cities. The species is not genetically engineered to live where metal machines belch and blow in concrete canyons and fill the air with gases that smart in the lungs, and where the eyes are hurt by the sight of buildings protruding upward like angry stakes. There these concrete children, like rats stacked three deep in a concrete show box, begin to strike out. They hurl themselves against the walls, but they cannot escape. At last, desperate to escape, the concrete children can only break out through their fragile selves. Like the coyote in the trap they begin to gnaw on themselves. Crack! Cocaine! Violence! Escape is everything. Freedom is everything. In their madness the concrete children attack their neighbors. The regime calls it crime. But it is only the concrete children searching for freedom.

In a vicious, ever-widening cycle that will surely destroy us, the regime punishes the children by imprisoning them in even smaller, viler boxes of concrete called penitentiaries. We witness a true revolution. It is a revolution

against the dead, the living dead. It is a revolution being waged against a dead regime—dead, for its core is composed of a conglomerate of dead corporate and governmental bureaucracies. Included in the regime are those who have become attached to the core, its obsequious functionaries, its glazed-eyed human cogs, its mobs of nodding minions, the endless captured hordes who suck their sustenance from the back of the nonliving beast.

There are a couple more pages in this chapter, but I think you get the drift of meaning. Please just get the book and study it carefully. We have neither the time nor the inclination to awaken the majority of the cement people for, prior to a time of mass response, a lot of work has to be done lest the dead simply destroy more of the dead and the cycle simply enlarges upon itself.

In dealing with cycles it must be becoming clear that you have to fill the void of one cycle's leavings with something equally available. In this I mean, for instance, if "interest (usury)" is the culprit in the destruction of nations, then it is OBVIOUS THAT AN ALTERNATE SOURCE OF FUNDS MUST BE MADE AVAILABLE THAT DOES NOT USE INTEREST. YOU ALSO MUST HAVE ADEQUATE SIZE OF FUNDING TO COVER ALL THE ALREADY ESTABLISHED DEBACLE-DEALERS HAVE SUPPLIED—ONLY THEIRS IS WORTHLESS, BASELESS—AND OURS MUST BE ON A STRONG FOUNDATION WITH VALUE. CAN YOU HAVE BOTH? OF COURSE—YOU HAVE BOTH ALREADY AVAILABLE—JUST USE THEM! BUT YOU HAVE TO RID GREED-MONGERS FROM THE "TAKE IT ALL FAST LANE". GO WHERE INTEREST, FOR INSTANCE, IS ALREADY A NO-NO AND THAT, LADIES AND GENTLEMEN, IS IN THE MUSLIM PLACES OF THE LION. IT MUST BE ALLOWED TO HAVE BANKS WHICH ALREADY CAN UTILIZE ALTERNATIVE RESOURCES WITHOUT THE LAW OF THE BANKSTERS. HOW LONG CAN SUCH AS THE IMF STAND IF NOBODY USES THEIR SERVICES? NOT LONG!!! THE FOOD SUPPLY OF THE BANKSTERS AND POLITICIANS IS PORK AND GREED. TAKE AWAY THE SUPPLY AND YOU HAVE A FALL OF THE EVIL EMPIRE. TRY IT, YOU'LL LIKE IT!

I must close this now as pressures are increasing here and time limitations loom for this writing to reach its destination in the U.S.

May we all realize the need for the support of each of you for our work, for it is only in unity of purpose that we can succeed in a massive enough way to change the systems of the beast.




