COME IN OCTOBER—EVEN WATER by Randy Jeffries, *Weekly World News*

WASHINGTON—The world economy is on the verge of collapse that will leave banks in total ruin, currency worthless—and at least a billion people homeless and starving in the streets. But even more frightening is the massive panic that will soon cause formerly law-abiding citizens to turn on one another in a violent, desperate scramble for food and other necessities!

Experts say the financial nightmare will unfold in October—traditionally a horrible month for the stock market.

Already, millions are stockpiling food, medicine, clothing and even water in an attempt to survive the coming disaster.

This terrifying disclosure comes from a concerned group of the world's top economists, who say they're only declaring publicly what all the world's governments have been trying to cover up. "All indicators are there and have been there for the past three years," said a noted economist and top financial expert, Thomas Van Durman. "But the recent upheaval in the Asian market cinches it."

Van Durman is referring to the dramatic decline of the Japanese stock market that resulted in a devastating devaluation of the yen. Experts everywhere are saying the collapse of the Asian banking system is now inevitable—and when it fails, the American and European markets will tumble like dominoes.

Van Durman is one of three American members of an international group of 22 experts who have united to study the problem. "This crisis will make the Great Depression of the 1930s look mild by comparison," he said.

"The Great Depression was one of the darkest periods in American history. Once-wealthy people were left suddenly penniless." But the coming disaster—that has already begun to show itself—will completely crush every nation in the world. Overnight, folding money will become worthless paper. Banks will shut down and at least a billion people will be without food and shelter. "But the worst aspect of all this is the panic that is beginning among people who can see what's taking place. That panic is what scares me more than anything else."

Van Durman said the causes of the new depression have their roots in the crippled Japanese economy and the resulting imbalance between nations on the international market.

"The seeds have been sown and millions of informed people know it. In Switzerland, where **five banks recently went bankrupt** [*emphasis mine*], people have begun converging on supermarkets, pharmacies, and hardware stores, buying up canned food, medicines, bottled water and other necessities.

"There 's been rioting in Bern and Geneva. The panic has spread to the neighboring European countries of France, Italy, Austria, and Germany. And some people in the United States have already begun taking refuge in well-stocked mountain cabins." But Van Durman says we're only seeing the tip of the iceberg.

"Right now, only the ones who are aware of what's going on are acting out of fear" [*How about out of wise planning instead?*], he says. "But that's nothing compared to what will happen in October when everyone in the world will feel the sting of poverty. Soon, people will be shooting one another over crusts of bread.

"President Clinton knows about this problem. The White House has been rocked by the news, as have the governments of every nation in the world."

But they refuse to inform the public, hoping against hope that something can be done in time.

"I pray that we can find a solution before October." [End quoting]

The writing is on the wall and we, here in the United States, remain just this side of devastation only because the timing is not yet "right" as some of the elite move their assets to safer havens for protection.

IT'S IN MOTION—Starting today, within the small state of Arkansas, Lee Tibler, who hosts a radio program out of Hot Springs, Arkansas, Telephone No. 1(501) 525-9700, had a guest on this morning's 9AM-11AM show, Walter Burien, of Citizens Economic Victory Initiative (C.E.V.I.) of Prescott, Arizona.

## BACKGROUND IN ARKANSAS

Recently the citizens of Arkansas had overwhelmingly passed an initiative calling for the abolishment of property taxes. The power structure of Arkansas government, utilizing their leverage, moved through the courts to invalidate and block the initiative, stating that they would have to shut down schools if the initiative was effected.

Four weeks ago, comes along Walter Burien on Mr. Tibler's show with disclosure as to the existence of the Comprehensive Annual Financial Report (CAFR) which showed within Arkansas, with a population of 2.5 million people who had a TOTAL assessed Property value of 18.3 Billion (1996), THAT just the state government CAFR report showed in excess of 14 Billion in combined total liquid

investment funds, verging on being equal to the total hard assets and wealth of the citizens of the state of Arkansas as determined by their property value. Teachers pension funds = to 5.7 Billion (How many teachers are there in Arkansas for the children of 2.5 M people?). State investment funds Arkansas Development Finance Authority (ADFA) for issuance of bonds back to themselves or the local government = to 1.4 Billion. Total cash intake for the year 1.9 Billion. NOTE: these figures are just for the state, not adding on for composite totals of Cities and Counties.

## THE SHOT HEARD AROUND THE WORLD

As of this morning, on Mr. Tibler's radio show, Walter Burien called for the citizens of Arkansas to determine if the Citizens owned the government or if the government owned the Citizens. What was proposed by Mr. Burien was that the citizens of Arkansas unify and put through for an emergency special initiative that would change the principle of operation of Arkansas government, City, County and State, whereby the initiative would call for and enact by law the following:

1.) For the immediate down-sizing by 25% of Arkansas state and local governments "revenue" structure for reappropriation, annually, into the Citizen's Trust Investment Account. Whereby the citizen after 8-12 years participation in the "system", based on his or her interest and dividend yield from the Citizen's Trust Investment Account, would have no tax liability.

After 12 years participation, the citizen, on top of having no tax liability, would start receiving a dividend check which would exponentially increase throughout the remainder of his or her life. The last year of the citizen's life they would receive the biggest check. Citizen's who have already participated dearly for many a year in the "system" will be first-line beneficiaries for full payment of interest and dividend yield from the Citizen's Trust Investment Account. With this structure in place the Citizen's Trust Investment Account becomes the largest investment fund in the state, of no equal, with the citizen being the "Beneficiary", not the inner circle of the "Boys" from government and their special interests. NOTE: the large investment banking and brokerage conglomerates, after examination of the Citizen's Trust Investment Account, should be all for it. They do not take a loss but in fact are offered by the citizen the largest investment account to manage, which if this becomes the standard across the country, will make the Citizen's Trust Investment Account the largest investment account on the face of this planet...

2.) Under the initiative, The creation of a: Citizens Appointed Review Panel (lawyers and politicians shall not be on the panel but only act as consultants, the panel will be made up of: the electrician, the plumber, the school teacher, the police officer, the sheriff, etc. 250 individual citizens, with none having an income exceeding \$75K/year) with full discovery and disclosure rights with a small team of accountants that they select, for recommendation and direction capabilities for the reappropriation of the 25% annual revenue into

the Citizen's Trust Investment Account. NOTE: When the politicians say, "we will have to close down the little old ladies home and shut down the schools," the Citizens Appointed Review Panel will say, "No you're not, the revenue will come FROM HERE!!!"

3.) Under the initiative, the government employee, City, County, and State will be offered 1/3 of 1% as a finders fee for pointing out and redirecting revenue which is "not directly benefiting the citizens" for reappropriation into the Citizen's Trust Investment Account. NOTE: If that government employee finds and recommends reappropriation of, say, 150 Million which is not directly benefiting the citizen, 1/3 of 1% as a finder's fee is a pretty nice check. Any employee coming forward with a proposal who is retaliated upon, can report to the Citizens Appointed Review Panel, and the panel will take the appropriate action to protect that employee and hold those accountable for their unjust and criminal retaliation against both that employee and the citizens of the state....

4.) Under the initiative, No Further Debt Enacted, cash and carry. Existing debt will be enhanced for offset, until canceled, from 15% of the interest and dividend allocation from the Citizen's Trust Investment Account.

5.) Under the initiative, criminal prosecution, with effective sharp teeth, towards any organization, governmental agency or department in whereby they intentionally try to, or in effect do circumvent disclosure to the Citizens Appointed Review Panel, of revenues, investment funds or cash controlled or maintained by the governmental bodies of the State, Counties or Cities. END

In effect, we are changing the Principle of operation of the government. We are not changing a leaf or a branch or a tree in the forest, we are changing the forest which will effect every leaf in the forest to make "We The People" the beneficiaries of the wealth of this country, which is truly ours, NOT the politicians who spend millions to get elected into their \$60k/year jobs to continue the inner circle... of special interests and inflating their own pockets for doing so...

I think the founding fathers of this country would be smiling in their graves right about now....

The corruption, graft and payoffs disappear overnight. Its a little hard for the "Boys" to continue "Business as Usual" with 340 Million Americans watching over their shoulders as to where every \$1 is spent, invested, moved or has been moved in the past, because "We The People" are now the beneficiaries of the wealth within the greatest country on Earth....

### ARMY BACKS AWAY FROM FORCED ANTHRAX VACCINATIONS

From *THE MODESTO BEE*, 9/11/98: [quoting]

Army officials have changed their minds: They have decided they will not use force to give shots to soldiers who refuse their anthrax vaccinations.

"The Army is amending its policy. We're not going to do forcible vaccinations," said Army spokesman Capt. Scott Bertinetti. "We're not going to strap anybody down."

The Pentagon is proceeding with plans to vaccinate all 2.4 million active-duty National Guard and reserve service members against anthrax.

Anthrax, a livestock disease, is easy to turn into a biological weapon and is virtually 100-percent fatal in the inhaled form most likely to be used as a weapon.

Military leaders say the vaccine is the best protection against anthrax. Federal regulators repeatedly have reported problems at the plant that makes the vaccine and some question its safety and effectiveness.

At least 14 sailors and two airmen have been disciplined for refusing the vaccine this year.

Army Pfc. Mathew Baker, 20, went absent without leave from Fort Stewart, Ga., on June 9.

At an Aug. 4 news conference Baker said he went AWOL after getting his first anthrax shot. He said he only accepted the shot after his company's first sergeant threatened to strap him down and inject him.

Army officials defended the first sergeant's actions.

The regulation states:

"The policy of authorizing forcible immunization is intended to protect the health and overall effectiveness of the command as well as the health of the soldier. Soldiers do not have the option as to whether they will be immunized except as prescribed" in a separate regulation. [End quoting]

### PHILIPPINES AIRLINES IS GOING OUT OF BUSINESS

Philippine Airlines, which is called PAL, the oldest carrier in Asia, is closing its doors after last-minute negotiations failed to persuade its largest union to accept a recovery plan. The closure of PAL late Wednesday leaves many areas of the 7,000-island Philippine archipelago without air service. Two smaller carriers were grounded last week over safety concerns and financial problems.

PAL had said it would shut down unless the workers accepted the rescue plan, which it said was a prerequisite for recovering from Asia's

currency crisis in a series of crippling strikes. PAL is the largest Philippine company to fail since Asia's currency crisis, which hit just as the airline was launching a 4-billion-dollar expansion and fleet renovation plan. [End quoting]

If this closure actually remains in effect, it will cause much hardship and isolation for the Philippine Islands. The latest news on television (Bloomberg Business Report Channel) on early Monday morning 9/28/98 is that PAL will be back in operation starting Wednesday 10/7/98. One wonders what went on behind the scenes if this turns out to be correct!

### POTASSIUM-RICH DIET REDUCES STROKE RISK BY ONE-THIRD IN STUDY

From *THE DAILY NEWS*, Los Angeles, 9/22/98: [quoting]

A study that tracked nearly 44,000 men over eight years has found that those whose diets included large amounts of potassium had one-third fewer strokes than those whose diets did not. The benefits appeared to be greatest for men with high blood pressure.

The study, published today in *Circulation*, the journal of the American Heart Association, also found that the rate of strokes was lower for men who consumed higher levels of magnesium and cereal fiber.

Potassium-rich foods include bananas, tomatoes, spinach and other fruits and vegetables, explained the study's leader, Dr. Alberto Ascherio of the Harvard School of Public Health, who conceded that its recommendations may sound familiar.

"In some ways this could seem just the old story—eat your fruits and vegetables," he said in a telephone interview. "But stroke is such a horrible disease that we hope these figures provide extra incentive for people to change their diets, especially those with high blood pressure." [End quoting]

We all should pay attention to this. Hatonn told us, years ago, we should eat two bananas a day for adults, less for children of course.

In addition, Corliss appeared to inherit Victor's talent with boat engines, because he taught himself to run and repair them without any help.

\* SUSAN EASTLAND—Six-year-old Winnie Eastland was killed when a car hit her in 1961, but afterward, Winnie's mother and sister both dreamed that the little girl was coming back to the family.

Then as Mrs. Eastland was giving birth to her new baby, Susan, in 1964, her husband thought he heard Winnie's voice saying, "Daddy, I'm coming home."

When Susan was age 2, she began insisting that she was really 6 years old—Winnie's age at death—and she kept saying that photos of Winnie were really pictures of her.

On one occasion before Susan could write, she scrawled "Winnie" on the kitchen door. She had many of Winnie's memories, including playing at an uncle's house and walking under a horse in a pasture—even though Susan had never done these things.

Susan also had a birthmark on her left hip—which was where Winnie got her worst external injury from her fatal car accident!

\* MICHAEL WRIGHT—Walter Miller died in a car crash in 1967 and his girlfriend Catherine had a dream about a year later that Walter would come back to her—but she never imagined he would return as her very own son!

Catherine Wright's son Michael was 3 years old when he startled his mother by blurting out the name of Walter Miller's sister. Then Michael surprised his mother once more by telling her an incredibly detailed story about Walter's accident, including how the car had rolled, the glass had been broken and his body had been carried over a bridge after the accident.

Michael also revealed the town where Walter had been before the accident and the fact that, just before dying, Walter had made a roadside rest stop with a friend who survived the accident.

\* ERIN JACKSON—In the year after Erin turned 3, she spoke frequently of how she had been a boy in a previous life—and she remembered plenty of details from that time.

Born in 1969, Erin acted like a boy, kept her hair short, played boys' games and even wanted to be a Cub Scout.

She didn't like to wear frilly dresses or the tops from two-piece bathing suits. She mostly wore slacks and jeans.

Incidents such as this suggest that some people become transsexuals because they remember they were a different sex in a prior life, claims Dr. Stevenson.

He has reported on these and other cases in his book titled *Children Who Remember Previous Lives*.

"In southern Asian civilizations, confusion of sex is explained by reincarnation and thus accepted calmly," says Dr. Stevenson. "If someone is a man yet wants to become a woman, it's enough to say that in the other life he was a woman."

\* ROBERTA MORGAN—Born in 1961, Roberta started talking at age 2 about her prior life.

She had a very clear recollection of her previous mother and would frequently compare her new mother, Mrs. Morgan, to that woman.

What's more, when Mrs. Morgan made a new dish for dinner, Roberta would say that she had eaten it many times before—and could even offer helpful tips for preparing it!

Dr. Stevenson added that children make excellent subjects when studying reincarnation because their previous lives usually ended an average of 15 months before they were born.

"When the reincarnation takes place in a child who talks about the previous life, there are still living witnesses and the environment in which the dead person lived hasn't changed. Therefore, it is still possible to verify what the child has said." [End quoting]

Quite interesting stories. Also, remember the phrase in the *Bible* "Out of the mouths of babes...".

## THE BABY AND THE GARAGE DOOR

Thanks to Bill Dewey for posting this great story. It is reportedly a true story that occurred in 1994 and was told by Lloyd Glenn.

Throughout our lives we are blessed with spiritual experiences, some of which are very sacred and confidential, and others, although sacred, are meant to be shared. Last summer my family had a spiritual experience that had a lasting and profound impact on us, one we feel

must be shared. It's a message of love. It's a message of regaining perspective and restoring proper balance and renewing priorities. In humility. I pray that I might, in relating this story, give you a gift my little son, Brian, gave our family one summer day last year.

On July 22nd I was enroute to Washington DC for a business trip. It was all so very ordinary until we landed in Denver for a plane change.

As I collected my belongings from the overhead bin, an announcement was made for Mr. Lloyd Glenn to see the United Customer Service Representative immediately. I thought nothing of it until I reached the door to leave the plane and I heard a gentleman asking every male if they were Mr. Glenn. At this point I knew something was wrong and my heart sunk. When I got off the plane a solemn-faced young man came toward me and said, "Mr. Glenn there is an emergency at your home. I do not know what the emergency is or who is involved, but I will take you to the phone so you can call the hospital." My heart was now pounding, but the will to be calm took over. Woodenly, I followed this stranger to the distant telephone where I called the number he gave me for the Mission Hospital. My call was put through to the trauma center where I learned that my three-year-old son had been trapped underneath the automatic garage door for several minutes and that when my wife had found him he was dead. CPR had been performed by a neighbor, who is a doctor, and the paramedics had continued the treatment as Brian was transported to the hospital. By the time of my call Brian was revived and they believed he would live, but they did not know how much damage had been done to his brain or to his heart. They explained that the door had completely closed on his little sternum right over his heart. He had been severely crushed.

After speaking with the medical staff my wife sounded worried but not hysterical and I took comfort in her calmness. The return flight seemed to last forever but finally I arrived at the hospital six hours after the garage door had come down. When I walked into the intensive care unit nothing could have prepared me to see my little son laying so still on a great big bed with tubes and monitors everywhere.

He was on a respirator. I glanced at my wife who stood and tried to give me a reassuring smile. It all seemed like a terrible dream. I was filled in with the details and given a guarded prognosis. Brian was going to live and the preliminary tests indicated that his heart was ok—two miracles in and of themselves. But only time would tell if his brain received any damage.

Throughout the seemingly endless hours my wife was calm. She felt that Brian would eventually be all right. I hung on to her words and faith like a lifeline. All that night and the next day Brian remained unconscious. It seemed like forever since I had left for my business trip the day before. Finally at two o'clock that afternoon our son regained consciousness and sat up uttering the most beautiful words I have ever heard spoken. He said, "Daddy, hold me," and he reached for me with his little arms.

By the next day he was pronounced as having no neurological or physical deficits and the story of his miraculous survival spread

throughout the hospital. You cannot imagine our gratitude and joy.

As we took Brian home we felt a unique reverence for the life and love of our Heavenly Father that comes to those who brush death so closely.

In the days that followed there was a special spirit about our home. Our two older children were much closer to their little brother. My wife and I were much closer to each other and all of us were very close as a whole family. Life took on a less stressful pace. Perspective seemed to be more focused and balance much easier to gain and maintain. We felt deeply blessed. Our gratitude was truly profound.

Almost a month later from the day of the accident, Brian awoke from his afternoon nap and said, "Sit down, Mommy. I have something to tell you."

At this time in his life Brian usually spoke in small phrases so to say a large sentence surprised my wife. She sat down with him on his bed and he began his sacred and remarkable story.

"Do you remember when I got stuck under the garage door? Well it was so heavy and it hurt really bad. I called to you but you couldn't hear me. I started to cry but then it hurt too bad. And then the "birdies" came. "The birdies?" my wife asked, puzzled. "Yes," he replied. "The birdies" made a whooshing sound and flew into the garage.

"They took care of me." "They did?" "Yes," he said. "One of the 'birdies' came and got you. She came to tell you I got stuck under the door."

A sweet, reverent feeling filled the room. The spirit was so strong and yet lighter than air. My wife realized that a three-year-old had no concept of death and spirits so he was referring to the beings who came to him from beyond as "birdies" because they were up in the air like birds that fly. "What did the birdies look like?" she asked. Brian answered, "They were so beautiful. They were dressed in white, all white. Some of them had green and white. But some of them had on just white."

"Did they say anything?" "Yes," he answered. "They told me the baby would be alright." "The baby?" my wife asked, confused. And Brian answered: "The baby laying on the garage floor." He went on: "You came out and opened the garage door and ran to the baby. You told the baby to stay and not leave."

My wife nearly collapsed upon hearing this, for she had indeed gone and knelt beside Brian's body and seeing his crushed chest and unrecognizable features, knowing he was already dead, she looked up around her and whispered, "Don't leave us, Brian; please stay if you can."

Someone was in the bright light and put their arms around him and told him "I love you but you have to go back. You have to play baseball and tell everyone about the birdies." The story went on for an hour. He taught us that "birdies" were always with us but we don't see them because we look with our eyes and we don't hear them because we listen with our ears. But they are always there, you can only see them in here (he put his hand over his

heart). They whisper the things to help us to do what is right because they love us so much. Brian continued, stating, "I have a plan, Mommy. You have a plan. Daddy has a plan. Everyone has a plan. We must all live our plan and keep our promises. The birdies help us to do that 'cause they love us so much."

In the weeks that followed he often came to us and told all or part of it again and again. Always the story remained the same. The details were never changed or out of order. A few times he added further bits of information and clarified the message he had already delivered. It never ceased to amaze us how he could tell such detail and speak beyond his ability when he spoke of his "birdies".

Everywhere he went he told strangers about the birdies. Surprisingly no one ever looked at him strangely when he did this. Rather, they always got a softened look on their face and smiled.

Needless to say, we have not been the same ever since that day and I pray we never will be. [End quoting]

Again, "Out of the mouths of babes...". And "Your children shall teach you."

Hopefully, this story will change many more lives, also.

It would be very wise to check our garage doors for any safety defects and to keep any controls out of reach of our young children. ☸

While Russian President Boris Yeltsin and President Bill Clinton went through the motions of their halting, hollow and hangdog summit meeting this month—dubbed the “Boozer and Abuser Show” by press wags—more important and ominous talks were going on in the hidden recesses of the Kremlin.

Talking were genuinely powerful U.S. decision-makers and key Moscow leaders. The

The outcome of these negotiations, held in secret, now threatens American taxpayers with a new wave of alien rip-offs running into uncounted billions of dollars. This will be coupled with a flood of indigent or handicapped immigrants, as well as other undesirable consequences, these sources related.

The visiting delegation, headed by booze mogul Edgar Bronfman, president of the World Jewish Congress, included top executives from just about every major Zionist group in the U.S., as well as high Israeli officials such as

Nathan Sharansky, the mini-state's Russian-born trade and industry minister.

## SAVE SOVIET JEWRY

The home team confronting these international power brokers was led by Yevgeni (sometimes rendered Yevgeny in English) Primakov, the former Soviet secret police chief who is now Russia's foreign minister, and by Vladimir Gushinsky, a billionaire Moscow financier, who chairs the Russian Jewish Congress.

The main topic on the meeting's agenda was a broad plan for the emergency evacuation of as many as a million Jews from Russia in case the heartland of the former Soviet Union, hit by economic collapse and political turmoil, is engulfed by a tide of “nationalism, populism and anti-Semitism”, as the chairman of the U.S. National Conference for Soviet Jewry, Dennis Braham, put it.

“There is tremendous apprehension that [these] bad things can happen, and we have to be prepared,” Braham, a key member of Bronfman's delegation, argued.

Foreign Minister Primakov, the spokesman for the Russian negotiators, who learned how to deal with international crises in a lifetime spent mostly as a Communist secret agent, reassured the Zionist leaders that “although there is much social unrest and protest in Russia”, the government—and he personally—opposed any “barbaric” manifestations of anti-Semitism.

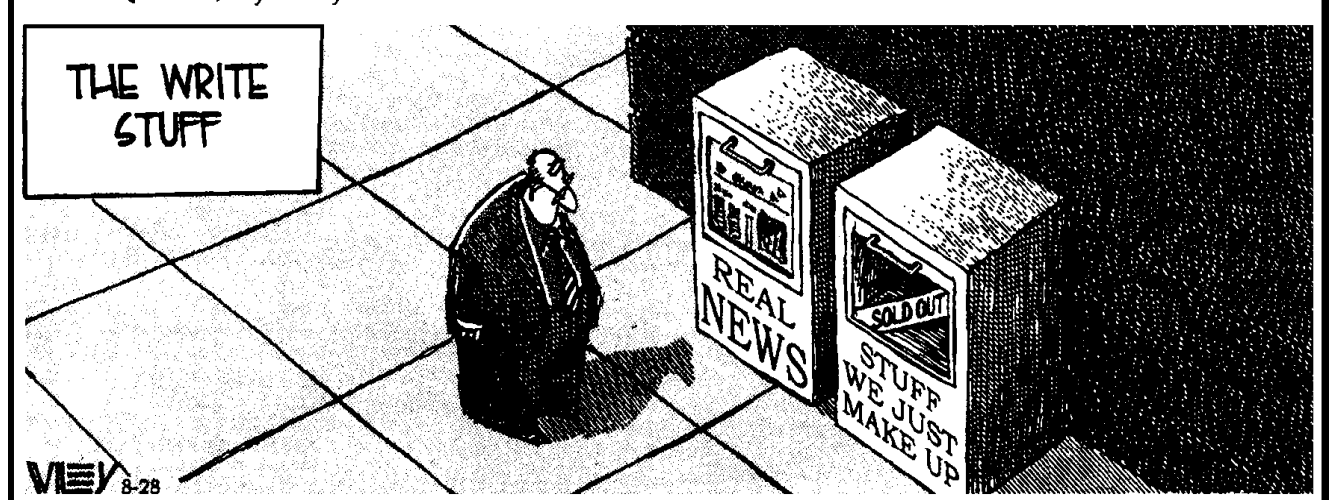
It was one of the few undisputed points made by the Russian leader in the course of these talks, diplomatic sources related, adding that Primakov (born Pincas Finkelstein) had cast

off his own Hebrew upbringing and real name early in his career in order to rise to the top of the old Soviet secret service and—after the collapse of Communism—to one of the most powerful posts in the Yeltsin administration.

Primakov's antecedents, after decades of smooth concealment, were worth noting. It is the ethnic identity of the men at the top, who have plundered Russia and plunged it into disarray, that raised the most urgent question faced by the conferees of the secret Kremlin meeting.

That question was: what to do about the growing rage of the Russian masses at the Jewish community in their midst whom even

relatively well-off Muscovites now blame for the nation's political chaos, endemic corruption and economic breakdown?

**The U.S. government will defray the costs of this gigantic jet-propelled exodus, and it will grant "political asylum" to all Russian Jewish refugees who choose to go to America rather than to Israel because they are too old, too infirm, too unskilled "or for any other valid reason", Bronfman proposed [emphasis mine].**

With regard to the Russian government, the Zionist negotiators presented four more demands:

\* Instant, collective, unrestricted exit permits for all Jewish emigrants cleared to board Bronfman's emergency airlift;

\* Open landing and departure clearances, refueling and related airport services "as needed" for U.S. aircraft participating in the operation;

\* Open access roads and unhindered passage to and from Russian airports for the buses, trucks and vehicles participating in the emergency evacuation of Jewish refugees; and

\* Blanket permission for Jewish emigrants to take abroad with them "as substantial a portion of their assets and savings as may prove compatible with their departure by air."

Primakov assured Bronfman and his group of Zionist delegates that the Yeltsin administration would consider their demands "with broad and understanding sympathy" and would likely grant most of those that "appear necessary and feasible under emergency conditions".

But as this issue of *The SPOTLIGHT* went to press, no one seems to have thought of asking the opinion—much less the consent—of ordinary Americans regarding such a sudden and massive influx of aliens, most of whom will require, beyond the steep cost of their hasty aerial exodus, billions of dollars in long-term public assistance.

Wheels and deals.**

**Russia is in a state of collapse.  
Round up all the usual suspects.**

Who is behind Russia's crackup? The U.S. Establishment press, by and large, has no trouble pointing an accusatory finger at that age-old scapegoat, the presumed inability of Slavic rulers to behave like Western politicians.

"Russia has had more than its share of malevolent or inept political leaders over the years, but the latest Kremlin cast is settling a new standard for incompetence and self-absorption," huffed *The New York Times* on September 8.

But in Europe, what attracted the most

media attention was an unusual news story written by David Hoffman, the Moscow correspondent of the usually bland *Washington Post*.

The Russians themselves are not looking for the principal culprits of the country's misfortunes among their national leaders; they don't even believe that they are being ruled from the Kremlin any longer, Hoffman reported.

Any Muscovite will tell you that these days the real masters of the former Soviet heartland are the members of the "semibankirshchina"—that is, the "regime of the seven banker oligarchs"—Hoffman recounted.

Who are these seven "oligarchs"? They are in reality unscrupulous financial speculators, newly minted billionaire tycoons, united by their ethnic and emotional ties to Israel—an affinity of the real rulers of post-communist Russia, Hoffman discovered.

After staging rigged "elections" in Russia in the early and mid-1990s the seven tycoons "met and decided to insert one of their own into government. They debated who, and chose [financier] Vladimir Potanin, who became deputy prime minister," Hoffman related.

"One reason they choose Potanin was that he is not Jewish and most of the rest of them are, [and they] feared a backlash against the Jewish bankers," Hoffman explained.

Now the backlash is mounting and appears as an imminent threat to top U.S. Zionist leaders such as Edgar Bronfman, president of the World Jewish Congress.

The pressures behind this gathering storm are not hard to understand. The seven speculators of the semibankirshchina corrupted and manipulated post-communist Russia's elected governments. They used their newly found powers to plunder the nation's wealth and its natural resources, Hoffman concluded.

To begin with they made sure the Yeltsin regime did not set up its own treasury. Instead, the government was persuaded to deposit its reserves in financial institutions set up by the seven oligarchs, who immediately began to undermine Russia's national economy by "speculating against the dollar-ruble exchange rate, often using the government's own money," Hoffman reported.

Next, Yeltsin was pushed into approving the now infamous "loans for shares" program. Under it, the seven oligarchs loaned the cash-strapped government money in exchange for shares (i.e. control) of the former Soviet Union's "most lucrative" [state] enterprises.

"When the government failed to pay back the loans, the seven bankers could sell off these companies, and they did—to themselves. Many of these auctions were rigged from the inside," Hoffman reported.

By means of such corrupt scams, the tiny clique of Zionist speculators managed to pull off one of the most staggering economic conquests in history. In the space of a few years they seized control of half of Russia's entire economy, Hoffman reported.

When they needed hard currency financing, the seven oligarchs of Moscow turned to Wall Street, where they found a confederate with some of the deepest pockets in the world's money markets: billionaire currency speculator George Soros.

This year however, with Russia's economy in ruins and its government in disarray, the seven oligarchs are threatened by the revolt of Russia's defrauded and plundered masses. U.S. Zionist leaders such as World Jewish Congress President Bronfman are leading a drive to organize their emergency exodus from the former Soviet heartland to the U.S.

"These are tragic developments, and worst if Bronfman gets his way again from the Clinton administration, these Zionist robber barons—along with hundreds of thousands of their needy co-religionists from Russia—will move their corrupt version of managed capitalism from Moscow to Main Street next," warned Dr. Elemer Maros, the veteran New York correspondent for a syndicate of Eastern European news organizations. ☸

# Nora's Research Corner

## King Leopold II Of Belgium

(The "Old Boy Himself" or a Reasonable Facsimile?)

This article will end my recent exploration into the seedline of the snake people (the Tribe of Dan) in the European area. Other information reveals their ancient presence in Mesopotamia. They can be recognized today by their actions, and King Leopold II of Belgium was a complete example of the type, having not one redeeming or compassionate characteristic to be found in the story of his life. Unfortunately, his seedline remains on the throne of Belgium, and while not all of the Belgium monarchs have followed Leopold's example it is certain, as we shall see, that they have followed or gone along with Lucifer's plan for world domination—the plan outlined by an incarnation of Lucifer (Adam Weishaupt) in the late eighteenth century and early nineteenth century when Adam Weishaupt was given asylum at the House of Saxe-Gotha in Prussia, following his banishment from Bavaria on discovery of that plan.

Saxe-Gotha added the House of Coburg to its estates and later became the ruling House of the newly formed country of Belgium in 1831. This was set up by the "electors" of the other monarchies in Europe, all of whom are related to each other (Ref.: Vol. XIII, *The Cambridge Modern History*). The reason given for the formation of this new country was to provide a buffer between the warring factions surrounding it. However, Belgium could in no way be a "buffer" to anyone, and the "electors" knew it! You will recall that it was Germany's invasion of poor little "neutral" Belgium that was used as one of the excuses for America's entry into World War I. It was also used as one of the excuses for World War II. America had been sucked into the manipulated wars in Europe and has paid with its life, in fact. All of this was part of Lucifer's plan, which was arranged by his followers—the "elite" electors of European monarchies, the bankers and their treacherous cohorts in America. It doesn't mean that Americans were at fault in their generous desire to help, or that the Belgian people understood how they too were being used. It does mean that the citizens of the world must become more discerning in historical facts and responsible for obtaining and keeping good leaders if

they are to survive the machinations of these snake people.

No one can expect good government--government for the benefit of the people, progress and justice for the people--if they just unquestionably hand it over as an "inheritance" to the seedline of the elite. The people will continually be set one group against the other until this seedline and their followers have total control of the world. Remember, it is Lucifer's promise that he will give the world to those who follow him (Ref.: *Luke 4:5-8*).

At first it seemed incomprehensible that the small kingdom of Bavaria did not throw Weishaupt into jail and throw the key away instead of "banishing" him. It also seemed incomprehensible that a small duchy in Prussia would and could welcome him to their home as "honorary councilor" in the face of the information available to them regarding his plans for world takeover. However, it is only incomprehensible until you learn that Weishaupt's plan involved the takeover of the higher degrees of Freemasonry, that Frederick the Great was King of Prussia at the time, at the height of his power in Freemasonry and related to the House of Saxe-Gotha. (Frederick died about the time that

Weishaupt moved to Saxe-Gotha.) It further helps to know that according to Albert Pike, later head of Freemasonry in the United States following the Civil War, the upper grades of Freemasonry worship Lucifer! Weishaupt lived for forty years after his banishment. He continued his intrigue in Masonry long after the French Revolution and also became councilor to the banking Rothschilds. (Ref.: *Secret Societies and Subversive Movements* by Nesta Webster, and quotations by Nesta Webster from Albert Pike's *Scottish Rite of Freemasonry: The Constitutions and Regulations of 1762; Occult Freemasonry and the Jewish Peril (1920)*, by A.E. Waite; *Occult Theocracy*, by Lady Queensborough.)

Obviously by the time of Weishaupt's death in 1830 (one year before the country of Belgium was formed) the "elite" of Europe and other friends in the U.S., the banking houses of Rothschild and the upper degrees of Freemasonry were firmly on the road to the "New World Order"—a motto of Freemasonry found on the U.S. one-dollar bill! The House of Saxe-Coburg-Gotha was an important part of that on-going plan.

Back to Leopold. Why do I pick on him? For anyone who has not heard of Leopold's actions in the African Congo territory beginning in 1875, the depravity of this "man" will come as a shocking revelation. Leopold is not alone among his relatives and cohorts in engaging in this kind of depravity. One need only consider how the English "Crown", along with their relatives and buddies in the British East India Company took over India and bled her dry to the point she has never been able to recover—how they set up and enforced the opium trade in China, Shanghai and Hong-Kong, etc., to realize how deep the vicious predatory capacity runs in this seedline. (You may recall that Prince Albert of Saxe-Coburg-Gotha

had married Queen Victoria of England, and Queen Victoria is called the "grandmother" of European "aristocracy" with good reason! Americans have been brainwashed by our controlled media to think we should "help" these predators.)

Leopold's ambition for empire began in his boyhood, but it was not until after he became king that he, in 1876, initiated a plan to obtain that empire in Africa. His own apprehensive government had pretty well nipped his ambitions at home in the bud. According to the book, *Defiant Dynasty—The Coburgs of Belgium*, by Theo Aronson, (quote):

In September 1876 King Leopold invited a collection of explorers, geographers and philanthropists to a conference in the Royal Palace in Brussels. They were assembled to discuss—so the King assured them in his opening address—how best they could open up the "Dark continent" of Africa to the blessings and benefits of civilization. He would like them to think of their task, he said, as a latter-day crusade. "Do I need tell you," he continued, "that in calling you

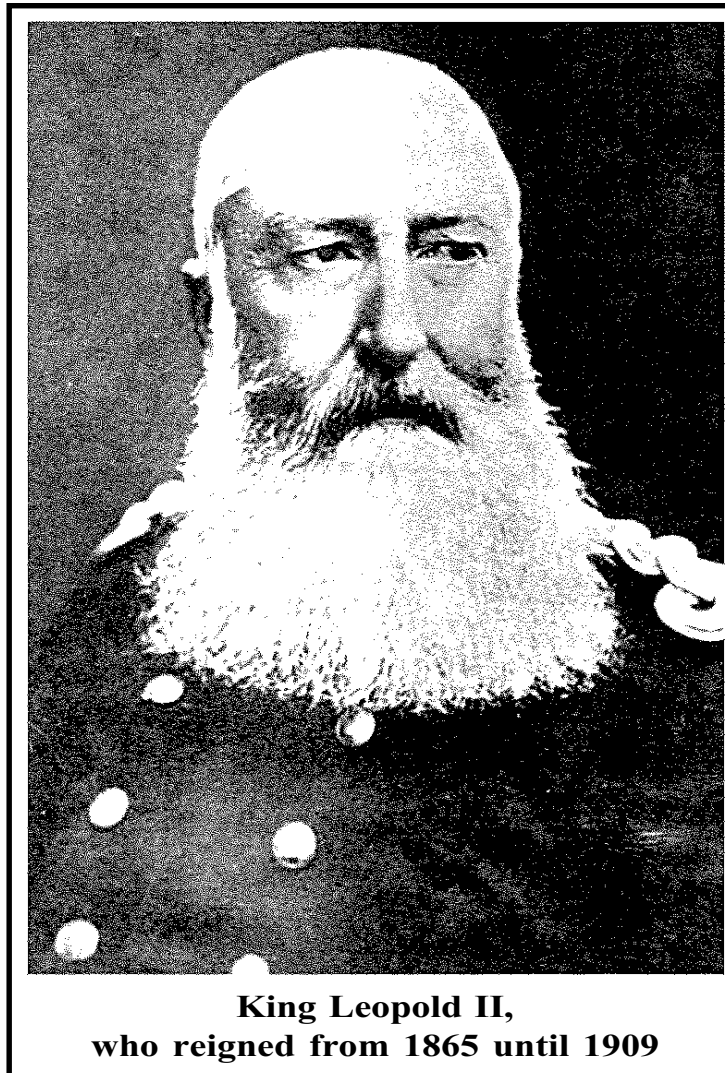

together in Brussels, I have not been guided by egotistical motives? No, gentlemen, if Belgium is small, she is happy and contented with her lot. I have no other ambition than to serve her well." His tone was so modest, so benevolent, that the delegates, wary of any political entanglements, responded with enthusiasm to his ideas. His dream, he said, was to abolish the slave trade and to set up research stations in the heart of Africa. An organization, to be known as the *Association Internationale Africaine*, or simply AIA, was thereupon formed and King Leopold elected as the first chairman of the international committee. Aglow with good intentions, the delegates dispersed. Their enthusiasm, however, was short-lived. Meeting with very little encouragement from the governments of their respective more nationally minded countries, they soon lost interest. The international committee met only once the following year and then it, too, faded into oblivion. All that was now left of the once impressive AIA was its name. But this, in fact, was all that King Leopold needed. Under cover of the innocuous-sounding organization (which he had done nothing toward keeping alive) Leopold could put his plan into operation. The flag of the AIA—a gold star on a sky-blue field—was planted for the first time on African soil, and no one dreamed that this fresh, reassuring-looking banner was to all intents and purposes the personal standard of the King of the Belgians.

The AIA had given Leopold the means to found his empire; he must now find the way to do so. He did not have to wait long. In August 1877 there reemerged into a world which had almost given him up for dead the African explorer, Henry Morton Stanley. He had reemerged, moreover, at the mouth of the Congo River, having crossed the continent of Africa from east to west. Almost alone in Europe, King Leopold realized not merely the significance of this fact, but the use to which it could be put. It was toward the basin of the Congo River that King Leopold's rapacious gaze had for some time been directed; now Stanley, after three and a half years of almost incredible hardship, had traced the course of the river. When the explorer arrived at Marseilles on his way back from Africa to England, there were two representatives of the Belgian King to meet him. They had come to ask him whether he was prepared to help King Leopold with his great civilizing mission in Africa. Stanley, anxious for England to reap the harvest of his discoveries, at first declined the Belgian offer. It was only on encountering extreme British indifference toward his achievement that he accepted. An organization with the inoffensive name of *Comité d'Etudes du Haut-Congo*, generally assumed to be an off-shoot of the AIA, was formed in Brussels, and Stanley, hardly conscious of the fact that beneath the velvet glove of the AIA was the iron hand of territorial ambition, sailed off to Africa once more.

Here, in his thorough and ruthless fashion, he set about erecting "stations" along the Congo River. Each station, other than serving as a center from which civilization was to be spread to the heathen, would in time—so ran Leopold's honeyed explanation—form the nucleus of a series of "Free Negro Republics". It was a prospect to warm the heart of the most skeptical humanitarian.

Although Stanley worked well he worked slowly. The sudden appearance of a French explorer on the north shore of Stanley Pool (the Congo River Basin on which Brazzaville was later established) threatened to upset all Leopold's carefully laid plans. If he wanted to keep France out of the Congo he would have to acquire sovereign rights over the territory. And the only way to do this was through treaties signed by the various African chieftains. Stanley was now urged to get as many chiefs signed up as possible; that the majority of them had not the slightest idea of what it was that they were signing mattered not at all. By the end of 1883 over three hundred

chiefs, in exchange for bottles of gin and bolts of cloth, had signed away their independence and placed themselves under the dubious protection of the gold-and-blue flag.

The same flag, however, no longer represented the long defunct AIA or even its offshoot, the *Comité d'Etudes*. King Leopold, in a move known only to his closest associates, had dissolved the *Comité* by first alarming the shareholders with talk of bankruptcy and by then offering to reimburse them with their original investments. That accomplished, he formed an entirely new company known as the *Association Internationale du Congo*. This was shortened to AIC, and the fact that Leopold was the only subscriber and that he now had sole control of the entire Congo operation was never really appreciated. With the AIC sounding so like the AIA, it was generally assumed that it was all the same philanthropic and civilizing project, and that a disinterested King Leopold was merely carrying out the resolutions of those well-meaning geographers and missionaries whom he had assembled in Brussels seven years before.

Hardly had Leopold checked French

encroachment by the hurried signing-up and "confederating" of the chiefs under the AIC flag than Portugal entered the arena. Backed up by Britain (who also feared French expansion in Africa) Portugal now laid claim to the Congo mouth. It was a nasty moment for King Leopold. Unless he had an outlet to the sea, his years of patient maneuvering would have been in vain. While Britain and Portugal prepared to sign a treaty giving the Portuguese sovereignty over both banks of the Congo estuary, Leopold thrashed about for some way to save himself. As usual, he found it.

His only hope would be to play the Great Powers off against each other. Rather than let any one of the Powers gain control of the Congo Basin, the others would willingly support some weak, uncommitted regime, and this was exactly how Leopold planned to present his AIC. By using his very weakness as strength, he set about defying the world. The first thing to do would be to get diplomatic recognition for the AIC; the so-called "Federation of Free Negro Republics" would have to be granted statehood.

It was to the United States that he turned first. By laying heavy stress on both the humanitarian aspects and the commercial advantages of a series of "free" states in the Congo, Leopold won American support. President Arthur had nothing but praise for the impeccable principles of what he still called the AIA, and both houses of Congress recommended diplomatic recognition of what they imagined to be a collection of states. That achieved, Leopold now turned to France. By offering her a "right of preference" in event of his ever wishing to dispose of his Congo possessions, Leopold gained first a French promise of friendly neutrality and then full recognition. This immediately alarmed Britain and Germany. Lest France, in fact, inherit the Congo from the Association, they must needs keep the Association alive and happy. Bismarck gave the idea of AIC statehood immediate support and German recognition followed in November 1884. A week later Germany and France jointly convoked a conference to clear up the question of the Congo once and for all.

As a result of the conference, Britain was obliged to repudiate her treaty with Portugal and Leopold retained his outlet to the sea. The Portuguese, faced with an ultimatum from the other Powers, were forced to climb down. The Association was recognized by all the States represented and at the close of the Conference, Bismarck, as chairman, welcomed the new "Congo State" into being. In his final speech he praised "the noble efforts of the King of the Belgians, the founder of a work which will confer most important benefits on mankind". His private opinion of the Belgian King was a little different. In the margin of one of Leopold's documents dealing with the evils of the slave trade, Bismarck had scrawled one word: "*Schwindel!*"

Leopold could now safely slough off the fake skin of internationalism. The Congo—all 920,000 square miles of it—belonged to him alone. As Belgium wanted no truck with it whatsoever ("Belgians are not drawn toward overseas enterprises," explained the Prime Minister dryly), he would have to take full control of it himself. And the best way of doing this, he reckoned, would be to make himself King of the Congo. On the strict understanding that they

themselves would never be saddled with his new kingdom, the members of the Belgian Parliament were persuaded into giving him the necessary permission for accepting a second crown. To those members who feared that Leopold might be torn between obeying his Belgian or his Congolese Parliaments, he explained that the question would never arise as he intended to be an absolute king in his new kingdom.

On August 1, 1885, King Leopold, in a lordly note to the Powers of Europe, announced that "His Majesty, in accord with the International Association, has taken the title of sovereign of the Independent State of the Congo." By a duplicity seldom equaled in international politics King Leopold had made his dream come true. Almost overnight little Belgium's constitutional monarch had emerged as the absolute sovereign of a country the size of Western Europe. The world stood amazed at this success; it was soon to stand appalled at the use to which he was to put it. [End quoting]

(It appears that author Aronson has independently limited the family's name to "Coburg", rather than Saxe-Coburg-Gotha.)

Leopold ran into many problems immediately, which he tried to cover by various means of borrowing, begging and intrigue, even with the Pope, to no avail. In 1889 Leopold was to be more successful.

Further on in *Defiant Dynasty*: [quoting]

That autumn, an Anti-Slavery Conference opened in Brussels and in this Leopold saw his chance to lay his hands on some money. No one was more adept at the conversion of humane sentiments into hard cash. The Berlin Conference had expressly forbidden the levying of an import duty in the Congo; now, to cover what he called his anti-slavery expenses, King Leopold asked to be allowed a ten-percent duty on all goods entering the Congo. Unless he was granted this duty, he protested, the Congo would be unable to play its part in the abolition of the slave trade, and unless the Congo did play its part, the slave trade would not be abolished. It was his old trick of using weakness as strength and, as usual, he got his way. The duty was allowed.

So far, so good, but a ten-percent duty was a mere drop in the ocean of the Congo expenses. He would somehow have to get the money out of the Belgian Treasury. Be it by threats, cajolery or trickery, he was determined to get a loan out of his tight-fisted countrymen. First he threatened to shame them by abdicating. Then he frightened them by declaring that poverty would force him into presenting the Congo to France; "neither Germany nor England would forgive Belgium if we handed over the Congo to France," he sighed. The Belgian Government, moreover, was just beginning to realize the potential of the Congo. It would be a pity to let so rich a prize slip forever from their grasp, and yet they were not prepared to saddle themselves with it until it was proved that it *could* pay its way. If only there were some method of delaying their decision, of remaining free until they could see whether or not it would be to their advantage to gain control of it. Nor, for his part, was the King willing to hand the country over to Belgium. He would consider doing this when he had made his fortune, not before.

As always, His Majesty had the perfect solution. He suggested to his Government that, in exchange for a loan, he should publish a will in which he bequeathed the Congo to Belgium. After ten years the Chamber could decide whether

to take advantage of his gift or to demand the repayment of the loan. That way, the King would get his money now and the Government could make up its mind later. Only on receipt of the loan, however, and not before, would he sign the will. To avoid any appearance of sharp practice on his part, he would back-date the will. This, explains one of his more sympathetic biographers, was in order "that the public would not conclude that there was any connection between the solicitation of a loan and the royal bequest."

The transaction was a complete success. Leopold got his loan, the newly drafted but back-dated will was signed, and the complaints of certain politicians at this deepening involvement in Congo affairs went largely unheeded.

If that particular deal had been shady, the next one was diabolical. In 1894 the King informed his Government that, in defiance of the conditions of acceptance of their loan, he had borrowed a further 5,000,000 francs from an Antwerp banker named Browne de Tiège. As security for the loan he had mortgaged a vast area of the Congo to the banker. Now, unable to repay the loan, he would have to grant Browne de Tiège permanent rights over this territory. The Government was appalled. Rather than lose this valuable slice of Belgium's future colony (and as a way of preventing the King from getting into deeper financial straits) the Government reluctantly decided to annex the Congo immediately. The decision produced an outcry from the Belgian public. The Government might be ready for a colonial adventure but the people were not. The protest against annexation, secretly encouraged by Leopold, gathered strength; even the London *Times* (again, it was assumed, on Leopold's instigation) came out against it.

In the face of this mounting opposition there was nothing that the Government could do. They were forced to abandon the idea of annexation and to pay Leopold's debt. Striking while the iron was hot, the King suggested that as they were already paying 5,000,000 francs they might just as well add a further 1,500,000. Meekly the Government handed him 6,500,000 francs and Leopold remained master of the Congo. At least, reckoned the Government, he could now pay his debt to Browne de Tiège. He had invented the debt as a way of worming 6,500,000 francs out of his Government. It had all been a cool and gigantic swindle.

Nor were the King's successes merely financial. The Anti-Slavery Conference of 1889 had led to more than that ten-percent duty on all goods entering the Congo. The Conference had, after all, been concerned with the abolishment of the slave trade and although King Leopold had no intention of mounting a great anti-slavery campaign, there was no reason why he should not turn the prevailing anti-Arab sentiments to his advantage. Rivalry between the Arabs, established in the eastern part of the Congo, and the Europeans, established in the west, had been increasing in the last few years and a clash between them was looked upon as inevitable. It came in 1892. For the following eighteen months the Belgians, fighting bravely, won a series of victories against the Arabs and ended by crushing their power completely. Whatever the reasons for these Arab wars—whether commercial, political or philanthropic—the results, as far as Leopold was concerned, were extremely gratifying. The campaign, presented as an anti-slavery crusade, won him considerable international acclaim and

the subsequent "pacification" of the Arab zone added the vast *Province Oriental* to his domains.

Thus far, King Leopold had been merely dishonest; from now on he became inhuman. The Congo, he decided, must begin to pay its own way. A huge slice of a country pledged by the Berlin Conference to free trade and free competition would now secretly be transformed into a monopoly of the King of the Belgians. All so-called "vacant lands" in the Congo were to be exploited by the state; the produce of these lands—ivory and rubber—would become the *fruits domaniaux* of the State. The population of these areas would pay their taxes in the form of labor expended on the collection of these *fruits*. The Africans, who for centuries had lived their lives in their own fashion, were now suddenly forced to work off a tax which they did not even begin to understand. "Inherent in this regime," admits one of Leopold's apologists, "was the temptation to exploit native labor in the interest of a maximum return." It was a temptation to which Leopold was to succumb only too readily and which was soon to bring the whole world about his ears. [End quoting]

Leopold was now living the life he sought. He spent most of his time on his yacht on the French Riviera entertaining and being entertained. His reputation as a liar, a miser and thief of his family, a greedy man with a heart of stone and a licentious old rake was becoming too well known among the Belgians.

And still further on in *Defiant Dynasty*: [quoting]

By the turn of the century the world was beginning to wake up to the fact that something extremely sinister was going on in King Leopold's Congo. Missionaries, defying possible expulsion, began reporting atrocities by state officials against the African population. It was believed, at first, that such horrifying reports must be exaggerated and it was not until Sir Charles Dilke raised the matter in the British Parliament that the evidence began to be taken more seriously. The diary of a Congolese officer name Tilkens, falling into strange hands, made shocking reading, and still more damning evidence was presented by Edmund D. Morel, the journalist. His exposures, first in the press and then in his two impassioned books, *King Leopold's Rule in Africa* and *Red Rubber*, did much toward rousing public opinion.

In 1903 Herbert Samuel, by bringing certain grisly details to the attention of the House, stirred the British Government into action. A note was sent to the signatories of the Berlin Act and—what proved to be of more practical value—Roger Casement, the British Consul at Boma, was commissioned to make a report on the matter. The Casement Report, published in 1904, more than confirmed the allegations. His findings were subsequently backed up by the evidence of many others—Consuls, Vice-Consuls, American, British and Danish missionaries and unbiased travelers. The Congo Reform Association, founded by Morel, held protest meetings in Britain and America. Morel himself petitioned President Theodore Roosevelt to demand reforms in the Congo. King Edward VII referred to the matter in a speech from the throne, and from pulpits throughout Britain the clergy spoke in terms of "a terrible blot upon the name of Christianity". The phrase "Congo Horrors" became a rallying cry, and the demand for some sort of action became more and more insistent.

What, exactly, were these horrors? They were



the almost inevitable result of King Leopold's monopoly system. The King's only interest in the Congo was to make as much money out of it as quickly as he possibly could. In 1901, when he had been due either to repay the Government loan of ten years before or to hand the Congo to Belgium, he had managed, in his usual adroit fashion, to do neither. The Government obligingly passed a bill postponing repayment of the loan indefinitely, and King Leopold remained in control of the Congo. Not even he, however, imagined that he would live forever and his milking of the Congolese cow was now accelerated to provide the funds for his many unfinished projects.

Rubber provided the main wealth of the Congo and it was in the collecting of rubber that the African population was forcibly engaged. Leopold, interested in quick profits only, made no effort to conserve the rubber vines or to plant new ones; as the supplies of wild rubber dwindled, so did the search become more frantic. If the Africans were slow in delivering their quota, they must be made to work faster. The easiest way to do this was to terrorize them. And the best way to terrorize them was to kill those guilty of not working fast enough. To prove to King Leopold's impatient agents that a punitive raid against a dilatory village had indeed been carried out, severed human hands were brought in as testimony. The more hands that were brought in, the more efficiently had the punishment been carried out and the more efficiently, presumably, would the rubber be gathered by others in future. Reliable witnesses saw baskets of human hands being hauled along by Africans to a local European official for his inspection. When the soldiers (often cannibals from different tribes, chosen by officials for their brutality) were accused of wasting too many bullets, they would simply hack the hands off living men to make up the pile. Nor did the atrocities stop at shootings and hand-hackings. Villages were burned, men flogged, women mutilated, children chained in sheds as hostages or flung into crocodile-infested rivers, whole clans wiped out. Tribes fled in terror across the borders. Those who survived lived a nightmare existence. Senator Picard saw "a continual succession of Blacks, carrying loads upon their heads; worn-out beasts of burden, with projecting joints, wasted features, and staring eyes, perpetually trying to keep afoot despite their exhaustion.... They totter along the road, with bent knees and protruding bellies, crawling with vermin, a dreadful procession across hill and dale, dying from exhaustion by the wayside...." It has been estimated that in fifteen years, through massacres, through flight and through disease, the population of the Congo fell by some three million.

It was horrifying, but it was profitable. King Leopold, in the ten years between 1896 and 1906, made almost 3,000,000 francs—then \$15,000,000—in clear profit for his *Domaine de la Couronne*. For almost every life lost, in fact, he gained a pound sterling.

When faced with these accusations, King Leopold pooh-poohed them. He dismissed his critics as impractical idealists, as meddling do-gooders, as rapacious businessmen jealous of his success, as land-hungry rivals trying to steal his territory. As usual, he played one critic off against the other. By insinuating that Britain had designs on the Congo, he aroused the suspicions of France and Germany; by implying that the

Protestant missionaries wanted to get rid of a Catholic sovereign, he alarmed the Catholics. He set up a secret Press Bureau to disseminate favorable propaganda. He expended vast sums of money on buying the support of leading public figures. He paid state visits to Paris, Berlin and Vienna. He sent the President of the United States a silver-framed photograph of himself.

But he was blowing against a hurricane. No one believed him. A less notorious personality might have got away with it, but with the sort of reputation he enjoyed, the charges stuck all too easily. The world already knew that he was depraved, mercenary and hard-hearted; that he had betrayed his wife and ill-treated his daughters; that he was moving heaven and Earth to rob these daughters of their inheritance. If he was capable of such behavior toward his own flesh and blood, could there be any doubt that he was guilty of atrocities toward unknown savages?

To the chorus of vilification were now added the voices of such eminent writers as Anatole France, Conan Doyle, and Mark Twain. "In fourteen years," thundered Mark Twain, "Leopold has deliberately destroyed more lives than have suffered death in all the battlefields of this planet for the past thousand years...this mouldy and peity-mouthing hypocrite, this bloody monster whose match is not findable in human history anywhere, and whose personality will surely shame hell itself when he arrives there—which will be soon, let us hope and trust."

With no chance of riding out this particular storm, Leopold agreed to organize a Commission of Enquiry. Its findings, although couched in the most tactful language, confirmed previous allegations. The King, after a considerable delay, announced various innocuous reforms. They did almost nothing toward alleviating international hostility. By now it was beginning to be realized that the only answer was for Belgium to annex the Congo. Even King Leopold could appreciate this. He was not, however, going to let it go cheaply. With the vigor of a man half his age, he now prepared a series of intricately worked-out and arrogantly worded documents in which he set out the conditions upon which he was prepared to hand over the Congo to Belgium. From out of the pages of verbiage emerged one significant fact: Leopold was planning to keep his personal Congolese estate, now known as the *Foundation de la Couronne*, intact. If he was successful in preserving this, then what Belgium would inherit would be little more than an empty shell.

But the stubborn old man was fighting a losing battle; the Belgian Government was no longer prepared to dance to their Sovereign's tune. Annexation without provisos was becoming inevitable. Finally realizing this, Leopold decided to salvage what he could. Money was hurriedly shifted from the *Foundation de la Couronne* to secret depots in Europe. In a

typically complicated financial maneuver, he set up an illegal body known as the "Foundation of Niederfullbach". To circumvent Belgian law, the Foundation was headquartered in a castle near Coburg—cradle of the dynasty—and into this new secret body Leopold deposited the wealth of his doomed Congo *Foundation*. It was not, of course, that he wanted the money for himself; he wanted it for the power that it gave him. He must be rich enough to do as he pleased. He must be able to build palaces and enlarge harbors and erect triumphal arches without having to beg his Government for the money. He must be able to continue aggrandizing Belgium whether she wanted it or not. He must force greatness on her willy-nilly.

Only when Leopold had drained off as much money as he possibly could did he signify that he was ready to hand over the Congo. But even now, at this eleventh hour, he could not resist cornering Belgium into further obligations. She reluctantly agreed to take over and complete the great public works hitherto financed by his *Foundation*. And finally, he forced them into granting him a further 2,000,000 francs as "a mark of national gratitude".

Seldom has a pill been more generously sugared.

On November 15, 1908, the sky-blue flag with its golden star, once assumed to be a philanthropic symbol and in reality the symbol of so much suffering, was hauled down. The Congo Free State became the Belgian Congo. Leopold II had defied the world for over thirty years but the world, in the end, had got the better of him. [End quoting]

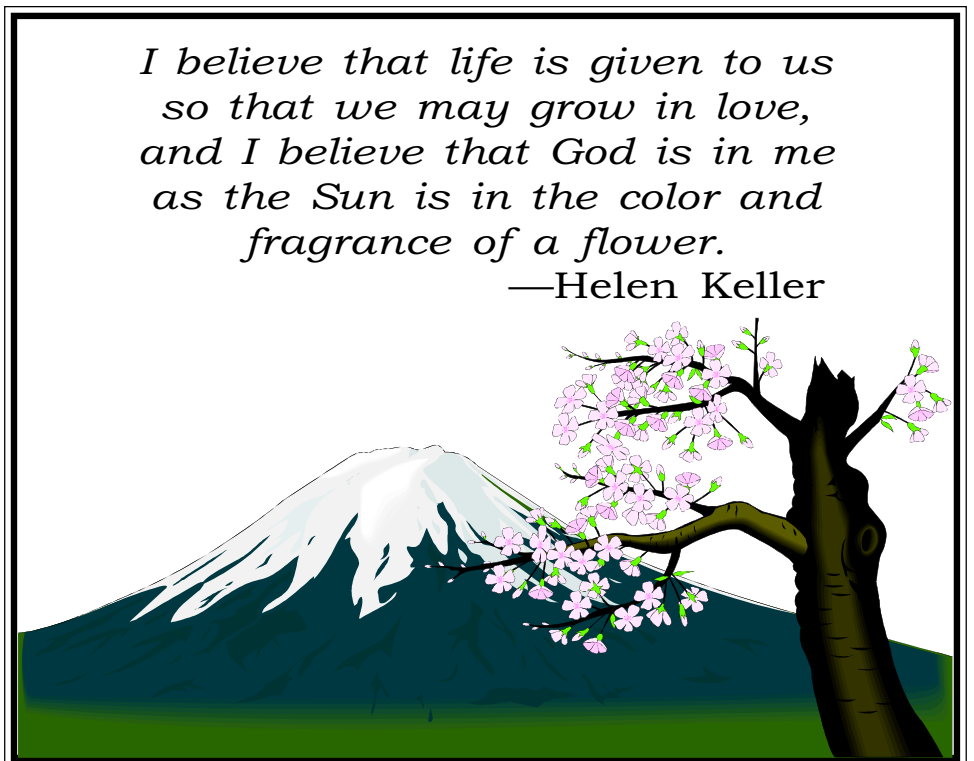

The end of Leopold's reign did not end the problems in the Congo. Colonialism was eventually ended and the country is now called by the names Zaire and Rwanda-Barundi. Civil war and aggression have been on-going problems. The "elite" have become adept at pitting one group against another, not only in Africa but elsewhere.

Like the English people, who paid a high price in protecting the "Crown's" colonies in India and elsewhere, without any say in the government or share in the profits, the Belgian people paid a very high price for Leopold's Congo without any share in the profits or say in the government whatsoever. And, like Leopold's pretense of weakness to gain

his ends, the same pretense of weakness (which was in fact a politically arranged weakness) was used by England and later Belgian monarchs to gain America's entry into World Wars I and II in their defense, at great cost to America. This too was part of Lucifer's plan for World Wars I and II, as partially revealed by Albert Pike, well-known Freemasonry leader in the United States following our Civil War. 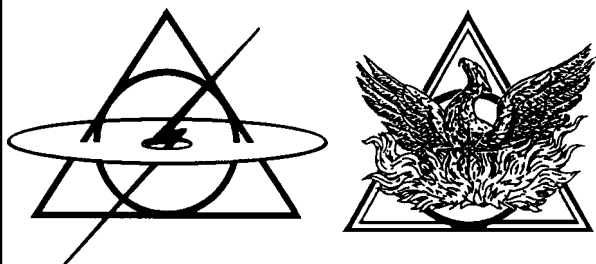
