## NEW NON-TOXIC COMPOUND SAID TO DESTROY ANTHRAX DISCOVERED

The University of Michigan News and Information Services: SAN DIEGO—BCTP looks like skim milk. Laboratory rats gain weight when they eat it. Spray it on your lawn and the grass will thrive. But according to tests conducted by University of Michigan scientists, this seemingly benign material could be a potent weapon against anthrax—one of the deadliest bacteria on Earth.

In a presentation at the Interscience Conference on Antimicrobial Agents and Chemotherapy (ICAAC) on Sept. 26, Michael Hayes, research associate in the UM Medical School, presented experimental evidence of BCTP's ability to destroy anthrax spores both in a culture dish and in mice exposed to anthrax through a skin incision. James R. Baker Jr., M.D., professor of internal medicine and director of the Center for Biologic Nanotechnology in the UM Medical School, directed the research study.

BCTP was developed by D. Craig Wright, M.D., chief research scientist at Novavax, Inc.—a bio-pharmaceutical company in Columbia, Md.—and president of Novavax Biologics Division. According to Wright, the material is made of water, soybean oil, Triton X 100 detergent and the solvent tri-n-butyl phosphate.

One of the most remarkable characteristics of this material is its ability to rapidly destroy a wide variety of dangerous bacteria and viruses, while remaining non-toxic to people, animals or the environment, Baker said.

BCTP's effectiveness against anthrax spores is especially significant, because they are so difficult to kill. Spores are like freeze-dried bacteria, Baker explained. Their tough outer coat is resistant to disinfectants, freezing, drought, virtually anything we can throw at them. Spores can survive in the environment for many years and still generate live bacteria when given the right combination of water, nutrients and temperature.

Concentrated doses of strong disinfectants

like bleach or formaldehyde will kill anthrax spores, according to Baker. Unfortunately, they also are toxic to people and the environment, which makes them useless for decontaminating a person, a piece of land or equipment exposed to the bacteria.

Since the Persian Gulf War, military authorities have become increasingly concerned about the threat anthrax and other biological warfare agents pose both to our armed forces and civilian populations. “Anthrax is often fatal and easily dispersed through air or water,” Baker said. We know that countries hostile to the United States have developed strains of anthrax which are resistant to antibiotics and existing vaccines. To counter that threat, the Defense Advanced Research Projects Agency (DARPA), is testing several possible new weapons against these biologic agents—including BCTP.

“When properly formulated, the components in BCTP form an emulsion of tiny lipid droplets suspended in solvent,” said Wright. These lipids fuse with anthrax spores causing the spore to revert to its active bacterial state. During this process, which takes four to five hours, the spore's tough outer membrane changes, allowing BCTP's solvent to strip away the exterior membrane. BCTP's detergent then degrades the spore's interior contents. In scanning electron microscope images, the spores appear to explode.

In his conference presentation, Hayes described how even low concentrations of BCTP killed more than 90 percent of virulent strains of *Bacillus anthracis* spores in a culture dish. “We observed sporicidal activity with dilutions as high as one part BCTP per 1,000 parts culture media,” Hayes said.

To determine its toxicity to animals, UM scientists fed large amounts of BCTP to laboratory rats and injected mice with the material subcutaneously. The animals gained weight, remained healthy and suffered no adverse effects.

To determine BCTP's effectiveness at treating animals exposed to anthrax spores, Baker's research team subcutaneously injected mice with *Bacillus cereus*—a closely related species of bacteria that can be safely handled in a university laboratory setting. Like *B. anthracis*, its lethal relative, *B. cereus* produces large, ulcerous areas of dead tissue if it penetrates the skin through a cut or injury. If untreated, these skin infections spread systemically, producing severe illness and death in 80 percent of the laboratory mice in the study.

“When we washed the animal's skin lesions with BCTP, the wounds began to heal,” Baker said. Mice receiving BCTP either simultaneously with *B. cereus* spores or whose wounds were washed with BCTP an hour after exposure had a 95 percent reduction in lesion size.

The death rate for mice receiving BCTP was only 20 percent.

“Rapid inactivation of anthrax bacteria and spores combined with low toxicity makes BCTP a promising candidate for use as a broad-spectrum, post-exposure decontamination agent,” Baker said.

In future studies, Baker plans to evaluate BCTP's effectiveness against inhaled anthrax spores, as well as other bacteria and enveloped viruses. His research has been funded by

DARPA's Unconventional Pathogen Countermeasures Program. The UM and Novavax have filed a patent application covering BCTP's use as a decontamination agent for various anti-microbial applications. Baker is a member of the Novavax scientific advisory board, but has no significant financial interest in the company.

### PHILIPPINES—TYPHOON ZEB

MANILA, Philippines—Typhoon Zeb set off on a menacing course toward Taiwan today after pounding the Philippines—killing 24 people there, touching off floods and mudslides and driving more than 100,000 from their homes.

The storm struck the Philippines on Wednesday, its 150-mph winds whipping up two-story-high waves that blasted the shoreline. By today, it was already buffeting Taiwan, which had two of its own storm-related deaths.

At least 103,000 people were forced to flee their homes in the Philippines as Zeb brought rampaging floods. Most have since returned home, but more than 10,000 people remained in 28 government shelters. Zeb weakened to 103 mph as it moved inland but was expected to pick up strength over the Pacific today, although forecasters said it would not equal its earlier power.

Authorities confirmed at least two dozen deaths and said more casualties were expected because of the many reports of landslides and floods.

"There are so many reports of landslides that will keep us busy for a while," Chief Insp. Ricardo Villena said today...

Zeb, the strongest of eight storms to hit the Philippines this year, was about 430 miles north of Manila this morning and moving slowly north, said weatherman Rene Molina. [End quoting]

The Philippines have been hit hard by disasters in the recent past. They need our prayers.

### SENATE PASSES SUBSTITUTE MONITORING BILL

To the American remnant and allies world wide:

What would motivate the Senate to unanimously vote broad new powers to a President who is under impeachment investigation for lying and abuse of power? The Senate Friday passed the so called INTERNATIONAL RELIGIOUS FREEDOM ACT (S-1868) sponsored by Senators Don Nichols, Joseph Lieberman and others by a vote of 98-0 in the closing hours of the session.

The bill is touted by the press as a "compromise" to the FREEDOM FROM RELIGIOUS PERSECUTION ACT, which was tabled by the Senate Foreign Relations Committee in May. In fact, the difference between the two bills is largely cosmetic, masking the powers granted to the president. S-1868 has already been referred back to the friendly Newt Gingrich-controlled House, where it received instant approval on Saturday. President Clinton reportedly finds the compromise bill acceptable, Undersecretary of State and Council on Foreign Relations member Stuart Eizenstat having negotiated an acceptable compromise for him.

S-1868 is less Orwellian than the Freedom From Religious Persecution Act, placing nearly open-ended discretionary sanction powers in the hands of the president in Section 405 under the heading of "Commensurate Action". It sets the stage for government to make religion its business while supposedly in search of persecutors. The bill is clearly internationalist legislation, relying upon the same United Nations covenants cited in the predecessor bill, and it goes a step further by recognizing the authority of the International Criminal Court; it provides for an appointed "commission" to "monitor" religions instead of an ORPM director, but the commission is chaired and dominated by a presidentially-appointed "ambassador at large". No doubt Mr. Clinton will add Christian influence to the committee, like parsley on a dinner plate, by appointment of a celebrity Christian to the commission.

Perhaps most ominous, S-1868 authorizes taking advice and input from "Non-Government Organizations" (NGOs) without any specifications as to which NGOs Mr. Lieberman and Mr. Nichols have in mind. The presidentially-appointed "Ambassador at Large" will choose whom he will listen to, and FREEDOM HOUSE and HUDSON INSTITUTE are NGOs that promoted the bill. These predominantly non-Christian groups might have direct and preferential input, but would your church? We Hold These Truths is an NGO, but we doubt if we will be consulted about questions of religious persecution and warmaking sanctions, any more than we were allowed to testify in the Senate Foreign Relations Committee. This bill invites selective, consensus decision making propaganda generation...

...To all those who have helped, we thank you for your understanding of our common problem, and your very effective efforts to expose the Freedom From Religious Persecution Act for what it is. Most important, we have discovered

in one another the presence of a committed and knowledgeable remnant that does not believe in compromise on matters of God.

### PIGEONS GO MISSING IN RACE— COULD SIGNAL PENDING MAJOR EARTHQUAKE?

The following note is from geologist and earthquake expert Jim Berkland and deals with the totally bizarre disappearance of 2,000 racing pigeons and how that might be linked to a very large, pending earthquake.

Daniel Karnes posted a significant news item on the Animals Page—about 90% of thousands of racing pigeons dropping out in two separate races on Monday back East. They say they have never seen anything like it and can't explain it by solar flares or bad weather. Another explanation is magnetic field changes prior to large earthquakes. I have established this quite well by working since the early 1980s with Nick Corini, pigeonmaster in Hollister, CA.

You can read about it in a chapter dealing largely with my work in the 1996 book, *CALIFORNIA FAULT*, by Thurston Clarke (Chapter titled "Lost Cats and Smashed Pigeons").

A smash race is one where few of the birds get back on time or do not return at all. Corini has records of Bay Area pigeon races going back decades, and he spent some time researching the greatest smash race in local history. The date caused me to gasp. It was March 24, 1964, which I knew was just 3 days before the greatest quake measured for North America, the 8.5M Richter (9.4Mw Moment magnitude) Alaskan Quake on Good Friday, 1964. It struck in the late afternoon on the day of a Full Moon!

It had been preceded by a few months of strange slowing of Old Faithful Geyser in Yellowstone. In recent months we have had a similar report about Old Faithful. I have had several unconfirmed reports of the federal scientists being concerned about a large US quake this fall. I don't know if that is true, but I do know that I am concerned, and this amazing coincidence of Smash pigeon races does not ease my mind. I am trying to learn if other parts of the world have experienced similar races.

The 1964 'smash' race occurred over 1600 miles from the location of the Alaska quake. Jim Berkland states that the location of the smash race may have little to do with the epicenter of any following quake, that the magnetic disturbance caused by fault stress is so powerful it can disrupt the internal magnetic guidance systems of pigeons great distances away. Jim Berkland has a very good record for predicting earthquakes, so it pays to be prepared when he puts out a warning.

Based in Cambridge, Massachusetts, E-Ink is the commercial incarnation of electronic ink developed at the Massachusetts Institute of Technology ["Electric Tales", June '97]. This electronic ink can be coated onto any surface using standard printing processes. To change a message, an electronic signal is applied to the surface, so the ink can change colors and form numbers and letters, for example.

E-Ink proposes to take the idea even further by linking the display to an existing paging system. Doing so would allow a sign to be updated remotely. An E-Ink display at a supermarket, for example, could be wirelessly updated to reflect changing prices or special sales. The display itself would be as thin as a sheet of paper, use very little power during updates, require no power to maintain, and be as

readable as an existing sign. And because electronic ink can be printed on many different types of surfaces and the displays updated remotely, they would be advantageous in difficult-to-access spots.

E-Ink ultimately hopes to develop a "radio paper" that looks and feels like a newspaper but that could automatically be updated each day—the newspaper would essentially typeset itself upon receiving transmitted information. The company also hopes to apply the technology to such products as electronic books and magazines. F.V. [End quoting]

Suddenly a deep voice roared, 'Keep still or I'll cut your throat!' and a terrible figure rose from among the tombstones."

"Then what happened?" I asked, enthralled.

"If you'd like to know," she answered, smiling, "read the book *Great Expectations*, by Charles Dickens." She made me want to go to the library.

Other times Barry and I would be out in the driveway on a Saturday shooting hoops, and his mother would say, "Boys, could you come and give me a hand?" The next thing we knew, we would be helping her with a student she was tutoring. I felt proud that Mrs. Williams valued my help. I didn't realize until much later that, by teaching someone else, Barry and I were learning too. Mrs. Williams made sure Barry and his brothers did their homework, and if I happened to be visiting, she watched while I did mine. Usually Barry and I studied at the kitchen table. Mrs. Williams stayed nearby, in case we had a question. At home I lived in fear of my father's alcoholic rages, and I wasn't used to that kind of discipline—or attention.

Her favorite words of encouragement were "You can do this." I heard them often because I was impatient and easily frustrated. When a math problem refused to yield its secrets or an essay had me confounded, I gave up and slammed

my pencil on the table. Calmly, Mrs. Williams took a seat beside me and talked me through the assignment step-by-step. Something about her quiet reassurance, "You can do this, Walter," settled me down, and I managed to finish my homework.

Barry and his brothers went to private schools—an expense that must have strained Mrs. Williams' budget—and she worried about the quality of my education. One day she took me to a local parochial school, had me tested, then persuaded my parents to let me change schools.

I attended for a while, but, after an angry exchange with a teacher, I was told not to come back. Unperturbed, Mrs. Williams took me to another school, had me tested again, made sure I would receive the necessary financial assistance, then convinced my parents that it was important for my future. I made it through two grades in one school year.

When we were ready for high school, Barry applied to boarding schools. Mrs. Williams believed that would be the best thing for me as well. Anything to get me away from the streets, where she saw too many kids getting into trouble. I was accepted into a prep school and again awarded a scholarship. But when I saw the other students—kids in pressed shirts and blazers—all my old insecurities came rushing back. I couldn't do it. I entered the high school in town. A year and a half later, failing nearly every subject, I dropped out.

One of the hardest things I've ever had to do was tell Mrs. Williams. She gazed at me with her cool brown eyes and said nothing. "I'm going into the Marines," I said, shrugging. "I won't need high school."

"Okay, Walter." Her voice was quiet,

resigned. "I don't agree with you, but you're old enough to make your own decisions."

Six months later, in the Marines, I realized how right she was. In three and a half years I would be out of the service, a 21-year-old with no diploma. What sort of future would I have? *Dear Lord*, I prayed, *please give me another chance*.

The next morning, I went to the First Sergeant and said, "I want to go to school." The first step was to take an exam for a high-school equivalency diploma. I must have done well, because after seeing my scores, the Marines enrolled me in a special electronics program.

Again I felt out of my league. *Dear God*, I prayed, *let me pass just one course*. The instructor began his lecture. I started taking notes, but there was so much I didn't know; so much I was afraid I would never know. *There's no way I'll get through this class*, I thought, putting my pen down. *I should just walk out the door right now*.

All at once I heard a familiar voice inside my head, warm and reassuring: "Don't give up, Walter. You can do this." I wasn't so sure, but I owed it to Mrs. Williams—and to myself—to try. Taking a deep breath, I picked up my pen and concentrated on my instructor's lecture.

I graduated seventh in a class of 24. It was the biggest thrill of my life. *I can't wait to tell Mrs. Williams*, I thought. But by the time I made it back home the Williamses weren't living across the street anymore. They had moved and no one knew their new address.

After the Marines I went on to receive my bachelor's degree. By the age of 26 I was well into a career in journalism. I became a newspaper editor and eventually editor-in-chief of

Several years ago when I spoke at a dinner, I told the audience, "All the successful people I've known have one thing in common. In their childhood there was someone who said, 'I believe in you'. For me, that was my best friend's mother, Mrs. Williams." It was gratifying to give her credit. Still, I longed to tell her how she had changed my life, to thank her for all she had done for me.

Some time later, I talked to *Parade's* senior investigative-reporter about Mrs. Williams. "I wish I could get in touch with her," I said.

"I can find her," he declared.

A few days later he called. "Walter," he said, "Mrs. Williams lives a few miles away from you. She's retired from teaching, and her son Barry is a successful attorney."

Mrs. Williams and I had a reunion at my house. All I could do at first was thank her over and over again. Then the words spilled out in a rush, as I told her about everything I had accomplished, eager to make her proud. "I graduated college as valedictorian. Then I got into journalism and today I'm the editor-in-chief of a magazine."

She gave me a broad smile. "Of course, you are, Walter," she said, her voice as full of assurance as it had been so many years ago. Ilza Louise Berry-Williams never doubted for a moment that I could accomplish anything I set my mind to. \* Ensure an economically just society in which there is a fair and equitable distribution of the wealth of the nation, in which there is

full partnership in economic progress.

Massive development is being underway in the “Technical Corridor” referred to above. And yes, we are going to speak of these things until you understand the possibilities of a life outside the slave compounds. Do you actually think we will not accomplish our little task? Wow, and where have you been in this Course of Miracles?

Our little team gets discouraged from day to day—with full impatience and concern over “how to keep going”, etc. But the picture only extends itself ready for the maturing fruit to reach the harvest. You cannot see the momentary growth of the apple—it seems the fruit sets, then somehow it is ready one day—for harvest. Fine, never mind horticulture—we

\* The fourth and final attribute is the most important, and that is good *LEADERSHIP*. Enlightened leadership brings vision, provides motivation, and points the way to development and modernization.

And the above are all listed as directives from a grand “leader”, right here, as a means of escaping the poverty trap and achieving sustained growth. It has been PROVEN in this little place in the South Pacific.

### MALAYSIA'S PRESCRIPTIONS GAIN ACCEPTANCE A YEAR LATER

*New Straits Times, Monday, October 5, 1998: [quoting]*

A YEAR ago when the international financial community met in Hong Kong for the annual World Bank and International Monetary Fund (IMF) meetings, the concern was about the Thai baht and the “potential spread of financial problems around East Asia”. One year on, the setting is Washington and the concerns are global.

A quarter of the world is in recession and the number of those living in poverty and hardship is growing by the hour, if not by the minute. Russia is in turmoil, Brazil is a matter

of concern as its problems could affect the US economy and the Long-Term Capital Management (LTCM) debacle has raised more questions than the US has answered with its lightning-speed bailout of the hedge fund.

The IMF prescriptions for the Asian countries have not worked. They have made the situation even worse. The IMF's managing director Michel Camdessus admitted that the Fund made mistakes and added that it should have done more to monitor the financial sector. (Many of the hedge funds and derivatives markets are not regulated.)

Now the global financial community is looking for ways to overcome the problem and prevent the contagion from spreading to the developed world. US President Bill Clinton is talking of “a new financial world order” while his Treasury Secretary Robert Rubin talks about redesigning the “global financial architecture and making it as modern as the markets” admits the realisation that the US cannot remain an “oasis of prosperity” when the rest of the world is in turmoil.

Other areas being considered, according to Rubin, are a new financing mechanism at the IMF to get ahead of contagion in emerging markets and developing countries; a new mechanism at the World Bank to enable emergency lending for social safety-net spending and for financial restructuring; and enhanced trade finance and multilateral development bank enhancement.

Moves for lower interest rates and increased liquidity are also gaining popularity among the world's financial community. The World Bank's president James Wolfensohn urged major industrial nations to cut interest rates to spur economic demand and Camdessus has echoed this suggestion.

Stimulating the economy with lower interest rates and increased liquidity are among the measures that Malaysia had suggested much earlier, only to be ridiculed. Malaysia was also criticised as it was not in sync with the IMF policies which were to tighten liquidity, increase interest rates and reduce government spending.

But today, the world is coming around to Malaysia's way of thinking. The Group of 7 industrialised nations (G-7), in their statement, acknowledged the need “to take stimulative measures to put their economies on the path of recovery and sustainable growth”.

The developed nations are also coming around to the idea of “pursuing stable foreign exchange rates for sustainable economic growth”. The violent currency fluctuations and the rapid and dramatic depreciation of the currencies in Asian countries had rendered them helpless and unable to plan for the future.

Malaysia has in fact taken the lead by pegging the Ringgit to the US dollar at RM3.80. It has also reduced interest rates and instituted capital controls to insulate the economy from being further devastated by the contagion.

The measures are already beginning to show results. Foreign reserves are up and the wheels of businesses are starting to move again. The lower interest rates are bringing smiles to the faces of many businessmen and entrepreneurs. The burden of the high interest rate regime has been removed from individuals and corporations. Savings accrue not only in the form of a lower cost of funds but also in lower repayments. As a result of the lower interest rates, a Malaysian

businessman is said to be able to realise savings of RM4 million a year.

One year later, and especially when the effects of the currency crisis are beginning to hit Latin America and closer to home with the collapse of LTCM, the US, IMF and other developed nations are becoming more accommodative to Malaysian views and solutions.

Japan's offer of US\$30 billion in aid to assist the troubled Asian countries did not receive the objections of a year ago. The Japanese Finance Minister, Kiichi Miyazawa, said the package was needed to ease the pain of Asian nations. He hoped that the aid package would lead to the creation of an Asian crisis fund. When the Japanese proposed forming such a Fund in September 1997 to stop the spread of the financial crisis, its creation was stopped and violently objected to by countries led by the US.

The arguments put forth then were that the lending conditions would not be as strict as the IMF's and that it would undermine the IMF's “reforms”. Today it is seen as “a constructive thing to be doing”.

The IMF reforms have not worked and it has had to revise its terms in all the three countries involved—Thailand, South Korea and Indonesia. The economic situation in the three countries has deteriorated even further even as the Fund continues with its medication. There is an urgent need to seek alternative solutions.

None of the countries that have had to resort to the IMF—be they in Asia, Latin America or Africa—have seen their economies improve to the pre-crisis levels. The per capita income in Mexico today is about the same as it was in 1974. There is increased unemployment and poverty, and economic polarisation has “steadily torn away at Mexico's economic and social fabric”. The worse affected are the small rural and urban producers.

A report on “The Development Group for Alternative Policies” points out that from 1982 to December 1994 when the Mexican economy collapsed, the Mexican Government implemented virtually all of the adjustment policies promoted by the World Bank and the IMF—reduction in public expenditure (including social services); elimination and/or targeting of subsidies; tax reforms; restriction of credit; privatization of most state enterprises; trade liberalisation; devaluation; removal of barriers to foreign investment and “competitive” wages.

The policies were intended to control inflation and generate foreign exchange to help pay off the debt. While the World Bank and the IMF were applauding Mexico's economic performance under adjustment, one half of the population was living in poverty and their ranks were swelling daily. This situation is no different from that in Asia where the IMF has lent its “helping hand”.

Even the narrow macro-economic indicators which the World Bank and IMF use to judge the success of the structural adjustment programmes (SAPs) showed that they had failed. While gross domestic product (GDP) growth resumed after the 1981-1982 crisis, GDP per capita, a key indicator of living standards, had barely recovered to pre-crisis levels in 1993.

Even today as the IMF applauds the “progress” made by Thailand, South Korea and Indonesia, the misery and the economic devastation that has been left in the wake of the

measures are not mentioned.

There is now a realisation that alternative measures and remedies including those proposed by Malaysia—lower interest rates, increased liquidity and fixed exchange rates to stimulate economic activity—may be the answer.

### **PM: JUDICIARY IS NOT BEHOLDEN TO GOVERNMENT**

KUALA LUMPUR, Thurs.—No one should question the independence of the Malaysian judiciary and its ability to make decisions freely because history has proven that it is not beholden to the Government, Prime Minister Datuk Seri Dr. Mahathir Mohamad said today.

He said the judiciary had ruled in favour of the Opposition more often than it did for the Government which had on all occasions accepted the decisions although at times the judgments “seemed unfair”.

However, he said, the Government did not protest or complain because it respected the freedom of the judiciary to make decisions without fear or favour.

“I am not complaining that the judiciary is unfair, but it seems to us that decisions are made without any regard to the Government ... not at all,” he told reporters after briefing Senators and Barisan Nasional MPs at Parliament House on the next Dewan Rakyat and Dewan Negara meeting which begins on Oct 20.

Dr. Mahathir cited an instance where an Opposition member was fined less than RM2,000 so that he would not be disqualified as an MP, although the maximum fine for the offence was much more than that.

“This is discrimination but we didn’t protest,” he said. Among recent cases involving Opposition MPs, Datuk Seri Joseph Pairin Kitingan, then Sabah Chief Minister, was fined RM1,800 after he was found guilty by the Kota Kinabalu High Court in 1994 for using his position to commit corrupt practice.

He was charged under the Emergency Ordinance (Essential Powers) which carries a maximum 20 years’ jail or a fine up to RM20,000.

In 1978, DAP secretary-general Lim Kit Siang was charged, convicted and fined RM15,000 on five charges relating to the disclosure of secret information regarding the purchase of four fast strike craft by the Royal Malaysian Navy in 1976.

He appealed to the Federal Court and successfully had the fine for each charge reduced to less than RM2,000.

Under the Federal Constitution, an MP who is fined RM2,000 or more or jailed for more than a year, will automatically be disqualified as a member of the Dewan Rakyat.

Dr. Mahathir said on the other hand, when cases involving the Government appeared before the court, they were severely dealt with.

“I don’t know what else you can say about the judiciary being fair when the same judiciary has decided very much against the Government in many instances.

“We are not saying that it is unjust. But the same judiciary had declared that Umno was an illegal party. We had to re-start Umno and we were put in big trouble by that decision.”

Umno was declared illegal by the High Court in 1988 after several members sought court redress over certain grievances arising from the party polls the year before.

Similarly, Dr. Mahathir said the judiciary had convicted many party officials who held high posts in the Government, including Ministers and Menteri Besar, for offences committed by them.

"So, the judiciary in Malaysia is not beholden to the Government. In some other countries, you can be sure that it (the judiciary) will decide for the Government and whoever attacks the Government will be punished to the point where there will be no return for them."

Dr. Mahathir said foreign countries, including members of Asean, were not in a position to criticise the Malaysian judiciary.

He said those who criticised the Malaysian judiciary should look at their own system which did not work well.

In the United States, he said, the policemen who beat up a Black man were freed by the court of all charges of brutality, resulting in a big riot in Los Angeles.

"Recently, another Black man had his feet tied to a lorry and dragged on the road until he died.

"A Japanese student who knocked on someone's door to ask for directions was shot dead by the owner of the house.

"The houseowner claimed that he was under the impression that the Japanese student was a robber. The court found him not guilty. This effectively means he can shoot whoever he wants."

Dr. Mahathir said such court decisions could only come from a country where there was no justice whatsoever, especially for the Blacks. "And now they are trying to teach us about justice."

In Malaysia, he said, everyone was treated equally, regardless of race.

Asked to comment on various statements by certain Asean [*sic*] leaders on Datuk Seri Anwar Ibrahim's impending trial which gave the impression that the judiciary was not free, Dr. Mahathir said:

"That is their right. They can raise it if they want. But we can also raise issues about their countries.

"I wish they will give the court a chance to decide. That is the judiciary in this country. Maybe in their countries, it is not the courts that decide, it is the mob on the streets which makes the decisions.

"In these countries, the mob is making the decisions. In our system, the courts make the decision."

#### APPLICATION FOR WRIT OF HABEAS CORPUS TO PROCEED, SAYS LAWYER

KUALA, LUMPUR, Thurs.—Datuk Seri Anwar Ibrahim will proceed with his application for a writ of *habeas corpus* although he was released from detention under the Internal Security Act yesterday and is now remanded at the Sungai Buloh prison.

His lawyer Pawancheek Merican said: "We

have our reasons to go ahead with the application and we will see what will happen in court."

While not disclosing the reasons, Pawancheek said the application which is fixed for hearing in the High-Court on Oct. 24, would be handled by Anwar's other counsel Sulaiman Abdullah.

Anwar, 51, who was arrested under the ISA on Sept. 30 and charged with 10 counts of sodomy and corrupt practices, was released from ISA detention yesterday and remanded at the prison pending trial as he was refused bail.

The High court has fixed for four of the five corrupt practices charges to be heard from Nov. 2 to 14. No hearing date was fixed for the other charges.

Anwar's lawyer filed the application for his release on Oct. 8 and on Oct. 18 filed a notice of appeal against the High Court's decision refusing him bail.

No date has been fixed for the hearing of the appeal.

Anwar, who was sacked as Deputy Prime Minister on Sept. 2 and dismissed from Umno the following day, is charged with committing carnal intercourse with five people at different places and times between Dec. 1997 and April this year.

The charges come under section 377 of the Penal Code which carries up to 20 years' jail and whipping.

He is also facing five counts of corrupt practices by interfering with an Anti-Corruption Agency investigation and directing two police officers to obtain statements from two people denying his alleged sexual misconduct.

Anwar allegedly committed the offences at his former office at the Ministry of Finance in Jalan Duta and in his official residence in August last year.

The offences come under Section 2(1) Emergency (Essential Powers) Ordinance No. 22, 1970, which carries a maximum sentence of 14 years jail and a fine of up to RM20,000.

#### TURN TO PRAYER IN SEEKING JUSTICE IN ANWAR'S SAGA

## CURRENCY CONTROLS THE BEST WAY OUT

About a year ago I spoke in Hong Kong on the Asian financial crisis and the need to regulate the activities of currency speculators to protect developing countries from having their limited wealth destroyed. Mine was a voice in the wilderness and my views were regarded as ridiculous in a world that was moving rapidly in the direction of ever greater globalisation, deregulation and liberalisation.

When borders and the obstacles against free trade were being dismantled, how could anyone talk of regulating the free flow of capital worldwide? Regulation would stifle international investments by the rich which would help the capital-poor countries to grow.

Malaysia of all countries should not talk of obstructing capital flow because it had benefited greatly through Foreign Direct Investments. Not only was Malaysia's industrialisation the result of investments by foreigners, but the Malaysian stock market, the biggest in Southeast Asia, was enriched greatly by massive injections of capital from the rich countries.

The capitalisation of the Kuala Lumpur Stock Exchange rose to around US\$350 billion following road-shows conducted by Malaysian companies to attract institutional investors from

the West. So why should Malaysia talk of curbing the activities of foreign funds, including the hedge funds?

Malaysia is no more capable of predicting the future than anyone else. No one actually predicted the extent of the economic turmoil which now engulfs the whole world. No one can claim they expected that the financial problems of Thai banks would spread so widely that today not only is the whole of East Asia affected, but Russia and Latin America are also affected.

Even the great United States of America is not beyond being affected by the turmoil which began in East Asia as demonstrated by the effect of massive losses by the Long-Term Capital Management Fund in its investments in affected countries.

As I said, Malaysia did not foresee the extent of the damage that could be caused by the currency trading of the hedge fund managers. Malaysia was concerned largely with the possible effect on the development objectives of the country.

Many experts talk about fundamentals, about confidence, about herd instincts and contagion effects. It was suggested that sound fundamentals and good transparent financial management would prevent contagion and the flight of capital.

Countries of Asia would do well to reform their financial system in order to create confidence among the people who control the flow of funds.

Malaysia was and is not convinced that currency traders do business based on their confidence or lack of it in any country. We believe they are motivated by pure greed, by their desire to make as much profit for their funds as they can, irrespective of the cost to others. If they have to destroy the wealth of countries and the livelihood of poor people they would not hesitate to do so, if there is good profit to be made.

We believe, and we said so, that currency traders are not speculators but are manipulators instead. The difference is that while speculators depend on their perception of the trend of the market and they place their bets accordingly, manipulators know exactly what direction the market would take because they have the capacity to manipulate the markets. Thus if they want the currency to be devalued, they can do so simply by repeated selling of that currency until the target is achieved.

Of course, central banks may defend the currency by buying it repeatedly. But the capacity of the central banks is limited by the reserves they hold. For developing countries like Malaysia the usual reserve would be around US\$20 billion.

But hedge funds can leverage their funds by twenty times through credit made available by giant international banks.

In the case of Long-Term Capital Management Fund, for their US\$4 billion, they were able to borrow US\$120 billion and leveraging on this, they obtained credit amounting to US\$1 trillion.

Between the hedge funds which are involved in currency trading, they hold about US\$180 billion. Leveraged by 20 times even, they would have at their disposal US\$3.60 trillion. No central bank can match them. Defending a currency under attack is an exercise in futility.

But hedge funds are not the only ones

involved in currency trading. The big banks worldwide have made currency trading their principal activity, their main source of profits.

Clearly these funds have unlimited resources to manipulate the market. They can buy or borrow any amount of any currency and sell to devalue. They are in a position to devalue any currency at will. They are not dependent on the vagaries of the market at all.

If they want to short-sell any currency they can do so. And, of course, they can literally determine how much profit they want to make for themselves. Their investors believe that the size of the funds they invest in will ensure that they can never lose. How can they when they can revalue or devalue according to the profit-making plans that their Nobel laureates had designed.

Clearly these funds and their managers have tremendous power, power which far exceeds those of Governments and countries. This power is real and the exercise of this power not only brings profits for them but can actually force Governments, affected or not, good or bad, to cringe and kowtow before them.

They, the funds' managers, can actually force the Governments of the countries they attack to submit to their whims and fancies. In fact, they can and they have brought down Governments.

With this enormous power, it would be a miracle if they do not become corrupted. We repeat, ad nauseam, power corrupts and absolute power corrupts absolutely. The hedge funds and the great banks of the world have absolute power and they are, therefore, absolutely corrupted. They would abuse that power to satisfy their greed. The LTCM debacle has proven this to be true.

This was what Malaysia saw when we condemned the hedge funds and currency trading. We saw shadowy figures in the world's financial centres wielding enormous power without any rule or regulation or morality. We saw them exploiting developing countries like Malaysia which had reached a certain stage of development and is, therefore, rich enough to make their kind of financial abuse profitable to

them.

And since no one supervises these funds, and there are no regulations, rules or laws for them to submit to, there is no limit to their quest for quick and limitless profits. Countries and people must suffer as a result.

That was what we saw and it was this that frightened us. It was the possibility of unending suffering from the destruction of what we painstakingly build every time. Human greed can only be curbed by human society.

If society gives a free hand to powerful, greedy individuals they will destroy everything in order to satisfy their lust for wealth and power. They will destroy society itself.

When Malaysia urged either the abolishment of currency trading or regulating it, we had not taken into account the role of the IMF (International Monetary Fund). This relic of the defunct Bretton Woods system has now become an instrument of the rich to dominate the poor.

The IMF is supposed to promote the restructuring of the financial system of the developing countries in order to improve their economic performance. But the remedy it proposes seems more likely to destroy the economies than to improve.

In the end, the banks and corporations will fail and their Governments bankrupted. Knowing this, the clients of the IMF would refuse to comply but, if they refuse, the currency traders and the stock-market raiders would devalue the currency and the shares.

Thus, the developing countries would comply with the demands by the IMF including opening up the markets. With the shares scraping bottom and the currency devalued, the foreign banks and corporations would be able to buy up the banks and all the businesses at rock-bottom prices.

Between the IMF, the currency traders and the big foreign banks and corporations, between them they would be able to buy up all the worthwhile businesses in the developing countries under IMF control. Once they have control of these businesses, it would be an easy matter to strip the assets or to refloat the economy and control the countries completely.

Maybe, Malaysia is paranoid but what has happened today has shown that it has reasons to fear, to be paranoid even.

Malaysia appealed to everyone to regulate currency trading. Most laughed at Malaysia for not understanding the workings of the world financial system, for not understanding herd instincts, the role of confidence, etc.

A few, and this includes the IMF, humoured Malaysia, promised to study and then did nothing. Time was running out and the Malaysian currency and shares were falling rapidly. In neighbouring Indonesia the currency had fallen through the bottom. Could Malaysia

wait while the IMF and others fiddled?

Believing that the world, especially the rich and powerful, would not help, Malaysia decided to do things on its own. It toyed with the idea of adjusting wages and prices to reflect the exact level of devaluation.

Thus if the currency is devalued by 20 per cent, then all wages and prices would be increased by 20 per cent. This way the people would not feel the effect of the currency devaluation. But the implementation of this solution would be too complex.

The best way was to isolate and insulate the Malaysian currency from the other currencies of the world. The ringgit should be legal tender only within Malaysia.

Any ringgit found outside Malaysia would be prohibited from being brought back into the country. This makes the ringgit outside Malaysia completely worthless.

Of course, most of the ringgit outside is not in the form of cash. Such offshore ringgit would have to be reflected in Vostro accounts in Malaysian banks. Any offshore transaction must involve transfers from one Vostro account into another Vostro account in Malaysian banks. To stop the offshore ringgit from being lent, bought or sold and so to have value abroad, transfers from one Vostro account to another is forbidden. Thus lending or sale of offshore Malaysian ringgit will not be acknowledged in Malaysia. Since the ringgit is not legal tender outside of Malaysia, owning Malaysian ringgit abroad becomes quite meaningless.

For the first month the offshore ringgit may be transferred back to Malaysia. After that it may not be transferred at all, thus rendering the offshore ringgit useless and without any value.

Within the borders of Malaysia the ringgit remains legal tender and can be used for all transactions including the purchase of all foreign currencies. The exchange rate of the ringgit was fixed at RM1 to US26 cents or RM3.80 to the US\$1 and to the dollar equivalent of all other currencies.


Since the exchange rates between the US dollar and other currencies fluctuate, obviously the exchange rates between the ringgit and other currencies except the dollar will also fluctuate. But this is not much of a problem as changes can be made to the exchange rate against the dollar in order that the competitiveness of Malaysian products will be maintained. However, this will not be done until every avenue for ensuring competitiveness has been explored and applied.

A fixed exchange rate can only be regarded as fixed if it remains at the level for a considerable length of time.

Besides the exchange rate of the ringgit, Malaysia has also insulated its stock exchange from being manipulated by foreigners who care nothing for the well-being of Malaysian companies or its people in their quest for quick profit from capital gains.

Today, as result of the measures we have taken, the share prices reflect the performance and asset value of the businesses more closely. Other measures have been taken to prevent manipulators from deliberately bankrupting the businesses so they may buy them cheaply, probably in order to strip assets.

We can expect the greedy foreign capitalists and their collaborators in their Governments and other institutions to try to undermine the

measures we have taken. They would want to force us to submit to them again. But so far we have been able to withstand their attempts.

In the first month of the implementation of the new strategies the performance of the Malaysian economy has been quite encouraging. Reserves have increased and business has generally improved. The slide into contraction has been slowed. Foreign direct investment has not been adversely affected.

Investors, both foreign and local, are finding that the fixed exchange rate makes forward planning easier and more reliable. Business needs predictability of the future environment and the fixed exchange rate provides this.

Exchange rate control is not the same as control on capital flows. Capital can flow in and out of Malaysia without restriction.

In even the most developed countries the movements of currency in and out of the country are recorded and controlled.

Of course, many developing countries require such movements to be declared. So what Malaysia has done is only to enforce currency movement regulations so as to be able to control the exchange rate.

Because capital can flow in and out of Malaysia, foreign investments and foreign trade are not affected. Trade settlements have to be in foreign currency because the ringgit has no value outside Malaysia. Foreign currency must be changed into ringgit to pay for all transactions in the country.

To take out money the ringgit must be changed into foreign currencies. As Malaysia has a large trade balance and minimal foreign short-term loans there will be no shortage of foreign currencies.

Since the implementation of the fixed exchange rate and the enforcement of the rules regarding the movement of money in and out of the country there has been no major problem.

The allegation that Malaysia is isolating itself from the international community is completely without basis. Malaysia is a trading nation. It just cannot isolate itself if it wants to trade. A fixed exchange rate facilitates trading.

Hedging is no longer as necessary as before and this reduces the cost of trading in goods and services. Long-term contracts for supply or construction can be entered into in ringgit without having to worry that it may lose its purchasing power during the period of the contract.

There is, of course, a need for Malaysia to conserve foreign exchange. Imports must therefore be limited to essentials and exports exanded. A "Buy—Made in Malaysia" campaign has helped a lot in slowing the outflow of funds. Travel abroad is possible but funds taken out in foreign currencies have to be limited. The limit is reasonable and not too restrictive.

Malaysia is mindful that it has a medium-sized airline and the viability of this airline depends on the number of Malaysians travelling in and out of the country. We cannot restrict travelling too much.

Clearly the control of the movement of money and the restriction of the Malaysian ringgit going out of the country is a limited exercise which is not noticeably more than the controls by many countries, developed and developing, over the movement of money

crossing their borders.

The main effect of Malaysian restriction on currency movement is to prevent the Malaysian ringgit from being traded by currency traders. To them the ringgit has zero value simply because to trade they will have to have the ringgit outside Malaysia. Any ringgit outside Malaysia will not be allowed to be brought back into Malaysia in whatever form.

Since the ringgit is legal tender only in Malaysia, not being able to bring the ringgit back into Malaysia makes it useless. Therefore, the main losers as a result of Malaysia's control over the movements of the ringgit are the currency traders.

But who gains? The Western detractors and their media are quick to broadcast that the beneficiaries are the cronies of the Government of Malaysia, as it is an Asian Government.

The Government of Malaysia has no cronies. We believe in co-operating with the private sector simply because the revenue of the Government comes largely from corporate taxes. Twenty-eight per cent of the profits of the private sector belong to the Government. In helping the private sector to make profits we are actually helping ourselves, the Government.

The measures taken by the Malaysian Government will benefit the whole business community, local and foreign. It will also benefit the indigenous (Bumiputera) businessmen, but not appreciably more than the non-Bumiputera businessmen.

We are in the process of redistributing wealth between the different communities in order to eliminate racial jealousies. We will continue to do this with apology to no one.

If you come to Malaysia you will not believe that we are facing economic turmoil. There is an appearance of business as usual everywhere. No one is starving. People are not searching for food in rubbish heaps. The shopping complexes and restaurants are doing good business. There is minimal unemployment.

The reason for our appearance of normalcy is due to our very strong fundamentals from the very beginning. We have been able to manage the currency and share market depreciation fairly well. And now with measures we have taken to control the movement of the ringgit and the share market we are less affected by outside manipulations.

We think we are already seeing the economy turning around. We think we are on the road to recovery.

In business the most important thing is stability and predictability. Business takes time to give a return. The measures taken by the Malaysian Government are calculated to achieve stability all round; political, economic, financial and social stability for now and for the foreseeable future. Since they will do this and are already doing this, they should be welcomed by the business community, whether foreign or local.

The only people who will not benefit from the measures taken by Malaysia are the currency traders. We are now seeing how destructive these people can be. If they lose I don't think we should be sorry. It is their abuse of currency exchange which has caused the present economic turmoil in the world. They deserve to lose.

Mr. Estrada, who is in Singapore for a state visit, said negotiations between Cathay and PAL “are almost over”.

He said United States carrier Northwest Airlines, which also had expressed interest in buying a stake in PAL, had dropped out of the bidding.

But Cathay spokeswoman Quince Chong Wai-yan denied a deal was close to being finalized.

“As of today (Wednesday), no decision has been made,” she said.

“My question is, what is the parameter of ‘close to’? Our position is that we are still reviewing and discussing our best options.”

Ms. Chong said the discussions had not yet reached the board level.

PAL went into receivership last month after defaulting on repayments of debts worth US\$2.1 billion, closing for two weeks from September 23 while it worked out its problems.

Aviation analysts said they questioned Cathay's motives in showing interest in investing in PAL at a time when the Hong Kong carrier was struggling to fill seats after undertaking an ambitious capacity expansion programme in the depressed market.

“How is Cathay going to be able to afford to recapitalize PAL?” one analyst said.

Last week, Philippines Secretary of Finance Edgardo Espiritu [H: Yes, we certainly do know this person!] said PAL needed nine billion pesos (about \$200 million) in new capital to resume normal operations, five billion of which would come from the new investor and the remainder from shareholders. [H: Please note that Mr. Tan and the Philippine government are the ONLY shareholders and Mr. Tan has proven he is not going to invest even one more centavo and the government declines any financial support at all. So, the union and all citizens have been lied to again and again and again in this one tiny fragment of public deceit. Again, I can use Malaysia as an example of the kind of thought-projections brought into open action that has worked best. No thing is perfection, short of God, so don't argue that fact, please. Let us consider what thoughts have been issued and shared and consider the intrinsic value of such societal allowances and integration.

I would recite the Ten Golden Rules for managing a multi-racial society as offered here in this gem of freedom and growth, and certainly I give honor to the authors thereof and to the founding parties who have led wisely to make the pattern come to life and work in a once-torn-asunder nation of contradictions. All nations are but contradictions of cultures, races and beliefs as mankind moves away from God Creator and into the damning ruts toward Evil Empires built on greed, ego gratification, impatience and consideration of one being somehow better than another.

### 10 GOLDEN RULES FOR MANAGING A MULTI-RACIAL SOCIETY

[QUOTING CEO MALAYSIA, *Strategy In Nation-Building*, by Hng Hung Yong, Pelanduk Publications; Appendix, page 71:]

MULTI-RACIAL living is a continuous experiment in tolerance and understanding. Where it succeeds, it is likely to evolve its own consensus of what constitutes behaviour that contributes to the development and enhancement of inter-ethnic harmony. What follows is an attempt to record, in a down-to-Earth style, what many Malaysians believe are best practices for the management of a plural society.

Rule #1: Isolate and de-politicise sensitive issues.

In a multi-racial society, there will always be competition for status, resources and rewards. That's normal and acceptable. But sensitive issues are different. They seek to operate beyond the framework of tolerance and accommodation which governs such competition.

They are deliberately provocative and if allowed to fester, can lead to chaos and violence. So remove them from the arena of public dispute. Isolate and de-politicise them. You may not resolve them this way, but at least you will be able to manage them better in a more controlled environment.

Rule #2: Build a stakeholder society.

A nation belongs to ALL its people, not just some of them. Similarly, all of society must feel they belong to the nation, not just some of it. So avoid favouring some members of society over others, or marginalising one sector for the benefit of another. In a stakeholder society, there must exist a fair distribution of wealth and opportunities. This is the minimum starting point for the building of a just and equitable society.

Rule #3: Reach out and build consensus.

A multi-racial society is a society of competing interests. But a competition need not lead to confrontation. So build consensus and cultivate common ground. Pursue a policy of consultation and accommodation with all groups. Reach out not just to political organisations and business interests, but also to minority groups, civic organisations and marginalised communities. Practise inclusion and avoid exclusion. Everyone counts, and everyone counts equally. Demonstrate your commitment through practical action. Doing is as important as believing. Multi-racial harmony will not just happen. You have to make it happen.

Rule #4: Practise moderation and condemn extremism.

In a multi-racial society, the first duty of a leader is to find the moderate centre, then to strengthen and defend it. This may not be a glamorous job, but it is the most important job. Have no patience with extremists or those who promote divisive causes. Identify and neutralise them. If necessary, use the big stick to limit the damage they can inflict on society. The interests of the community must prevail over that of the individual.

Rule #5: Level up, not level down.

Equity in nation-building does not mean taking away from some to give to others. It means ensuring that new wealth, and the opportunity to build new wealth, are distributed fairly. The first rule of nation-building, therefore, is to create wealth without taking away from anyone. The duty of the government is to create the conditions which will enable it to happen. **WEALTH CREATION IS THE KEY TO MANAGING A MULTI-RACIAL SOCIETY [H: OR ANY SOCIETY].**

Rule #6: Satisfy needs, not wants.

Enough is never enough. No matter how much wealth or opportunity is created or made available, it will never be sufficient to satisfy everyone. Therefore, differentiate between needs and wants. The first you must satisfy. The second you only need to try to. And if your resources are limited, get your priorities right. Help those who need help most.

Rule #7: Prosper thy neighbour.

We do not live in a zero-sum society where one community's gain is another community's

loss. There is enough wealth and opportunity on this planet for everyone. It is up to man's ingenuity to tap it. So helping one community to succeed need not mean putting another community down. When one community prospers, the flow-on effect benefits everyone, even those outside it. Similarly, if one community is in decline, other communities around it will suffer also. In a multi-racial society, it is not possible to maintain vastly different standards of living for different communities. Communities must lift each other up. The alternative is to pull everybody down.

Rule #8: Take charge, do not depend on chance.

Competition for space, status and advantage goes on all the time in a multi-racial society. But if it threatens to go out of control, take charge and act to defuse the situation. Taking charge also involves letting people know where you stand on issues that matter. Disguising or fudging your position when it comes to the crunch is not taking charge. It is taking chances, and that is opportunism. Leaders must lead. That's their job. If they don't or won't, it is time to move on.

Rule #9: Produce results, and showcase them.

Nobody ever said that managing a multi-racial society is easy. It requires exceptional skill and sensitivity. But if you succeed and have something to show for it, it is important that you let others know. Success builds confidence and generates momentum. It can also be infectious. So don't be bashful. Announce your successes to the world. Humbly, but proudly.

Rule #10: Keep at it. Again and again and again...!

Managing a plural society is a continuous experiment. There are no easy answers or ready solutions. Success is never assured. But if you are doing it for all the right reasons, don't give up. Keep at it. Again and again and again! The alternative is not worth contemplating.

HATE HAS NOTHING TO DO WITH IT EXCEPT TO INCITE ONES FURTHER TO RIOT AND CONFRONTATION. MURDER, FOR INSTANCE, IS UNLAWFUL—NO MATTER WHAT THE UNREASON. EVERY NEW LAW YOU MAKE IN SUCH STUPID INTENT—**

**ONLY MORE DEEPLY ENSLAVES YOU, BOTH IN MIND AND SOUL—NOT TO EVEN MENTION PHYSICAL STATUS.**

### **HEDGE FUNDS AND BAILOUTS**

Dr. Mahathir was asked yesterday, in Japan, about the bailout of Long Term Capital Management (LTCM). He said it was the “worst form of cronyism” ever witnessed.

Background: The Greenwich-based hedge fund was headed by John Meriwether, a Wall Street star of long-standing. His team included two Nobel prize winning economists and a former vice-chairman of the Federal Reserve. **[H: BEWARE, ALREADY!]** In addition, a number of leading Wall Street executives had personal investments in the hedge fund.

Goldman Sachs, Merrill Lynch, UBS and J.P. Morgan acted in their own self-interest when they joined a consortium of financial institutions and investment banks, facilitated by the New York Federal Reserve, to put up US\$300 million EACH to bail out LTCM. Germany’s Deutsche Bank AG also joined in.

**[H: What can you glean from just this little bit of information? Well, there are magical numbers here if you add up the input and consider the necessity of a bailout of any kind. Wow, you move right into the magic numbers of unlawful Superfund trashing, don’t you? Moreover, they now tell you from whence came the problem and of the bad investments (unlawful empty paper)—Deutsche Bank! Next they give away the intent—NOT TO BE CAUGHT IN THEIR DIRTY CRIMINAL ACTIVITIES—AND, TO DRAIN LIQUIDITY OUT OF THE NON-LIQUID PAPER ASSETS. SIMPLE? INDEED!**

### **TRADE IN FINANCIAL CURRENCIES: A Case For Regulation**

Following the end of the Pacific War, we have witnessed commendable development and increasing economic prosperity amongst most of the newly-independent countries. By the late 1980s and early 1990s, most of the countries of East Asia, Africa and Latin America had achieved tangible development with or without

help from the developed countries and international agencies. The Southeast Asian countries had progressed so much that they were dubbed “economic tigers and dragons”, and were held up as examples of how developing countries could govern themselves well and manage economic growth with great skill.

In fact, they contributed to the wealth of the developed countries and that of the world. Their continued growth promised to make the world community prosperous and contribute towards the eradication of poverty worldwide and to the banishment of hunger and other scourges which plagued the world.

Yet in July this year (1997), these prosperous countries were thrown into an unprecedented and rapid economic regression. Their currencies devalued rapidly and continuously. Their stock markets collapsed with unwelcome consequences. Thriving and profitable companies became insolvent and tycoons as well as small-time investors became bankrupt. Construction projects were halted and completed offices and houses found no occupants or buyers, causing developers to lose money and compounding their debts. Banks foreclosed companies unable to come up with margin payments and sold off collaterals at give-away prices, further depressing the stock and property markets.

**[H: You who participated with us through the Tuten-Yount saga and gold “calls”, etc., need a bit of a lesson right here. Green’s original idea was workable in its concept—but any time you work on “margins” you run the risk of “calls”. So, E.J. built in that possibility with a fund set aside by Yount to cover such a “call”. Tuten refused to meet “her” call and then convinced Yount to “not meet hers”—and to strip the fund for that purpose. So, nobody ended up meeting the call—and “bye-bye blackbird”. Tuten suing the Institute is about as equally silly as the other things that idiot bunch bring to bear. You interested parties should have sued the daylights out of that person and her guides and handlers, Green, et al. But, you didn’t, and confound it, you still don’t DO anything which certainly does annoy me from time to time. Talking a thing to death NEVER WORKS.**

Then again it happened—that “call” from the gold money-gods—and that time Tuten had joined with the receivership crowd with her suit, which disallowed the Institute to “do business”. But, ladies and gentlemen, even with the demons at the door—E.J. and Doris have not gone off to Mexico—only to MALAYSIA. We will go to the mat before we allow the thieves and criminals in our own little corner of this world get off clear and free with their thefts, legal gleanings, and other criminal actions. There is no excuse under “ignorance”, for the guides and handlers knew and know exactly what they were doing. Tuten? Greed gets in the way of intelligent actions. Fort? Leon simply refuses to even look at even the paperwork which involves him directly and personally so, can you imagine a better legal CLIENT for a totally unethical old attorney-politician claiming to retire on the case? For goodness sakes, friends, God will not just do it for you—you have to do SOMETHING.]

Huge loans raised from foreign banks could

not be repaid and pressure was applied on the governments to devalue and float their currencies. And when they did, the currencies rapidly depreciated against the U.S. dollar and the currencies of the developed countries.

The devaluation impoverished the country and the people, in particular the business community. They found themselves almost totally unable to pay foreign debts as they needed more of their own currencies in order to make up for the loss of value. And all the time the currencies in the countries of Southeast Asia kept depreciating at a rapid rate, making adjustments quite impossible.

The governments of the Southeast Asian countries—which until then had been praised for performing economic miracles, for their skills in administration, for their liberal investment policies and the incentives they had invented—these governments were roundly blamed for the depreciation in the exchange value of their currencies.

They were told that they had caused a loss of investor confidence because they had engineered unsustainable levels of growth, they had external payments deficits, and had allowed their banks to be overexposed to the property sector. They were told their policies were just bad and their institutions were weak.

Despite their record of growth, their success in reducing poverty, their investments in infrastructure and in capital goods for growth in productivity, they were told that their spending was excessive and lacking in prudence and was weakening their economy. All these things, it seemed, were eroding investor confidence and therefore the investors pulled out. As a result, the currencies of these countries depreciated and their stock markets plunged.

We admit that we have been guilty of some of these things, but not all. A few countries did have one or two of these problems but these could be remedied. Malaysia’s only identifiable weakness was a deficit in its balance of payments, which reached a peak in 1995. By 1996 it had been almost halved. And in the early months of 1997, the deficit had decreased further. Some of Malaysia’s infrastructure and development projects were big, but past experience had shown that they were manageable. But the so-called investors insisted that they could not maintain confidence in Malaysia.

They pointed out that the Thai currency which had devalued would make Thailand more competitive than Malaysia and this would erode Malaysia’s trade. So would the competitiveness of Indonesia and the Philippines. **[H: Clever little manipulators, aren’t these New World Order bankster liars?]** Never mind that the economies of these countries are not exactly duplicates of each other; never mind that the markets for their products are growing. It was suggested that Malaysian, Indonesian and Philippine factories would close down because the Thais would render them uncompetitive and redundant. It was implied that this would happen overnight, unless the other Asean countries also devalued. Since they would not devalue voluntarily, then the so-called investors would dump their currency holdings in order to avoid a loss when devaluation occurs.

Lo and behold. The moment the currency traders sold off the currencies of these countries, the currencies depreciated. It would seem that

by pulling out quickly the currency traders had saved themselves some losses.

But is this really true? Were the currencies about to depreciate on their own or did they depreciate because the currency traders dumped huge amounts of these currencies? **[H: And please note that throughout the whole slaughter—the International Monetary Fund continued to pay off the traitors.]**

Since currency trading is not open, not transparent, but very secretive, it is difficult to ascertain how much of the so-called exotic currencies were held by the traders. Yet there seems to be an inexhaustible supply of offshore money, running into billions and billions, in the hands of the currency traders, for them to sell in the market.

Actually, of course, this offshore currency did not exist. Currency trading as devised by the currency traders is such that they can borrow offshore money and sell, in most cases, to each other. **[H: You know, friends, like George Green claiming to have sold the Overton gold to himself! Boy, did George-boy ever plan to make a bundle off us in this criminal way.]** And every time they sell, the currency devalues by a number of points. By repeatedly selling a currency, its value can be depressed almost indefinitely. And when the currency has been depressed it can be bought back at the lower price and delivered to the buyers. No real money was moved, except probably at the final stage, if ever the currency stops being sold.

The only way the currency can recover is when someone purchases the currency by selling U.S. dollars. **[H: And wow, the U.S. dollar has nothing backing it AT ALL! IS THIS NASTY OR WHAT?]** Central banks with dollar reserves can do this but their funds are limited and they deal in cash. Against the limited funds of the central banks, the currency traders can leverage their funds by more than twenty times. It is estimated that between them the currency traders have funds amounting to some US\$180 billion. Twenty times this would be US\$3.6 trillion. No central bank, no developing country, can match this. And the currency traders work in concert.

*Clearly the devaluation of currencies can be easily manipulated by the traders. They never did invest or hold the currencies which they asserted would depreciate. They never ran any risk of losing money. All they did was to borrow the currency from banks, sell and resell it repeatedly and took their profits from the difference in the initial high price that they sold and the lower price money that they delivered. It is a classic case of short selling, only this time the movements were caused DELIBERATELY by them and not by anything that the governments did or any weakness of the fundamentals.*

*And since the movements were caused by them, there really was no real risk when compared to ordinary speculative activity. They have discovered, or rather invented, a sure-fire way of making billions in a few short days through selling and buying currencies and they can use this against any country they choose. As a bonus, they also depress the stock markets through their attack on currencies.*

The reaction of central banks to such attacks is to raise interest rates. A rise in interest rates stifles the trading in shares. The share prices go down and, through short selling the currency,

traders make more money. Sometimes they have been able to lend out the money they had earlier borrowed, but at a higher rate to take advantage of central banks' interest rate increases. More money was made.

It is the operations of the currency traders which has caused the devaluation of the currencies of the countries of Southeast Asia. There may be some fundamental weaknesses in their economies, but these have had only a minimal effect on the value of their currencies. Without the currency traders, the currencies may have devalued slightly but may regain their values later. Indeed, the currencies of many countries of Southeast Asia, including Malaysia, had in the past revalued upwards against the U.S. dollar when the United States was not performing well economically. But such currency movements were never extreme. The operations of the currency traders, on the other hand, have caused a devaluation of between 30 and 50 per cent of the currencies of Southeast Asian nations.

It is clear that with the huge resources at their disposal, the currency traders can attack any country, no matter how strong their economy may be. There is no shortage of reasons for subverting the economy of any country. The currency traders publish and circulate analyses of the financial futures of every country. Through constant releases of unfavourable news and rumours about the markets, they have been able to create grounds for devaluation. In the absence of information to prove otherwise, their prophecy becomes self-fulfilling. From then on, the so-called herd instinct amongst them takes over.

[INTERRUPT QUOTING]

I ask to interrupt this writing at this point because I want to make some statements along about here in the presentation. I also will want to make a lot of comments at the end of this particular topic so it is better to simply interrupt rather than overload.

In dealing with such a nation as Malaysia, we have to consider many things that have taken place. It, for one, is necessary to destroy the very foundation of Malaysia lest the invaders end up destroyed. It was mandatory to get close to and within leadership at very high levels to allow the invasion to take hold and work for the Bastards of Hell—at any cost to participants, whoever they might be.

Let us consider how Anwar Ibrahim, the man in focus of the IMF and world media, in downthrust to the world, and that GOOD FRIEND OF CLINTON AND GORE, FITS INTO THIS PICTURE.

Satanic leadership always knows the weaknesses and fallacies of such as Clinton and Anwar. It is said that among Anwar's closest friends were Albright, Cohen and amazingly high ranking officials of the International Monetary Fund and the Federal Reserve. He was, for goodness sakes, jointly writing a book WITH IMF Managing Director Michel Camdessus. Perhaps, after all, you are known by the company you keep and the sins of one rubs off onto the heads of the others.

More than this, there had been established, for Anwar's use, covering corporations, etc., in Labuan and elsewhere, so that Anwar could take massive amounts of pay-off money for "cooperation" and then "takeover" of the Malaysian government.

But this should be determined, the extent of involvement, by a COURT OF LAW. I would suggest that if Mr. Anwar had any sense at all he would turn "evidence" and let the world really KNOW who and what corrupted him and made available the tools and advantages. But he would be killed, wouldn't he? Isn't that the way the World Controllers work—JUST MURDER THE HONEST? But can a person simply walk away from their dirty deeds and criminal activities? They should not—but in this modern world they DO.

Now, perhaps you understand better what I AM DOING HERE! I intend to do all that will be accepted to give help and support to the brave and daring honorable leaders left dangling over the pit of vipers. Who you may believe me to be—makes not one iota of difference to me—I AM EXACTLY WHO I SAY I AM AND I SHALL NOT TURN AWAY JUST BECAUSE IT IS DIFFICULT FOR MEN TO UNDERSTAND MY PRESENCE. SO BE IT.

Now to return to Dr. Mahathir's speech of December 1, 1997:

[CONTINUE QUOTING]

A favourite gambit is contagion. Thus, because of the devaluation of their currencies, the Southeast Asian countries were said to have become more competitive than Hong Kong, Taiwan and South Korea. To regain competitiveness, the currencies of these countries must in turn fall in value. The traders then proceed to declare that they have lost confidence in these countries, and loudly reveal their desire to pull out and sell their investments in their currencies.

Through the same process of borrowing and selling these currencies repeatedly, they were able to say that their prediction was correct. The currencies have indeed devalued and their stock markets have nosedived as well.

Another gambit was to say that since the countries whose currencies have been devalued have now become poorer, their capacity to buy goods from their trading partners has also been reduced. These trading partners must now face a recession and their currencies, too, could be devalued. And indeed, countries like Australia face the prospect of losing its big markets in the Far East. And so the Australian currency was devalued, although not by very much.

What is the effect of devaluation? Basically, it reduces the purchasing power of imports [power to purchase imports]. And since all countries have to import goods, foods and services, they will not be able to sustain the standards of living they had reached. In other

words, they would become poorer.

For Malaysia, a 40-percent devaluation of the Malaysian ringgit is tantamount to a reduction of per capita income from US\$5,000 to US\$3,000. In GDP terms, this amounts to approximately US\$40 billion yearly. At the same time, more than US\$100 billion was wiped out from our stock market which had tumbled by almost 60 per cent. Altogether we have lost about US\$140 billion.

The other countries of Southeast and Northeast Asia between them must have lost more than US\$500 billion in terms of their purchasing power of imports.

How much have the currency traders made from their impoverishment of these countries? Quite a lot, but still only a fraction of the total loss suffered by the countries attacked. We see some of them posting good profits, but on the whole, the wealth transferred to them falls far short of the wealth lost by the countries they attacked. There is, therefore, a huge net loss of wealth not only for these countries but actually for the world, given that the rest of the world has lost a good size of its market.

***We accept the need to exchange money. We cannot trade otherwise. But currency trading which we have seen destroying the economies of many developing countries has really no direct connection with trading in goods and services. Currency trading treats money as a commodity. But money is nothing more than tokens with no intrinsic value. Money is not like rubber, tin, copper or gold. The value that money has is what we agree to give it. Its value can, therefore, be depreciated or appreciated at will. The unfortunate thing is that, when it is devalued, people and countries suddenly become poor, sometimes very poor, through really no fault of their own. They really do not deserve the misfortune inflicted upon them by those who fiddle with currency values.***

Would trade in goods and services contribute tangibly to economic development and well-being of people? They create jobs, business, industries, freight, insurance, the building of roads, railways, ports and airports and a lot of other amenities which benefit mankind.

Currency trading is said to be twenty times bigger in money terms than world trade in goods and services. Yet what benefits do we derive from it? Apart from a few people making huge sums of money, and losing it sometimes, it has created no increase in employment, no growth in business or in the wealth of nations and people. On the other hand, it has obviously impoverished millions and millions of people. It has impoverished countries and regions. It has wiped out decades of hard work, of sweat, toil and tears.

But the worst is yet to come. An *Associated Press* report pointed out that, "Turmoil in Asian economies and weakness in Japan ... have led to volatile stock swings on global financial markets.... Investors fear the Asian troubles will hurt North American and European companies that export into the region."

In the face of these currency troubles, and a deterioration of the ability to repay loans, what has the IMF to offer? It offers to lend money with which to repay loans to foreign lenders. But the loans come with a string of conditions attached, principal among which is the opening of the domestic financial sector to full foreign

participation. It is likely that this will result in foreign banks eventually dominating the finances of the country concerned.

For this reason South Korea hesitated. Seoul, according to the same AP report, "sees that route—with its accompanying economic control—as a last resort, one that would reduce a proud country to a beggar surrendering its sovereignty." That hesitation caused the Korean won to depreciate by another 10 per cent.

There is no conspiracy to dominate the economy of the developing countries of East Asia [H:???] but obviously their troubles have afforded an opportunity to force open their economies and lead to possible domination by strong and powerful nations.

The assaults by the currency traders against the emerging economies of the South have done nothing good for these target countries. Much has been made about the eventual recovery of these countries, but even if they do recover, they would have lost a lot of their wealth and the fruits of their struggle. In addition, they may have lost their economic sovereignty as well.

Surely no one can argue that the right of the currency traders to make huge profits override the well-being and the wealth of millions of people and of countries and regions. True, the countries themselves may be at fault, but without the manipulation of the currency traders, they would not be in such dire straits.

If currency trading is to be allowed, then it should be made transparent and it should be regulated. It is ridiculous that at a time when governments and all other business are being exhorted to be open and transparent, currency traders must be allowed to do their trading in almost absolute secrecy. We don't know who they are, how much capital they have, how much they have borrowed, what currency they hold, whom they sell to and whom they buy from? What and to whom do they pay taxes on the profits they make from their target countries? Certainly these countries collect no taxes from them.

While trade in stocks and shares and in commodities is carried out in the open and in properly designated markets, there is no proper market for currency trading, no membership, no rules and no government regulations to stop abuses. Who decided that the traders can leverage up to twenty times or more of the funds they deposit with their bankers? Who are these bankers who can make available trillions of dollars to their clients? What are the capital resources of these banks? Who invested in them and how much? How can these banks become richer than most countries of the world?

We believe in globalization and the liberalization of trade, in dismantling national laws and rules which hamper trade and cross-border flows of capital. But surely liberalization and deregulation of national entities should not result in exposure to an anarchic world. Haven't we been told to abide by the rule of law? How come the abolition of national laws should lead to absence of the rule of law in the enlarged world market?

If globalisation and open markets are to contribute to growth and enrichment, there must be the rule of international law for everyone to respect. Without laws, the strong and the corrupt will rule and dominate. Is this what is being advocated?

International trade is being regulated by

principles, policies and regulation agreed to in the World Trade Organisation (WTO). Why should currency trading be exempted from the purview of the WTO? Why can't the WTO discuss and formulate rules and regulations for international currency trading, rules which the rich and poor alike have a hand in drawing up, rules which are fair and just and designed to create wealth and prosperity for all? Since currency trading is twenty times bigger than world trade, is it logical to control the world trade in goods and services which make up only 5 per cent of world trade and leave unregulated a trade that is twenty times bigger and beyond the purview of those who are responsible for achieving fairness in world trade?

The IMF should continue to supervise, but if currency trading is trade, then the WTO must be the one to formulate the regulations. Why is regulation considered objectionable for currency trade when it is good for trade in goods and services? Is there something sacred about currency trading, or is there something about it that does not bear public examination? In a world which believes in the right to know, a world which pries and probes into the private lives of very private people, are we not allowed to know of the people and activities of currency traders whose decisions can inflict all kinds of misery on millions of people and a large number of countries?

It is normal for people who make money from what they do to pay taxes to the governments of the people they make money from. The money these currency traders make is from trading in the currencies of many countries. As far as is known, these countries receive no payment of taxes. Is it fair for the countries of their domicile alone to collect the taxes? Certain countries impose taxes on profits made in other countries. Do the countries which provide the currencies for the traders to make money from have no right to impose taxes on them?

Looked at from any angle, currency trading demands to be regulated in the interest of everyone. Every country would be affected adversely by their activities, even the developed countries, even the countries of their domicile. They have left a trail of shattered and disoriented economies wherever they have been. These nations and others not yet visited by them live in fear of their attacks. And for so long as they are not regulated, for so long as they can have trillions of dollars at their disposal, their capacity to attack and to damage economies will remain, and they will strike fear in the hearts not just of governments and finance ministers, but of businessmen and people, rich and poor alike.

On the eve of his departure to address the World Economic Forum's East Asia summit, a private conference in Singapore, Philippine President Joseph "Erap" Estrada borrowed a line from his predecessor Fidel Ramos. Estrada said in a radio interview he was traveling to Singapore "not to have a good time but to work". Yet the four-day trip afforded plenty of good times for Estrada and some 2,000 Filipinos who had gathered in the Lion City to greet the one-time movie idol. 
