CONTACT Staff Locked-Out Under Cloak Of Darkness How About Those Glaring Clues?!

3/25/99 CONTACT STAFF

Last evening, March 24th, at approximately 8:30 P.M., the locks on all of the *CONTACT* offices were abruptly being changed by a local locksmith.

When directly confronted with the question as to what “authority” has instructed the locksmith to make such a blatantly obtrusive move, a letter was produced by New Gaia Products’ Diane Kunick (Doris Ekker’s daughter) which was signed by E.J. Ekker and by Doris Ekker. The letter, which follows [*see inset*], is written on Phoenix Institute for Research & Education, Ltd. letterhead, authorizing action on behalf of three Nevada corporations: Continental Development (It is

interesting to note that this is NOT the actual name, readers; the true name is Continental Developers—a deliberate effort at deception or an example of further mental melt-down?); *CONTACT*, and Phoenix Source Distributors. Jack and Diane Kunick were therein “authorized” by E.J. Ekker, as President of the Phoenix Institute, to take measures to secure “the property and equipment of the above named corporations”. To the best of our knowledge, they were not appointed as corporate representatives through resolution by the corporate board, but rather, they were just, so to speak, “deputized”.

You will recall us mentioning, in the March 15th edition of *CONTACT* (page 29), wherein in Hatonn’s own words is the statement (through Doris; dated 2/23/94): “The Ekkers have no business interest at all in the *CONTACT* or, for that matter, the publishers of the journals (Phoenix Source Distributors).” Now, readers, the Ekkers testified to this fact in U.S. District Court (Federal). They were either lying then (perjury?) or they are lying now. Which is it? Or, as Dr. Young put it on the Front Page of the same 3/15/99 issue of *CONTACT*: “It is downright stupid, if not preposterous, and maybe even tragic, that E.J. Ekker should attempt such a desperate threat [*referring to terminating Dr. Young as Editor-In-Chief*], through the avenue of Global Alliance Investment Association—especially since it wasn’t that long ago, during the last wave of the University of Science & Philosophy law cases, when Commander Hatonn went to great lengths to assert, over and over again for their own safety from prison, that Doris and E.J. Ekker had nothing to do with the operations of the *CONTACT* business entity, and were associated with *CONTACT* only in the capacity of

contributing journalists.”

Why would the Ekkers start “flexing their muscles” in such a rude manner as to change the locks on legitimate offices at night, after business hours, wherein the *CONTACT* is produced weekly? Could it be that there is an effort to stop THE TRUTH from reaching you, the reading audience? (Perhaps the last two editions were speaking just a little too close to home?)

Two significant collateral items should be noted concerning this “Memorandum” from the Ekkers. First, for all of you who have invested in the Phoenix Institute and may be justifiably concerned about the financial solvency of the Institute, the Memorandum clearly states that E.J. Ekker is the President and thus the person to whom you should direct your concerns, as the Institute’s responsible head. Secondly, according to a phone conversation with Nora Boyles (of “Nora’s Research Corner” popularity) as we go to press, no one has bothered to inform either her (or Vice President Paul Lienthal) that Doris Ekker—and not Nora Boyles—is the Secretary of the Phoenix Institute! This, of course, causes even more concern about the Ekkers executing valid business practices.

Perhaps we need to only look back one week for some insight and foresight about “directions” as supplied in the 3/14/99 writing from Hatonn (not through Doris Ekker) which states, near the end: “Dr. Young: You are hereby given complete authority over the *CONTACT* newspaper. I trust you will continue to use discernment as to the content and the viability of that entity. If one takes over the *CONTACT* Corporation, then I ask you simply to start up another newspaper and continue as usual. You will have the necessary resources (people and funding) in order to do this, if it should come to such countering of that level of reactionary, “I’ll show you!” ego-tantrum spite.” I guess we got our answer on that one! It would certainly seem that a new newspaper now becomes a practical necessity.

But wait—there’s more, getting back to the lock-out saga. The next morning, several *CONTACT* staffers went by the *CONTACT* offices to attempt to secure personal belongings, as suggested in E.J. Ekker’s letter—only to be met with a highly agitated Bruce Tracey (with, literally, a “crazed” look in his eyes and puffy-faced countenance), rapidly snapping-off flash photographs of those “intruders” present. The entire scenario would have been funny, if it were not so pathetic.

There seems to be the mistaken impression by some that there is a call for taking sides. Well, if anything, we ARE calling for an examination of certain facts, events, and influences. If this serves as a catalyst for a Larger Sorting, then so be it!

Because of what has just occurred, we are taking an extra measure of effort to get this Special Edition of *CONTACT* into your hands, so that you may have the necessary facts with which to discern Truth for yourselves. This is what *CONTACT* has always been about!

Continuing the saga, the corporate record book (with stock ledger, corporate seal, etc.) for *CONTACT* was REMOVED from its longtime, secure, “fire-proof” location (by a person or persons unknown) within the last few days. None of the *CONTACT*-related staff (including Mr. Martin, Vice-President of the corporation), has access to those records. Why all the clandestine activity concerning corporate business records (and positions of legal authority) if Mr. Ekker may truly issue such edicts?

In the meantime, writings received from the Philippines, allegedly from “Hatonn” through Doris Ekker, from 3/21-23/99, paint a picture of the questionable nature of the source of her “receptions”, especially recently.

[QUOTING, March 21, 1999:] Dr. Ed had already usurped the paper to push his next “Ray Book”, which we will call the Toy Ray Gun (Toy) and, actually, if you take notice—HIS FIRST ONE. He is caught between the Devil and Lucifer because if he “gives in to reason” he has a DISCOUNTED BOOK AS TO SPIRITUAL TRUTH—WHICH IS EXACTLY WHAT HE HAS FOR OFFERING. Who gets caught WITH HIM is his problem and theirs—not yours or mine. [END QUOTING.]

Contrast the tone and wisdom of the above words with those from a 1/21/98 Hatonn writing (again through Doris, which was most recently offered on page 42 of the 3/15/99 Special Edition of *CONTACT*) wherein Hatonn cannot speak highly enough about the *WISDOM OF THE RAYS* collection of spiritual writings produced through the very same receivers! Why the radical contrast and actual flip-flop? Hasn’t Hatonn always instructed the readers to READ EVERYTHING? Why the sudden investment in bashing this most important and appreciated spiritual work?

The “clues” are everywhere, dear readers, and you don’t have to be Sherlock Holmes to see them.

Let us continue our examination of recent writings.

[QUOTING, same writing:] Dr. Ed’s great Astral-Etheric presence along with Tricky Ricky’s, aided and abetted by Charles, refused to run the writings, including the one not yet even in their hands on handling of public (and private) negotiations and treaty agreements with the institutions above named—in conjunction with the “players” otherwise involved. [END QUOTING.]

Excuse us. Did we miss something here? Refused to run writing not yet even in their hands? Huh?

How about those references to Astral Ed (later referred to as Eddy Astral) and Tricky Ricky? Does that sound like the commentary of a Lighted Host of God TO YOU?

Turning now to the 3/22/99 writing from this “Hatonn” through Doris, we read the following so-called “wisdom”. [QUOTING:]

So far so good? No, for on the return to the U.S. and “home” Rick Martin pushed through, still on lies and deceit, a TAKING OVER of the paper, *CONTACT*. This was the paper which was birthed and written and “owned” by “Hatonn”—or, if on a human level—human parties. Already the paper Editor, in his new and great status as an Astral-Etheric Energy WITH GOD, and not just a mere mortal receiver such as Dharma—HAD REFUSED AND CONTINUES TO REFUSE TO ALLOW ANY DIRECT WORD FROM THE OWNERS OF THE PAPER, THE PUBLISHERS OF THE PAPER—AND DID IN FACT DISALLOW ALL INPUT TO SUBSCRIBERS. [END QUOTING.]

Again: excuse me?!?

Did not Hatonn, in his very own words (from 2/23/94, mentioned earlier in this article), say: “The Ekkers have no business interest at all in the *CONTACT* or, for that matter, the publishers of the journals.” We repeat, again: either the Ekkers were lying then, or they are lying now. Which is it?

Here is another portion of a 3/23/99 so-called “Hatonn” writing through Doris. [QUOTING:]

Now, when you consider use of the term

“dharma” as a “handle” or identification of my transcriber—it is exactly THAT: an identification. We have always preferred the use of the label in SMALL TYPE to simply identify for recognition. Editors always choose to CAPITALIZE the word as we use it as “transcriber”, simply because it acts as a “name”. ALL RECEIVERS, TRANSCRIBERS, TRANSMITTERS AND SPEAKERS MUST HAVE IDENTIFICATION OR THERE IS NO ABILITY TO DISCERN FACT FROM FICTION. The message is of the utmost importance but WHO brings the message is the focus in every instance in your recognition of this world BEFORE CHANGE.

The “identification” word (name) need not be up front but in some manner of reference within the text. I have chosen to ask that it be put right up top, henceforth.

I asked long ago that this identification be made for all writings presented through any connection with Dr. Ed Young, only to be denounced and ignored. If you don’t think, readers, that this is important—you are grossly in error. And, further, Dr. Young’s assurance that he is equal to those Etheric Beings doing the speaking [*he’s never said any such thing, but this is yet another typical example of absurd twisting and distorting of what has been written or spoken*] and can sort and discern all messages is total hogwash. Why would a worthy receiver who acts in integrity hesitate even a moment to identify? All can do so without ever using their given human names.

In the written word there is no real ability to discern energy—ONLY STYLE OF PRESENTATION, so all the blathering in self-identification up front, or at the rear, or both, from a discarnate energy MEANS ABSOLUTELY NOTHING. Neither, for instance, does it mean anything for the transcriber to go through the silly antics. The reader, however, had best get alert and alive or you will be dumped on, as recently underway—by the self-styled ego-trippers. [END QUOTING.]

There are several most important things to note, here, readers. First, this entity(s) is absolutely FIXATED on identifying just WHO is the human receiver for various spiritual writings appearing in recent issues of *CONTACT*. It goes without saying that the actual Hatonn knows FULL WELL who received these writings—but this questionable “Hatonn” entity(s) is gunning for the actual NAMES. Meanwhile, in writings from Hatonn through this same Doris Ekker, it has long been stated, with much emphasis, that the receivers have always been of little to no consequence; the instruction has always (until lately!) been to NOT FOCUS ON THE RECEIVER, BUT UPON THE MESSAGE! In fact, at one point, Hatonn requested that THE RECEIVERS NOT BE IDENTIFIED. Again, which is it?

A second worrisome point, which stands out clearly, is that there has been, in recent weeks, a STRONG resistance on the part of Doris’s “Hatonn” concerning the matters of clearing of dark entities from personal space, and requiring clear identification of the speaker. IF NOTHING ELSE, THIS POSTURE SHOULD SERVE AS A SIGNIFICANT CLUE TO ALL THAT THE BELOVED HATONN THAT WE HAVE COME TO KNOW SO WELL IS NOT WHO IS SPEAKING FROM MANILA!

However, let us clarify another important point here. We at *CONTACT* deeply appreciate and acknowledge the longstanding devotion and hard

work of Doris and E.J. Ekker to the bringing of Lighted Truth to the world. Our recent disclosing of information concerning a gradual adversarial overshadowment condition does not in any way negate all their past work. FURTHER, WE STILL ASK ALL READERS TO SEND DORIS AND E.J. PRAYERS AND LIGHT!

Let's take a moment now to examine a few comments typical of the sentiments frequently being communicated to us from our reading public (at least until yesterday's lock-out). Here is one of the first letters we received from a long-time reader, C. N., in Florida. [QUOTING:]

This is a short note to express my support in and during such a trying time. I called Rick Martin this morning to express my support for him and you [E.Y.] in the ever ongoing struggle against the dark forces. Recent events pointedly demonstrate that evil is ever at the door, wearing a mask of salvation, wrapped in a cloak of prosperity, bearing promises of worldly treasures. I think regular readers have been aware of ostensible problems spilling over into the paper. I thought that the travels were causing stress to personalities and writing. Looking back, I recall quite a period of garbled and meaningless messages. Possibly we should look at this as God's demonstration of evil's constant attack against the ones bringing forth truth. Could the Gold Certificate have been the ultimate test by God of Light? What greater test than boundless gold? Now that the masks are off, we can reaffirm our direction and purpose, to bring forth truth and fulfill the instructions from God of Light, as given by the Lighted Masters. Please accept my sincere thanks and appreciation for the tremendous job you have done and continue to do at CONTACT. My love, blessings, and respect are with you and the staff of CONTACT. A job well done. Bravo! [END QUOTING.]

A woman subscriber from Washington State, M. B., faxed the following letter to our offices on 3/24/99; it reads as follows. [QUOTING:]

Dear Ed (my brother),

I wish to say how proud I am of you; to stand up and say what needed to be said was courageous!

I know in my heart that E.J. and Doris are being manipulated and it breaks "ALL" of our hearts, that's why this situation is so important. What a feather in our adversary's hat, so he thinks. We've had years of schooling on discernment and there were so many red flags; it just shows us that staying real close to God and all the teachings is SO extremely important!

Brother, I know you must feel bad for E.J. and Doris, but I look at it this way: this is an illusion with a lot on the line—"Man's Soul"—and that's my focus. I think this was a bigtime test that no one should be excused on accountability. Evil wears a clue—which we've been taught over and over again. We're at the University level, ready to graduate; this was a BIG test for all of us.

What I hope and pray is that this will make us spiritually stronger, closer as the family that we are, and more determined on the mission that we are on. And to get as many souls home as we can. WE stand for TRUTH, and we work for the Brotherhood of Light as their hands and feet in service, and nothing is more important than that.

These are extremely important times. The

adversary knows his days are numbered, so he is going to push as hard as he can. You're sitting in an important position; watch your back. I really believe Doris and E.J. would be proud of you, too, because that's what their desire was, also; so let their ideals and goals not perish, but bring us closer for the Bigger Picture.

Miracles are happening left and right. Look at Richard Hoagland when Art Bell asked everyone to pray for him. He's back with us, proving that even a hit like he got isn't going to work any more. And that, my friend, [is] an example of truth, which comes in a big way as a beautiful newspaper called CONTACT. I salute you!!!! We're with you, STANDING UP ON THE MARCH! Bless you.

And last, but certainly not least, here are some thought provoking comments from a well-known researcher and frequent CONTACT contributor, Calvin Burgin. [QUOTING.]

I had noticed for some time that the atmosphere at CONTACT was changing. My first thought on possibilities was to wonder if perhaps Hatonn had decided to drop the American operation and start up a foreign operation. I also began to wonder if Dharma was getting off track. Could that happen? Could Billy Meier get off track? Could Tuella, Tuieta, and many more names I could name get off track? The answer was, of course, that it COULD happen; but was it happening with Dharma? Or was I the one getting off track?

When I and two friends of mine offered to help

in any way we could with trying to obtain resolution on the Overton gold (Overton, remember, was MY PERSONAL FRIEND and customer), Hatonn's astonishing reaction was the trigger that made me realize that something major was wrong....

It became obvious to me that Hatonn had become controlling and very negative. It was also obvious that we all have a problem looking to gurus to solve our problems and telling us what to do, which puts burdens on them that they cannot handle.... [END QUOTING.]

It had been hoped by we at CONTACT that there had been enough dialog shared with you readers concerning this particular subject. However, with the surprise of the recent lock-out event at the CONTACT offices, it has become necessary to take things one step further to keep you abreast of the changes now in the wind.

In a book which was "required reading" for many early Phoenix Project participants, titled DARK ROBES, DARK BROTHERS, written by Master Hilarion through Maurice B. Cooke back in 1981, we read. [QUOTING:]

We have dealt with the groups and movements which are intended to trap the unwary seeker. Most of these things are abetted and encouraged by the energies of the Dark Brotherhood—which is not to say that the leaders or main instigators are themselves mere puppets of the dark ones. In some cases this is true, but in the majority of such movements, the Dark Brotherhood merely spurs on the innate negativity of the leader, prompting him (or her) to seek wealth through the



movement, or control over others, or fame.

[QUOTING:]

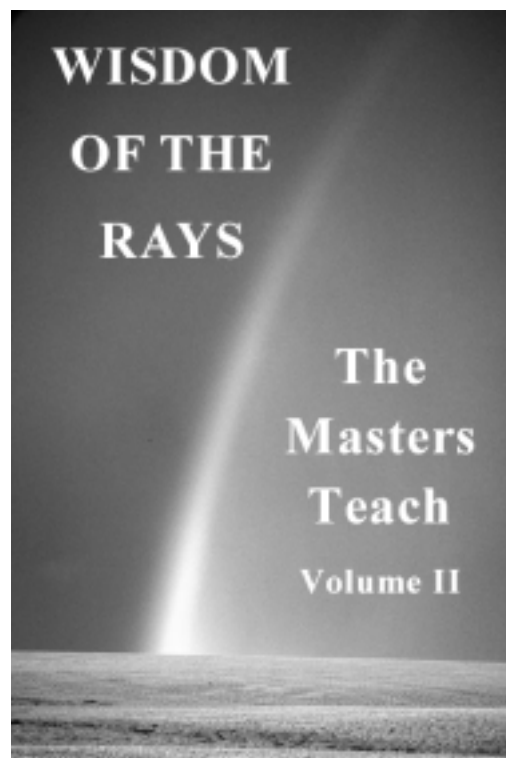
