AID. The number of Americans involved was small enough that a relatively high degree of secrecy could be maintained. In contrast to the tens of thousands of Laotians who died in the war, few Americans were killed, and those who were casualties were not CIA career officers but rather mercenaries, contract officers, and personnel of the agency's air proprietaries. The agency considered Laos to be a very successful operation. And Colby received much of the credit for keeping things under control.

The agency's clandestine activities in Vietnam were not so well organized, concealed, or successful as its Laotian operation. In the mid-1960's the CIA was swept along with the rest of the U.S. government into launching huge programs designed to support the war effort. The agency would have preferred to run relatively small, highly secret operations (or to have had complete control of covert action), but the stiffer and stiffer demands of the Johnson Administration made this impossible. Thus, if the President wanted a larger contribution from the CIA, the CIA would contribute. In 1965 Colby, still stationed in Washington, oversaw the founding in Vietnam of the agency's Counter Terror (CT) program. In 1966 the agency became wary of adverse publicity surrounding the use of the word "terror" and changed the name of the CT teams to the Provincial Reconnaissance Units (PRUs). Wayne Cooper, a former Foreign Service officer who spent almost eighteen months as an advisor to South Vietnamese internal-security programs, described the operation: "It was a unilateral American program, never recognized by the South Vietnamese government. CIA representatives recruited, organized, supplied, and directly paid CT teams, whose function was to use Viet Cong techniques of terror--assassination, abuses, kidnappings and intimidation-against the Viet Cong leadership". Colby also supervised the establishment of a network of Provincial Interrogation Centers. One of these centers was constructed, with agency funds, in each of South Vietnam's forty-four provinces. An agency operator or contract employee directed each center's operation, much of which consisted of torture tactics against suspected Vietcong, such torture usually carried out by Vietnamese nationals.

### THE PHOENIX TERRORIST **PROGRAM!!**

In 1967 Colby's office devised another program, eventually called Phoenix, to coordinate an attack against the Vietcong infrastructure among all Vietnamese and American police, intelligence, and military units. Again CIA money was the catalyst. According to Colby's own testimony in 1971 before a congressional committee, 20,587 suspected Vietcong were killed under Phoenix in its first two and a half years. Even Colby has admitted that serious abuses were committed under Phoenix. Former intelligence officers have come before congressional committees and elsewhere to describe repeated examples of torture and other particularly repugnant practices used by Phoenix operatives. Political calls were made and other promises made and Moynihan decided that suddenly he did not want the U.N. ### **KISSINGER'S CLONE**

Henry Kissinger was now Bush's boss even more than Nixon was, and later, as the Watergate scandal progressed into 1973, the dominion of Kissinger would become even more absolute. During these years Bush, serving his apprenticeship in diplomacy and world strategy under Kissinger, became a virtual Kissinger clone in two senses. First, to a significant degree, Kissinger's networks and connections merged together with Bush's own, foreshadowing a 1989 administration in which the NSC director and the number two man in the State Department were both Kissinger's business partners from his consulting and influence peddling firm, Kissinger Associates. Secondly, Bush assimilated Kissinger's characteristic British-style geopolitical mentality and

The most essential level of Kissinger was the British one. This meant that U.S. foreign policy was to be guided by British imperial geopolitics, in particular the notion of the balance of power: The United States must always ally with the second strongest land power in the world (Red China) against the strongest land power (The U.S.S.R.) in order to preserve the balance of power. This was clearly and succinctly expressed in the 1971-72 Nixon-Kissinger opening to Beijing, to which Bush would contribute from his U.N. post. The balance of power, since it rules imperialism and neocolonialism, aniout a positive engagement for the economic progress of the international community as a whole, has always been a recipe for new wars. Kissinger was in constant contact with British foreign policy operatives like Sir Eric Roll of S. G. Warburg in London, Lord Victor Rothschild, the Barings Bank and others.

On May 10, 1982, in a speech entitled "Reflections on a Partnership" given at the Royal Institute of International Affairs at Chatham House in London, Henry Kissinger openly expounded his role and philosophy as a British agent-of-influence within the U.S. government during the Nixon and Ford years:

"The British were so matterof-fact helpful that they became a participant in internal American deliberations, to a degree probably never before practiced between sovereign nations. In my period in office, the British played a seminal part in certain American bilateral negotiations with the Soviet Union--indeed, they helped draft the key document. In my White House incarnation then, I kept the British Foreign Office better informed and more closely engaged than I did the American State Department.... In my negotiations over Rhodesia I worked from a British draft with Britgrasp the distinction between a working paper and a Cabinet-approved document."

### NATIONALIST CHINA OUSTED FROM U.N.

One of the realities of 1971 was themselves to be financially unable to maintain their military presence in the Indian Ocean and the Far East, in the area "East of Suez". Part of the timing of the Kissinger China card was dictated by the British desire to acquire China as a counterweight to India in this vast area of the world, and also to insure a U.S. military presence in the Indian Ocean, as seen later in the U.S. development of an important base on the island of Diego Garcia.

On a world tour during 1969, Nixon had told President Yahya Khan, the dictator of Pakistan, that his administration wanted to normalize relations with Red China and wanted the help of the Pakistani government in exchanging messages. Regular meetings between the United States and Beijing had gone on for many years in Warsaw, but what Nixon was talking about was a total reversal of U.S. China policy. Up until 1971, the U.S.A. had recognized the government of the Republic of China on Taiwan as the sole sovereign and legitimate authority over China. The United States, unlike Britain, France, and many other cynical, duplicitous diplomatic cha-Western countries, had no diplomatic rade in which Bush would have the relations with the Beijing Communist leading part.

This meant that the honor of U.S. commitments to the R.O.C. had to be dumped overboard as so much useless ballast, whatever the domestic political consequences might be. This was the task given to Kissinger, Nixon, and George Bush.

### HATCHING "TWO CHINAS" DECEIT

The maneuver on the agenda for 1971 was to oust the R.O.C. from the U.N. Security Council and assign their seat to Beijing. Kissinger and Nixon calculated that duplicity would insulate them from domestic political damage: While they were opening to Beijing, they would call for a "two Chinas" policy, under which both Beijing and Taipei would be represented at the U.N., at least in the General Assembly, despite the fact that this was an alternative that both Chinese governments vehemently rejected. The U.S.A. would pretend to be fighting to keep Taipei in the U.N., with George Bush leading the fake charge, but this effort would be defeated. Then the Nixon Administration could claim that the vote in the U.N. was beyond its control, comfortably resign itself to Beijing in the Security Council, and pursue the China card. What was called for was a

This scenario was complicated by The Chinese seat among the five the rivalry between Secretary of State Rogers and NSC boss Kissinger. Rogers was an old friend of Nixon, but it was of course Kissinger who made foreign policy for Nixon and the rest of the government, and Kissinger who was incomparably the greater evil. Between Rogers and Kissinger, Bush was unhesitatingly on the side of Kissinger. The Nixon-era China card took shape during July 1971 with Kissinger's "Operation Marco Polo I", his secret first trip to Beijing. Kissinger says in his own memoirs that Bush was considered a candidate to make this journey, along with David Bruce, Elliot Richardson, Nelson Rockefeller, and Al Haig. Kissinger first journeyed to India, and then to Pakistan. From there, with the help of Yahya Khan, Kissinger went on to Beijing for meetings with Chou En-lai and other Chinese officials. He returned by way of Paris, where he met with North Vietnamese negotiator Le Duc Tho at the Paris talks on Indo-Returning to Washington, China. Kissinger briefed Nixon on his understanding with Zhou. On July 15, 1971 Nixon announced to a huge television and radio audience that he had accepted "with pleasure" an invitation to visit China at some occasion before May of 1972. He lamely assured "old friends" (meaning Chiang Kai-shek and the R.O.C. government on Taiwan) that their interests would not be sacrificed. Later in the same year, between October 16 and 26, Kissinger undertook operation "Polo II", a second, public visit with Zhou in Beijing to decide the details of Nixon's visit and hammer out what was to become the U.S.-P.R.C. Shanghai Communique, the joint statement issued during Nixon's stay. During this visit, Zhou cautioned Kissinger not to be disoriented by the hostile Beijing propaganda line against the U.S.A., manifestations of which were everywhere to be seen. Anti-U.S. slogans on the walls, said Zhou, were meaningless, like "firing an empty cannon". Nixon and Kissinger eventually journeyed to Beijing in February of 1972.

### FARCE IN THE U.N. OF "TWO CHINAS"

It was before this backdrop that Bush waged his farcical campaign to keep Taiwan in the U.N. The State Department had stated through the mouth of Rogers on August 2 that the

United States would support the adwould oppose the expulsion of Taiwan. This was the so-called "two Chinas' policy. In an August 12 interview, Bush told the Washington *Post* that he was working hard to line up the votes to keep Taiwan as a U.N. member when the time to vote came in the fall. Responding to the obvious impression that this was a fraud for domestic political purposes only, Bush pledged his honor on Nixon's commitment to "two Chinas". "I know for a fact that the President wants to see the policy implemented," said Bush, with his usual straight "lips moving'' face. He added that he had discussed the matter with Nixon and Kissinger at the White House only a few days before. Bush said that he and other members of his mission had lobbied 66 countries so far, and that this figure was likely to rise to 80 by the following week. Ultimately Bush would claim to have talked personally with 94 delegations to get them to let Taiwan stay, which a fellow diplomat called "a quantitative track record".

It was noted that the U.S. activity was entirely confined to the highprofile "glass palace" of the U.N., and that virtually nothing was being done by U.S. ambassadors in capitals around the world. But Bush countered that if it were just a question of going through the motions as a gesture for Taiwan, he would not be devoting so much of his time and energy to the cause. The main effort was at the U.N. because "this is what the U.N. is for", he commented. Bush said that his optimism about keeping the Taiwan membership had increased over the past three weeks.

By late September, Bush was saying that he saw a better than 50-50 chance that the U.N. General Assembly would seat both Chinese governments. By this time, the official U.S. position as enunciated by Bush was that the Security Council seat should go to Beijing, but that Taipei ought to be allowed to remain in the General Assembly. Since 1961, the U.S. strategy for blocking the admission of Beijing had depended on a procedural defense, obtaining a simple majority of the General Assembly for a resolution defining the seating of Beijing as an important question, which required a two-thirds majority in order to be implemented. Thus, if the U.S.A. could get a simple majority on the procedural vote, one-third plus one would suffice to defeat Beijing on the second vote.

Compared to other aspects of the Vietnam war, the CIA's use of the black market is not a major issue. It simply points up the fact that the CIA is not bound by the same rules that apply to the rest of the government. The Central Intelligence Agency Act of 1949 makes this clear: "The sums made available to the Agency may be expended without regard to the provisions of law and regulations relating to the expenditures of Government." The CIA in Vietnam even escaped the Johnson administration's worldwide edict that all cars purchased by the American government would be of American manufacture. While State Department and AID personnel were forced to navigate Saigon's narrow streets in giant Chevrolets and Plymouths, the agency motorpool was full of much smaller and more practical Japanese Toyotas. 

This intelligence was forwarded to CIA headquarters in Langley, Virginia and from there sent on an "eyes only" basis to Henry Kissinger at the White House and top officials of the State Department, the Defense Department, and the National Security Agency. Within a few days, on October 8, the same radicals identified in the CIA report commandeered at gunpoint a Brazilian commercial airliner with 49 people aboard, and after a refueling stop in Guyana, forced the pilot to fly to Havana. Neither the CIA nor the other agencies of the U.S. government which had advance warning of the radicals' plans moved to stop the crime from being committed, although at measures to stamp our aerial piracy.

> This system, the doctrine of 3CI, has matured into a global scale based on maximum utilization of electromagnetic energy and pulse systems-mostly through the sophisticated testing on the military "soldiers" (troops) in that Vietnam War. Two things happened; in the physicals and injections, etc., the soldiers were implanted with "receiver chips" whereby the instructions could be sent directly and individually as well as in group reception. As other substances were "tested" the manipulation could be studied by differing experiments and enhancement of any transmission by direct control.

The only restriction ever placed on this military doctrine since its inception was derived from the period of time immediately following World War II and during the beginning of the 'Cold War''. In the early 1950's, the Also, remember, that since that Department of Defense recognized the need for some sort of "safe exposure standard" for microwaves. This led directly to the establishment of the Tri-Services Program, based in the Rome Air Development center in the task of determining this standard. However, even before the Tri-Services Program began, the military eagerly adopted the concept that only thermal effects were damaging to living organisms. Based solely in calculations, the magic figure of 10 milliwatts per square centimeter was adopted by the Air Force as the standard for safe exposure. Subsequently, the thermal-effects concept has dominated policy decisions to the complete exclusion of nonthermal bioeffects.

> While the 10 mW/cm<sup>2</sup> standard was limited to microwave frequencies, the thermal concept was extended to all other parts of the electromagnetic spectrum. Unless it heated tissue, electromagnetic radiation was thought to be harmless, so there were quencies below microwave.

The military organism was designed on the 10-mW standard and, once in place, it had to be defended against the possibility of nonthermal bioeffects. The recognition and validation of these effects would mean the collapse of the total organism and the death of 3CI. By the early 1970's it was fully apparent that scientists and engineers involved in the program were sucked into a massive conspiracy--especially in the early programs involving electrical control systems and the bioeffects of electromagnetic fields. It was quickly seen that evidence for nonthermal effects was viewed as a total threat to national security. 

A derivative of this program is HPM (high-power pulsed microwave), a system producing intense, extremely short pulses of microwave. Several types, ranging in frequency from 1200 MHz to 35 GHz with powers up to 1000 megawatts, are tested and ready for use. These are also ready for use as weapons against humans and, against these weapons, no gun can even be relatively compared.

There is a report which can (or maybe can't be) acquired which deals with the testing program of the Microwave Research Department at the Walter Reed Army Institute of Research. It states, "Microwave energy in the range of 1 to 5 GHz, a militarily important range, penetrates all organ systems of the body and thus puts all organ systems at risk." Effects on the central nervous system are considered very important. The testing program, begun in 1986, is divided into four parts: 1) prompt debilitation effects; 2) prompt stimulation through auditory effects; 3) work interference/ stoppage effects; and 4) effects on stimulus-controlled behavior. The report goes on to state, "Microwave pulses appear to couple to the central nervous system and produce stimulation similar to electrical stimulation unrelated to heat." It appears that HPM is capable of altering behavior in the same fashion as Delgado's electrical stimulation (which we will not go into herein).

The production of cognitive and behavioral alterations by HPM is a sledgehammer effect in comparison to the subtle alterations produced by ELF fields. 

#### **TESLA REMEMBERS**

It is lonely I am for a good snowcovered day for communion as we have had in the past with sharing and visitation. It is indeed sad that ones deny the contact and choose their own mystical journeys instead of honoring their contract for service--choosing to "run away" before the cake is finished to the serving. Impatience and greed are the curse of man.

It is impossible to resist your courteous request extended on an occasion of such moment in the life of your JOURNAL. Your request has vivified the memory of our beginning friendship, of the first imperfect attempts and underserved successes, of kindnesses and misunderstandings. Always it brings painfully to mind the greatness of early expectations, the quick flight of time, and alas! the smallness of realizations. The following was given to the world but so few paid heed and then, as is the case in the human experiment--the mystery found its way into the hands of evil doers.

Let me look back toward the close of your year 1898 in which a systematic research, carried on for a number of years with the object of perfecting a method of transmission of electrical energy through the natural medium, led me to recognize three important necessities: first, to develop a transmitter of great power; second, to perfect means for individualizing and isolating the energy transmitted; and, third, to ascertain the laws of propagation of currents through the earth and the atmosphere. Various reasons, not the least of which was the help proffered by my friend Leonard E. Curtis

Company, determined me to select for my experimental investigations the large plateau, two thousand meters above sea-level, in the vicinity of that delightful resort, which I reached late in May, 1899.

I take note that the general area is still a bustling center of activity, mostly underground now, for completion of that which I was not destined to finish in my sojourn--now turned to the most heinous of uses in destruction and control of the masses of civilians into imprisonment of a world.

I had not been there but a few days when I congratulated myself on the happy choice and I began the task, for which I had long trained myself, with a grateful sense and full of inspired hope. The perfect purity of the air, the unequaled beauty of the sky, the imposing sight of a high mountain range, the quiet and restfulness of the place-all around contributed to make the conditions for scientific observation ideal. To this was added the exhilarating influence of a glorious climate and a singular sharpening of the senses. In those regions the organs undergo perceptible physical changes. The eyes assume an extraordinary limpidity, improving vision; the ears dry out and become more susceptible to sound. Objects can be clearly distinguished there at distances such that I prefer to have them told by someone else, and I have heard-this I can venture to vouch for--the claps of thunder seven and eight hundred kilometers away. I might have done better still had it not been tedious to wait for the sounds to arrive, in definite intervals, as heralded precisely by an electrical indicating apparatus--nearly an hour before.

In the middle of June, while preparations for other work were going on, I arranged one of my receiving transformers with the view of determining, in a novel manner, experimentally, the electric potential of the globe and studying its periodic and casual fluctuations. This formed part of a plan carefully mapped out in advance. A highly sensitive, self-restorative device, controlling a recording instrument, was included in the secondary circuit, while the primary was connected to the ground and an elevated terminal of adjustable capacity. The variations of potential gave rise to electric surgings in the primary; these generated secondary currents, which in turn affected the sensitive device and recorder in proportion to their

and the Colorado Springs Electric literally, alive with electrical vibra- ished it again. Nevertheless, my intions, and soon I was deeply absorbed in this interesting investigation. No better opportunities for such observafound anywhere. Colorado is a country famous for the natural displays of electric force. In that dry and rarefied atmosphere the sun's rays beat the objects with fierce intensity. I raised steam, to a dangerous pressure, in barrels filled with concentrated salt solution, and the tin-foil coatings of some of my elevated terminals shriveled up in the fiery blaze. An experimental high-tension transformer, carelessly exposed to the rays of the setting sun, had most of its insulating compound melted out and was rendered useless.

> Aided by the dryness and rarefaction of the air, the water evaporates as in a boiler, and static electricity is developed in abundance. Lightning discharges are, accordingly, very frequent and sometimes of inconceivable violence. On one occasion approximately twelve thousand discharges occurred in two hours, and all in a radius of certainly less than fifty kilometers from the laboratory. Many of them resembled gigantic trees of fire with the trunks up or down. I never saw fire balls, but as a compensation for my disappointment I succeeded later in determining the mode of their formation and producing them artificially. Never be dismayed or disappointed at that which is given and which at the moment seems without merit--for it can only open the way into deeper and more profound information as you allow your mind to for the most part--an evil civilization consider the circumstance.

In the latter part of the same month I noticed several times that my instruments were affected stronger by discharges taking place at great distances than by those near by. This puzzled me very much. What was the cause? A number of observations proved that it could not be due to the differences in the intensity of the individual discharges, and I readily ascertained that the phenomenon was not the result of a varying relation between the periods of my receiving circuits and those of the terrestrial disturbances. One night, as I was walking home with an assistant, meditating over these experithought. Years ago, when I wrote a chapter of my lecture before the Franklin Institute and the National Electric Light Association, it had preintensity. The earth was found to be, it as absurd and impossible. stinct was aroused and somehow I felt that I was nearing a great revelation.

It was on the third day of July--the tions as I intended to make could be date I shall never forget--when I obtained the first decisive experimental evidence of a truth of overwhelming importance for the advancement of humanity. A dense mass of strongly charged clouds gathered in the west and towards the evening a violent storm broke loose which, after spending much of its fury in the mountains, was driven away with great velocity over the plains. Heavy and long persisting arcs formed almost in regular time intervals. My observations were now greatly facilitated and rendered more accurate by the experiences already gained. I was able to handle my instruments quickly and I was prepared. You see, it is always good to be prepared and therefore be able to move on without interrupting distractions. If you are, for instance, trying to survive you certainly have no time for invention other than to the problem immediately at hand. I suggest you pay close attention to your friend, Gyeorgos, come forth to give you a hand in your tedious journey. We are not yet of that higher level of total understanding and cannot serve in the same guidance capacity. I, myself, am most limited to my realm of expertise and as of yet have no need of more general "life" knowledge in the "knowingness". I am most happy to be of assistance to you but I feel no obligation nor pressure to serve in that capacity longer. I found my journey on your place to be most disagreeable filled with vile vipers.

At any rate, back to my story--the recording apparatus being properly adjusted, its indications became fainter and fainter with the increasing distance of the storm, until they ceased altogether. I was watching in eager expectation. Surely enough, in a little while the indications again began, grew stronger and stronger and, after passing through a maximum, gradually decreased and ceased once more. by my assistant, Mr. Fritz Lowenstein, and shortly afterward several admirable opportunities presented themselves which brought out, still more forcibly, and unmistakably, the true nature of the wonderful phenomenon. No doubt whatever remained: I was observing stationary waves.

As the source of disturbances moved away the receiving circuit came successively upon their nodes and loops. Impossible as it seemed, your planet, despite its vast extent, behaved like a conductor of limited dimensions. The tremendous significance of this fact in the transmission of energy by my system had already become quite clear to me. Not only was it practicable to send telegraphic messages to any distance without wires, as I recognized long before, but also to impress upon the entire globe the faint modulations of the human voice, far more sull, to transmit power, in unlimited amounts, to any terrestrial distance and almost without any loss whatsoever.

With these stupendous possibilities in sight, with the experimental evidence before me that their realization was henceforth merely a question of expert knowledge, patience and skill, I attacked vigorously the development of my magnifying transmitter, now, however, not so much with the original intention of producing one of great power, as with the object of learning how to construct the best one. This is, essentially, a circuit of very high self-induction and small resistance which, in its arrangement, mode of excitation and action, may be said to be the diametrical opposite of a transmitting circuit typical of telegraphy by Hertzian or electromagnetic radiations. It is difficult to form an adequate idea of the marvelous power of this unique appliance, by the aid of which the globe will be transformed. The electromagnetic radiations being reduced to an insignificant quantity, and proper conditions of resonance maintained, the circuit acts like an immense pendulum, storing indefinitely the energy of the primary exciting impulses and impressions upon the earth and its conducting atmosphere uniform harmonic oscillations of intensities which, as actual tests have shown, may be pushed so far as to surpass those attained in the natural displays of static electricity.





raised \$100,000 for the Clinton campaign. Stephens had the controlling interest in Worthern National that gave the \$2 million line of credit to Clinton. Another inner-circle Clinton associate, Dan Lasater, headed the now "deceased" Lasater and Company with his brother Roger. Both Lasaters were arrested in connection with cocaine handling on very serious charges.

Hillary Clinton's law firm's name is on the ADFA-related bond issues and the loan agreement papers, and Mrs. Clinton has represented a company in litigation owned by Stephens and son Warren. Hillary Clinton's law partner, Webb Hubbel, represented POM Company who got the first loan from ADFA. POM has been frequently mentioned within the framework of Mena, the hub of drug smuggling in western Arkansas. Webb Hubbel represented Seth Ward, Jr., the president of POM in the first ADFA loan. Ward is a Clinton insider. The Worthern Bank that made \$2 million available to Clinton had liens on POM.

While Clinton purports to be against drugs and says he wants to interdict drugs coming into U.S., he has done nothing about the airport at Mena, the hub of drug smuggling in Arkansas. Clinton was FULLY informed about operations at Mena by state prosecutor Charles Black in 1988. Before that, in 1983, the State Police also joined a grand jury investigation, which jury was eventually dissolved. Local press accounts at the time said members of the grand jury were prevented from seeing crucial evidence, hearing important witnesses. The panel was not even permitted to see twenty-nine draft indictments on money laundering drawn up by the Justice Department's "Operation Greenback"

In 1989 Governor Clinton was petitioned by Arkansas citizens demanding he convene a state grand jury and continue the investigation. William Bryant, now State Attorney, made drugs and Mena an issue in his election campaign. In 1990 Bryant delivered files and petitions to special prosecutor Walsh who has thus far apparently sat on them. On August 12th, 1991. Clinton got his criminal justice advisor to write to citizens who had petitioned Governor Clinton. The letter

stated the governor understood that the matter of criminal goings-on in Mena was being studied by Bryant, Walsh and Rep. Bill Alexander.

Since then Clinton has done AB-SOLUTELY NOTHING to further the matter. His state prosecutor has all authority to reconvene the grand jury and order a full investigation. In spite of urgent requests from Charles Black that Clinton allocate funds for such an investigation, CLINTON COM-PLETELY IGNORES BLACK'S **REQUESTS.** Representative Alexander says the only thing holding up the investigation is lack of funding. In November 1991, Alexander got Congress to allocate \$25,000 for the investigation, but the money is "lost" somewhere in Arkansas bureaucracy.

Clinton MUST be asked questions about these matters, especially about the drug matters related to Mena. We can be sure that Bush will do nothing. and we all know the reason why. It is the duty of those in the press and television media to call for a full scale investigation of Clinton, his BCCI funding and the activities of his wife's law firm. But will they? Given the fact that Clinton is Rockefeller's blueeyed boy, it is likely that nothing will be forthcoming.
