
The shelter placed in an excavated area with entrance way attached prior to covering with earth.








The entrance way hatch at ground level has no projections and lies flush with the ground surface.

Riconosciuto, a primary electronics expert for the U.S. intelligence community, was arrested seven days after providing Congress with testimony in the INSLAW case. When his attorney Dennis Eisman was to have picked up critical information in the case which was destined for Casolaro and Riconosciuto, he was found shot to death. Some of the individuals and companies Casolaro was following leads on at the time of his death are: Dominic and Bob Balsano, Gemini Industries, The Papago Indian Tribe, the Menominee Indian Tribe, The Cabazon Indian Tribe, The Primerit Bank of Nevada, BCCI and 312 other related financial institutions, Dr. Earl Brian, Southern California, Home Savings and Loan of Seattle, Theodore Strand, Robert Booth Nichols, The Department of Commerce, and the Wackenhut Corp.

Casolaro was also investigating the links between the deaths of Indians and journalist Don Bolles who was killed in a car explosion in Arizona in 1976. # CORPORATE BUSINESS EXPENSES

In managing an active corporation, it is important to be familiar with all the aspects of a corporation's functioning. Part of those management responsibilities are being familiar with business expenses. This means understanding which expenses are deductible to a corporation and which are not. By familiarizing yourself with all legal business expenses, you can dramatically reduce your corporate taxes and receive more personal tax-free perks. Below we are listing business expenses that we feel are noteworthy, plus those expenses that could be considered perks or fringe benefits.

Before we begin, we would like to recommend, to each corporate manager, that they acquire IRS Publications: 535 on "Business Expenses", 529 on "Miscellaneous Expenses", 542 on "Tax Information", and 1120 called "U.S. Corporation Income Tax Package". All of these publications can be obtained either by going in person to your local IRS office or can be mailed to you free by calling 1-800-TAX-FORM.

#### SELECTED BUSINESS EXPENSES:

- \*Start-Up Costs: No deductions are allowed for start-up expenses unless the corporation chooses to treat those expenses as deferred expenses and to amortize them equally over a period of no less than 60 months; i.e. fees paid to start a corporation.
- \* Employee Achievement Awards: These are non-cash awards and their value cannot exceed \$400.
- \* Car Mileage: 28 cents per mile is the current rate that a business can reimburse an individual for using their car for business purposes. This is not considered income to the individual. (Note: an alternative to this is to rent a car to a corporation. This is a way of drawing funds out of a corporation without Employee Taxes or Self-Employment Taxes being paid on rental income.)
- \* Automobile Lease Program: This is for vehicles leased by the corporation.
- \* Meals And Lodging: Generally you can deduct the costs of these as long as the expense is an ordinary and necessary business expense.
- \*Entertainment: 80% of an entertainment expense is deductible to a corporation. This expense must be somehow related to business activities. Why not plan a tax-deductible business trip and take in a bit of tax-deductible entertainment while you're at it.

deduct educational expenses for employees as long as the education is job related. This would include college courses, business programs and any related seminars. Why not hire a son or daughter about to enter college, to work for your corporation, and have your business pay for their school? (As long as that education would benefit the corporation, it is considered a legitimate business expense.)

- \* Employee Health Insurance.
- \* Employee Dental Insurance.
- \* Monies Given To Qualified Non-Profit Businesses: This use of funds is how the Rockefeller Corporations support their own Non-Profit Organizations, which in turn go and do business with those same Rockefeller Corporations. This allows them to float profits through these organizations year after year without paying taxes on those profits.
- \* State Income Tax: If a corporation has to pay State Income Tax, this is a deductible item. However, if the business is a Nevada Corporation, there is **NO** State Income Tax.
- \* Child Care: You may pay up to \$5000 annually for an employee's child care without considering it income to the employee. (Note: This is not an option for those individuals who

are contractors to a corporation.)

Keeping these corporate expenses in mind, and reviewing the IRS Publications mentioned above, you will have a much better understanding of just how to properly manage the tax potential of your corporation's revenues. Needless to say, there is much latitude for judicious tax savings by the legal yet skillful and informed utilization of a corporate business structure.


